

MUKARUGWIZA v BANK OF KIGALI LTD (BK)

[Rwanda URUKIKO RW'UBUJURIRE – RS/INJUST/RCOM 00004/2019/CA (Mukandamage, P.J., Ngagi na Kamere, J.) 04 Nzeli 2020]

Amategeko agenga imiburanishirize y'imanza z'ubucuruzi – Gusubirishamo urubanza ingingo nshya – Inyandiko ishyikirijwe urukiko nk'ikimenyetso gishya – Iyo urukiko rusuzuma ikimenyetso rwashyikirijwe niba ari gishya rwarangiza rukakigereranya n'ibindi byatanzwe mbere, ntirwemeza ko rutakiriye ikirego ahubwo rucyacyira rugasuzuma ishingiro ry'ikimenyetso rwashyikirijwe niba ari gishya.

Amategeko agenga imiburanishirize y'imanza z'ubucuruzi – Ingwate – Kwandikisha ingwate – Kwishyura umwenda wavuye mu cyamunara – Iyo banki yahawe ingwate ku myenda y'abantu batandukanye ikayandikisha ku rwego rutari rwo (rang/ranking) hagendewe ku masezerano impande zombi zagiranye bigatuma umutungo wari waratanzweho ingwate ugurishwa mu cyamunara, muri icyo gihe hishyurwa umwenda hagendewe ku ngwate yari yandikishijwe mbere.

Incumake y'ikibazo: Banki ya Kigali yahaye umwenda Mukarugwiza atanga n'ingwate. Mu masezerano bagiranye bemeranyijwe ko ingwate ye yandikwa ku rwego rwa mbere. Karenzi John nawe yaje guhabwa inguzanyo na Banki ya Kigali atanga ingwateho inzu ya Mukarugwiza, yandikwa ku rwego rwa kabiri kuri iyo ngwate.

Banki ya Kigali yaje kubona ko Karenzi atishyura isaba guteza cyamunara ingwate yari yatanze ariko ntihabanza gukurwamo umwenda wafashwe na Mukarugwiza.

Mukarugwiza yatanze ikirego mu Rukiko rw'Ubucuruzi rwa Nyarugenge asaba ko amafaranga yavuye mu cyamunara yagombaga kubanza kwishyura umwenda we yari asigayemo Banki ya Kigali. Urukiko rw'Ubucuruzi rwa Nyarugenge rwemeje ko ikirego cye gifite ishingiro ariko Banki ya Kigali ijuririye Urukiko Rukuru rw'Ubucuruzi rubibona ukundi ivuga ko ingwate ya Mukarugwiza itanditse mu bitabo by'ingwate.

Mukarugwiza yasubirishijemo urubanza ingingo nshya agaragaza ko ingwate yari yanditse ariko Urukiko Rukuru rw'Ubucuruzi rwanga kwakira ikirego cye. Mukarugwiza yasubirishijemo urubanza ku mpamvu z'akarengane avuga ko Mukarugwiza yagiranye amasezerano y'inguzanyo na Banki ya Kigali itanga ingwate yaje kwandikisha nyuma y'imyaka ibiri (2). Indi nguzanyo yahaye Karenzi nawe agatanga ingwate ya Mukarugwiza Banki ya Kigali nayo yayanditse ku rwego rwa mbere kandi yari kuyandikisha ku rwego rwa kabiri nk'uko byari bikubiye mu masezerano bagiranye.

Banki ya Kigali yireguye ivuga ko amafaranga yavuye mu cyamunara cy'inzu ya Mukarugwiza yagombaga kwishyura umwenda wa Karenzi kandi ko ingwate ye ariyo yanditswe mbere.

Incumake y'icyemezo: 1. Iyo urukiko rutasuzumye niba koko ikimenyetso gishya cyatanzwe n'umuburanyi asaba gusubirishamo urubanza ingingo nshya kitarashingiweho mu ica ry'urubanza ku buryo byaba byaramuteye akarengane, kandi ko cyari ikimenyetso cya kamarampaka, icyo gihe ruba rugomba kwemeza ko ikirego cy'uwo muburanyi cyakiriwe, rugafata umwanzuro ukwiye rukurikije uko rwagisuzumye. Bityo, ikirego cya Mukarugwiza kikaba kigomba kwakirwa kigasuzumwa hitabwa ku bimenyetso byatanzwe.

2. Banki niyo ifite inshingano zo kwandikisha neza ingwate yahawe. Iyo ikoze amakosa yo gushyira ingwate imwe yatanzwe ku myenda ibiri ku ku rwego rumwe, kandi izi neza ibikubiye mu masezerano yagiranye n'abo yahaye inguzanyo, bigatuma hatezwa cyamunara, amafaranga avuye mu cyamunara abanza kwishyura umwenda w'uwigombaga kwandikwa ku rwego rwa mbere hakurikijwe amasezerano y'inguzanyo impande zombi zagiranye. Bityo, amafaranga yavuye mu cyamunara akaba agomba kubanza kwishyura umwenda wahawe Mukarugwiza.

[26] Ingingo ya 64 y’Itegeko no 45/2011 ryo ku wa 25/11/2011 rigenga amasezerano iteganya ko “Amasezerano akozwe mu buryo bukurikije amategeko aba itegeko ku bayagiranye. Ashobora guseswa ari uko babyumvikanyeho cyangwa ku mpamvu zemewe n’amategeko. Agomba kubahirizwa nta buriganya”.

[27] Naho ku byerekeye uburyo amafaranga avuye mu ngwate yagurishijwe akoreshwa, ingingo ya 22 y’Itegeko no 10/2009 ryo ku wa 14/05/2009 ryerekeye ubugwate ku mutungo utimukanwa nk’uko ryahinduwe kandi ryavuguruwe kugeza ubu, iteganya ko “akoreshwa hakurikijwe urutonde rw’ibikenewe rukurikira: 1° kwishyura inyungu yose, amafaranga y’ubukode, amahoro, ayakoreshejwe cyangwa andi mafaranga ya ngombwa kandi agomba kwishyurwa ku ngwate; 2° kwishyura amafaranga yakoreshejwe n’andi yose agomba kwishyurwa, harimo ayishyurwa uwahawe gucunga ingwate; 3° kwishyura umwenda wa mbere watangiwe ingwate cyangwa igice cy’uwo mwenda gisigaye, inyungu cyangwa ibindi bintu byatumye haba igurisha; 4° kwishyura ingwate yose y’inyongera ku mutungo utimukanwa hakurikijwe urutonde rw’ubusumbane mu bugwate.
