[2] SOMEX S.A. yaje kuregera Urukiko rw'Ubucuruzi rwa Nyarugenge ivuga ko yoherereje CHAPA KAZI Ltd amabalo afite agaciro ka 843.265.56 Usd, ariko ko CHAPA KAZI Ltd yabasigayemo umwenda ungana na 438.269 Usd, kuko ibicuruzwa bifite reference za AFY 8370, AFY 8371, AFY 8372, bitishyuwe, akaba ariyo yishyusa hamwe n'inyungu zayo zihwanye na 60.000 Usd n'indishyi zo gukurikirana urubanza, ariko CHAPA KAZI Ltd yo ikavuga ko SOMEX S.A. ariyo yishe amasezerano kuko yabagemuriye amabalo 1.565 aho kugemura 2.500, ko kuri ayo mabaro hishyuwe 704.250 Usd, nyuma yishyura 780.000 Usd kuri konti BE 8764309249431 ya SOMEX S.A. iri muri Banca Monte PASCHI Belgique, ko amabalo yose SOMEX S.A. yohereje yishyewe, ahubwo ko yarengejeho 76.188,73 Usd kuko nta décompte bakoraga.
