Amategeko agenga umuryango – Umutungo wa bashakanye – Ubugure bw’inzu – Inzu yagurishijwe n’umwe mu bashakanye akagura indi igabana ritararangira – Iyo abashakanye bari barumvikanye uburyo bagabana imitungo ariko iryo gabana rikaza guteshwa agaciro kandi hari umwe wamaze kugurisha umutungo bari baragabanye nyuma akaguramo undi, uwaguze umutungo wagabanywe mbere ntiyahungabanywa mu burenganzira bwe ahubwo abashakanye baba bagomba kugabana umutungo waguzwe nyuma y’iryo gurisha mu buryo bungana.

Incamake y’ikibazo: Uwamwezi yashakanye na Ranguella mu buryo bukurikije amategeko baza kugera ho bumvikana kugabana imitungo yabo bakora “*contrat de partage*”. Mu mitungo yeguriwe Ranguella uherereye i Nyarugenge yaje kuwegurira sosiyete SOGIS Ltd nayo iwugurisha Rugenera Marc n’umugore we Kitenge

Uwamwezi yatanze ikirego mu Rukiko rw’Ubucuruzi asaba ko amasezerano y’ubugure bw’inzu yagurishijwe Rugenera n’umugore yatashwa agaciro kuko bayigurishijwe atabitangiye uburenganzira kandi ari umutungo bahuriyeho. Urukiko rwemeje ko ikirego cya Uwamwezi gifite ishingiro kuko ari umugore w’isezerano kandi na “*contrat de partage*” yabo ikaba yari yarateshejwe agaciro n’Urukiko rw’Ikirenga. icyo gihe rwategetse ko SOGIS Ltd gusubiza Rugenera n’umugore we 120.000.000 frw y’ikiguzi cy’inzu.

Ranguella na SOGIS Ltd ku ruhanda rumwe bajuririyeye Urukiko Rukuru rw’Ubucuruzi ku rundi ruhanda Rugenera n’umugore we nabo barajurira bavuga ko bavuga ko batishimiye imikirize y’urubanza maze Urukiko Rukuru rw’Ubucuruzi rwemeza ko ubujurire bwa Ranghella na SOGIS Ltd nta shingiro bufite ko ubwa Rugenera n’umugore we Kitenge bufite ishingiro kuko nyuma yo kugura inzu ya Nyarugenge Ranghella yaguzwe indi nzu Kamonyi, ko iyo ariyo Ranghella yagabana na Uwamwezi mu buryo bungana.

Uwamwezi yajuririyeye Urukiko rw’Ubujurire avuga ko ubugure bwabaye hgate ya SOGIS Ltd na Rugenera n’umugore we Kitenge bwatashwa agaciro ngo kuko igihe inzu yagurwaga “*contrat de partage*” itari ikiriho kuko yari yarakuweho n’Urukiko rw’Ikirenga.

Ranguella na SOGIS Ltd bo bireguye bavuga ko umutungo wagurishijwe ari uwa SOGIS Ltd kuko rwemeje ko ubugure Rugenera n’umugore we bagiranye na sosiyete bufite agaciro; bityo ko Uwamwezi nta ruhare yagira ku mutungo w’inzu ya Kamonyi kuko ari uwa sosiyete.

Rugenera n’umugore we Kitenge bireguye bavuga ko baguze inzu mu buryo bwemewe na sosiyete SOGIS Ltd knadi n’urukiko rukaba rwari rufite amakuru ko amafaranga yavuye mu kiguzi cy’inzu baguze yaguzwe indi nzu ku Kamonyi; bityo basaba ko batahungabanywa mu mutungo baguze kuko amakimbirane y’abashakanye atakagombye kubagiraho ingaruka.

y'iryo gurisha mu buryo bungana. Bityo, Uwamwezi Joséphine na RANGHELLA Giuseppe bagomba kugabana agaciro k'inzu iri ku Kamonyi mu kibanza n° 2603 ku buryo bungana, haba hari umwe mu bashakanye ushaka kuyigumana agasubiza undi 1/2 cy'agaciro kayo mu mafaranga.

Mu mitungo bahuriyeho hari iyagiye ku ruhande rwa Ranguella Giuseppe irimo inzu y'ubucuruzi iri mu kibanza UPI 1/01/09/03/788 kiri i Nyarugenge. Iyo nzu Ranguella Giuseppe yaje kuyegurira sosiyete yitwa SOGIS Ltd, nayo iza kuyigurisha Rugenera Marc n'umugore we Kitenge Berthe.

[2] Uwamwezi Joséphine n'umwana wabo Barbara Ranguella baje gutanga ikirego mu Rukiko rw'Ubucuruzi, barega Ranguella Giuseppe, Rugenera Marc, Kitenge Berthe na SOGIS Ltd, basaba urukiko gutesha agaciro amasezerano y'ubugure bw'iyi nzu, hamwe n'amasezerano yose y'iherekanyamutungo yakorewe kuri iyi nzu icyangombwa cy'ubutaka cyayo.

[3] Uwamwezi Joséphine asobanura ko Ranguella Giuseppe yashyize uwo mutungo muri sosiyete SOGIS Ltd atabitangiye uburenganzira kandi ari umutungo bari bahuriyeho nk'abashakanye, iyo sosiyete nayo, ikaba yarawugurishije Rugenera Marc n'umugore we Kitenge Berthe. Barbara Ranguella we akavugaga ko ari umunyamigabane wa SOGIS Ltd, kandi ko iyi nzu yari umutungo wayo yagurishijwe atabyemeye, kuko icyemezo cyo kuyigurisha cyafatiwe mu nama atatumwemo.

[5] Urukiko rwanzuye ko amasezerano y'ubugure ateshejwe agaciro, kuko SOGIS Ltd yagurishije ibitari ibyayo, ruvuga ko SOGIS Ltd isubiza Rugenera Marc na Kitenge Berthe 120.000.000 Frw bari baguze iyo nzu, rutegeka Ranguella Giuseppe na SOGIS Ltd guha Uwamwezi Joséphine indishyi z'akababaro zingana na 1.000.000 Frw, rutegeka kandi Ranguella Giuseppe, SOGIS Ltd, Rugenera Marc na Kitenge Berthe guha Uwamwezi Joséphine indishyi z'ibyo yatakaje ku rubanza; harimo 200.000 Frw y'ikurikiranarubanza, 500.000 Frw y'igihembo cya Avoka na 50.000 Frw y'igarama.

[6] Ku birebana n'ikirego cyatanzwe na Barbara Ranguella, Urukiko rwemeje ko nta shingiro gifite, kuko asaba ibijyanye n'inzu yita iya SOGIS Ltd kandi Urukiko rw'Ikirenga rwaramaze gutesha agaciro amasezerano yo kugabana umutungo «*contrat de partage*» yashingiweho igihe iyo nzu yahabwaga sosiyete SOGIS Ltd.

[10] Iburanisha ry'urubanza ryabaye mu ruhame ku wa 18/05/2020 Uwamwezi Joséphine na Barbara Ranguella bahagarariwe na Me Ndagijimana Emmanuel, Rugenera Marc na Kitenge Berthe bahagarariwe na Me Twiringiyemungu Joseph, naho Ranguella Giuseppe na SOGIS Ltd bahagarariwe na Me Nkurunziza François Xavier.

[18] Me Twiringiyemungu Joseph, uhagarariye Rugenera Marc na Kitenge Berthe avuga ko ku itariki ya 30/04/2009, aribwo inama rusange ya SOGIS Ltd yemereye Ranguella Giuseppe gushyira iyo nzu muri SOGIS Ltd, kandi ibyo byakozwe «*contract de partage* » igifite agaciro, kuko urubanza ruyitesha agaciro rwaciwe n'Urukiko rw'Ikirenga mu mwaka wa 2018, ariko Urukiko rukaba rwari rufite amakuru ko amafaranga yavuye muri iyi nzu yaguzwemo indi nzu ku Kamonyi rubikemura ruvuga ko bagabana iyo nzu yavuye mu mafaranga yagurishijwe iyo ya Nyarugenge, kandi ko Urukiko Rukuru rw'Ubucuruzi rwemeje ko ikibanza no 778 kitakiri mu mutungo w'abashakanye, ko ahubwo ikigomba gusuzumwa ari ukugabana agaciro mu mafaranga hagati ya Uwamwezi na Ranguella, bivuze ko Rugenera na Kitenge bagumana umutungo baguze, icyo cyemezo Uwamwezi akaba atarigeze akivuguruzwa, ahubwo abifata nk'aho nta cyemezo cyabayeho kuri icyo kibazo.

Avuga ko inkiko zasesenguye ikibazo cyabo zirinze guhungabanya ibyagiye bikorwa na buri wese ku mutungo yegukanye, ari yo mpamvu imitungo yegukanywe na Uwamwezi Joséphine akayitangaho ingwate yananirwa kwishyura ikagurishwa, abayiguzze batigeze bategekwa kuyigarura nkuko urukiko rwabigenje ku mutungo waguzwe na Rugenera Marc na Kitenge Berthe.

“*contrat de partage*” itagomba guhungabanywa, ahubwo bagabanywa ku buryo bungana ibyo bari bafite icyo gihe.
