Indishyi – Ibarwa ry'indishyi zikomoka ku mpanuka zitewe n'ibinyabiziga – Indishyi mbangamirabukungu – Indishyi mbangamirabukungu zibarwa hashingiwe inyandiko mpamo zerekana inyungu uzisaba yacyuye ku mwuga wabo mu gihe cy'amezi 12 yabanjirije impanuka, mu gihe izo nyandiko zitagragajwe indishyi zibarwa hashingiwe ku mushahara muto w'umwaka udashobora kugibwa munsi wemewe nk'uko biteganywa n'amategeko agenga ibipimo byo guhuza imishahara n'ihindagurika ry'ibiciro by'ibantu nkenerwa – Itegeko N° 41/2001 ryo ku wa 19/09/2001 ryerekeye imyishyurire y'abangirijwe n'impanuka zitewe n'ibinyabiziga bigenzwa na moteri kandi bigenda ku butaka, ingingo ya 4, igika cya 5 n'icya 8.

Incamake y'ikibazo: Ku wa 11/02/2019 Harorimana ubwo yaratwaye imodoka yakoze impanuka yamuhitanye biturutse ku ikamyo itaramenyekanye yamugonze ikamurenza umuhanda agapfa ndetse n'imodoka ye ikangirika cyane. Abagize umuryango we barimo umugore we witwa Uwanyirigira n'abana be Kirenga, Rwema na Rwamurangwa basabye indishyi zikomoka ku mpanuka Special Guarantee Fund kuko imodoka yamugonze itabashije kumenyekana ibasubiza ko izo ndishyi batazihabwa kuko inyandikomvugo yakozwe n'umugenzyaha kuri iyo mpanuka yagaragaje ko nyakwigendera ariwe nyirabayazana w'ijo mpanuka. Ibi byatumye Uwanyirigira mu izina rye ndetse no mu izina ry'abana be atanga ikirego mu Rukiko Rwisumbuye rwa Ngoma barega Special Guarantee Fund basaba indishyi zikomoka ku mpanuka yahitanye Harorimana.

Urukiko Rwisumbuye rwasanze icyo kirego gifite ishingiro hanyuma rutegeka ko Special Guarantee Fund yawkwisyura abarega indishyi zinyuranye ariko uregwu ntityanyurwa bituma ajurira icyo cyemezo mu Rukiko Rukuru urugerekko rwa Rwamagana asaba Urukiko gusuzuma niba impanuka yahitanye Harorimana yaratewe n'ikinyabiziga kitamenyekanye, niba abatangabuhanya urukiko rwashingiyeho ari abo kwizerwa no gusuzuma ko indishyi zatanzwe zategetswe zarabazwe mu buryo bukurikije amategeko.

Urukiko Rukuru rwemeje ko ubujurire bufite ishingiro, ko imikirize y'urubanza rwaciwe n'Urukiko Rwisumbuye rwa Ngoma ihindutse ku bijyanye n'indishyi mbangamirabukungu. Urega ntityanyuzwe n'ijo mikirize y'urubanza bituma ajurira mu Rukiko rw'Ubujurire asaba kumenya niba inyandiko yiswe "Profit and loss account 31 December 2018" ifite inenge ku buryo itagenderwaho mu kubara indishyi, iyi nyandiko akaba ariyo urega avuga ko igaragaza umutungo nyakwigendera yinjizaga.

Mu iburanisha urega avuga ko Urukiko rubanza rutahaye agaciro iyo nyandiko ngo kuko yakozwe kandi igatangwa na Uwanyirigira ngo kuko yari umugore wa Nyakwigendera bigatuma rufata Harorimana nk'umuntu utaragiraga icyo akora kinjiza. [18] Mu gika cya 57 cy'urubanza N° RCA 00034/2020/HC/RWG, Urukiko Rukuru, Urugerekko rwa Rwamagana rwasanze inyandiko yiswe" Profit and Loss Account 31 December 2018" yakozwe na Uwanyirigira Josée itafatwa nk'inyandiko mpamo ku buryo Urukiko rubanza rwashoboraga kuyigenderaho mu kugena indishyi, cyane ko niba yari azi ko nyakwigendera yari rwiyemezamirimo, nta cyari kumubuza gushaka inyandiko mpamo ziteganywa n'itegeko. Rwabonye ko iyo nyandiko igaragaza urwunguko rwa sosiyete, ariko ikaba itagaragaza imisoro yatanzwe, abakozi, imishahara bahabwa, ibi byose bituma idahabwa agaciro mu ibarwa ry'indishyi mbangamirabukungu.
