Urwo Rukiko rwaciye urubanza rwemeza ko uregwa ahamwa n'icyaha cyo guceruza ibiyobyabwenge byo mu bwoko bw'urumogi, rumuhanisha igifungo cy'imyaka makumyabili (20) n'ihazabu y'amafaranga miliyoni makumyabili (20,000,000frw), ndetse ruta geuka ko urumogi rwafatanywe Habakurama Côme rutwikwa.

Uregwa yajuririye Urukiko Rukuru avuga ko yahawe igihano kiremereye kandi yaraburanye yemera icyaha kuva yafatwa, asaba kugabanyirizwa ibihano biruseho. Urwo Rukiko narwo rwaciye urubanza rwemeza ko nta gihindutse ku mikirize y'urubanza rwajuririwe kuko ngo Urukiko rubanza rwamugabanyirije ibihano ku buryo buhagije.

Uregwa yarongeye ajuririra Urukiko rw'Ubujurire avuga ko agamije kwemera icyaha mu buryo budashidikanwaho ngo kuko yakiburanye mbere atacyemera neza, akaba asaba kugabanyirizwa ibihano yahawe ngo byaba na ngombwa bigasubikwa kugira ngo ajye kwita ku muryango yasize utishoboye, iindi kandi akaba ari ubwa mbere yari akoze icyaha.

[1] Urubanza rwatangiriye mu Rukiko Rwisumbuye rwa Gicumbi, Ubushinjacyaha bukurikiranyeho Habakurama Côme icyaha cyo gukora ibikorwa byerekerye n'ibiyobyabwenge, aho bwasobanuye ko kuwa 29/5/2019 inzego zishinzwe umutekano zasatse abagenzi bari mu modoka RITCO yerekezaga iKigali, Habakurama Côme wari muri iyi modoka afatanwa ibiyobyabwenge byo mu bwoko bw'urumogi yari yahishe mu isarubeti, uyu akaba yarahise yemera icyaha anagisabira imbabazi.

[2] Mu rubanza RP 00279/2019/TGI/GIC rwaciwe kuwa 03/07/2019, Urukiko Rwisumbuye rwa Gicumbi rwemeje ko Habakurama Côme ahamwa n'icyaha cyo guceruza ibiyobyabwenge byo mu bwoko bw'urumogi, rumuhanisha igifungo cy'imyaka makumyabili (20) n'ihazabu y'amafaranga miliyoni makumyabili (20,000,000frw), ndetse rutegeka ko urumogi rwafatanywe Habakurama Côme rutwikwa.

[3] Habakurama Côme yajuririye Urukiko Rukuru avuga ko yahawe igihano kiremereye kandi yaraburanye yemera icyaha kuva yafatwa, asaba kugabanyirizwa ibihano biruseho.

[5] Habakurama Côme yajuririye Urukiko rw'Ubujurire avuga ko agamije kwemera icyaha mu buryo budashidikanwaho ngo kuko yakiburanye mbere atacyemera neza, akaba asaba kugabanyirizwa ibihano yahawe ngo kuko byaba na ngomba bigasubikwa kugira ngo ajye kwita ku muryango yasize utishoboye, ikindi kandi akaba ari ubwa mbere yari akoze icyaha.

[6] Ubushinjacyaha bwasubije buvuga ko impamvu ye y'ubujurire nta gaciro yahabwa kubera ko mu gusobanura ubujurire bwe, Habakurama atagaragariza Urukiko rw'Ubujurire ikosa Urukiko Rukuru rwakoze mu rubanza yajuririye, ko kandi Urukiko rudategetswe kugabanya igihano kugeza aho umuburanyi yifuza.

[7] Iburanisha ryabaye kuwa 7/7/2022 Habakurama Côme yunganiwe na Me Faida Jean Bosco naho Ubushinjacyaha buhagarariwe na Dushimirimana Claudine, Umushinjacyaha ku Rwego rw'Ighugu.

[8] Uru rukiko rurasuzuma niba Habakurama Côme yakwongera kugabanyirizwa ibihano kubera kwemera icyaha no kugisabira imbabazi, runasuzume niba yasubikirwa ibihano.

II. ISESENGURWA RY'IKIBAZO KIGIZE URUBANZA.

[9] Habakurama Côme yajuriye avuga ko inkiko zamuhanishije ibihano biremereye kandi yaraburanye yemera icyaha kuva agifatwa, ko ukuri avugira muri uru Rukiko aruko yatanze amakuru kuri Rukundo nawe wafatanwe urumogi, ibyo ngo bikaba byaratumye afatwa. Urukiko rwamubajije uburyo yatanze amakuru, asubiza avuga ko abapolisi bahagaritse imodoka hanyuma Rukundo akiruka, ariko we arafatwa ndetse ashinja Rukundo bafatanije gutunda urumogi.

[10] Habakurama yasabye kugabanyirizwa igihano kugeza ku myaka 10 no kugisubikirwa kugira ngo asange imfubyi yasize kandi ko yamaze kumenya ububi bw'icyaha ashinjwa, ko kandi rwashingira ku kuba ari ubwa mbere aguye mu cyaha.

[11] Me Faida Jean Bosco wunganira Habakurama Côme avuga ko kuba Urukiko Rukuru rwaragumishijeho igihano yahawe bihabanye n'ubutabera buboneye, ko rwagombye kwita ku myifatire ya Habakurama waburanye yemera icyaha no kuba ari ubwa mbere akoze icyaha.

[12] Ubushinjacyaha bwasubije buvuga ko Habakurama atagaragariza Urukiko rw'Ubujurire ikosa Urukiko Rukuru rwakoze mu rubanza yajuririye, kuko uretse kuvuga gusa ko nta cyabuzaga Urukiko Rukuru kongera kumugabanyiriza igihano, atanagaragaza icyabirutegekaga, bityo kuba avuga ko kuba Urukiko Rukuru rutarongeye kumugabaniriza igihano bihabanye n'ubutabera buboneye, nta shingiro bifite. Bwavuze kandi ko ushijnwa atagaragaza uburenganzira ku butabera buboneye buteganijwe mu ngingo ya 29 al.1 y'Itegeko Nshinga rya Repubulika y'u Rwanda ryo mu 2003 ryavuguruwe mu 2015 yaba yaravukijwe.

[13] Ku birebana n'imanza uwunganira Habakurama ashingiraho, Ubushinjacyaha bwavuze ko ntacyo zamumarira kuko nubundi yahawe igihano kiri munsi y'igihano gito giteganyijwe n'Itegeko kuko yahanishijwe igifungo cy'imyaka 20 mu gihe igihano gito agenerwa n'Itegeko ari igifungo cy'imyaka 25, bityo akaba agomba kuguma kubihano yahawe kuko ntacyo anenga urubanza yajuririye. Ku birebana n'isubikagihano, Ubushinjacyaha bwavuze ko ntaryo akwiye kuko yahanishijwe igifungo kirenze imyaka 5.

[14] Ingingo ya 11 y'Itegeko n° 69/2019 ryo ku wa 08/11/2019 rihindura Itegeko n° 68/2018 ryo ku wa 30/08/2018 riteganya ibyaha n'ibihano muri rusange, yahinduye ingingo ya 263 iteganya ko « (...) Umuntu wese ukora, uhinga, uhindura, utunda, ubika, uha undi, ugurisha mu gihugu ibiyobyabwenge cyangwa urusobe rw'imiti ikoreshwa nka byo mu buryo bunyuranyije n'amategeko, aba akoze icyaha. Iyo abihamijwe n'urukiko ahanishwa: 1 ° igifungo cya burundi n'ihazabu y'amarafanga y'u Rwanda atari munsi ya miliyoni makumyabiri (20.000.000 Frw) ariko atarenze miliyoni mirongo itatu (30.000.000 Frw), ku byerekeye ibiyobyabwenge bihambaye. [16] Dosiye igaragaza ko kuwa 29/5/2019 inzego zishinzwe umutekano zafatanye Habakurama Côme udupfunyika tw'urumogi 500 ari mu modoka itwara abagenzi (RITCO) yerekeza iKigali, uregewa akaba yaraburanye yemera icyaha avuga ko uru rumogi yari yaruguze mu mujyi wa Musanze akaba yari arujyanye iKigali , ko yaragiye kurucuruza kugira ngo abone amafaranga yo kubakisha inzu ye yamunaniye kuzuza iherereye mu Karere ka Bugesera, ko agapfunyika 1 yakaranguye ku mafranga 150frw ,nawe akaba yaragombaga kujya akagurisha 250 frw.

[17] Urukiko rurasanga impamvu y'ubujurire bwa Habakurama Côme muri uru Rukiko igamije gusaba urukiko rw'ubujurire kumugabanyiriza ibihano hashingiwe ku kuba yemera icyaha, kuba

aribwo bwa mbere aguye mu cyaha, kuba yararangije kugororoka bihagije no kuba afite umuryango yasize utishoboye ashaka kujya kwitaho.

[18] Urukiko rurasanga Habakurama Côme yarahaniwe icyaha cyo guceruza ibiyobyabwenge byo mu bwoko bw'urumogi, hashingiwe ku mvugo ye yemera icyaha, iyi mvugo ikaba yuzuzwa n'inyandiko mvugo y'ifatira yasinyeho ndetse n'ubuhamya bwa Mundge Bernard na Nirere Ange, abapolisi bashinnzwe umutekano wo mu muhanda, bamushinja kuba baramufatanye udupfunyika 500 tw'urumogi arukuye iMusanze aruhyanye iKigali. Rurasanga Habakurama Côme yaranishijwe igifungo cy'imyaka 20 n'ihazabu y'amafaranga 20.000.000 mu mwanya w'igifungo cya burundi n'ihazabu irihagati ya 20.000.000Frw na 30.000.000Frw kubera ko yaburanye yemera icyaha, ushinchwa akaba asanga ataragabanyirijwe bihagije.

[20] Urukiko rurasanga, ingingo ya 263 y'itegeko n°68/2018 ryo ku wa 30/08/2018 riteganya ibyaha n'ibihano muri rusange nk'uko yahinduwe n'ingingo ya 11 y'Itegeko n° 69/2019 ryo kuwa 08/11/2019, igaragaza ko Umushingamategeko yashatse gutandukanya abantu bakoresha ibiyobyabwenge mu guhaza irari ryabo (consommation à usage personnel) n'abababikwirakwiza mu bantu (drugs trafficking network), urugero rw'ibihano byagenewe icyiciro cy'ababikwirakwiza rukaba rwerekana ko ari ikibazo gifite ingaruka zikomeye ku muryango nyarwanda ku buryo kidakwiye kwhanganirwa. Zimwe muri izi ngaruka, nuko ibiyobyabwenge bizahaza ubuzima bw'ababikoresha, bikenesha ababyishoramo n'imryango yabo, ndetse iki cyaha kikaba inkomoko y'ibindi byinshi birimo gusambanya abana, ubujura, gukubita no gukomeretsa. Rurasanga kuba Habakurama yarafashwe mu ruhererekane rw'ibiyobyabwenge adashobora kuvuga ko nta ngaruka byateye kubera ko byafatiriwe, kuko izi ngaruka zidatangirira ku munsi byafatiriwe, ahubwo uko ibiyobyabwenge bihererekana ninako ingaruka zabyo zibiherekeza, bityo ingaruka zivuzwe haruguru zikaba zibarwa ku muntu wese wemeye kujya mu runana rw'ababikwirakwiza.

[22] Urukiko rurasanga kuba umuntu aburana yemera icyaha bitavanaho ko Urukiko rushyira mu gaciro uburemere bw'icyaha no gutanga igihano gikwiranye n'icyaha cyakozwe nk'uko bitaganywa mu ngingo ya 49 y'Itegeko n° 68/2018 ryo kuwa 30/08/2018 ryavuzwe, ndetse bikaba byaragarutsweho mu manza zitandukanye zaciwe n'Urukiko rw'Ikirenga¹, bityo ushinchwa akaba adashobora kuvuga ko yimwe ubutabera buboneye hashingiwe gusa ku buremere bw'igihano yahawe.

[23] Urukiko rw'Ubujurire rurasanga imvugo ya Habakurama y'uko akwiye kugabanyirizwa igihano kugira ngo ajye kwita ku muryango we udafite kivurira nta shingiro ifite, kuko atakwitwaza ingaruka mbi z'icyaha yakoze ngo asabe kudahanishwa igihano Itegeko ryagiteganyirije. Uwo akaba ari nawo murongo watanzwe n'Urukiko rw'Ikirenga mu rubanza n° RPAA 0020/14/CS rwaciwe ku wa 15/09/2017, Ubushinjacyaha buburana na Nyirabigirimana Olive²

[24] Urukiko rushingiye ku bisobanuro byavuzwe haruguru, rurasanga igihano cy'igifungo cy'imyaka 20 n'ihazabu ya 20.000.000Frw Habakurama yahanishijwe gikwiranye n'uburemere bw'icyaha yakoze kandi yahamijwe cyo gutunda no gucuruza urumogi (500 boules), bityo igabanyagihano asaba akaba yaramaze kurihabwa ku buryo nta rindi yahabwa kuri uru rwego. Icyo ninacyo gitekerezo kiboneka mu rubanza RPA 0249/13/CS rwaciwe n'Urukiko rw'Ikirenga ku wa 25/11/2016 aho rwavuze ko bitari ngombwa kongera kugabanyiriza ibihano umuntu wagabanyirijwe mu buryo buhagije mu rubanza ajuririra³.

[28] Iyo ngingo yumvikanisha kandi ko isubikagihano rituruka ku cyemezo cy'umucamanza, usuzuma niba rikwiye cyangwa ridakwiye, yaryemeza akabitangira impamvu. Ubwo bwisanzure bw'umucamanza bunasobanurwa n'abahanga mu mategeko, bagaragaza ko n'iyo ibisabwa n'Itegeko byaba byujujwe kugira ngo umuntu abe yasubikirwa igihano, umucamanza adategetswe kugisubika⁴.
