

JIN JOSEPH v. KANYANDEKWE

[Rwanda URUKIKO RW'UBUJURIRE – RCOMAA 00045/2019/CA (Nyirandabaruta, P.J., Mukanyundo na Ngagi, J.) 30 Nyakanga 2020]

Amategeko agenga imanza z'ubucuruzi – Sosiyete – Imikorere ya sosiyete z'ubucuruzi – Ubwishyu bwishyuwe sosiyete – Gutanga uburenganzira kw'inama y'ubutegetsi ya sosiyete – Umuyobozi mukuru w'isosiyete nta shobora gushingira ko ari umuyobozi cyangwa kwitwaza ko ari umunyamigabane wa sosiyete abereye umuyobozi ngo ashire amafaranga y'ubwishyu kuri konti ye aho kuba iya sosiyete mu gihe atabihere we uburenganzira n'inama y'ubutegetsi.

Amategeko agenga imanza z'ubucuruzi – Sosiyete – Igikorwa kitakozwe mu nyungu za sosiyete – Mu gihe umuyobozi mukuru w'isosiyete atagaragaje ikimenyetso cy'uburyo yakoresheje amafaranga ya sosiyete mu nyungu zayo kandi akayakoresha adafite uburenganzira ahabwa n'inzego za sosiyete zibifitiye ububasha, ategekwa kuyasubiza.

Incamake y'ikibazo: Kanyandekwe yareze JIN Joseph mu Rukiko rw'Ubucuruzi asaba ko yasubiza kuri konti Mutara E&C Ltd 565.000 USD, sosiyete bombi babereye abanyamigabane. Kanyandekwe avuga ko aho kugira ngo JIN Joseph yishuze amadolari yavuzwe haruguru ashirwe kuri konti ya sosiyete yaciye ruhinga asaba sosiyete bakoreraga imirimo yo kuhira ko iyishura kuri konti bwite ya JIN Joseph.

Urukiko rw'ubucuruzi rwemeje kandi rutegeka ko JIN Joseph asubiza 490.750 USD kuri konti ya MUTARA E&C Ltd.

JIN Joseph yajuririye Urukiko Rukur rw'Ubucuruzi avuga ko ikirego cya Kanyandekwe cyitari kwakirwa kuko ari inshinjabyaha, kandi ko nta bubasha yari afite bwo kurega kuko yatanze ikirego ku giti cye kandi yari kugitanga ahagararaiye sosiyete. Yongeye avuga kandi ko mu gushyira amadolari kuri konti ye bwite yari abifitiye uburenganzira kandi ko kuva aho ashirwe kuri konti hari ayo yagiye akoresha ibikorwa bya sosiyete.

Urukiko Rukuru rw'Ubucuruzi rwemeje ko ubujurire bwa JIN Joseph nta shingiro, ko kandi nta gihindutse ku rubanza rwaciwe n'Urukiko rw'Ubucuruzi uretse ingano y'amadolari yagombaga kwishyura kuri konti ya Mutara E&C Ltd angana na 499.750 USD.

JIN Joseph yarongeye ajuririra Urukiko rw'Ubujurire avuga ko Urukiko Rukuru rw'Ubucuruzi rutitaye ku mategeko agenga imikorere y'amasosiyete, ko kandi amadorali rwategetse gusubiza atari kuri konti ye kuko hari ayakoreshejwe mu nyungu za sosiyete, asaba ko yasubizaho 245.000 USD asigaye.

Kanyandekwe yireguye avuga ko ubujurire bwa JIN Joseph nta shingiro bufite kuko ibyo yakoze ashirwe ubwishyu bwa sosiyete kuri konti ye bwite itigeze ibimuhera ububasha.

Kubijanye n'amafaranga JIN Joseph yavuze yakoresheje mu nyungu za sosiyete nabyo bavuze ko nta shingiro bifite kuko nta gikorwa gikwiriye kwitirirwa ko cyakozwe mu nyungu za sosiyeti, mu gihe itigeze ikibona nk'igikenewe ngo ikigenere ingengo y'imari (*budget*).

Kanyandekwe yabyuririye atanga ubujurire bwuririye ku bundi asaba guhabwa amafaranga y'ikurikirana rubanza n'igihembo cya Avocat. Kuri iyi ngingo, JIN Joseph yireguye avuga ko amafaranga Kanyandekwe asaba nta shingiro ryayo kuko ariwe nyirabayazana w'uru rubanza.

[1] Uru rubanza rwatangiriye mu Rukiko rw'Ubucuruzi rwa Nyarugenge, Kanyandekwe Pascal asaba urwo Rukiko gutegeka JIN Joseph gusubiza kuri konti ya *MUTARA E&C Ltd* 565.000 USD y'iyo sosiyete bombi babereye abanyamigabane, no kwishyura 2.000.000 Frw y'ikurikiranarubanza n'igihembo cya Avoka.

[2] Mu gusobanura ikirego cye, Kanyandekwe Pascal yavuze ko we na JIN Joseph bashinze sosiyeti y'ubucuruzi *MUTARA E&C Ltd*, maze tariki ya 12/10/2016, bagirana amasezerano ya *Consultancy* na sosiyeti yitwa *OM METALS INFRA PROJECTS Ltd* mu rwego rwo gukurikirana no kubahagararira mu mushinga wo kuhira (*Irrigation and Water Shed Development Mpanga Sector,Tender Nº RAB/ WAP/EPC-IRR&WS/Mpanga/2016 RAB*) banumvikana ko bazishyurwa binyujijwe kuri konti ya sosiyete *MUTARA E&C Ltd* iri muri Banki ya Kigali Ltd, ariko ko igihe cyo kwishyura, JIN Joseph yayobeje ubwisyu bungana na 565.000 USD abushyira kuri konti ye bwite iri muri *ACCESS Bank Ltd*.

[3] JIN Joseph yireguye avuga ko ubwishiyo bwanyujije kuri konti ye bwite ari ubwa 490.750 USD ko kandi yari yarabyemeranyijweho na Kanyandekwe Pascal basangije sosiyete nk'uko bigaragara mu masezerano bagiranye ku wa 21/04/2017 bahaye izina rya *Mutara E&C Operation and Management Agreement*, atanga n'inzitizi yo kutakira ikirego cya KANYANDEKWE Pascal, kuko cyatanzwe mu buryo bunyuranyije n'amategeko.

[4] Mu rubanza N° RCOM 00977/2018/TC/NYGE rwaciwe ku wa 07/09/2018, Urukiko rw'Ubucuruzi rwasanze inzitizi yo kutakira ikirego yari yatanzwe na JIN Joseph avuga ko Kanyandekwe Pascal nk'umunyamigabane wa sosiyete ya *MUTARA E&C Ltd* atagombaga gutanga ikirego atabanje kubisabira uruhushya Urukiko rubifitiye ububasha nta shingiro ifite, kuko kuba ari umunyamigabane n'umuyobozi w'iyo sosiyete, afite ububasha bwo gutanga ikirego mu Rukiko ku giti cye kugira ngo ashobore kurengera inyungu za sosiyete. [5] Ku byerekeye imizi y'urubanza, Urukiko rw'Ubucuruzi rwasanze nk'uko bigaragara mu masezerano ya *Consultancy* yo ku wa 12/10/2016, sosiyete *MUTARA E&C Ltd*, JIN Joseph ahuriyeho na Kanyandekwe Pascal yagiranye na *OM METALS INFRAPROJECTS Ltd*, ubwishiyo mu madolari bwaragombaga kunyuzwa kuri konti ya *MUTARA E&C Ltd* iri muri Banki ya Kigali Ltd, rutegeka JIN Joseph gusubiza 490.750 USD kuri iyo konti ifite n° 000950771574105 kandi akishyura Kanyandekwe Pascal, 800.000 Frw y'igihembo cya Avoka n'ikurikiranarubanza.

[6] JIN Joseph ntibishimiye imikirize y'urwo rubanza arujuririra mu Rukiko Rukuru rw'Ubucuruzi avuga ko ikirego cya Kanyandekwe Pascal kitagombaga kwakirwa kuko ari inshinjabyaha kandi akaba yaragitanze ku giti cye aho kugitanga ahagarariye sosiyete. Mu bujurire bwe kandi JIN Joseph yavuze ko Urukiko rw'Ubucuruzi rwirengagije inyandiko yo ku wa 21/04/2017, imuha uburenganzira bwo gushyira amadolari yaregewe kuri konti ye bwite nk'umuyobozi wa sosiyete, runirengagiza ko mu gihe rwategeka ko ayo madolari asubizwa kuri konti ya *MUTARA E&C Ltd*, hagomba kubanza kuvanwamo ayo yakoresheje mu bikorwa no mu nyungu za sosiyete, asaba ko Kanyandekwe Pascal amuha indishyi z'akababaro zo gushorwa mu manza no kumwanduriza izina, amafaranga y'ikurikiranarubanza, ay'igihembo cya Avoka, akamusubiza n'ingwate y'igarama yatanze ajurira.

rw'Ubujurire rwemeza ko 245.000 USD yasigaye kuri konti ye ari yo yashyirwa kuri konti ya *MUTARA E&C Ltd* ifunguye muri Banki ya Kigali Ltd, asaba indishyi zo gushorwa mu manza n'ighembo cya Avoka.

[9] Urubanza rwaburanishijwe mu ruhame ku wa 22/07/2019, JIN Joseph ahagarariwe na Me *MURAGIJIMANA* Emmanuel, naho Kanyandekwe Pascal ahagarariwe na Me Taremwa Danitar Daniel, habanza gusuzumwa inzitizi y'iburabubasha bw'Urukiko rw'Ubujurire ishingiye ku gaciro k'ikiburanwa, Urukiko rufatira icyemezo mu ntebe, rwemeza ko iyo nzitizi nta shingiro ifite, rushingiye ku ngingo ya 52 y'Itegeko n° 30/2018 ryo ku wa 02/06/2018 rigena ububasha bw'inkiko, ruvuga ko iburanisha rizakomeza ku wa 09/10/2019 kugira ngo uregwa abanze yiregure ku mpamvu z'ubujurire, ariko rumutegeka gutanga ihazabu mbonezamubano ya 200.000 Frw kuko rwasanzе kutiregura ari impamvu yo gutinza urubanza.

II. IBIBAZO BIGIZE URUBANZA N'ISESENGURA RYABYO

A. UBUJURIRE BWA JIN Joseph

1. Kumenya niba Urukiko rwarirengangije nkana imikorere ya sosiyete z'ubucuru

[13] Me Muragijimana Emmanuel, uhagarariye JIN Joseph, avuga ko impamvu yajuriye ari uko Urukiko rwirengagije nkana imikorere ya sosiyete z'ubucuru, ko JIN Joseph nk'Umuyobozi Mukuru wa *MUTARA E&C Ltd* ari we washyize umukono ku masezerano *MUTARA E&C Ltd* yagiranye na *OM METALS INFRA PROJECTS Ltd* (Rwanda), ko mu gihe uwo basinyana atari ahari (ngo yari yarabuze) we nk'Umuyobozi Mukuru yasabye *OM METALS INFRA PROJECTS Ltd* guhindura konti bari kwishyuriraho kugira ngo ashobore kubaha serivisi zari zikenewe muri icyo gihe, kandi ko ibyo yabikoze ashingiye ku masezerano yiswe *MUTARA E&C Ltd Operation and Management Agreement*, ko rero ibyo yakoze byari mu bubasha bwe, cyane cyane ko Kanyandekwe yari amaze igithe kirekire ataboneka kandi akagenda atabimubwiye.

[14] Akomeza avuga ko JIN Joseph nk'umukozi wa sosiyete yagombaga guhembwa kandi agomba kubaho ndetse akagira n'ibindi bikorwa akora bikeneye amafaranga, ibi akaba ari byo byatumye agaragaza indi konti yashoboraga kubikuzaho amadolari bitabaye ngombwa ko akenera umukono wa Kanyandekwe Pascal.

[15] Abahagarariye Kanyandekwe Pascal biregura bavuga ko ibyo JIN Joseph avuga bikubiye mu nyandiko yiswe “*MUTARA E&C Operation and Management Agreement*” yo ku wa 21/04/2017, ntaho bihuriye no kuyobia ubwishiya sosiyeti yari igenewe kubw’ amasezerano hagati yayo na *OM METALS INFRAPROJECTS Ltd* akayashyira kuri konti ye bwite, ko muri iyo nyandiko abanyamigabane bemeranje ko amafaranga ya *office operation and management budget* azajya abanza kwemezwa na *Steering Committee* kugira ngo hamenyekane amafaranga akenewe mu bikorwa byo mu biro (*office operations*), ndetse n’ajyanye n’ ibikorwa by’imisoro (*taxation budget*) n’ ibindi bitandukanye, ariko ko igitangaje ari uko JIN Joseph ashaka gukoresha iyo nyandiko yumvikanisha ko imuha uburenganzira bwo gushyira amafaranga kuri konti ye bwite kandi atari byo, bakavuga ko uko kuyobia ubwishiya, usibye kuba binyuraniye n’ amasezerano mu ngingo yayo ya 3 hagati ya *MUTARA E&C Ltd* na *OM METALS INFRAPROJECTS Ltd*, binanyuraniye ahubwo ubwabyo n’ibivugwa mu nyandiko yitirira ko imuha ububasha, ko iyo nyandiko ivuga amafaranga ajyanye na “*expenses*“ ariko nabyo bikabanza kugaragazwa no kwemezwa na komite ibifite mu nshingano.

[16] Bakomeza bavuga ko hashingiwe ku ngingo ya 149 y’Itegeko no 27/2017 ryo ku wa 31/05/2017 rigenga amasosiyete y’ubucuruzi ryakurikizwaga mu gihe hakorwaga inyandiko igibwaho impaka yo ku wa 21/04/2017, iteganya ko “*ugize Inama y’Ubutegetsi, mu gihe akoresha ububasha bwe nk’ugize Inama y’Ubutegetsi, akorana ubwitonzi, ubushishozi n’ubumenyi bushobora gukoreshw n’undi ugize Inama y’Ubutegetsi wakora mu bihe nk’ibyo, ko kandi ugize Inama y’Ubutegetsi kandi akoresha ububasha bwe hari ikigamijwe kigaragara*”, ko basanga iryo tegeko ryarashyizweho hirindwa uwakoresha ububasha ubwo ari bwo bwose akora ibikorwa sosiyeti itamutumye, ibyo JIN Joseph yakoze bikaba binyuranyije n’itegeko. Basoza bavuga ko ibyo JIN Joseph yakoze bishobora kugira ingaruka zikomeye kuri sosiyete haba mu bijyanye n’ibaruramari (*comptabilité*) ryayo cyangwa igenzura ry’umutungo (*audit*), bakaba basanga nta kosa Urukiko Rukuru rw’Ubucuruzi rwakoze rwemeza ko nta burenganzira JIN Joseph yari afite bwo kuyobia ubwishiya bwari bugenewe *MUTARA E&C Ltd*.

Ingingo ya 144 y’iryo Tegeko iteganya ko “*Haseguriwe ibibujije n’inyandiko z’ishingwa ry’isosiyete, Inama y’Ubutegetsi ishobora guha ububasha*

[22] Urukiko rurasanga kandi nk’uko biteganyijwe n’gingo ya 144 y’Itegeko rigenga amasosiyete, JIN Joseph nk’Umuyobozi Mukuru wa *MUTARA E&C Ltd* yaragombaga guhabwa uburenganzira n’Inama y’Ubutegetsi kugira ngo abashe gushyira ubwishi bwa sosiyete ahanti hantu. Urukiko rurasanga ibyo uburanira JIN Joseph avuga ko impamvu yashyize ubwishi bugenewe *MUTARA E&C Ltd* kuri konti ye, ari uko Kanyandekwe Pascal yari yarabuze nta shingiro bifite, kuko usibye kubivuga gusa ntaho agaragaza ko yigeze amushaka ngo koko bigaragare ko yabuze, cyane ko nawe yemereye Urukiko ko nta ngingo y’Itegeko azi yemererega JIN Joseph gushyira ubwishi bugenewe sosiyete kuri konti ye bwite, mu gihe uwo bafatanyije gacunga konyi ya sosiyete adahari.
