Shakubone yajuririye Urukiko Rukuru, anenga Urukiko Rwisumbuye ko rwamuhanishije igihano kirekire kandi yaraburanye yemera icyaha cyo kunywa urumogi aho kuba icyo kurucuruza maze Urukiko Rukuru rusanga, ibyo asaba byo kugabanyirizwa igihano nta shingiro byahabwa kuko ibyo asaba yabikorewe, rwemeza ko ubujurire bwe nta shingiro bufite.

Shakubone yarongeye ajuririra Urukiko rw'Ubujurire avuga ko noneho yemeye kuvugisha ukuri, ko yemera icyaha cyo guceruza urumogi akanagisabira imbabazi kuko n'ubwo udupfunyika 46 yafatanywe yatunywaga nk'umuti yivura amarozi, n'uwanaganaga amafaranga yamugurishaga bitewe n'udupfunyika “boules” akeneye, asaba Urukiko rw'Ubujurire kumugabanyiriza igihano rukamuhanisha igihano gihwanye n'icyaha yakoze, cyane ko yemera icyaha akagisabira imbabazi.

[8] Shakubone Reverien avuga ko yaburanye yemera icyaha akanagisabira imbabazi ariko urukiko Rukuru rumuhanisha igihano cy'igifungo cy'imyaka 25 nyamara Ubushinjacyaha bwaregagamo Ntezimana Jean Bosco aho urukiko rwamuhamije icyaha cyo guceruza urumogi, rumuhanisha igifungo cy'imyaka 3 n'ihazabu ya 5.000.000 Frw asaba rero ko nawe yahanishwa igihano gihwanye n'icya Ntezimana Jean Bosco kuko icyaha bahamijwe ndetse n'igihano basabirwaga n'Ubushinjacyaha ari bimwe, asaba Urukiko rw'Ubujurire guca inkoni izamba rukongera kumugabanyiriza igihano kuko yamaze kubona ububi bw'icyaha akaba atazongera guceruza ibiyobyabwenge.

[9] Me Ndayisabye Alex, avuga ko kuba Shakubone Reverien yemera icyaha ku buryo budashidikanywaho akanasobanura uko yagikoze bitandukanye n'uko yacyemeye mu Rukiko Rukuru, bikwiriye gushingirwaho akagabanyirizwa igihano kuko mbere atahawe ubutabera buboneye, hagashingirwa ku murongo watanzwe n'Urukiko rw'Ikirenga mu rubanza n° RS/INCOSNT/SPEC rwaciwe ku wa 04/12/2019, no ku rubanza n° RPAA 00031/2021/CA rwaciwe n'Urukiko rw'Ubujurire ku wa 28/10/2021 haburana Ubushinjacyaha na Bahati Françoise, aho rwamuhanishije igifugo cy'imyaka 10 ruvuye ku gihano cy'imyaka 25 yari yahanishijwe n'Urukiko rubanza, ariko ko iyi myaka icumi nayo byemewe kuyijja muni nk'uko byakozwe mu rubanza n° RP 00353/2021/TGI/NYGE, rwaciwe ku wa 25/06/2021 hagati y'Ubushinjacyaha, Habarurema, Nizeyimana Jean Claude, Uwase Nicole, Ntawigena Jean Baptiste, umucamanza mu kugabanya akaba yarashingiye ku mirongo yatanzwe yavuzwe hejuru,

nawe mu gutanga ubutabera buboneye abahanisha igifungo cy'emyaka 6 ku cyaha cyo kubika no guceruza ibiyoyabwenge by'urumogi, asaba ko icyemezo cyafashwe n'Urukiko Rukuru cyahinduka, Urukiko rw'Ubujurire rugategeka ko Shakubone Reverien ahanishwa igihano cy'igifungo cy'emyaka 5 n'ihazabu ya 1.000.000Frw.

Anavuga ko urubanza n° RPAA 00031/2021/CA, rwa Bahati Françoise n'Ubushinjacyaha narwo rutashingirwaho kuko nta murongo rutanga kandi rukaba runyuranya n'ibiteganyijwe n'amategeko, bityo asaba Urukiko rw'Ubujurire kwemeza ko ubujurire bwa Shakubone Reverien nta shingiro bufite, hakagumaho imikirize y'urubanza rwajuririwe.

## UKO URUKIKO RUBIBONA

[12] Hakurikijwe imiburanire y'uregwa n'iy'Ubushinjacyaha, impaka ziri muri uru rubanza zigamije kumenya niba Shakubone Reverien yaragabanyirijwe igihano bihagije mu nkiko zibanza ku buryo atakongera kugabanyirizwa.

[13] Ku birebana n'icyo umucamanza ashingiraho mu kugena igihano, ingingo ya 49 y'Itegeko n° 68/2018 ryo ku wa 30/8/2018 riteganya ibyaha n'ibihano muri rusange iteganya ko "Umucamanza atanga igihano akurikije uburemere bw'icyaha, ingaruka icyaha cyateye, impamvu zatumye agikora, uko uwagikoze yari asanzwe yitwara, imibereho ye bwite n'uburyo icyaha cyakozwemo".

Iyo amaze kwemeza ko zashingirwaho

atanga igihano kijyanye n'uburemere bw'icyaha ndetse n'ingaruka zacyo. Ubwo burenganzira bufitwe na buri mucamanza usuzuma urubanza yashyikirijwe harimo n'Umucamanza uburanisha urubanza rujuririrwa<sup>1</sup>.
