

EQUITY BANK RWANDA Plc v DUSABE SANGANO

Incamake y'ikibazo: Equity Bank yashizeho uburyo bworohereza abakozi bayo kubona inguzanyo ku gipimo cy'inyungu (8%) gitoya kuri muni y'igipimo 18.25% iyo banki atangiraho inguzanyo ku bakiliya basanzwe, bityo Sangano nk' umukozi w'iyi Banki nawe yafashe inguzanyo ibariwe kuri icyo nyungu. Nyuma iyo banki yahinduye igipimo cy'inyungu ku nguzanyo zihabwa abakozi bayo kiva ku 8% kijya kuri 6%, bituma n'inguzanyo yari yarahaye Sangano ishyirwa kuri icyo gipimo ku mwaka.

Nyuma Sangano yarirukanye ku kazi ahita atangira kubarirwa inyungu ku nguzanyo yari asigayemo ku gipimo cy'inyungu cya 18.25% iyo banki itangiraho inguzanyo ku bakiliya basanzwe. Kuko atariyishimiye icyemezo cyo kwirukanwa mu kazi n'icyo guhitamo azamurirwa igipimo cy'inyungu ku nguzanyo yatanze ibirego bibiri, ikirego kirebana n'iby'inguzanyo mu Rukiko rw'Ubucuruzi asaba ko Equity Bank yagaragaza imbonerahamwe y'uko umwenda uhagaze ndetse no kumumanurira ijanisha ry'inyungu kuri uwo mwenda rigasubira kuri 6%, kuyitegeka kumusubiza ikinyuranyo cy'amafaranga yose yishyuye ku gipimo cy'inyungu cya 18.25% hiyongereyeho inyungu zayo urwo rukiko rwemeza ko ikirego cy'e kidafite ishingiro, ajuririra Urukiko Rukuru rw'Ubucuruzi rwo rwemeza ko inguzanyo yagombaga kuguma kuri 6%. , ikindi kirego cy'umurimo agitanga mu rundi rukiko rubifitiye ububasha avuga ko yirukanywe mu buryo budakurikije amategeko, aho urwo Rukiko rwemeje ko y'irukanywe mu buryo bunyuranyije n'amategeko,

EQUITY BANK RWANDA Plc yajuririye Urukiko rw'Ubujurire ivuga ko Urukiko Rukuru rw'Ubucuruzi rwasobanuye nabi amasezerano y'inguzanyo yahawe urega kuko rwavuze ko igikorwa kizaba gitewe na Sangano gituma ava ku kazi ari cyo kizafatwa nk'imbarutso yo guhindura igipimo cy'inyungu, ko kuba Equity Bank Rwanda Plc yaramwirukanye mu buryo bunyuranyije n'amategeko, inyungu zigomba gukomeza kubarirwa kuri 6% kandi mu masezerano y'inguzanyo impande zombi zagiranye hadateganyijwe uburyo umukozi azatandukana n'umukoresha kugira ngo igipimo cy'inyungu gihinduke, ko ahubwo mu gihe uko gutandukana gutewe n'impamvu iyo ari yo yose ari byo bizatuma igipimo cy'inyungu gihinduka.

Uregwa yiregura avuga ko avuga ko ikibazo kiri mu rubanza ari icyo kumva neza *context* ayo masezerano y'inguzanyo yakozwemo, ko yakoraga mu yindi banki, uwajuriye aramureshya kubera ko ari umukozi mwiza yari akeneye nyuma aramwirukana, kandi ko mu gihe atagaragaza ko yamukoreye nabi biba bigaragaza ko yamwirukanye mu buryo budakurikije amategeko, ko ku rwego rwa mbere mu Rukiko rw'Ubucuruzi yatsinzwe n'uko nta kimenyetso yari afite kigaragaza ko yirukanwe arenganyijwe kuko urubanza rw'umurimo rwari rutararangira, ariko ko urubanza rwageze mu Rukiko Rukuru rw'Ubucuruzi ikimenyetso cy'urubanza rw'umurimo cyaramaze kuboneka kikagaragaza ko yirukanywe arenganyijwe.

Iyo banki yakase amafaranga umuntu mu buryo budakwiye kuko iba yarayacurujye nka banki y'ubucuruzi, iba igomba kuyasubizanya n'inyungu zayo zibariwe ku gipimo yagaragarijeho ko ari cyo yacuruzagaho amafaranga muri icyo gihe yayakataga hatagendewe ku kuba uwo yayakase atari umucuruzi, bityo kuba uregwa yakatagwa amafaranga abariwe ku gipimo cy'inyungu cya 18.25%, mu gihe cy'amezi 22 mu buryo butari bwo kandi iyo Banki ikaba itarayabitse ahubwo yarayacurujye nka banki y'ubucuruzi, ikaba igomba kuyasubizanya n'inyungu zayo zibariwe na zo kuri 18.25% yayacururizagaho.

I. IMITERERE Y'URUBANZA

[1] Kuwa 04/01/2016, DUSABE SANGANO Javan yagiranye amasezerano y'umurimo na EQUITY BANK RWANDA PLC ariko mbere yo kuba umukozi wa EQUITY BANK akaba yari umukozi wa KCB Bank yari yaranamuhaye inguzanyo yishyuraga ku gipimo cy'inyungu cya 7% ku mwaka cyari cyemerewe guhabwa abakozi bayo gusa. DUSABE SANGANO avuga kandi ko kimwe mu byo EQUITY BANK yamusezeranyije kugira ngo yemere kuva muri KCB Bank kwari ukumwimurira iyo nguzanyo yari afite muri KCB akajya ayishyurira muri EQUITY BANK ariko ku ijanisha ry'inyungu ryagenewe abakozi ba EQUITY BANK.

[2] Kuwa 28/02/2018, Equity Bank Rwanda Plc yagiranye amasezerano y'inguzanyo ya 146.536.603 Frw na DUSABE SANGANO Javan, igice kinini cy'iyonguzanyo cyakoreshejwe mu kurangiza kwishyura inguzanyo yo muri KCB Bank yavuzwe haruguru kandi iyo nguzanyo yagombaga kujya yishyurirwa ku gipimo cy'inyungu cya 8% ku mwaka kubera ko SANGANO nawe yari amaze kuba umukozi wa Equity Bank. Ingingo ya 4 y'ayo masezerano yateganyaga kandi ko mu gihe SANGANO yaba avuye mu kazi ka Equity Bank, igipimo cy'inyungu kizahinduka nta yindi nteguza kikaba igipimo amabanki atangiraho inguzanyo [*“Should you leave the employment of Equity Bank Rwanda LTD, the interest will be charged at the prevailing commercial rate without prior notice to the borrower”*]. Nanone kandi Ingingo ya 6 igika cya 5 y'Amabwiriza agenga inguzanyo yateganyaga ko inguzanyo izishyurwa mu gihe cyagenwe kandi ko mu gihe umukoresha ahindutse inguzanyo izatangira kwishyurwa ku gipimo cy'inyungu amabanki atangiraho inguzanyo [*“Loan to be repaid within agreed period and if there is a change of the Employer, facility to assume commercial rate of interest”*].

[3] Kuwa 11/09/2019, ubuyobozi bwa Equity Bank bwafashe icyemezo cyo guhindura igipimo cy'inyungu ku nguzanyo zihabwa abakozi bayo kiva ku 8% kijya kuri 6%, bituma n'inguzanyo yavuzwe haruguru yari yarahawe SANGANO Javan ivanwa ku gipimo cy'inyungu cya 8% ishyirwa ku cya 6% ku mwaka.

[4] Kuwa 30/4/2020, Equity Bank Rwanda Plc yirukanye mu kazi DUSABE SANGANO Javan, maze ishingiyeye ku ngingo ya 4 n'ya 6 igika cya 5 by'amasezerano y'inguzanyo zavuzwe haruguru SANGANO wari utakiri umukozi wa Equity Bank ariko atemera uburyo yirukanywemo ahita atangira kubarirwa inyungu ku nguzanyo yari asigayemo ku gipimo cy'inyungu cya 18.25% ku mwaka.

[5] SANGANO utarishimiye icyemezo cyo kwirukanwa mu kazi n'icyo guhita azamurirwa igipimo cy'inyungu ku nguzanyo yatanze ikirego kirebana n'iby'inguzanyo mu Rukiko rw'Ubucuruzi asaba ko Equity Bank yagaragaza imbonerahamwe y'uko umwenda uhagaze ndetse no kumumanurira ijanisha ry'inyungu kuri uwo mwenda rigasubira kuri 6%, anatanga ikindi kirego cy'umurimo mu rundi rukiko rubifitiye ububasha avuga ko yirukanywe mu buryo budakurikije amategeko.

[6] Kuwa 31/03/2021, Urukiko rw'Ubucuruzi rwaciye urubanza ku bijyanye n'inguzanyo, rwemeza ko ikirego cya DUSABE SANGANO Javan kidafite ishingiro, maze rutegeka ko akomeza kwishyura inguzanyo ku gipimo cya 18.25%.

[7] DUSABE SANGANO Javan ntiyishimiye imikirize y'urwo rubanza ajurira mu Rukiko Rukuru rw'Ubucuruzi, avuga ko Urukiko rw'Ubucuruzi rwasobanuye nabi ingingo ya 4 y'amasezerano y'inguzanyo yagiranye na Equity Bank ngo kuko guhagarika kuyibera umukozi byaturutse ku kuba yarirukanwe mu buryo bunyuranyije n'amategeko.

[8] Mu gika cya 16 cy'urubanza RCOMA 00349/2021/HCC, Urukiko Rukuru rw'Ubucuruzi rwasobanuye ko ingingo ya 4 y'amasezerano y'inguzanyo iteganya ko mu gihe DUSABE SANGANO Javan ari we wateye iseswa ry'amasezerano y'umurimo ari bwo ijanisha ry'inyungu ku mwenda riziyongera, ariko ko mu gihe ari Equity Bank yatera iryo seswa azakomeza kwishyurira ku ijanisha riri mu masezerano (6%). Urukiko Rukuru rw'Ubucuruzi rushingiye kuri icyo gisobanuro (interpretation) no ku rubanza rw'umurimo RSOCA 00103/2021/HC/KIG rwari rwaramaze kwemeza ko EQUITY BANK yirukanye DUSABE mu buryo budakurikije amategeko, rwemeje ko EQUITY BANK idafite uburenganzira bwo guhindura ijanisha inguzanyo yishyurirwagaho, bivuze ko inguzanyo yagombaga kuguma kuri 6%.

[9] Ku wa 08/04/2022, EQUITY BANK RWANDA Plc yajuririye Urukiko rw'Ubujurire, ubujurire bwandikwa kuri n° RCOMAA 00057/2022/CA, ivuga ko Urukiko Rukuru rw'Ubucuruzi rwasobanuye nabi ingingo ya 4 n'ya 6 agace ka 5 by'amasezerano y'inguzanyo kuko rwongeyeho conditions zitari ziteganyijwe muri ayo masezerano.

[10] DUSABE SANGANO Javan avuga ko yemera icyemezo cyafashwe n'Urukiko Rukuru rw'Ubucuruzi ariko ntiyishimira uburyo Urukiko rutategetse EQUITY BANK RWANDA Plc kumusubiza 18.449.618 Frw arenga ku yo yagombaga kwishyura kuri 6%, hiyongereyeho inyungu ya 18.25% ku mwaka bivuze 5.297.063 Frw akomeza kwiyongera kugeza urubanza ruciwe. DUSABE Javan SANGANO akaba yatanze ubujurire bwuririye ku bundi asaba kuyasubizwa.

[11] Impaka ziri mu rubanza zishingiye ku masezerano y'iguriza yabaye hagati ya EQUITY BANK RWANDA Plc na DUSABE Javan SANGANO, aho impande zombi zitumvikana ku bikubiye mu ngingo ya 4 n'ya 6 al 5 z'amasezerano yo ku wa 22/02/2018, aho Equity Bank Rwanda Plc isanga Inkiko zabanje zarasesenguye nabi izo ngingo bigatuma zifata icyemezo kiyirenganya, naho DUSABE Javan SANGANO we akavuga ko Inkiko zabanje zasobanuye neza izo ngingo, ngo uretse ko zitategetse ko asubizwa 18.449.618 Frw yakaswe nyuma y'uko Equity Bank Rwanda Plc ihinduye ijanisha ry'inyungu, ari na yo mpamvu y'ubujurire bwe bwuririye ku bwa Equity Bank Rwanda Plc.

Should you leave the employment of EQUITY BANK RWANDA Ltd; the interest will be charged at the prevailing commercial rate without prior notice to the borrower", aho Urukiko rw'Ubucuruzi rwasobanuye ingingo ya 4 n'ya 6 z'ayo masezerano ruvuga ko mu gihe DUSABE Javan SANGANO azaba atakiri umukozi wa EQUITY BANK RWANDA Plc azatangira kubarirwa ku nyungu z'ubucuruzi zisanzwe, naho Urukiko Rukuru rw'Ubucuruzi mu gika cya 17 cy'urubanza

RCOMA 00349/2021/HCC rujurirwa rugasobanura ko ijambo “leave”, rivuga kimwe na “abandon”, “desert” na “quit”, rigaragara mu masezerano bishatse kuvuga ko igikorwa kizaba gitewe na DUSABE Javan SANGANO gituma avya ku kazi ari cyo kizafatwa nk'imbarutso yo guhindura igipimo cy'inyungu, ko kuba EQUITY BANK RWANDA Plc yaramwirukanye mu buryo bunyuranyije n'amategeko, inyungu zigomba gukomeza kubarirwa kuri 6%. Avuga ko Urukiko rwasobanuye nabi iyo ngingo, kuko mu bisobanuro rwatanze rwongeyemo ibitari bikubiye mu masezerano nk'uko bigaragara mu gika cya 16 cy'urubanza rujurirwa, aho rwavuze ko “Should you leave” ari igikorwa kizaba cyatewe na SANGANO Javan DUSABE, mu gika cya 21 rukavugaga ko impamvu ituma uwahawe inguzanyo adakomeza kubarirwa mu bakozi ba EQUITY BANK RWANDA Plc igomba kwitabwaho, yaba ikomoka kuri banki, inyungu zigakomeza kubarirwa ku gipimo zabarirwagaho mu gihe yari akiri umukozi wayo.

[14] Avuga kandi ko mu masezerano y'inguzanyo impande zombi zagiranye hatateganyijwe uburyo umukozi azatandukana n'umukoresha kugira ngo igipimo cy'inyungu gihinduke, ko ahubwo mu gihe uko gutandukana gutewe n'impamvu iyo ari yo yose ari byo bizatuma igipimo cy'inyungu gihinduka, ko rero Urukiko Rukuru rw'Ubucuruzi rwirengagije ko DUSABE Javan SANGANO yahawe inguzanyo ku nyungu zo hasi mu rwego rwo guha *avantages* abakozi bayo, mu gukora interprétation y'ingingo ya 4 n'ya 6 al. 5 rukaba ngo rwaragombaga kureba ibiteganywa n'ingingo ya 66 y'Itegeko n°45/2011 ryo ku wa 25/11/2011 rigenga amasezerano iteganya ko “*Gusesengura amasezerano cyangwa imwe mu ngingo zayo ari ugusobanura icyo ayo masezerano agamije n'icyasezeranyijwe.*”

[15] Uburanira EQUITY BANK avuga kandi ko Urukiko Rukuru rw'Ubucuruzi rwagombaga kwita ku ngingo ya 68 y'Itegeko rimaze kuvugwa haruguru na yo iteganya ko “*Imvugo n'indi myitwarire bigamije amasezerano bisesengurwa hakurikijwe uko ibintu biteye, kandi iyo ikigamijwe cy'ibanze ku mpande zigirana amasezerano gishobora kumenyekana neza, byitabwaho*”, ibyo ngo bikaba bisobanuye ko mu gihe DUSABE Javan SANGANO yari kuba atakiri umukozi wa EQUITY BANK RWANDA Plc atagombaga gukomeza guhabwa *avantage* zihabwa abakozi bayo, ari na yo mpamvu mu masezerano y'inguzanyo hatigeze hateganywa ikigomba gushingirwaho kugira ngo umukozi utandukanye na Equity Bank ashirwe ku nyungu zisanzwe.

[16] Akomeza avuga ko Urukiko rubanza rwirengagije ko mu rubanza RSOCA 00103/2021/HC/KIG, DUSABE Javan SANGANO yarezemo EQUITY BANK RWANDA Plc ibyo kumwirukana mu kazi mu buryo butemewe n'amategeko yagenewe 29.000.000 Frw nk'indishyi z'akababaro kubera kuva ku kazi, ko ibyo bisobanuye ko mu kuva ku kazi hari inyungu (*advantages*) nyinshi yatakaje Urukiko rwashingiyeho rumugenera izo ndishyi, mu nyungu yatakaje hakaba ngo harimo no kuba agomba kuzamurirwa ijanisha mu kwishyura umwenda afitiye banki. Bityo akaba asaba Urukiko kongera gusuzuma ingingo ya 4 n'ya 6 igika cya 5 by'amasezerano y'inguzanyo yo ku wa 22/02/2018, rukabona ko mu ngingo ya 6 igika cya 5 ku bijyanye na *condition of sanction* hateganywa ko mu gihe umukoresha ahindutse atakiri Equity Bank Plc iyo nguzanyo izakomeza kwishyurwa hakurikijwe igipimo cy'inyungu gitangwa n'amabanki y'ubucuruzi, bityo ngo rukemeza ko DUSABE Javan SANGANO agomba gukomeza kwishyura inguzanyo ku nyungu za 18.25% ku mwaka.

[17] DUSABE Javan SANGANO n'umwunganizi we Me TUYISHIME Jean Pierre biregura kuri iyi ngingo y'ubujurire bavugaga ko mu rubanza rujurirwa, Urukiko Rukuru rw'Ubucuruzi rwasesenguye neza ingingo ya 4 y'amasezerano y'inguzanyo, ko ibyo EQUITY BANK RWANDA Plc ivugaga ko rwasobanuye iyo ngingo rutitaye ku bikubiye mu ngingo ya 66 n'ya 68 z'Itegeko n°45/2011 ryo ku wa 25/11/2011 rigenga amasezerano, nta shingiro byahabwaga, kuko mu gika cya 21

n'icya 22 by'urubanza RCOMA 00349/2021/HCC Urukiko rwasesenguye ibikubiye mu ngingo ya 66, aho rwasobanuraga impamvu ingingo z'amasezerano zivugwa zabayeho, aho rwavuze ko impamvu irebana no kuba DUSABE Javan SANGANO yari atakiri umukozi wa Banki yagombaga kwitabwaho, kandi ko n'ingingo ya 68 rwayitayeho mu gusobanura icyo amasezerano yari agamije nk'uko bigaragara mu gika cya 16 cy'urubanza rwajuririwe, aho rwasobanuye ko amasezerano yari agamije ko mu gihe DUSABE Javan SANGANO yivanye ku kazi inyungu zizazamuka, ibyo bikaba bisobanuye ko igihe yari kuguma ku kazi cyangwa akakavanwaho bitamuturutseho, EQUITY BANK RWANDA Plc nta burenganzira yari ifite bwo kuzamura inyungu.

[18] Bakomeza bavuga ko EQUITY BANK RWANDA Plc yakuye DUSABE Javan SANGANO aho yakoraga muri KCB imwizeza ko izamugurira inguzanyo itazamuye inyungu, kandi ikazamara igihe kirekire, aho impande zombi zumvikanye ko izishyurwa mu gihe kingana n'amezi 180.

[19] DUSABE Javan SANGANO avuga ko ikibazo kiri mu rubanza atari icyongereza, ko ahubwo ari icyo kumva neza *context* ayo masezerano y'inguzanyo yakozwemo, ko atari ubwa mbere akoze muri Banki, ko yakoraga muri KCB Bank, EQUITY BANK ikamureshya kubera ko ari umukozi mwiza yari ikeneye, ikamuha umushahara munini, ikanamugurira umwenda yari afite muri KCB, ariko ko mu gihe batagaragaza ko yabakoreye nabi bamwirukanye mu buryo budakurikije amategeko. Yongeraho ko ku rwego rwa mbere mu Rukiko rw'Ubucuruzi yatsinzwe n'uko nta kimenyetso yari afite kigaragaza ko yirukanwe arenganyijwe kuko urubanza rw'umurimo rwari rutarangira, ariko ko urubanza rwageze mu Rukiko Rukuru rw'Ubucuruzi ikimenyetso cy'urubanza rw'umurimo cyaramaze kuboneka kigaragaza ko yirukanywe arenganyijwe.
