Ayo masezerano yagombaga kumara igihe cy'amezi atatu (3), abarwa uherye igihe yakorewe kugeza ku wa 22/07/2020, kandi yateganyaga ko izo nzugi n'amadirishya bizagemurwa mu byiciro bibiri, aho ku cyiciro cya mbere hagombaga kugemurwa kimwe cya kabiri cyabyo, hanyuma ku cyiciro cya kabiri hakagemurwa ibisigaye.
