Iyo nguzanyo yatanzwe mu byiciro nk'uko impande zombi zabyumvikanyeho, aho ku cyiciro cya mbere bahawe 25.000.000 Frw, nyuma yuko BANK OF KIGALI Ltd isuye iyo ingwate yongera kubaha 25.000.000 Frw ku cyiciro cya kabiri.

Ko kandi nubwo bene umutungo batamenyeshejwe ibijyanye na cyamunara ariko ko nta mpungenge byari bibateye, kuko bari bizeye ko agaciro ingwate yari ifite kangana na 252.474.861 Frw nk'uko kemejewe na RDB karutaga umwenda, ariko ko batunguwe nuko BK Plc yafashe indi mitungo yahoze ari iya NZABARINDA Jean Pierre yagurishije abandi bantu, hategerejwe gukorwa ihinduza mutungo (mutation) ikayiteza cyamunara, umwe ukagurishwa 6.000.000 Frw, undi 3.100.000 Frw, ndetse hakaba hakiri urubanza kuri iyo mitungo rukiburanishwa, ko ari naho bamenyeye ko umwenda wari ugeze kuri 55.803.611 Frw, ko n'ingwate yagurishijwe 25.100.000 Frw.

MUSABYIMANA Spéciose yazabiregera mu kirego cyihariye, kuko atagomba guhindura icyaregewe na cyane ko mu gika cya 12 cy'urubanza rujuririrwa yiymereye umwenda.
