Amategeko agenga imiburanishirize y'imanza z'ubucuruzi – Ubujurire bwa kabiri ku kirego gisaba gutesha agaciro cyamunara – Ikirego gisaba gutesha agaciro cyamunara gishobora kujuririrwa bwa kabiri kuko aba ari ikirego cyigenga cyangwa cyihagije kidashamikiye ku kindi kirego cy'iremezo kandi kikajuririrwa mu gihe kitarenze iminsi itatu – Bifata isura y'ibirego byihutirwa ku birebana n'ibihe byo kurega no kuburanishwa gusa, hagamijwe cyane cyane ko izo manza zidatinda mu nkiko harebwe agaciro (importance) kazo ku baburanyi – Itegeko no 22/2018 ryo kuwa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, ingingo ya 188 igika cya 2.

Nyuma yo guteza cyamunara, Ntaganda yatanze ikirego mu Rukiko rw'Ubucuruzi asaba gutesha agaciro cyamunara aho yavugaga ko umutungo we wateshejwe agaciro, ko umutungo we waguzwe kuri cyamunara ya mbere, ko kandi habayemo ruswa mukuwugura.

Yaba Urukiko rw'Ubucuruzi ndetse n'Urukuru rw'Ubucuruzi zasuzumye ikirego n'ubujurire bwari bwatanzwe na Ntaganda zisanga nta shingiro ikirego cye gifite kuko zasanze umutungo we utarateshwjwe agaciro kandi ukaba waraguzwe kuri cyamunara yakozwe ku nshuro ya gatanu, ko kandi ibimenyetso by'abatangabuhanya yatanze avuga ko habayemo ruswa inkiko zitabihaye agaciro kuko mu bitabiriye cyamunara abo batangabuhanya batagaragaye.

Ntaganda yarongeye ajuririra Urukiko rw'Ubujurire avuga ko umutungo we wateshejwe agaciro, ko inyandiko yatanze z'abatangabuhanya b'abakomisiyoneri bari bahari zitahawe agaciro, ko kandi umutungo we waguzwe ku ncuro ya mbere.

Banki of Kigali, Ngendahayo n'Akagera Motors baregwaga muri uru banza batanze inzitizi ebyiri (2) zo kutakira ubujurire bwa Ntaganda. Inzitizi ya mbere bavugaga ko Ntaganda yatanze ubujurire bwa kabiri ku birego byihutirwa kandi bitemewe naho inzitizi ya kabiri bavugaga ko Urukiko rw'Ubujurire butakwiye kwakira ubujurire bwe kubera ko yatsinzwe ku rwego rwa mbere n'urwa kabiri ku mpamvu zimwe.

Ku nzitizi ya mbere, Ntaganda yireguye avuga ko n'ubwo ibirego bya cyamunara ku birebana n'ibihe bifatwa nk'ibirego byihutirwa, mu byerekeye gutanga ikirego bifatwa nk'imanza zisanzwe, akaba nta makosa yakoze atanga ubujurire bwa kabiri.

Ku nzitizi iijyanye n'ibirabubasha bw'Urukiko rw'Ubujurire, Ntaganda yireguye avuga ko inkiko zombi zabanje, mu guca imanza zitashingiye ku mpamvu zimwe, ko ikirego cya cye kiri mu bubasha bw'Urukiko rw'Ubujurire.

[2] Ntaganda Joseph yaregeye Urukiko rw'Ubucuruzi, asaba ko iyo cyamunara yateshwa agaciro kuko yakozwe mu buryo bunyuranyije n'amategeko, avuga ko igenagaciro ryakozwe mu gihe cy'itangwa ry'umwenda ryagaragaje ko uwo mutungo usite agaciro ka 908.215.632 Frw, ariko ko mu cyamunara wateshejwe agaciro ku buryo bukabije, kuko wagurishijwe kuri

582.000.000 Frw, ko wahise ugurishwa kuri cyamunara ya mbere kuko ku zindi nshuro nta cyamunara zabayeho kubera ko nta baguzi bigeze bitabira, ko ushinzwe kugurisha yirengagije amategeko, arimo ingingo ya 11 n'ya 12 z'Amabwiriza y'Umwanditsi Mukuru n° 03/2010/ORG yo ku wa 16/11/2010, agenga ibyerekeye gukodesha, kugurisha muri cyamunara ndetse no kwegukana ingwate.

[3] Mu rubanza n° RCOM 02588/2019/TC rwo ku wa 27/1/2020, Urukiko rw'Ubucuruzi rwemeje ko ikirego cya Ntaganda Joseph nta shingiro gifite, rumutegeka kwishyura buri wese mu baregwa 600.000 Frw y'ikurikiranarubanza n'igihembo cya Avoka.

[4] Ntaganda Joseph ntuyishimiye icyo cyemezo, ajuririra Urukiko Rukuru rw'Ubucuruzi, muri urwo Rukiko, Banque de Kigali Plc na Ngendahayo Sylvère batanga inzitizi bavuga ko ubujurire budakwiye kwakirwa kuko atubahirije ibihe byo kujurira, ko urubanza rwajuririwe rwaciwe ku wa 27/1/2020, ajurira ku wa 30/1/2020, kandi ingingo ya 188, igika cya kabiri (2), y'Itegeko n° 22/2018 ryo ku wa 29/4/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi iteganya ko igithe cyo kujuririra icyemezo cyafashwe ku birego byihutirwa ari iminsi itarenze itatu (3) y'akazi, uhoreye ku munsi icyemezo cyasomeweho cyangwa ababuranyi bakimenyeyeho, bityo ko umunsi wa nyuma wo kujurira wari ku wa 29/2/2020.

[5] Nyuma yo gusobanura ko rusanga Ntaganda Joseph yarubahirije ibihe byo kujurira kuko umunsi icyemezo cyasomeweho cyangwa ababuranyi bakimenyeyeho, utabarwa mu minsi itatu yo kujurira, ahubwo ko iyo minsi itangira kubarwa nyuma y'umunsi icyemezo cyasomeweho cyangwa ababuranyi bakimenyeyeho, Urukiko Rukuru rw'Ubucuruzi, mu rubanza n° RCOMA 00120/2020/HCC rwo ku wa 10/3/2020, rwemeje ko ibihe byo kujurira byubahirijwe. Rwaciye kandi urubanza mu mizi, rusuzuma ikibazo cyo kumenya niba cyamunara yarakozwe mu buryo bunyuranyije n'amategeko n'ibirebana n'indishyi, rwemeza ko ubujurire bwa Ntaganda Joseph nta shingiro bufite, runamutegeka kwishyura abaregwa 300.000 Frw y'igihembo cya Avoka mu bujurire, kuri buri wese.

[6] Ntaganda Joseph ntuyishimiye imikirize y'urubanza, ajuririra Urukiko rw'Ubujurire ku wa 13/3/2020, avuga ko atishimiye icyemezo cyafashwe n'Urukiko Rukuru rw'Ubucuruzi, aho rwemeje ko ubujurire bwe nta shingiro bufite kandi cyamunara yarakozwe ku nshuro ya mbere bagahita bagurisha umutungo we na Umubyeyi Noëlla, ko umutungo wagurishijwe ku giciro gito cyane ugereranyije n'agaciro nyakuri wari usanganywe, kandi ko Urukiko rwatesheje agaciro inyandiko mvaho yakozwe n'aba *commissionaires*, mu buryo bunyuranyije n'amategeko.
