Amategeko agenga imiburanishirize y'imanza z'ubucuruzi – Ububasha bwo kurega – Gutanga ikirego mu izina ry'ubucuruzi – Entreprise y'umuntu kigiti cye nta bubasha bwo kurega ifite kuko atari isosiyete y'ubucuruzi ifite buzima gatozi; ahubwo bugirwa na nyirayo mu izine rye bwite kabone n'iyo yaba afite izina ry'ubucuruzi.

Incamake y'ikibazo: Global Services Enterprise ya Nkiranuye Théophile yagiranye amasezerano n'Akarere ka Ngororero yo kugemura imashini no gukora “installation” yazo mu ruganda rusya ifu y'imyumbati rw'ako Karere (fourniture et installation des machines pour l'usine de manioc dans le District de Ngororero). Mu gihe cy'ishyirwa mu bikorwa ry'amasezerano haje kuvukamo amakimbirane aho Global Service Enterprise yavugaga ko Akarere ka Ngororero katubatse aho imashini zagombaga guterekwa bituma hari izangiritse. Akarere ka Ngororero byabaye ngombwa ko kagura aho imashini zagombaga gushyirwa kuko ahari hanzwe mbere hari hatwo ariko imashini zimaze kugeramo gakemanga ubuziranenge bwazo.

Ibi byatumye Global Services Enterprise iregera Urukiko rw'Ubucuruzi rwa Musanze isaba ko hakubahirizwa amasezerano bagiranye maze Akarere ka Ngororero kakishyura amafaranga kayifitiye ndetse inabisabira indishyi zitandukanye.

Urukiko rwemeje ko Akarere ka Ngororero kishyura 49.710.000Frw ariko kakayishyura ari uko Global Services Enterprise imaze gusimbuza imashini zitujuje ubuziranenge izibwujije kandi zizigwa umugese (carbon steel) ikazisimbuza izitagwa umugese (stainless cyangwa inox). Urukiko kandi rwategetse Global Services Enterprise ko itahabwa 24.855.000Frw (10% y'isoko) ahwanye n'igihombo ivuga ko yatejwe no gutinda kwishyurwa kuko igomba kubanza gusimbuza imashini zigwa umugese (carbon steel) izitagwa umugese.

Global Service Enterprise yajuriye Urukiko Rukuru rw'Ubucuruzi, rwemeza ko ubujurire bwayo nta shingiro bufite; ruvuga ko nta gihindutse ku mikirize y'urubanza rwaciwe n'Urukiko rw'Ubucuruzi rwa Musanze.

Global Services Enterprise yongeye ijuririra Urukiko rw'Ubujurire ivuga ko Urukiko Rukuru rw'Ubucuruzi rwemeje ko igomba gusimbuza imashini yazanye izindi zitari zikubiye mu masezerano impande zombi zagiranye, ko rwashingiye kuri raporo ya RSB yakozwe ibisabwe n'Akarere ka Ngororero mu mwaka wa 2015, aho gushingira kuri raporo yakozwe ku wa 13/09/2013, aho RSB yemeza ko imashini zivanwa mu bubiko bwa MAGERWA zikajya

gukoreshwa. Akarere ka Ngororero ko kireguye gatanga inzitizi y'iburabubasha kavuga ko ubujurire bwa Global Services Enterprise budakwiye kwakirwa kubera ko yatsinzwe ku mpamvu zimwe ndetse ko n'agaciro kaburanwa katageze ku gateganywa n'Itegeko kugira ngo ubujurire bwa kabiri bwayo bube mu bubasha bw'Urukiko rw'Ubujurire.

Mbere yo gutangaza icyemezo ku nzitizi zari zatanzwe n'Akarere ka Ngororero, Urukiko rw'Ubujurire rubyibwirije rwasabye ababuranyi kujya gukora imyanzuro ku kibazo kijyanye n'ububasha bwa Global Services Enterprise bwo gutanga ikirego mu Rukiko kubera ko rwabonaga ariyo yareze kuva urubanza rugitangira kandi kuri "certificate of enterprise registration" yatanzwe na RDB, hagaragara ko Global Services Enterprise ari izina ry'ubucuruzi rya Nkiranuye Théophile. Mu myanzuro yako, Akarere ka Ngororero kavuze ko ubujurire bw'uwajuriye butakwagirwa kuko ari "entreprise individuelle" idashobora kurega nka sosiyete kuko yo nta buzimagatozi ifite. Uwajuriye we yavuze ko Global Services Enterprise ari izina ry'ubucuruzi ko kandi ari sosiyete iriho, isora ndetse igahabwa n'amasoko; bityo ikaba ifite ubushobozi bwo kurega kubera ko yanditse mu masezerano kandi n'Akarere ka Ngororero kakaba karagiranye amasezerano nayo.

Kuba itegeko rigenga iby'amasosite ritegenya ko iyandikisha, imiterere n'imikorere by'ibikorwa by'ubucuruzi bikorwa n'abantu badashobora kwinjiza nibura ibihumbi icumi (10.000) ku muni bigenwa n'Iteka rya Minisitiri ufite ubucuruzi mu nshingano ze, Julia Shop ikaba yaranditswe hashingiwe ku Iteka rya Minisitiri N° 02/09 MINICOM ryo kuwa 08/05/2009 ryerekeye ubucuruzi bukorwa n'abantu badafite ubushobozi buhagije bigaragaza ko Global Services Enterprise ari izina ry'ubucuruzi bw'umuntu ku giti cye; ku bw'ibyo ikaba idafite ubuzima gatozi ku buryo yatanga ikirego mu rukiko. Bityo rero Global Services Enterprise ntiyashoboraga gutanga ikirego mu rukiko kuko nta bubasha ibifitiye.

Ibyo bikaba byaragombaga kuba byarangiyeye gukorwa mu gihe kitarenze amezi atanu uheryeye ku italiki ya 22/04/2013, umunsi amasezerano yavuzwe haruguru yashyiriweho umukono, ni ukuvuga tariki ya 22/09/2013, ariko Global Services Enterprise ivuga ko atari ko byagenze kuko Akarere ka Ngororero katigeze kubahiriza amasezerano bagiranye.

[17] Ku kibazo cyo kumenya niba Global Services Enterprise yakwishyurwa umwenda iregera muri uru rubanza ungana na 49.710.000 Frw, Urukiko rw'Ubucuruzi rwa Musanze rwavuze ko rushingiye kuri raporo yakozwe na Rwanda Standards Board (RSB) yo ku wa 22/06/2015, yemeje ko imashini zagemuwe muri urwo ruganda zigwa umugese (carbon steel) zigomba guhindurwa mu rwego rwo kubungabunga ubuzima bw'abantu, runashingiye ku mahame mpuzamahanga ngenderwaho ku isuku y'ibiribwa (Recommended International Code of Practice General Principles of Food Hygien) aho biteganijwe ko mu gihe hatunganywa ibiribwa hagomba kwirindwa ikintu cyose cyakwangiriza ubuzima bw'abantu ndetse ko ibikoresho bitunganya ibiribwa bigomba kuba byubatswe cyangwa bikozwe ku buryo butagira uwo byanduza, ruvuga ko ibikoresho cyangwa imashini zigwa umugese (carbon steel) bitakwakirwa n'Akarere ka Ngororero, kandi ko katategukwa kwishyura amafaranga katishyuye uko ari 49.710.000 mu gihe cyose ibikoresho bituzuye ubuziranenge bitarasimburwa n'ibibufite.

[20] Mu gusobanura icyemezo rufashe (motivation), Urukiko Rukuru rw'Ubucuruzi rwavuze ko rugendeye ku miterere y'icyo ibyo bikoresho byari byaguriwe n'ingaruka byagira k'ubuzima bw'abantu mu gihe byakoreshwa, Akarere katagomba guhamana ibyo bikoresho ngo kabe kasubiza Global Services Enterprise igice cy'amafaranga, ko ahubwo igomba kubisimbuza ibizima cyangwa ikabisubirana ntiyishyurwe.

[21] Urukiko rwavuze ko Global Services Enterprise itakwitwaza ko ibikoresho mbere yo gusohoka muri gasutamo byaba byarasuzumwe na RBS cyangwa ngo yitwaze ko Akarere kaba karabyakiriye ngo yumve ko ntacyo igomba kuryozwa, kuko kuba nta kimenyetso cya RBS igaragaza cyemeza ko ibyo bikoresho byujuje ubuziranenge, niyo RBS yaba yarabisuzumye ariko ntibone inenge yihishe (vice cashé) ishobora kuba iterwa no kuba haba haraguzwe ibitujuje ubuziranenge (pirate) aho kugura iby'umwimerere (original), nk'uko biteganywa n'amategeko, ibyo bitabuzwa rwiyezimirimo kwirengera iyo nenge, kuko nk'inararibonye afite inshingano yo

kugemura ibikoresho bidafite inenge no kumenya ibidashobora kuzana umugese, bityo rwemeza ko nta gihindutse ku mikirize y'urubanza rwaciwe n'Urukiko rw'Ubucuruzi rwa Musanze.
