Urukiko rw'Ubucuruzi rwafashe icyemezo ku nzitizi yo kutakira ikirego yatanzwe na RAB kubera iburabubasha ry'urega, rusanga n'ubwo amasezerano yakozwe na Joint Venture Benedetta Group & A.I Engineering, ububasha bwo gukurikirana ibijyanye n'ayo masezerano bwarahawe Benedetta Group, rwemeza ko inzitizi yatanzwe nta shingiro ifite. Rufata n'icyemezo ku rubanza mu mizi, rwemeza ko ikirego cyatanzwe na Benedetta Group Ltd gifite ishingiro, rutegeka RAB kuyishyura umwenda ungana na 335.163.425 Frw, n'inyungu zitandukanye. [23] Ingingo ya 3 y'itegeko n° 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi iteganya ko "*Ikirego cyakirwa mu Rukiko iyo urega afite ububasha, inyungu n'ubushobozi byo kurega, keretse igihe itegeko ribiteganywa ukundi. Ku mashyirahamwe, imiryango n'ibigo bidafite ubuzimagatozi, harega kandi hakaregwa abayobozi babyo mu izina ry'ababigize*".
