Rwigamba ntiyanyuzwe nicyo cyemezo, ikijuririra mu Rukiko Rukuru, anenga Urukiko rwabanje kuba rwaremeje ko urubanza rw'ubutane, atari ikimenyetso kigaragaza umwenda uregerwa nyamara urwo rubanza ari rwo shingiro ry'umwenda kuko ari rwo aheraho yishyura amafaranga yakabaye yarishyuye na Murenzi Rukata. Avuga kandi ko Urukiko Rwabaje rwarenze ku itegeko rugaca urubanza ku cyo rutaregowe kandi ko ngo rutasobanuye icyatumye rudaha agaciro ibimenyetso rwashyikirijwe. [13] Murenzi Rukata Mark na Me Mbarushimana Aimé umwunganira, bavuga ko mu gika cya 35 cy'urubanza rwaciye n'Urukiko Rukuru ari narwo rujuririrwa, urwo Rukiko rwavuze ko Murenzi Rukata Mark avuga ko atishyuriye abana be amafaranga y'ishuri kuko bajanywe mu mashuri ahenze kandi yarashyigikiye igitekekerezo cy'uko bajya kwiga muri Canada, nk'uko bigaragara muri message "E-mail" yo ku wa 06/04/2017 n'iyo ku wa 12/04/2017, ko kuba nyina w'abo bana yaragiye abishyurira kandi ari inshingano ya se, Murenzi Rukata Mark agomba kumusubiza amafaranga yishyuye. Banenga urwo Rukiko kuba rwarafashe ibintu uko bitari, kuko ibaruwa ya Rwigamba Molly yo kuri "e-mail" n'igisubizo Murenzi Rukata Mark yatanze rwabifashe nk'amasezerano bagiranye kandi atariko biri, kuko nta masezerano bigeze bagirana.

I support the idea of Canada, like I would support USA or UK Universities depending on tuition and convenience"; zumvikanisha ko Murenzi Rukata Mark atigeze yemera ko abana bajyanwa kwiga mu mahanga kandi no kwemera ko azabishyurira, kuko Rwigamba Molly ubwe yanditse yiyemerera ko amashuri ahenze, ndetse ko abana bazahabwa scholarship 100%. Bavuga ko Murenzi Rukata Mark yamusubije ko ashigikiye icyo gitekerezo, ariko ko byose bizaterwa n'amafaranga azishyurwa (Tuition) n'ubushobozi buzaba buhari (Convenience), ko rero Urukiko Rukuru rutagombaga guhindura izo mvugo amasezerano yo kwemera umwenda, ngo rutegeke Murenzi Rukata Mark kwishyura

amafaranga y'ishuri, bityo bagasaba Urukiko rw'Ubujurire kvanaho icyemezo cyafashwe n'urwo Rukiko.

[38] Urukiko rw'Ubujujire rurasanga n'ubwo "e-mails" Murenzi Rukata Mark yandikiranye na Rwigamba Molly zitafatwa nk'amasezerano y'umwenda, ni ikimenyetso kigaragaza ko Murenzi yemeye ko Murenzi Portia yoherezwa kwiga muri Canada, anizeza uwo mwana na nyina Rwigamba Molly ko azishyura amadolari y'Amerika ibihumbi icumi (10,000USD) muri Nzeli 2016, bityo akaba ari ikimenyetso cy'uko Murenzi yemeye kwishyura ayo madorari, kandi hashingiwe ku ngingo ya 12 yavuzwe haruguru⁵ Murenzi akaba nta kindi atanga kivuguruzwa icyo kimenyetso.

[39] Mu gusesengura ikibazo kijyanye no gusubiza umwe mu bari barashyiringiranywe ariko nyuma bakaza gutana ibyo yatanze ku nshingano zari gukorwa na mugenzi we, twakeneye kumenya uko bigenda mu bindi bihugu, dusanga atari umwihariko w'u Rwanda kuko n'ahandi ari bwo butabera butangwa: mu rubanza N° 642/2008 rwaciwe n'Urukiko rw'Ikirenga rwa Afurika y'epfo kuwa 26 Ugushyungo 2009, Fish Hoek Primary School iburana na G W, urwo Rukiko rwatanze umurongo ko bitagibwaho impaka ko mu nyungu z'umwana, umubyeyi utabana nawe (non-custodian parent) kandi atagaragaza ubushake bwo kumwishyurira amashuri agomba kubihatirwa, byaba ngombwa agategekwa kwishyura ishuri ry'umwana we. Urwo Rukiko rwemeje kandi ko iyo umubyeyi ubana n'umwana (custodian parent) atanze amafaranga arenga uruhare rwe mu yo agomba, afite uburenganzira bwo kuyasubizwa n'undi mubyeyi w'umwana wagombaga kuba warayatanze⁶.

[40] Na none mu rubanza N° 53198/2013 rwaciwe n'Urukiko Rukuru rwa Afrika y'epfo, Urugereko rwa Pretoria, Sone Cloete aburana na Johann Chris Blignaut batandukanye (divorce) mu mwaka wa 1996, Sone Cloete aregera urukiko arusaba gutegeka uwahoze ari umugabo we (Johann Chris Blignaut) kumwishyura amarandi miliyoni ebyiri, ibihumbi magana atanu mirongo itandatu na kimwe, magana acyenda mirongo itatu n'icyenda (R2,561,939) yatanze yita ku bana babyaranye, harimo ayo yatanze mu buvuzi ndetse no mu burenze bwabo kuwa mu mwaka wa 2009 kugeza 2012, nyuma aza gusaba ko asubizwa kimwe cya kabiri cyayo (1,280,969Frw). Sone Cloete yatsinzwe kubera kubura ibimenyetso by'ayo marandi yasabaga kwishyurwa, ariko urwo Rukiko rusanga mu gihe umugabo n'umugore batanye, umwe akishyura amafaranga arenga uruhare rwe mu kwita ku bana babo, uwatanze ayo mafaranga afite uburenganzira bwo gusaba kuyasubizwa arimo n'ayo yatanze ku mashuri yabo (The child's educational needs)⁷.
