Amategeko agenga imiburanishirize y'imanza z'ubucuruzi – Ingwate itangwa n'abanyamahanga – Sosiyete y'inyamahanga ntishobora gusabwa gutanga ingwate isabwa abanyamahanga baregeye inkiko zo mu Rwanda mu gihe hari uburenganzira yabivukijweho.

Amategeko agenga imiburanishirize y'imanza z'ubucuruzi – Ububasha n'ubuzima gatozi bw'isosiyete y'inyamahanga – Sosiyete y'inyamahanga igaragaje ibyangombwa byayo by'umwimerere byatanzwe n'igihugu ikomokamo, byemejwe na MINAFET (legalisation) biyiha ububasha n'uburenganzira bwo kuregera inkiko z'u Rwanda.

[25] Kuba rero Innscor International Ltd igaragaraza ko ibirango irikuregera ari ibyayo ndetse yanandikishije mu rwego rubifitiye ububasha (Rwanda Development [SEP]Board "RDB") ndetse nk'uko yanabigaragaje mu bindi bimenyetso biribuzwe gusobanurwa mu kibazo cya kabiri cy'urubabanza, Innscor International Ltd ikaba itacibwa iyi ngwate hashingiwe ku byanditswe na Gasasira Ephraim nk'uko bisabwa n'ababuranira abaregwa kuko inyandiko z'abahanga zifashishwa iyo nta tegeko rihari cyangwa ntacyo rivuga kuri icyo kibazo , kuba rero itegeko rihari kandi risobanutse rikaba ariryo rigomba gukoreshwa.

[27] Me Kizito Safari asobanura ko Urukiko rw'Ubucuruzi rwa Nyarugenge ngo rwanze kwakira ikirego cy'urega ngo kuko adafite ubushobozi bwo kurega ngo kuko nta cyerekana ko Innscor International Ltd ifite ubuzima gatozi ko ndetse ngo n'ibyo yagaragaje by'umwimerere bigaragaza ubuzima gatozi ngo urukiko rwabyirengagije rwemeza ko nta gaciro byahabwa.

[28] Mu kubyima agaciro rukaba ngo rwarasesenguye nabi ingingo z'amategeko rwashingiyeho rwanga kwakira ikirego.

[29] Asobanura na none ko Innscor International Ltd ngo ari sosiyete ifite ubuzima gatozi ngo nk'uko bigaragazwa n'icyemezo cyayo cy'umwimerere cy'iyandikisha (certificate of incorporation) cyatanzwe n'umwanditsi wa Company wo mugihugu cya Mauritius iyi company yanditswemo. Kuba ngo ari sosiyete izwi kandi ifite ubuzima gatozi ngo bishimangirwa na RDB, ibi ngo bikagaragazwa n'inyandiko (correspondences) RDB yagiye yandikira Innscor International Ltd nka sosiyete y'ubucuruzi izwi. Kuba Innscor ngo ari sosiyete ifite ubuzima kandi ngo byongera gushimangirwa na RDB ubwo yayemeraga kwandika ibirango byayo mu Rwanda ikanabitangaza mu igazeti (publication journal) ya 2014 ngo harimo n'ibiburanwa ubu,aha ngo byumvikane neza ko iyo Innscor International Ltd iba nta buzima gatozi ifite RDB itari kwakira no kwemera ubusabe bw'umuntu utariho.
