

## CELA COMPANY LTD v PHILIPP COTTON

*Amategeko agenga ububasha bw'inkiko – Umuyobozi wanze kurangiza urubanza rwaciwe mu bibazo by'ubucuruzi – Ububasha bw'inkiko z'ubucuruzi mu guhatira umuyobozi w'ikigo cya Leta kurangiza urubanza – Umuyobozi wanze kubahiriza ibyategetswe mu rubanza rwaciwe n'urukiko rw'ubucuruzi ashobora guhamagazwa nurwo rukiko kugira ngo yisobanure ku mpamvu zamubujije kubyubahiriza, iyo bisabwe n'umuburanyi ubifitemo inyungu.*

**Incamake y'ikibazo:** CELA Company Ltd yagiranye imanza na University of Rwanda iza no kuyitsinda ariko University of Rwanda ntiyubahiriza ibyari bikubiye mu manza baburanye zarangiriye mu Rukiko Rukuru rw'Ubucuruzi.

CELA Company Ltd yaje gutanga ikirego mu buryo bw'inyandiko nsobanurakirego isaba gutegeka Phipp Cotton, Umuyobozi wa University of Rwanda kwishyura amafaranga yari isigaje kuyishyura ndetse no kumugenera igihano gihatira kwishyura kubera kudashyira mu bikorwa ibyategetswe n'urukiko.

Philipp Cotton yagobokeshejwe mu rubanza atangira atanga inzitizi ebyiri (2) zituma ikirego cya cya CELA Company Ltd kitakwakirwa. Inzitizi ya mbere yabanje gusobanura ko Urakiko Rukuru rw'Ubucuruzi rudafite kuburanisha ikirego cyatanzwe mu rwego rwa mbere kuko ngo mu bubasha bwarwo umushingamegeko atabivuze, ko ahubwo yakagombye kuregwa mu manza z'ubutegetsi kuko ingingo awareze ashingiraho ya 184 y'Itegeko n° 22/2018 ryo kuwa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi iherereye mu bice birebana n'imanza z'ubutegetsi. Yatanze indi nzitizi ya kabiri avuga ko ikirego cy'awareze yagitanze nabi kuko kitagomba gutangwa mu buryo bw'inyandiko nsobanurakirego itanzwe n'umuburanyi umwe kuko nta bwihutire burimo, ko hagomba kuba hatarimo impaka kandi akaba abona zirimo ndetse ko atari awareze atariwe wari gusaba ko agobokeshwa mu rubanza. Kuri izi nzitizi, kuya mbere awareze yireguye avuga ko inzitizi yatanze na Phipp Cotton nta shingiro ifite kuko amategeko yateganyije ko ikirego yatanze cyo guhatira umuyobozi kurangiza urubanza gitangwa mu rukiko rwaruciye bwa mbere; bityo ko Urakiko Rukuru rw'Ubucuruzi arirwo rufite ububasha.

Ku cyijyanye n'inzitizi ya kabiri, uwareze yireguye avuga ko nayo nta shingiro ifite bitewe n'uko hari ubwihutire kuko ifitiye amadeni banki kandi ikaba iri ku gitutu cyayo; ko kandi uburyo yanzemo ikirego abona bukurikije amategeko.

Kubirebana n'urubanza mu mizi, CELA Company Ltd isobanura ko mu rubanza RCOMA 00748/2016/HC/HCC, Universty of Rwandayaratsinzwe maze itegekwa Urukiko ruyitegeka kuyishura amafaranga y'imrimo yakoze ariko yishuyeho amafaranga macye ikaba kandi yanditse n'ibaruwa ivuga ko itazongera kwishyura ibyo yategetswe n'Urukiko, bityo niyo mpamvu yaregeye uru Rukiko kugira ngo ibashe kurenganurwa

Philip Cotton Umuyobozi wa University of Rwanda, yisobanura kuri iyi mpamvu y'ikirego cya CELA Company Ltd, avuga ko urega yitiranyije icyemezo cy'Urukiko, kuko icyo Urukiko Rukuru rw'Ubucuruzi rwategetse, atari indishyi mbumbe zigomba kwishyurwa na Kaminuza y'u Rwanda, ahubwo byari facture igomba gukorwa ikishyurwa mu buryo amasezerano yateganyaga hagati ya kaminuza na rwiyemezamirimo kandi Kaminuza ikaba ayo mafaranga yarayishyuye, bityo akaba asanga ko ntacyo yarakwiye gutegekwa gukora cyangwa guhatira kurangiza urubanza, kuko ibyo University of Rwanda yategetswe, atari Bwana Philip Cotton wabitegetswe, ariko nyamara kandi University of Rwanda yarabirangije..

## **Urubanza**

### **I. IMITERERE Y'URUBANZA**

[1] CELA Company, Ltd isobanura ko mu rubanza yaburanye na Real Construction and Supply Services Ltd na University od Rwanda (Rukara College of Education) rwo kuwa 29/06/2017, uru Rukiko rwategetse University of Rwanda kuyishyura amafranga yaregeye akomoka ku mirimo yari yarakozwe ku nyubako ya *Laboratoire* yo muri University of Rwanda, Ishamyi rya Rukara. CELA Company Ltd ivuga ko University of Rwanda, LTD yanze gushyira mu bikorwa icyo cyemezo, ikayishyura amafaranga make gusa muyo yategetswe.

[2] CELA Company, LTD yahisemo rero kuregera uru Rukiko kuba Bwana Philip COTTON, umuyobozi wa Universty of Rwanda adashaka gushira mu bikorwa ibyemejwe n'Urukiko, bityo uru Rukiko rutegeke Umuyobozi ubwe uregwa kwishyura, mu gihe atabikora ku itariki yategetswe, agatanga igihano gihatira kurangiza urubanza nk'uko biteganywa n'amategeko.

[3] Philip Cotton wagobokeshejwe muri uru rubanza, yabanje gutanga inzitizi ebyiri zo kutakira iki kirego ku mpamvu z'uko kitari mu bubasha bw'uru Rukiko, no ku mpamvu z'uko urega yatanze ikirego mu buryo budakurikije amategeko; nyuma y'izi nzitizi nubwo yireguye ku mpamvu ikirego gishingiyeho, nayo agasobanura ko idafite ishingiro.

[4] Ikigiye gusuzumwa no gufatwaho umwanzuro muri iki kirego ni (1) Kumenya niba ikirego kiri mu bubasha bw'uru Rukiko. (2) Kumenya niba ikirego cyatanzwe mu buryo bwubahirije amategeko. Mu gihe rwasanga izi nzitizi zifite ishingiro, nibwo rusuzuma ingingo ya gatatu, (3) Kumenya niba Philip COTTON, Umuyobozi wa Universty of Rwanda yategekwa kwishyura CELA Company, Ltd, Rwf 54.915 000.

### **IIISEENGURA RY'IBIBAZO BIRI MU RUBANZA**

#### **A) Gusuzuma niba uru Rukiko rufite ububasha bwo kuburanisha iki kirego.**

[5] Philip Cotton yatanze inzitizi y'iburabubasha bw'Urukiko Rukuru rw'Ubucuruzi, ashingiye kuba ingingo ya 82, igika cya 1, icya 3, n'icya 4, y'Itegeko n°30/2018 ryo ku wa 02/06/2018 rigena ububasha bw'Inkiko, igaragaza ububasha bw'Urukiko Rukuru ku rwego rwa mbere; aho iteganya mu gika cya 1, ko Urukiko Rukuru rw'Ubucuruzi ruburanisha ku rwego rwa mbere ibirego bisaba kurangiriza mu Rwanda ibyemezo n'imanza z'ubucuruzi, iz'imari, iz'imisoro n'amahoro byafashwe n'Inkiko zo mu mahanga. Mu gika cya 2, ko Urukiko Rukuru rw'Ubucuruzi rufite kandi ububasha bwo kuburanisha ibirego bisaba kurangiriza mu Rwanda inyandikompamo zifite ikigaragaza ko zanditswe n'abategetsi bo mu mahanga, iyo zujuje ibyangombwa bikurikira: a) iyo impamvu bazisabira irangizwantaho zinyuranyije n'amategeko rusange ndemyagihugu, kimwe n'amahame ashingiweho n'amategeko y'u Rwanda; b) iyo hakurikijwe amategeko y'Ighugu zandikiwemo, zujuje ibyangombwa byose bigaragaza ko ari imvaho. Mi gika cya 3, ko Urukiko Rukuru rw'Ubucuruzi ruburanisha kandi imanza zigamije gusuzuma niba ibyemezo byafashwe n'abakemurampaka byubahirije amategeko.

[6] Philip Cotton asobanura asobanura ko uko bigaragara muri ibi bika bitatu by'iyi ngingo, ntaho Urukiko Rukuru rw'Ubucuruzi rukura ububasha bwo kuburanisha ku rwego rwa mbere

Umuyobozi wanze kubahiriza ibyategetswe mu rubanza urwo arirwo rwose, rwaba n'urwo yaciye. Ko ibiteganywa n'ingingo ya 184 y'itegeko no 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegets, CELA Company, Ltd Ishingiraho, bireba inkiko zifite ububasha bwo kuburanisha imanza z'ubutegets, nk'uko n'umutwe zibarizwamo ibigaragaza, ko ari imiburanishirize y'imanza z'ubutegets. Bityo rero, Urukiko Rukuru rw'Ubucuruzi rukaba ntaho ruhuriye n'ibibazo by'ubutegets. Ko kuba ibisabwa bishingiye ku miburanishirize y'imanza z'ubutegets, uru Rukiko rukwiye kuvuga ko rudafite ububasha bwo kuburanisha uru rubanza, rushingiye ku miburanishirize y'imanza zitari mu bubasha bwarwo.

[7] CELA Company, Ltd yiregura kuri iyi nzitizi, ivuga ko iregera uru Rukiko ubwisyu bukomoka ku mikirize y'urubanza rwaciwe n'uru Rukiko mu mwaka wa 2016. Ko rero kuba hari Umuyobozi w'umukozi wa Leta wanze kwishyura ubwisyu bwategetswe n'Urukiko, yitwaje «budget» n'ibindi, ariyo mpamu CELA Company, Ltd yatanze ikirego ishingiye ku bitemanwa mu ngingo ya 184, igika cya kane, kivuga ko icyo kirego gishyikirizwa Urukiko rwaciye urubanza. Ko rero iki kirego cyayo kirega umuyobozi wanze kubahiriza ibyo Urukiko rwategetse. Hakaba kandi mu kirego harimo ubwihutire kuko urega afite imyenda ya Banki arimo kwishyuzwa. Ko rero iyi nzitizi ya Philip Cotton idafite ishingiro, kuko Itegeko ryemera kuregera uru Rukiko umuyobozi wanze kurangiza urubanza rwaciwe n'uru Rukiko.

[8] Rushingiye ku bisobanuro bitangwa n'ababuranyi bombi kuri iyi nzitizi y'iburabubasha bw'uru Rukiko; rushingiye kuba CELA Company, Ltd yaregeye uru Rukiko Rukuru rw'Ubucuruzi, Bwana Philip Cotton nk'Umuyobozi wa University of Rwanda, gutegekwa kwishyura CELA Company, Ltd amafaranga (asigaye mu) yategetswe n'uru Rukiko mu rubanza rwaciye RCOMA 00748/2016/CHC/HCC rwaciwe kuwa 29/06/2017; rushingiye kandi kuba, nubwo ingingo za 183 na 184 z'Itegeko n° 22/2018 ryo kuwa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegets, zashinzwe n'Umushingamategeko (Lawmaker) mu Mutwe w' "IMIBURANISHIRIZE Y'IMANZA Z'UBUTEGETSI"; bigaragara ariko muri uyu mutwe ko ugizwe n'Ibyiciro bibiri, ariyo icya mbere "IKIREGO GISABA GUKURAHO IBYEMEZO BY'UBUTEGETS N'IBURANISHA RY'URUBANZA MU MIZI YARWO", iki cyiciro kikagira nacyo utwiciro tubiri, aritwo; aka mbere "IKIREGO GISABA GUKURAHO IBYEMEZO BY'UBUTEGETSI" N'aka kabiri, "IKIREGO CYEREKEYE IBURANISHA RY'URUBANZA RW'UBUTEGETSI MU MIZI YARWO". Mu gihe ariko Icyiciro cya kabiri cy'uru Mutwe, cyiswe "IGIHANO GIHATIRA KUBAHIRIZA ICYEMEZO CY'URUKIKO".

[9] Isesengura ry'ibyo Umushingamategeko yateganije muri uyu Mutwe w'Itegeko, na cyane cyane ibyo yateganije mu byiciro bibiri byayo, yerekana ko koko uyu mutwe ugena uburyo Imanza zo mu rwego rw'ubutegets ziregerwa n'uko ziburanishwa. Ikigaragara na none, n'uko mu cyiciro cya mbere hagaragazwa ahanini uko haregwahakanaburanishwa imanza (z'ubutegets, bivuga) ziregwamo ibyemezo byafashwe n'Inzego z'Ubutegets. Mu gihe mu cyiciro cya kabiri, "IGIHANO GIHATIRA KUBAHIRIZA ICYEMEZO CY'URUKIKO", bigaragara ko kinagena uko bigenda mu manza zose (zitari gusa izaciwe mu rwego rw'ubutegets mu mizi) iyo habaye umuyobozi (cyangwa umukozi weze wo mu rwego rw'Ubutegets/Administratif) utubahiriza

(udashyira mu bikorwa) icyemezo (cyose) cy'Urukiko. Hakaba aribwo ibi bigenwa n'uyu mutwe kuko hajemo uruhare rw'uwo muyobozi.

[10] Rushingiye kuri ibi bisobanuro, binashimangirwa n'uko igika cya mbere cy'ingingo ya 183 y'Itegeko rivuzwe hejuru, kigena ko "Iyo urubanza rwabaye itegeko rutegeka Leta, Umujyi wa Kigali, ubuyobozi bw'Akarere cyangwa urundi rwego rwa Leta kuriha amafaranga rwagenny, ayo mafaranga agomba kwishyurwa mu mezi atandatu (6) uhereye ku munsi w'imenyeshwa ry'urubanza." No mu zindi ndimi zikoreshwa muri iri Tegeko, havugwa "When a judicial decision." (mu Cyongereza), kandi "Lorsqu'une décision juridictionnelle." (mu Gifaransa); bisobanura neza ko izi ngingo zitagenta gusa imanza zaciwe mu rwego rw'Ubutegetsi, ahubwo ikaba ari imanza zose zaciwe n'Inkiko, zabaye Itegeko, zikaba haribyo zategetsemo Leta, izindi nzego z'Ubutegetsi cyangwa urundi rwego rwa Leta, kugira ibyo zikora. Kuko izi nzego zitaburana gusa imanza z'ubutegetsi; ziburana n'izindi manza, harimo n'iz'ubucuruzi.

[11] Rushingiye kuri ibi rubonye, no kuba ingingo ya 184 y'Itegeko rimaze kuvugwa, igena mu gika cyayo cya mbere, ko "Umuyobozi wanze kubahiriza ibyategetswe mu rubanza ashobora guhamagarwa mu rukiko rwafashe icyemezo kugira ngo yisobanure ku mpamvu zamubujije kubyubahiriza, bisabwe n'umuburanyi ubifitemo inyungu (...)" Rusanga kuba urubanza RCOMA 00748/2016/CHC/HCC rwaciwe n'uru Rukiko, nirwo rero rufite ububasha bwo kuburanisha iki kirego cya CELA Company, Ltd. Rusanga rero iyi nzitizi yatanzwe na Philip COTTON idafite ishingiro.

#### **B) Gusuzuma niba ikirego cya CELA Company, Ltd cyatanzwe mu buryo bwubahirije amategeko.**

[12] Philip Cotton asobanura iyi nzitizi ye ya kabiri, avuga ko asanga CELA Company, Ltd yaratanze ikirego mu buryo bw'inyandiko nsobanurakirego itanzwe n'ababuranyi, kandi nyamara isaba ko Urukiko rumutegeka kwishyura amafaranga 78,887,854 Frw; ubu buryo bukaba bwashingirwaho kutakira iki kirego. Kuko hifashishije itegeko n° 22/2018 ryo kuwa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, mu ngingo yaryo ya 189, igika cya mbere, isobanura neza ko « Inyandiko nsobanurakirego itanzwe n'umuburanyi umwe ni uburyo budasanze bwo kuregera umucamanza umusaba kugira ibyo aramira mu buryo bwihuse. Ibikubiye muri iyo nyandiko bigomba kandi kuba ari ibibazo bigaragara ko nta mpaka biteye ku buryo byaba ngombwa ko undi muburanyi ahamagarwa. » Philip Cotton asanga muri iyi ngingo y'itegeko, harimo ibintu bitatu, a) Kuba hari ibigomba kuramirwa, b) kuba nta mpaka ibyo bibazo biteye, c) kuba urega atari we ufata iya mbere mu guhamagaza cyangwa gusaba kugobokesha undi muburanyi.

[13] Philip Cotton asanga rero, nk'uko bimaze gusobanurwa mu gika kibanziriza iki, nta bibazo urega agaragaza byihutirwa ku buryo ikirego cye cyagombaga kuba mu bwoko bw'ikirego gitanzwe n'umuburanyi umwe ku buryo umucamanza agomba kugifataho icyo cyemezo kugira ngo agire ibyo aramira mu buryo bwihuse. Ko ibi aribyo byanemejwe n'Urukiko rw'Ubucuruzi rwa Huye mu Urubanza RCOM 00003/2016/TC/Hye aho sosiyite yitwa Mount Meru Petroleum (Rwanda) Ltd yari yarareze isaba ko HASHI yimirwa muri sitasiyo; umucamanza ategeka ko, kugira ngo hatangwe ikirego cy'inyandiko y'ikibazo kitanzwe n'umuburanyi umwe, ni ngombwa ko icyemezo cyifuzwa kigomba gufatwa kiba ari icyemezo cy'ifatira ry'agateganyo, gisabwa umucamanza kugira ibyo aramira mu buryo bwihuse cyane, ku buryo kigomba kuramirwa kitarangirika. Philip Cotton akaba avuga rero ko ikirego cya CELA Company Ltd kitihutirwa

cyane ko CELA Company Ltd yishyuwe igice cya nyuma cy'amarafaranga, hari kuwa 19/11/2018, ikaba yaraje gutanga ikirego kuwa 08/03/2019, bigaragaza ko nta bwihutirwe bwari burimo.

[14] Philip Cotton asobanura na none ko ibyo imaze kwerekana aribyo umucamanza yagarutseho mu rubanza rwifashishijwe avuga ko Mount Meru Petroleum (R) Ltd nayo yaratanzze ikirego hashize amezi hafi ane yose, ko ari ikigaragaza ko yabonaga ko ikirego cyayo nta bwihutirwe gifite kuko nta byakwangirika ku buryo budasubirwaho, ngo ibe yarihutiye gusaba Umucamanza kubiramira. Ikindi ngo kikaba uko ingingo zaregewe na CELA Company Ltd zitagaragaza ko nta mpaka kuko uregwa ari we Bwana Philip Cotton hari ibyo asabwa/ategekwa, bityo akaba yaragombaga kuba ari umuburanyi muri uru rubanza kugira ngo agire icyo asobanura kubyo asabwa. Ibi bikaba bivuze ko iki kirego cyari gutangwa mu buryo busanzwe, ibirego mu manza z'ubucuruze bitangwamo ku rwego rwa mbere. Ko kuba uwatanze ikirego we ubwe anasaba ko hategekwa igihano gihatira kwishyura, ubwabyo bigaragaza impaka ku buryo iki kirego kitagakwiye gutangwa nk'inyandiko nsobanurakirego itanzwe n'umuburanyi umwe.

[15] Philip Cotton na none avuga ko mu ngingo urega yasabye ko zisuzumwa, harimo isaba kumugobokesha nk'Umuyobozi wa University of Rwanda mu rubanza. Kandi mu birego bitanzwe mu buryo bw'inyandiko nsobanurakirego, ntabwo uwatanze ikirego ari we usaba ko hagira urundi ruhande ruhamagazwa, ahubwo Urukiko nirwo rubitegeka mu gihe rusanzze ari ngombwa. Ibi bikaba bigaragaza ko hari impaka muri uru rubanza zagakwiye gusuzumwa mu buryo bw'ibirego bisanzwe, hakaregerwa Urukiko rw'ubucuruze. Ko hashingiwe ku Itegeko ryavuzuze haruguru mu ngingo yaryo ya 83 mu gika cyayo cya kane, igira iti « *Impamvu ituma ikirego kitakirwa ni ingingo yose isaba kutakira ikirego cy'umuburanyi (...) iyo hari imihango itarubahirijwe iteganywa n'Itegeko.* » Ko rero asanga hari imihango itubahirijwe n'urega iteganywa n'itegeko, kuko uburyo yatanzemo ikirego butaribwo. Akabishingiraho asaba uru Rukiko kutakira ikirego cya CELA Company Ltd.

[16] CELA Company Ltd yireguye mu iburanisha kuri iyi nzitizi, ivuga ko idafite ishingiro kuko irega umuyobozi wanze kubahiriza ibyo Urukiko rwategetse, kandi ikaregera Urukiko rwaciye urubanza.
