

## **RRA v GIKONKO RICE**

[Rwanda URUKIKO RUKURU RW'UBUCURUZI – RCOMA 00815/2018/HCC (Kayisire, P.J.) 12 Nyakanga 2019]

*Amategeko agenga imisoro – Umusoro nyongeragaciro – Umuceri utonowe ntabindi binyabutabire bivanzemo – Gutakaza isura kw'ikiribwa mu gihe cy'isarura – Gutonora umuceri ukoresheje imashini, nta zindi mvange z'ubutabire ziwuhindura ikiribwa cy'ubundi bwoko, ntibitandukanye n'uko umuhinzi awukorera isuku akoresheje uburyo bwa gakondo (kuwutonora ukoresheje intoki) kugirango awugurishe – Umuceri ucurujwe muri ubwo buryo ntucibwa umusoro nyongeragaciro kuko uba udafatwa nk'ikiribwa cy'ubwoko bushya nubwo uba watakaje ishusho yawo mu isarura mu gihe cyo kuwutonora.*

**Incamake y'ikibazo:** GIKONKO RICE yakorewe igenzura na Rwanda Revenue Authority (RRA) mu 2017 na 2018 bituma icibwa umusoro ku nyongeragaciro ungana na 232.030.192 frw. GIKONKO RICE yaregeye Urukiko rw'Ubucuruzi isaba uvanwaho maze urukiko rwemeza ko uvanwaho.

RRA yajuririye mu Rukiko Rukuru rw'Ubucuruzi ivuga ko umusoro wagombaga kugumaho kuko umuceri ucuruzwa na GIKONKO RICE uba watunganyijwe ukaba ikiribwa cy'ubwoko bushya kuko uba watonowe. Yasabye kandi ko yahabwa indishyi z'ikurikirana rubanza n'igihembo cya Avocat.

GIKONKO RICE yireguye ivuga ko ubujurire bwa RRA nta shingiro bufite kuko umuceri icuruza atari ikiribwa gishya kuko umuceri atari ikiribwa gitunganyijwe cyavuyemwo ikiribwa cy'ubundi bwoko, bityo ukaba utagomba gucibwa TVA. Yongeye yiregura ivuga ko nta ndishyi z'ikurikirana rubanza n'igihembo cya Avocat yatanga ahubwo isaba itanga ubujurire bwuririye ku bundi isaba RRA kuyishyura amafaranga y'ikurikirana rubanza n'igihembo cya Avocat.

## **Urubanza**

Mu mikirize y'urubanza RCOM 02039/2018/TC, Urukiko rwemeje ko umusoro wa TVA ungana n'amafaranga 232.030.192fiw RRA yaciye GIKONKO RICE Ltd ukuweho. RRA ntiyishimiye imikirize y'urwo rubanza, irajurira.

[7] Me Biseruka Frank uhagarariye GIKONKO RICE Ltd yagaragaje ko ibyo RRA isaba Urukiko gusuzuma niba umuceri wacurujwe na GIKONKO RICE Ltd atari ikiribwa gitunganyije ku buryo utari gucibwaho umusoro wa TVA, nta shingiro bifite kuko Urukiko rw'lkirenga rwabifasheho umwanzuro rwemeza ko umuceri atari ikiribwa gitunganyijwe cyavuyemwo ikiribwa cy'ubundi bwoko, bityo ukuba utagomba gucibwa TVA.

[9] Urukiko rusanga ingingo ya 6 agace ka 13 y'ltegeko n° 37/2012 ryo kuwa 09/11/2012 rishyiraho Umusoro ku Nyongeragaciro nk'uko ryahinduwe kandi rikuzuzwa kugeza ubu, ku bijyanye n'ibintu na serivisi bisonewe, iteganya ko ibikomoka ku buhinzi n'ubworozi byose bisonewe, uretse ibitunganyijwe; naho ingingo ya 2 agace ka 3 k'iryo tegeko, ku bijyanye n'ibisobanuro by'amagambo, ikaba iteganya ku bijyanye n'ibiribwa bitunganyijwe ko uretse ibiteganywa ukundi n'iryo tegeko, ibiribwa bitunganyijwe bisobanura ibiribwa bitunganyijwe ku buryo bivamo ibiribwa by'ubundi bwoko n'agaciro bishya, nk'uko byagenwa n'lteka rya Minisitiri. Na none, ingingo ya 1, igika cya 1 y'lteka rya Minisitiri n°010/16/10/TC ryo ku wa 01/11/2016 ryerekeye ibiribwa bitunganyijwe n'ibiranga ibyemezo bigabanya imyenda n'ibiyongera, ku bijyanye n'ubwoko n'agaciro bishya by'ibiribwa bitunganyijwe, iteganya ko muri iryo teka, ikiribwa cyose, cyaba igikomoka ku buhinzi cyangwa ku bworozi, gifatwa nk'ikiribwa cy'ubwoko bushya iyo cyatakaje ishusho yacyo yo mu isarura mu gihe bagitunganyaga, naho mu gika cya 2, ikaba iteganya ko ikiribwa kivugwa mu gika cya mbere cy'iyi ngingo gifatwa nk'icyagize agaciro gashya iyo agaciro kacyo ku isoko kazamutse biturutse ku gikorwa cyo kugitunganya.

[10] Urukiko rusanga umusoro wa TVA, RRA yaciye GIKONKO RICE Ltd ushingiyeye kuri notice of assessment yo mu kwezi kwa 11 n'ukwa 12/2017 n'iyi mu kwezi kwa 1 n'ukwa 2/2018, ikaba ariyo mpamvu RRA igaragaza ko uwo musoro ukurikije amategeko, ko utari ukwiye gukurwaho kuko umuceri ucuzuzwa na GIKONKO RICE Ltd uba watunganyijwe ukavamo ibiribwa by'ubundi bwoko n'agaciro bishya, hakurikijwe uko bisobanurwa mu ngingo ya 1 y'lteka rya Minisitiri ryavuzwe haruguru; bityo hashingiwe ku gisobanuro cy'ibiribwa by'ubwoko bushya nk'uko cyagaragajwe haruguru mu gika cya 9, bikaba bigaragara ko umuceri ucuzuzwa na GIKONKO RICE Ltd uba watakaje ishusho yawo yo mu isarura mu gihe cyo kuwutonora.

[11] Nubwo bigaragara ko umuceri ucuzuzwa na GIKONKO RICE Ltd uba watakaje ishusho yawo yo mu isarura mu gihe cyo kuwutonora, Urukiko rusanga ibyo ubwabyo atari byo byatuma ufatwa nk'ikiribwa cy'ubwoko bushya, nk'uko byemejwe mu rubanza RCOMAA 0023/13/CS rwaciwe n'Urukiko rw'lkirenga ku wa 16/01/2015, aho RRA yaburanaga na SODAR Ltd, Urukiko rw'lkirenga rukaba mu gika cya 20 mu mikirize y'urwo rubanza rwarasobanuye ko ibikorwa SODAR Ltd ikorera umuceri biba bitagamije guhindura umwimerere wawo cyangwa ngo biwugire ikiribwa cy'ubundi bwoko, naho mu gika cya 21, Urukiko rw'lkirenga rukaba rwarasobanuye ko kuba SODAR Ltd itonora umuceri ikoresheje imashini, nta zindi mvange z'ubutabire ziwuhindura

ikiribwa cy'ubundi bwoko, bitatandukanywa n'umuhinzi uwukorera isuku akoresheje uburyo bwa gakondo (kuwutonora ukoresheje intoki) kugirango awugurisha.

[12] Hashingiwe ku byasobanuwe haruguru mu gika cya 11, Urukiko rusanga umusoro wa TVA waciye GIKONKO RICE Ltd udakwiye kugumaho kuko bigaragara ko nubwo umuceri icuruza uba watakaje ishusho yawo yo mu isarura mu gihe cyo kuwutonora, ubwabyo atari byo byatuma ufatwa nk'ikiribwa cy'ubwoko bushya n'agaciro bishya kuko iby'agaciro gashya bijyana n'uko ikiribwa kiba cyahindutse icy'ubwoko bushya; ibyasobanuwe haruguru bikaba na none bishimangira ko urubanza RCOMA 0023/13/CS rwaciye n'Urukiko rw'lkirenga rugomba gushingirwaho muri uru rubanza, bityo ubujurire bwa RRA bukaba nta shingiro bufite kuko itashoboye kugaragariza Urukiko ko umuceri GIKONKO RICE Ltd igurisha uba wahinduwe ku buryo iwugurisha wabaye ikiribwa cy'ubwoko bushya.

[16] Ku bijyanye n'indishyi zasabwe na GIKONKO RICE Ltd, iz'ikurikiranarubanza ntikwiye kuzihabwa kuko zitagararijwe ibimenyetso, naho igihembo cya avoka, ikwiye kugihabwa hashingiwe ku biteganywa n'ingingo ya 258 y'igitabo cya gatatu cy'urwunge rw'amategeko mbonezamubano, iteganya ko igikorwa cyose cy'umuntu cyangirije undi gitegeka ny'ir'ugukora ikosa rigikomokaho, kuriha ibyangiritse, bityo RRA ikaba igomba kuyiha amafaranga 500.000frw y' indishyi z'igihembo cya avoka, kuko yari ifite uyiburanira muri uru rubanza yarezwemo.
