

## MUREBWAYIRE v. IKIGO CY'IMISORO N'AMAHÔRO (RRA)

[Rwanda URUKIKO RUKURU – RADA00004/2018/HC/KIG (Hitimana, P.J.) 27 Mata 2018]

**Incamake y'ikibazo:** Murebwayire yareze Ikigo cy'Imisoro n'amahôro mu Rukiko Rwisumbuye rwa Nyarugenge nyuma yaho cyimwirukanye ku kazi. Urwo Rukiko rwategetse icyo kigo kumuha imishahara y'amezi atatu atigeze ahabwa, indishyi zo kwirukanwa binyuraniye n'amategeko, insimburakiruhuko, indishyi z'akababaro, amafaranga y'ikurikiranarubanza n'ighembo cya avoka, no gusubizwa ingwate y'igarama yatanze. Ikigo cy'Imisoro n'amahôro cyajuriye mu Rukiko Rukuru, narwo rwemeza ko amafaranga y'insimburakiruhuko ntayo kigomba kumuha ahubwo rtegeka icyo kigo kumuha ighembo cya avoka ku rwego rw'ubujurire kandi rwemeza ko ku bindi nta gihindutse.

Murebwayire yaregeye Urukiko Rukuru avuga ko impaka zavutse mu irangizwa ry'urubanza ubwo Ikigo cy'Imisoro n'amahôro cyavugaga ko amafaranga cyategetswe n'Urukiko hagomba kuvanamwo amafaranga y'umusoro, ay'ubwiteganyirize, n'ayo kwivuza kubera ko indishyi yahawe zabariwe ku mushahara mbumbe, Murebwayire, we akaba avuga ko agomba guhabwa amafaranga yose nk'uko Urukiko rwayategetse.

Ikigo cy'Imisoro n'amahôro cyatanze inzitizi y'iburabubasha kivuga ko ikibazo kigomba gusuzumwa kijyanye no kumenya niba aya mafaranga yakurwaho umusoro kitari mu bubasha bwarwo ahubwo kiri mu bubasha bw'inkiko z'ubucuruzi, gitanga n'indi nzitizi ivuga ko ikirego kidakwiye kwakirwa kubera ko cyatanzwe impitagihe.

Murebwayire we avuga ko itegeko rivuga ko impaka zivutse mu irangizwa ry'urubanza zikemurwa n'Urukiko rwaruciye bwa nyuma kandi ko nta gihe ntarengwa giteganywa n'itegeko ikirego kigomba kuba cyatanzwemo, bityo uru Rukiko nirwo rufite ububasha bwo kuburanisha iki kirego, Urukiko narwo rwasanze izo nzitizi zombi zidafite ishingiro, bityo rtegeka ko urubanza rukomeza kuburanishwa mu mizi.

Murebwayire avuga ko nyuma y'imanza yaburanye n'Ikigo cy'Imisoro n'amahôro, yasabye ko cyakwisyura ibyo yatsindiwe mu rubanza, ariko imisubiza ko igiye kwisyura 1.017.867Frw, na ay'amezi 3 atahembwe, kandi nyamara Urukiko rwarategetse ko ayo mafaranga ahwanye na 1.577.019Frw, indishyi z'amezi atandatu zatanzwe zihwanye na 4.731.060Frw Ikigo cy'Imisoro n'amahôro cyatanze 3.005.604Frw, indishyi z'akababaro zo zatanzwe uko zakabaye, kimwe n'amafaranga y'ikurikirana rubanza n'ighembo cya avoka, kimwe n'ingwate y'igarama. Ibi bivuze ko RRA yagombaga kwisyura 8.658.079Frw nyamara yishyuye 6.073.471Frw, bityo ashingiye kw'itegeko Nshinga rya Repubulika y'u Rwanda mu ngingo ya 151 agace ka 4 aho ivuga ko ibyemezo by'ubucamanza bigomba gukurikizwa n'abo bireba bose, zaba inzego z'ubutegetsi bwa Leta cyangwa abantu ku giti cyabo, ko bidashobora kuvuguruzwa cyeretse binyuze mu nzira no mu buryo buteganjwe n'amategeko, bityo asaba ko icyo kigo cyamwisyura 2.584.608Frw yasigaye ku yo yagenewe n'Urukiko.

RRA ivuga ko indishyi z'amezi 6 yagenewe zabariwe ku mushahara mbumbe, rwemeza ko mu gihe cyo kumwisyura ushinzwe kwishyura agomba gukura muri uwo mushahara ibiteganywa n'amategeko Ibi ngo byatumye mu gushyira iki cyemezo cy'urukiko mu bikorwa, RRA yabaze indishyi n'imishahara zamugenewe habanje kuvanwamo ibyo amategeko ateganya bigizwe n'umusoro ku mishahara (TPR), CSR na RAMA.

[1] Murebwayire Justine yahoze ari umukozi wa Rwanda Revenue Authority aza kwirukanwa, arega RRA mu rubanza RAD00193/2016/TGI/NYGE ko yamwirukanye mu buryo bunyuranyije n'amategeko, urubanza rucibwa ku wa 08/11/2016, Urakiko Rwisumbuye rwa Nyarugenge rutegeka ko RRA iha Murebwayire Justine ibi bikurikira - Imishahara y'amezi atatu atigeze ahabwa ihwanye na 1.577.019Frw, indishyi zo kwirukanwa binyuranije n'amategeko zihwanye na 788.510Frw (Umushahara we mbube) x 6 = 4.731.060Frw, insimburakiruhuko ya 2011, 2012, na 2013 zihwanye na

788.510Frw x 3 = 2.365.530Frw, n'indishyi z'akababaro zihwanye na 1.000.000Frw, amafaranga y'ikurikiranarubanza n'igihembo cya avocat bihwanye na 1.000.000Frw, no gusubizwa ingwate y'igarama ya 50.000Frw, yose hamwe akaba 10.673.609Frw + 50.000Frw.

[2] RRA yajuririye iyo mikirize y'urubanza muri uru Rukiko, rwemeza ko amafaranga 2.365.530 RRA yari yategetswe guha Murebwayire Justine nk'insimbakiruhuko ya 2011, 2012 na 2013 ntayo igomba kumuha, rutegeka RRA guha Murebwayire Justine igihembo cya avocat ku rwego rw'ubujurire gihwanye na 300.000Frw, rwemeza ko ku bindi nta gihindutse.

[3] Impaka zavutse mu irangizwa ry'urubanza ni amafaranga RRA ikata kuri aya mafaranga Urukiko rwayitegetse kwishyura Murebwayire Justine, we akaba avuga ko agomba guhabwa amafaranga yose nk'uko Urukiko rwayategetse, RRA yo ikavuga ko hagombaga kuvaho amafaranga y'umusoro, ay'ubwiteganyirize, n'aya RAMA, kubera ko indishyi Murebwayire Justine yabariwe, zabariwe ku mushahara mbumbe.

[4] Uhagarariye RRA yatanze inzitizi avuga ko uru Rukiko nta bubasha rufite bwo gukemura iki kibazo, kuko ari ikibazo kijyanye no kumenya niba aya mafaranga yakurwaho umusoro, ibyo bikaba bitari mu bubasha bwarwo. Yatanze n'indi nzitizi ivuga ko ikirego kidakwiye kwakirwa kubera ko Murebwayire Justine yagitanze akererewe.

[5] Harasuzumwa niba uru Rukiko rufite ububasha bwo kuburanisha ikirego cya Murebwayire Justine. Mu gihe rwaba rufite ububasha, harasuzumwa niba hari ige ntarengwa cyashyizweho n'itegeko cyo kuregera impaka zavutse mu irangizwa ry'urubanza, no kumenya niba kitarubahirijwe ku buryo byatuma ikirego cya Murebwayire kitakirwa. Mu gihe ikirego cyaba cyakiriwe, harasuzumwa niba RRA yemerewe gukura amafaranga y'umusoro, ay'ubwiteganyirize bw'umukozi n'ayo ubwishingizi bwo kwivuza ku ndishyi urukiko rwayitegetse guha Murebwayire Justine.

[17] Uhagarariye Rwanda Revenue Authority avuga ko Urukiko Rukuru mu cyemezo cyarwo RADA00183/HC/2016/HC/KIG mu gika cya 23 ku rupapuro rwa 11 urukiko rwarasobanuye ko indishyi z'amezi 6 zingana na 4.731.060Frw Murebwayire Justine yagenewe n'Urukiko rwa mbere zabariwe ku mushahara mbumbe, rwemeza ko mu gihe cyo kumwishyura ushinzwe kwishyura agomba gukura muri uwo mushahara ibiteganywa n'amategeko atabyishimira akaregera inkiko zifite ububasha (Reba urubanza RADA00183/HC/2016/HC/KIG, p. 11). Avuga ko mu mafaranga Murebwayire yagenewe, hari n'umushahara w'amezi atatu ungana na 2/3 mu gihe yari yahagaritswe by'agateganyo mu kwezi kwa gicurasi, Kamena na Nyakanga, urukiko rwamugeneye warabariwe ku mushahara mbumbe. Ibi ngo byatumye mu gushyira iki cyemezo cy'urukiko mu bikorwa, RRA yabaze indishyi n'imishahara zagenewe Murebwayire Justine, habanje kuvanwamo ibyo amategeko ateganya bigizwe n'umusoro ku mishahara (TPR), CSR na RAMA, bibazwe mu buryo bukurikira : - Ku mishahara y'amezi atatu (3) Murebwayire Justine atigeze ahabwa ingana na 1.577.019Frw havanywemo angana na 425.106Frw ajyanye na TPR, angana na 42.054Frw ajyanye na RSSB n'angana na 91.992 Frw ya RAMA. Ayakuwemo yose angana na 559.152Frw, yishyurwa 1.017.867Frw (net). - Ku ndishyi zingana na 4.731.060Frw zijiyanie n'amezi atandatu (6) zo kwirukanwa mu buryo budakurikije amategeko, havanywemo angana na 1.323.318Frw y'umusoro ku mishahara, angana na 126.162Frw ya RSSB n'angana na 275.976Frw ya RAMA. [18] Uhagarariye Rwanda Revenue Authority avuga ko ku bijyanye n'amategeko yashiniweho na RRA, yashiniye ku ngingo ya 13 y'itegeko N°16/2005 ryo ku wa 18/08/2005 rigena imisoro itaziguye ku musaruro, mu gace ka 1° iteganya ko « Umusaruro ukomoka ku kazi ugizwe n'amafaranga yose yishyurwa umukozi hamwe n'agaciro k'ibintu bihabwa umukozi bijyanye n'akazi ke, ayo mafaranga akaba ari aya akurikira: 1° ibihembo, umushahara, amafaranga yishyurwa mu gihe cy'ikiruhuko,

amafaranga yishurwa mu gihe cy'uburwayi n'agenerwa kwivuza, amafaranga atangwa mu mwanya w'ikiruhuko, amafaranga y'insimburamubyizi, amafaranga, (...) 7° ibindi byishurwa ku birebana n'akazi kariho n'akakabanjirije n'akazaza». Naho mu guca uwo musoro (TPR) ku ndishyi z'amezi atandatu zizyanye no kwirukanwa bidakurikije amategeko, hashingiwe ku ngingo ya 13 y'itegeko N°16/2005 ryavuzwe abaniza mu gaka ka 7° iteganya ko uwo musoro ucibwa no ku « ibindi byishurwa ku birebana n'akazi kariho n'akakabanjirije n'akazaza». Naho ku bijyanye n'amafaranga y'ubwiteganyirize bwa pansiyo hashingiwe ku ngingo ya 7 y'itegeko N°05/2015 ryo kuwa 30/03/2015 rigenga imitunganyirize y'ubwiteganyirize bwa pansiyo.

## **UKO URUKIKO RUBIBONA**

[20] Urukiko rurasanga ku mafaranga y'imishahara y'amezi atatu Murebwayire Justine yagenewe, umuhagarariye ayasaba, nk'uko bigaragara mu gika cya 17 cy'urubanza RAD00193/2016/TGI/NYGE, rwaciwe n'Urukiko Rwisumbuye rwa Nyarugenge ku wa 09/11/2016, yasabye guhabwa 2/3 by'amafaranga 788.510, ni ukuvuga amafaranga 525.673 ukubye 3, ariyo yabaye amafaranga 1.577.019. Uyu mushahara w'amafaranga 788.510, ababuanyi bemeranywa ko ariwo wari umushahara mbumbe wa Murebwayire Justine.

[21] Urukiko rurasanga aya mafaranga yavuzwe mu gika kibanziriza iki, si amafaranga y'indishyi, ahubwo ni amafaranga y'umushahara, Murebwayire Justine yagombaga kuba yahembwe igithe yari akiri umukozi wa RRA, aho kuyahembwa, akaba yaragiye ahembwa 1/3, hagasigara 2/3. Aya mafaranga ahwanye na 2/3 niyo Urukiko Rwisumbuye rwategetse ko Murebwayire Justine ahawwa, kandi yabariwe ku mushahara mbumbe wa 788.510. [26] Uhagarariye Rwanda Revenue Authority avuga ko asanga Murebwayire atari akwiye kwemererwa igihembo cya avoka kuko ariwe wishoye mu manza zidafite ishingiro. Bityo aya mafaranga akaba akwiye kuvanwaho. Ikindi ni uko ari umurengera.

[27] Uhagarariye Rwanda Revenue Authority avuga ko ahubwo hagendewe ku ngingo ya 258 y'Igitabo cya III cy'urwunge rw'amategeko mbonezamubano, RRA irasaba guhabwa n'urega amafaranga angana na 1.000.000Frw ajyanye n'igihembo cya avoka n'ibyatanzwe kuri uru rubanza guhera rutangiye kugeza uyu munsi kuko yayishoye mu manza zidafite ishingiro. RRA ifite abakozi b'aba « specialists » bashinzwe kuburana imanza zayo, kandi bakagira ibyo bagenerwa byihariye kubera ako kazi bakora; ibyo kandi ntabwo ari bishya, kuko n'abavoka baburanira ibigo byigenga bagenerwa imishahara arikko bakaka igihembo cya avoka inkiko zikakibagenera. Kuba kandi RRA yagenerwa igihembo cya avoka byanemejwe n'Urukiko rw'Ikirenga mu rubanza RCOMAA0021/15/CS rwaciwe n'Urukiko rw'Ikirenga ku wa 03/11/2017. Bityo ibyo RRA isaba ikaba ikwiye kubihabwa kuko bifite ishingiro.
