Incamake y'ikibazo: Harindintwari yareze Real Contractors Ltd mu Rukiko Rwisumbuye rwa Gasabo asaba indishyi zo kwirukanwa mu kazi binyuranyije n'amategeko, indishyi zo kudatanga integuza, amafaranga nsimburakiruhuko y'imyaka ibiri, indishyi zo kudahabwa icyemezo cy'imirimo yakozwe, asaba gutangirwa imisanzu ya RSSB atatangiwe n'umukoresha we, amafaranga y'insimburakiruhuko cya buri cyumweru atahawe, amafaranga y'ikurikiranarubanza, n'igihembo cya Avoka, akanasubizwa igarama yatanze arega.

Urukiko Rwisumbuye rwemeje ko Uregwa aha Urega amafaranga y'icyemezo cy'umurimo, y'ikurikiranarubanza n'amafaranga y'igihembo cya Avoka, runamutegeka kumusubiza amafaranga y'amagarama. Ibi byatumye Uregwa ajuririra Urukiko Rukuru avuga ko Urukiko rwabanje rwirengagije ibyo yarugaragarije bijyanye n'uko Urega ariwe ubwe wanze kwakira icyemezo cy'umurimo, ko rero atabiryozwa, asaba ko indishyi zijyanye n'igihembo cya Avoka, ikurikiranarubanza n'igarama zivanwaho.

[2] Urukiko Rwisumbuye rwa Gasabo rwaciye urubanza rwemeza ko Real Contractors Ltd igomba guha Harindintwari Jean Damascène amafaranga 210.000 Frw y'icyemezo cy'umurimo, 200.000 Frw y'ikurikiranarubanza, n'amafaranga ibihumbi magana atanu 500.000 Frw y'ighembo cya Avoka, runayitegeka gusubiza Harindintwari Jean Damascène amafaranga ibihumbi makumyabiri (20.000 Frw) yatanzeho ingwate y'amagarama arega.

[3] Real Contractors Ltd yajuririye Urukiko Rukuru ivuga ko Urukiko Rwisumbuye rwa Gasabo rwirengagije ibyo yarugaragarije bijyanye n'uko Harindintwari Jean Damascène ariwe ubwe wanze kwakira icyemezo cy'umurimo, kuba ataragisabye cyangwa se ngo ajye kugifata acyimwe, ko ahubwo yakimuhaye aracyanga, ko rero itabiryozwa, isaba ko indishyi zижyanye n'ighembo cya Avoka, ikurikiranarubanza n'igarama zivanwaho.

Ingingo ya 5 y'iri tegeko nayo igateganya ko uretse iyo itegeko ribiteganya ukundi, uregwa afite uburenganzira ku byo aregwa bukurikira: 2° gusaba kumvikana n'uwo baburana igihe cyose urubanza rutarasomwa.
