

## MUSENGIMANA v EUCL

*Amategeko agenga imanza z'imbonezamubano – Impanuka – Indishyi zikomoka ku mpanuka y'amashanyarazi - Indishyi z'akababaro – Mu mpanuka zikomoka ku muriro w'amashanyarazi, indishyi z'akababaro zigenwa mu bushishozi bw'urukiko.*

**Incamake y'ikibazo:** Uru rubanza rwatangiriye mu Rukiko Rwisumbuye rwa Gasabo uwitwa Musengimana aregera indishyi avuga ko ubwo yakoraga ku modoka itwara ibishingwe mu kimoteri cya Nduba, bageze aho bamena ibishingwe yavuye ku modoka ajya gufata inkoni bakinguzaga urugo rw'imodoka hanyuma ahura n'urutsinga rwari rwarashishutse rurimo umuriro w'amashanyarazi ucungwa na Energy Utility Corporation Ltd (EUCL) rumutwika ku mutwe ndetse no ku kuboko. Yaje kujya kwivuzwa, abaganga bemeza ko yagize ubumuga buhoraho bungana na 92% ndetse n'ibangamira ry'uburanga kuko ukuboko kwe kwaje gucika. Yaje gutanga ikirego mu Rukiko rwisumbuye rwa Gasabo asaba indishyi zitandukanye maze rumugenera indishyi z'akababaro zinga na miliyoni 5.000.000 Frw ariko ntiyanyurwa ajurira icyo cyemezo mu Rukiko Rukuru.

Urukiko rukuru rwakiriye ubwo bujuriye maze rusuzuma ikibazo cyo kumenya niba indishyi zatanzwe zitarabazwe mu buryo bukwiye no kumenya icyashingirwaho mu kugena izo ndishyi n'uko zabarwa. Musengimana avuga ko indishyi zagombaga kugenwa hashingiwe ku Iteka rya Perezida N°31/01 ryo kuwa 25/08/2003 rishyiraho uburyo bwo kwishyura indishyi ku bubabare bw'umubiri buturutse ku mpanuka zitewe n'ibinyabiziga akagenerwa indishyi zitandukanye ariko EUCL yo ikavuga ko ntaho izo ndishyi ziteganywa mu itegeko bityo zitagomba gutangwa. Mu kumenya indishyi zigomba gutangwa, uko zibarwa n'ugomba kuzitanga, urega avuga ko izo ndishyi zabarwa hagendewe ku ngingo ya 18 y'Iteka rya Perezida N°31/01 ryavuzwe hejuru kuko yagize ubumuga buhoraho butuma nta kindi kintu ashobora gukora ndetse agatakaza n'uburanga. Uregwa we avuga ibivugwa n'iryo teka bijyanye n'impanuka zo mu muhandanda gusa.

## **Urubanza**

### **I. IMITERERE Y’URUBANZA**

[1] Musengimana Jean Baptiste yatanze ikirego mu Rukiko Rwisumbuye rwa Nyarugenge avuga ko yakoraga ku modoka itwaye ibishingwe ibijyanye mu kimoteri cya Nduba, gihereye mu murenge wa Nduba, mu karere ka Gasabo mu mujyi wa Kigali, kuwa 17/04/2019, i saa 18 h30 ubwo iyo modoka yari iparitse avamo, agira ngo akingure urugi rw’imodoka ibone uko isuka imyanda, agiye gufata inkoni bakoresheye bayikingura yagonganye n’urutsinga rw’amashanyarazi rwa Energy Utility Corporation Ltd (EUCL), rwariho rutendera, rwaranashishutse rumutwika mu mutwe, n’ukuboko kw’iburyo, ata ubwenge akanguka agejejwe mu bitaro bya CHUK, bimuviramo ubumuga budahoraho bungana na 90%, buzamara igihe cy’amezi atandatu (6), banamuca ukuboko kw’iburyo nk’uko byemejwe muri raporo yo kuwa 28/06/2019 ya muganga w’ibyo ibitaro;

[2] Musengimana Jean Baptiste yavugaga ko kuwa 31/01/2020 yegereye Energy Utility Corporation nyiri izo nsinga z’amashanyarazi, ngo imuhe indishyi yasabaga mu bwumvikane bikananirana kuko yamusaba ko yamenyekanisha impanuka y’amashanyarazi yagize, kandi yarayihaye dosiye ikibiyemo inyandiko za ngombwa zose zashingirwaho mu kumwishyura. Musengimana Jean Baptiste yasabag urukiko gutegeka ko agenerwa indishyi zikwiye zingana na 38.750.400 Frws y’indishyi mbangamirabukungu, 10,000,000 Frws y’indishyi z’akababaro, 416,217 Frws y’indishyi z’amafaranga yakoresheje mu kwivuza n’ingendo, ndetse n’amafaranga y’ikurikiranarubanza n’igihembo cy’Avoka ndetse no gusubizwa ingwate y’amagarama y’Urukiko;

[3] Ku ruhande rwa Energy Utility Corporation (EUCL) yabanje kwiregura ivuga ko iki kigo kidakwiye kuryozwa indishyi zikomoka kuri iyo mpanuka y’amashanyarazi isabwa, kuko nta kigaragaza ko yabaye, kandi nta n’ikibazo cyabaye ku nsinga z’amashanyarazi z’umuyoboro wayo uherereye i Nduba. Mu iburanisha uwari uhagarariye Energy Utility Corporation yavugaga ko idafite umuyoboro w’insinga zica i Nduba, ko ubaye unahari Musengimana Jean Baptiste yaba yaragize uburangare agasagarira insinga zayo kuko abazwa yavuze ko yazikojejeho umutwe

n'ukuboko, kandi ko ikigaragza ko iyo mpanuka itabaye ari uko itariki 17/04/2019 Musengimana Jean Baptiste avuga ko yabereyeho ivuguruzanya n'itariki ya 17/05/2019 igaragara muri raporo ya muganga w'ibitaro bya CHUK, itariho na reference, kandi na Musengimana Jean Baptiste atagaragaza ikimenyetso cyerekana ko ari umukozi w'iyo Company yari itwaye ibishingwe mu kimoteri cya Nduba, kandi yari umuyede.

[4] Energy Utility Corporation (EUCL) yasabaga ko ikirego cya Musengimana Jean Baptiste kitahabwa ishingiro, bitewe n'uko kidashingiye ku itegeko, ahubwo gishingiye gusa ku mvugo ze n'iz'abatangabuhamya yatangiye mu bugenzacyaha, bikaba bidahuye na kamere y'ikiburanwa;

[5] Urukiko rushingiye ku bimenyetso byatanzwe na Musengimana Jean Baptiste bigizwe n'abuhamya bwatangiye ku rwego rw'ubugenzacyaha n'abakorana na Musengimana Jean, aho bose bahuriza kuko kuba impanuka y'amashanyarazi Musengimana Jean Baptiste yagize yarabereye mu kimoteri cya Nduba ku itariki ya 17/04/2019 ubwo bari bagiyeyo kuhamena ibishingwe babikuye Nyacyonga, babonye ibishashi by'amashanyarazi biturika mu kirere nk'aho umurimo ukubise umuntu, hakaba inyandiko-mvugo yo mu bushinjacyaha igaragara muri dosiye, ndetse na raporo ya muganga w'ibitaro bya CHUK, n'uw'ibitaro bya Kanombe bamusuzumye, bose bemeje neza ko iyo mpanuka yabaye kuwa 17/04/2019 yateye n'urutsinga rw'amashanyarazi rwamufashe ku mutwe no ku kuboko, bikamuviramo ubumuga buraho agacibwa ukuboko rwemeje ko ikirego cya Musengimana Jean Baptiste gifite ishingiro kuri bimwe;

[6] Urukiko rwasanze mu kubara indishyi rutashingira ku iteka rya Perezida n° 31/01 ryo kuwa 25/08/2003 rishyiraho uburyo bwo kwishyura indishyi ku bubabare bw'umubiri buturutse ku mpanuka zitewe n'ibinyabiziga kuko iyi itari impanuka yo ku muhanda;

[7] Urukiko rwategetse ENERGY UTILITY CORPORATION kwishyura Musengimana Jean Baptiste indishyi z'akababaro zingana na 5,000,000 frws zibazwe mu bushishozi bw'urukiko, ndetse n'indishyi z'amafaranga yakoresheje mu kwivuzwa n'ingendo zingana na 516,217 frws, yose hamwe akaba 5,516,217 frws.

[8] Musengimana Jean Baptiste ntiyishimiye imikirize y'urubanza ajurira mu Rukiko Rukuru avuga ko indishyi zatanzwe zitabazwe mu buryo bukwiye; Urukiko rutagaragaje icyo rwashingiye ruzigena, ngo zikaba zidahura n'uko Musengimana Jean Baptiste yakomeretse (prejudice) kuko abaganga bemeje yagize ubumuga buhoraho bungana na 92% ndetse n'ibangamira ry'uburanga akaba nta kindi azongera gukora, cyangwa gukorera umuryango we, nyamara akiri muto;

[9] Energy Utility Corporation Ltd (EUCL) mu bujirire yiregura itemera indishyi igahakana ko nta mpanuka yabaye kuri Musengimana Jean Baptiste itewe n'urutsinga rw'amashanyarazi rwa EUCL, kandi ko atari umukozi wo mu kimoteri cya Nduba. EUCL Ltd yatanze ikirego kiregera kwiregura isaba guhabwa amafaranga y'igihembo cy'avoka n'ikurikiranarubanza;

[10] Urukiko rurasuzuma niba indishyi urukiko rwageneye Musengimana Jean Baptiste zitarabazwe mu buryo bukwiye, harebwe n'ibijyanye n'igihembo cy'avoka;

## **II. ISESENGURA RY'IBIBAZO BIGIZE URUBANZA**

[11] Uhagarariye Musengimana Jean Baptiste mu myanzuro ye avuga ko mu gika cya 28 cy'urubanza RC 01087/2020/TGI/NYGE rujuririrwa, Urukiko rwavuze ko rugeneye Musengimana Jean Baptiste indishyi z'akababaro zingana na 5.000.000frw akaba asanga izi ndishyi zatanzwe zitaragararijwe aho Urukiko rwashingiye ruzigena kuko asanga zidahura n'uko Musengimana Jean Baptiste yakomeretse (prejudice) kuko abaganga bagaragaje ko yagize ubumuga buhoraho bungana na 92% ndetse n'ibangamira ry'uburanga, bigaragara ko nta kindi azongera gukora, cyangwa gukorera umuryango we, nyamara akiri na mutoya arebye imyaka afite. Nkuko yari yabigaragaje ko nta tegeko rihari rigaragaza uburyo izi ndishyi zikwiye kubarwa;

[13] Uhagararire Energy Utility Corporation Ltd (EUCL) mu myanzuro avuga ko Musengimana Jean Baptiste yabajijwe n'urukiko aho yahereye abara indishyi, agaragaza ko yashingiye ku itegeko rigena uburyo indishyi zibarwa iyo habaye impanuka y'ikiyabiziga kigendesha moteri, kandi ubu si bwo bwoko bw'impanuka bwamubayeho. Ikindi niba ari umuyede wari wagiye mu kimboteri kugira ibyo ashaka mu myanda (ibi bibaho), ntabwo impanuka yahura na yo yayiryoza EUCL kuko atemerewe nyine kujya mu kimboteri, impamvu ya gatatu ni uko nta nsinga ya EUCL ipfutse ica mu kimboteri cya Nduba.

[15] Uhagararire Energy Utility Corporation Ltd (EUCL) avuga ko uyu Musengimana ashobora kuba yarahuriye n'impanuka ahandi, yabona ko atabasha kuyisobanura agahimba ko yayigiriye mu kimboteri cya Nduba, akaba ariyo mpamvu agomba kubanza kugaragaza ko yari yemerewe kujya muri icyo kimboteri, akagaragaza kandi n'uburyo yahuye n'urusinga rupfutse kandi nta ruhaba, akabanagaraza impamvu nta musekirite cyangwa se umushoferi wari utwaye iyo modoka bigeze babazwa mu bugenzacyaha. Ikindi kandi ubugenzacyaha si bwo bwemeza uwateje impanuka, kuko ntibwigeze bugera aho ibyo byabereye, bwashingiye ku magambo bwabwiwe gusa bityo indishyi zatanzwe zikwiye gukurwaho kuko ntacyo zishingiyeho.

[16] Uhagararire Energy Utility Corporation Ltd (EUCL) arasaba Urukiko kandi kuzasuzuma niba Musengimana yarajyeze aho yakoreye impanuka mu kimoteri cya Nduba mu gihe yibarizwa kuwa 01/10/2019 yivugiye ko ari umuyede kandi akaba atarigeze agaragaza company y'isuku yakoreraga bityo iyi mpanuka ikaba yaratewe n'izindi mpamvu cyangwa ahandi hantu atabasha kugaragaza mbere yo kuregera indishyi akwiye kubanza kugaragaza ibimenyesto bihuye n'ibyo yivugiye yerekana aho yahuriye n'ikimoteri cya Nduba kandi yari umuyede hakaba nta chantier yari yo. Uhagararire Energy Utility Corporation Ltd (EUCL) avuga ko kubijyanye no kwemera responsabilitite ntaho bihuriye no kwishyura ntabwo EUCL yijyeze yemera responsabilitite.

[17] Me Twagirayezu Kanuma Christophe uburanira Musengimana mu iburanisha yasobanuye ko bajuriye kubera ko urukiko rwabaze nabi indishyi akaba asaba ko indishyi zabarwa hashingiwe ku iteka rya Perezida numero 31/01 rigena uko babara indishyi ku mpanuka zitewe n'ibinyabiziga hagendewe ku bumuga Musengimana Jean Baptiste bwa 92%. Me TWAGIRAYEZU Kanuma Christophe avuga ko ibyo EUCL ishaka kugarura bijyanye n'ikibazo cya responsabilitite, bihabanye n'ingingo ya 150 CPCCSA kuko bajuririye gusa uburyo indishyi zabazwemo, nta kongera gutanga ubundi bujurire kandi icyo kibazo cya responsabilitite cyarafashweho umurungo EUCL ntiyabijuririra, ikaba igomba kwiregura ku bujurire bwabo gusa.

Me Niyitegeka Eraste anenga ko uwari utwaye imodoka atigeze abazwa kimwe n'ushinzwe kuharinda, hakaba nta mategeko yirengagijwe yari gutuma bajurira. Bumva kandi nta tegeko umucamanza yishe akoresha ingingo ya 9 CPCCSA.

Urukiko rufata icyemezo ku ngingo zatumye uwatanze ubujurire ajurira cyangwa uwabwuriyeho na we akajurira. Urukiko mu gusuzuma imyanzuro yo kujurira rurasanga uwajuriye ari Musengimana Jean Baptiste gusa ajuririra ko indishyi yagenewe ari nkeya, ntaho Energy Utility Corporation Ltd (EUCL) yigeze itanga ubujurire busanzwe cyangwa ubujurire bwuririye ku bundi ihakana ko impanuka yabaye
