Hagabotsemo Succession Mohamed Yussuf Bin Abdulaziz.

[2] Muri urwo rubanza RCAA 0006/08/CS rutambamirwa, Urukiko rw'Ikirenga rwemeje ko ubujurire bwa Assini Omar nta shingiro bufite, ko ubwa *Succession* Yussuf Bin Abdulaziz bufite ishingiro, ko igoboka ku bushake rya *Succession* Mohamed Yussuf Bin Abdulaziz ritaburanishijwe kubera ko Me Musonera watanze ikirego yivanye mu rubanza ntiha gira umusimbura.

[3] Urukiko rw'Ikirenga rwategetse Assini Omar guha *Succession* Yussuf Bin Abdulaziz 3.780.000Frw y'ubukode yiyongera kuri 28.620.000Frw yaciwe mu rubanza rwaciwe n'Urukiko Rukuru, Urugereko rwa Musanze, yose hamwe akaba 32.400.000Frw, no gufatanya na Ali Fikirini kwishyura 300.000Frw y'ikurikirana rubanza yiyongera kuri 1.431.000 Frw baciwe n'Urukiko Rukuru, buri wese akanishyura 4% y'umusogongero wa Leta ku mafaranga atsindiwe, bagafatanya na none kwishyura 36.650Frw y'amagarama y'urubanza, batayatangana mu gihe cy'iminsi 8 akavanwa mu byabo ku ngufu za Leta.

Ibyo bikaba bisobanuye ko iyo nzira y'ubujurire idasanzwe yo gutambamira urubanza rw'abandi (*tierce opposition*) ishobora kuzitirwa n'itegeko nk'uko ingingo ya 84 y'Itegeko Ngenga n° 1/2004 imaze kuvugwa yabikoze.

[21] Ku byerekeye imanza ebyiri, RSOCAA 0008/09/CS, EER yaburanye na Mgr Sebununguri na RC 0002/05/CS Kagoyire Christine yaburanye na Abdallah Sultan na Succession Hamud zaciwe n'Urukiko rw'Ikirenga ababuranyi bavugaga ko ari "jurisprudence" bashingiyeho, bamwe bemeza ko ikirego cyo gutambamira urubanza rw'abandi (*tierce opposition*) cyakwirwa muri uru rukiko, abandi bahakana ko rutayakira, uru Rukiko rurasanga "jurisprudence" iba igizwe na "une série de décisions concordantes à un problème determine", bityo izo manza ebyiri zikaba zitafatwaho ko zigize "*jurisprudence*" ngo zibe zashingirwaho.

[22] Na none kuri urwo rubanza RSOCAA 0008/06/CS rwa EER na Musenyeri Sebununguri rwaciwe tariki ya 17/07/2009 Urukiko rurasanga rwarafashwemo icyemezo cyerekeranye no gusubirishamo urubanza (*opposition*) rukaba rero rutashingirwaho mu gusuzuma iki kirego cyo gutambamira urubanza rw'abandi (*tierce opposition*), cyane ko nk'uko bimaze kuvugwa, iyi nzira y'ijurira itemewe ku manza zaciwe burundu n'uru rukiko.

[23] Hakurikijwe ibimaze gusobanurwa haruguru, Urukiko rurasanga ikirego RC 0002/09/CS cyatanzwe na Khalid Foz kigamije gutambamira urubanza RCAA 0006/08/CS kitagomba kwakirwa ngo gisizumwe.

[24] Ku birebana n'inzitizi yatanzwe na Assini Omar yerekeye iburabubasha rya Succession Yussuf Bin Abdulaziz n'indi yatanzwe na Me Hakizimana ijyanye n'ingwate yakwa abanyamahanga, urukiko rurasanga isuzuma ry'izo nzitizi ritakiri ngombwa kuko ikirego cyatanzwe na Khalid Foz kitakiriwe.
