**Incamake y'ikibazo:** SORAS Ltd yareze ITEX s.a.r.l mu Rukiko Rukuru rw'Ubucruzi ivuga ko yagiranye amazerano y'ubwishingizi bw'icyayi na sosiyeti y'ubwikorezi yitwa TACT Ltd. Nyuma y'aho TACT Ltd yaje kumvikana na sosiyeti ITEX s.a.r.l ngo ibe ariyo yikorera icyayi cya OCIR-THE. Imodoka yari icyikoreye igeze mu gihugu cya Kenya yaje gukora impanuka icyayi yari itwaye kirangirika.

TACT Ltd yaje gusaba SORAS Ltd kuyishyura agaciro k'icyayi yari yishingiye, nyuma SORAS Ltd irabikora, nayo ihita isimbura TACT Ltd mu burenganzira bwayo bwo gukurikirana ITEX s.a.r.l ku gihombo yatewe no kuba ITEX s.a.r.l itaragejeje imizigo aho yagombaga kugezwa. Urukiko Rukuru rw'ubucruzi rwemeje ko ikirego cya SORAS Ltd nta shingiro gifite.

SORAS Ltd yajuiriye Urukiko rw'Ikirenga ivuga ko Urukiko Rukuru rw'ubucruzi rwirengangije ibimenyetso yatanze bigaragaza ko hagati ya ITEX s.a.r.l na TACT Ltd habaye amasezerano y'ubwikorezi bw'icyayi cya OCIR-THE.

ITEX s.a.r.l yo yavuze ko mu bimenyetso byatanzwe birimo na “lettre de transport” igaragaza ko umwikorezi ari TACT Ltd kandi yafashe ubwishingizi ndetse SORAS Ltd ikaba yarishyuye OCIR-THE icyayi cyayo. Yongeye ivuga kandi ko SORAS itagaragaje ko imodoka yakoze impanuka ari iya ITEX s.a.r.l, ndetse ko niyo iza kuba iyayo, ibyo bitari kuba bihagije kugirango iryoze icyayi cyangiritse kuko nta masezerano y'ubwikorezi yari hagati ya ITEX sarl na TACT Ltd.

ITEX s.a.r.l yatanze ubujurire bwuririye ku bundi isaba ko SORAS Ltd itegekwa kuyishura indishyi z'akababaro kubera gukomeza kuyishora mu manza ku maherere, amafaranga y'ikurikirana rubanza n'ay'igihembo cy'Avoka.

SORAS Ltd yo yasabye ko ITEX s.a.r.l iyishura inyungu zibariwe kuri 18% y'amafaraga yishuye TACT Ltd, abazwe kuva igihe ITEX s.a.r.l yaboneye integuza. Yanasabye kandi amafaranga y'ikurikirana rubanza n'igihembo cy'Avoka.

**Incamake y'icyemezo:** 1. Amasezerano y'ubwikorezi ntagaragazwa gusa no kuba yanditse, ashobora no kugaragazwa n'ibimenyetso byose biteganywa n'amategeko nk'inyemezabwisyu yabaye hagati y'umwikorezi n'uwo apakiriye ibintu, icyemezo cy'ubwikorezi bwo mu muhanda mpuzamahanga, ingano y'ibiro bigomba coherezwa ugenewe ibicuruzwabihura n'ibipakiwe. Bikaba bigaragara rero ko TACT Ltd yagiranye na ITEX s.a.r.l amasezerano y'ubwikorezi bw'icyayi cya OCIR-THE gifite 49.418kg kandi ikaba yari yishuye igiciro cy'ubwo bwikorezi(4.448\$).

SORAS Ltd rero ikaba ifite uburenganzira bwo gusaba ITEX s.a.r.l amafaranga 20.700.150 yishuye TACT Ltd.

4. Inyungu zijiyanne no kutishyuriwa igihe ziratangwa kandi zikabarwa hashingiye ku gipimo cyemewe na Banki Nkuru y'igihugu. Izo nyungu zibarwa haherewe ku munsi uzisaba yihanangirijeho ugomba kuzimwishiye.

## Urubanza

### I. IMITERERE Y'URUBANZA

[1] Soras Ltd yareze ITEX Sarl mu Rukiko Rukuru rw'Ubucuruzi ivuga ko yagiranye amasezerano y'ubwishingizi bw'icyayi na sosiyeti y'ubwikorezi yitwa TACT Ltd (Trans-Africa Container Transport Ltd), hanyuma TACT Ltd yaje guha sosiyeti ITEX Sarl icyayi cya OCIR-THE ngo ibe ariyo icyikorera, imodoka yari icyikoreye igeze mu gihugu cya Kenya, ikora impanuka icyayi yari itwaye kirangirika.

[2] Nyuma y'uko TACT Ltd isabye SORAS Ltd kwishyura icyo cyayi yariyarishingiye, SORAS Ltd yishuye TACT Ltd agaciro k'icyayi cyangiritse kangana na 20.700.150Frw, SORAS Ltd nayo ihita isimbura TACT Ltd mu burenganzira bwayo bwo gukurikirana ITEX Sarl kuri icyo gihombo (préjudice) yatewe no kuba ITEX Sarl itaragejeje imizigo aho yagombaga gusohozwa, ari nacyo Soras Ltd yaregeye ITEX Sarl.

[3] Urukiko Rukuru rw' Ubucuruzi rwemeje ko icyo kirego cya SORAS Ltd nta shingiro gifite, rwemeje kandi ko ikirego cyo kwiregura cya ITEX Sarl, kigamije gusaba indishyi, kitakiriwe kuko cyatanzwe impitagihe iburanisha ry'urubanza ryaramaze gusozwa.

[4] SORAS Ltd ntuyishimiye imikirize y'urwo rubanza, ijuririra mu Rukiko rw'Ikirenga ivuga ko Urukiko Rukuru rw'Ubucuruzi rwirengagije ibimenyetso byatanzwe bigaragaza ko hagati ya ITEX Sarl na TACT Ltd habaye amasezerano y'ubwikorezi bw'icyayi cya OCIR-THE cyangiritse, ahubwo rwavuze ko ibyo bimenyetso byose bitabigaragaza, ndetse ko fagitire yo kuwa 22/3/2010 ITEX Sarl yakoreye TACT Ltd itagaragaza ko yishuzaga ubwikorezi bw'icyayi cya OCIR-THE. ITEX Sarl yatanze ubujurire bwuririye ku bundi isaba kosoras Ltd itegekwa kuyishyura indishyi z'akababaro kubera gukomeza kuyishora mu manza ku maherere, iy'ikurikiranarubanza n'ighembo cy'avoka.

[5] Urubanza rwaburanishijwe mu ruhame kuwa 15/04/2014, SORAS Ltd ihagarariwe na Me Ruzindana Ignace, naho ITEX Sarl ihagarariwe na Me Ndagiimana Emmanuel.

### II. ISESENGURA RY'IBIBAZO BIGIZE URUBANZA

[6] Me Ruzindana Ignace, uhagarariye SORAS Ltd, avuga ko nk'uko bigaragara mu gika cya 5cy'urubanza rujuririrwa, Urukiko Rukuru rw'Ubucuruzi rwavuze ko ibimenyetso Soras Ltd ishingiraho ikirego cyayo ari inyandiko-mvugo yakozwe na Polisi ya Kenya igaragaza izina rya Bisamaza ITEX nka nyir'ukuyimenesha imizigo yangiritse ubwo yari yikorewe ivanywe mu Rwanda igana Mombasa, fagitire yo kuwa 22/3/2010 ya 4.448USD, ITEX Sarl yakoreye TACT Ltd iyishyuza ubwikorezi bw'icyayi cya OCIR-THE kivugwa muri uru rubanza n'ibaruwa yo kuwa 2/2/2010, Twagirumukiza Benoît, "courtier" wa TACT Ltd yandikiye SORAS Ltd, ariko urwo Rukiko rwasanze ko ibi bimenyetso byose bitagaragaza ko hagati ya ITEX Sarl na TACT Ltd habaye amasezerano y'ubwikorezi bw'icyayi cya OCIR-THE cyangiritse, SORAS Ltd ikakishyurira, none ubu ikaba iregera kugaruza amafaranga yacyishyuriye.

[7] Me Ruzindana Ignace asobanura ko ku byemeza gutyo, Urukiko Rukuru rw'Ubucuruzi rwivuguruje kuko rwemeza ko fagitire yo kuwa 22/3/2010 ya ITEX Sarl irebana n'icyayi cya OCIR-THE kivugwa muri uru rubanza, hanyuma rukarangiza ruvuga ko nta bimenyetso bigaragaza ko habaye amasezerano y'ubwikorezi bw'icyayi cya OCIR-THE cyangiritse, hagati ya ITEX Sarl na TACT Ltd. Asobanura ko kuvuga ko fagitire yo kuwa 22/3/2010, ITEX Sarl yakoreye TACT Ltd iyishyuza ubwikorezi bw'icyayi, itari ikimenyetso kibishimangira, ahubwo ibyo bigaragaza ko Urukiko Rukuru rw'Ubucuruzi rutayisesenguye neza, kuko mu miburanire, ntaho ITEX Sarl yigeze ivuga ko icyayi cyishyuzwa kuri fagitire ivugwa, kijjanye n'ubundi bwikorezi butari ubw'icyayi cya OCIR-THE. Asobanura kandi ko 4.448Usd ari amafaranga y'ubwikorezi, atari agaciro k'icyayi cyane ko ITEX Sarl itari kwishyuza TACT Ltd icyayi, ko ITEX Sarl itashoboye kugaragaza nyiri icyayi, imodoka ye yari yatwaye, ndetse usibye ko ITEX Sarl itari gufata ubwishingizi bw'icyayi kuko icyayi cyari cyishingiwe na TACT Ltd, bigaragara neza ko ari icyayi cya OCIR-THE kubera ko ingano (quantité) y'icyayi igaragara kuri "lettre de transport" ihura n'ibyo TACT Ltd yayihaye, bityo akaba asanga ibi bimenyetso byari bihagije, bitari ngombwa ko habaho amasezerano yanditse, ariyo mpamvuITEX Sarl igomba gusubiza SORAS Ltd 20.700.150Frw yishyuye TACT Ltd kubera icyayi cyangirikiye mu mpanuka yakozwe n'imodoka yayo.

[8] Ku birebana n'imodoka yakoze impanuka, Me Ruzindana Ignace avuga ko ibivugwa mu rubanza rwajuririwe mu gika cya 5 ku rupapuro rwa 4 y'uko "yo modoka iza kugaragazwa ko ari iya ITEX Sarl, ibi bitaba ubwabyo bivuga ko ari yo yaryozwa inshingano z'umwikorezi kuko byanashoboka ko TACT Ltd yaba umwikorezi ariko akora akazi k'ubwikorezi yiyambaje imodoka ya ITEX Sarl cyangwa se y'undi uwo ariwe wese babyumvikanyeho mu masezerano yihariye atari ay'ubwikorezi", ataribyo kuko mu miburanire ya ITEX Sarl itigeze ivuga ko imodoka zayo zakodeshejwe na TACT Ltd mu buryo aribyo byatumye ikora fagitire yo kuwa 22/3/2010 yishyuzaga TACT Ltd cyangwa ngo igaragaze imodoka bari bakodesheje n'igiciro cy'ubukode, bityo akaba asanga Urukiko Rukuru rw'Ubucuruzi rwarashingiye icyemezo cyarwo ku bitagaragajwe mu iburanisha.

[9] Me Ndagiimana Emmanuel avuga ko uretse ko ITEX Sarl na TACT Ltd bakorana imirimo myinshi, iyo fagitire yo kuwa 22/3/2010 ari fagitire y'icyayi ITEX Sarl yatwariye TACT Ltd gifite agaciro ka 4.448Usd, gitandukanye n'icyayi kivugwa muri uru rubanza gifite agaciro kangana na 20.700.000Frw. Akomeza avuga ko SORAS Ltd itagaragaza ko imodoka yakoze impanuka ari iya ITEX Sarl, ndetse ko niyo iza kuba iyayo, ibyo bitaba bihagije kugirango iryozwe icyayi cyangiritse kuko nta masezerano y'ubwikorezi ari hagati ya ITEX Sarl na TACT Ltd.

[10] Me Ndagiimana Emmanuel asobanura ko "lettre de transport" igaragaza umwikorezi na nyiri icyayi, bityo akaba asanga OCIR-THE idashobora kwemera ko umwikorezi atwara icyayi cyayo atafashe ubwishingizi. Akomeza avuga ko umwikorezi ari TACT Ltd kandi yafashe ubwishingizi, ndetse ko Soras Ltd yishyuye OCIR-THE icyayi cyayo cyagize impanuka, bityo akaba asanga nta mpamvu yatuma ITEX Sarl iza mu masezerano yabaye hagati ya TACT Ltd na Soras Ltd. Asoza avuga ko iyo ITEX Sarl iza kuba umwikorezi yari gufata ubwishingizi kuko ntabwo yari gufata "risque" zo kohereza imodoka yayo ntabwishingizi.

Rurasanga kandi muri dosiye hari fagitire yo kuwa 22/3/2010, ITEX Sarl yakoreye TACT Ltd, iyisaba kwishyura 4.448Usd y'ubwikorezi bwa 49.418Kg y'icyayi cy'umukara yikoreye kuva Kigali kugeza Mombasa (Kenya), ndetse ko iyo fagitire igaragaza neza ibyanditse no muri "lettre de transport routier international" (international trucking bill of lading) n° 157/2010 yo kuwa 2/2/2010, aho usanga ikilo cy'icyayi kigomba cohrezwa Mombasa kwa Bahari (T) Co Ltd (destinataire) ari 49.418Kg (Poids Brut: G. Weight) nk'uko bigaragarano muri "liste de colisage n°029/2010" yo kuwa 2/2/2010, TACT Ltd yari yohherereje Bahari (T) Co. Ltd kuwa 19/2/2010 na Soras Ltd, umwishingizi, kuwa 5/4/2010. Byongeye kandi inyandiko yo kuwa 4/3/2010 bita "arrival advice", nayo ikaba igaragaza ko icyayi kivugwa cyohhererejwe Bahari (T) Co. Ltd.

[17] Hakurikijwe ibyavuzwe haruguru, Urukiko rw'Ikirenga rurasanga nk'uko bitemanywa n'ingingo ya 10 y'Itegekoryo kuwa 19/1/1920 ryerekeye intumwa mu bucuruzi n'abikorezi aho ryemeza ko amasezerano y'ubwikorezi agaragazwa n'ibimenyetso byose bitemanywa n'amategeko, ibyo bimenyetso byose bivugwa mu gika kibanziriza iki, bigaragaza neza ko TACT Ltd na ITEX Sarl bagiranye amasezerano y'ubwikorezi bw'icyayi cya OCIR-THE gifite 49.418Kg kigomba cohrezwa Mombasa kwa Bahati (T) Co. [19] Ku birebana na 20.700.150Frw SORAS Ltd yishyuza ITEX Sarl, Urukiko rw'Ikirenga rurasanga mu gihe bigaragara ko SORAS Ltd yishyuye TACT Ltd ayo mafaranga kuwa 22/7/2010 ikoreshje "chèque" n°BB 03920994 (tiré sur la Banque de Kigali) kuko na OCIR-THE yayisabaga kuyishyura icyayi cyayo cyangiritse mu mpanuka yavuzwe haruguru, SORAS Ltd, nk'umwishingizi (assureur), ifite uburenganzira bwo gusimbura TACT Sarl uwo yishingiye mu rugero rw'indishyi yishyuye, isaba ITEX Sarl kuyisubiza ayo mafaranga, bityo hashingiwe ku ingingo ya 431n'ya 432z'Igitabo cya III cy'urwunge rw'amategeko mbonezamubano, ku ngingo ya 18y'Itegeko ryerekeye intumwa mu bucuruzi n'abikorezi no ku ngingoya 32,igika cya 1 y'Itegeko-Tekan<sup>o</sup> 20/75 ryo kuwa 20/6/1975 ryerekeye Ubwishingire, ITEX Sarl ikaba igomba kwishyura SORAS Ltd 20.700.150Frw.

[21] Me Ruzindana Ignace, mu myanzuro yanditse, asaba ko ITEX Sarl itegekwa guha Soras Ltd inyungu z'ubukererwe ku mafaranga 20.700.150Frw zibariwe kuri 18%, uhoreye igithe ITEX Sarl yaboneye integuza.
