Noteri Kayitesi yabirenzeho akomeza cyamunara, inzu igurwa na Mberabagabo nyuma y'iminsi ibiri yishyuye. Dunia yatanze ikirego mu Rukiko Rukuru rw'Ubucuruzi asaba gusesa cyamunara y'inzu ye kuko yakozwe nyuma yo kwishyura umwenda . Muri urwo rubanza hagobotsemo na Fiat Amelie wari waguze inzu na Dunia ku bwumvikane mbere y'uko cyamunara iba.

Urukiko Rukuru rw'Ubucuruzi rwemeje ko cyamunara yabaye hakurikijwe amategeko, ko kandi ikirego cya Fiat Amelie kitakiriwe kuko nta nyungu n'ububasha yari afite byo kurega. Dunia na Fiat bajuririye urwo rubanza mu Rukiko rw'Ikirenga ariko mu gihe rutaraburanishwa bareka urwo rubanza ahubwo bongera kuregera Urukiko Rukuru rw'Ubucuruzi basaba gusubirishamo urubanza ingingo nshya ku mpamvu z'uko Urukiko rwitiranyije uko ibintu byagenze, maze urwo Rukiko rwemeza ko cyamunara yakozwe

iteshejwe agaciro, runategeka ko Kayitesi Judith ( Notaire), Mberabagabo Innocent wari ufatanyije sosiyete na Butera wanaguze inzu mu cyamunara bishyura Fiat Amelie 29.575.000Frw y'ubukode bw'inzu yari kubona mu mezi 13 iyo nzu yaguze idatezwa cyamunara, banategekwa kandi kwishyura 500.000Frw by'igihembo cy' Avoka.

Kayitesi, Mberabagabo Innocent na Butera bandikiye umuvunyi Mukuru bamusaba gusubirishamo urubanza ku mpamvu z'akarengane kagaragarira buri wese kuko hari amategeko n'ibimenyetso byirengagijwe maze byemezwa ko rusubirishwamo ku mpamvu z'akarengane.

Mu Rukiko rw'Ikirenga, Kayitesi, Mberabagabo Innocent na Butera basobanura ko akarengane kagaragarira mu kuba Urukiko Rukuru rw'Ubucuruzi atari rwo rwari rufite ububasha bwo gusubirishamo urubanza ku mpamvu z'akarengane, ko ahubwo bwari bufitwe n'Urukiko rw'Ikirenga bityo Urukiko Rukuru rw'Ubucuruzi rukaba rutaragombaga kwakira ikirego cyo gusubirishamo urubanza ingingo nshya cya Dunia na Fiat kandi hari ubujurire bari baratanze mu Rukiko rw'Ikirenga, ko kandi ubugure bw'inzu bwabaye hagati ya Dunia na Fiat bwatumye Dunia abona ubwishyu bwo kwishyura BCR butari guhagarika cyamunara yabaye bitewe n'uko inzu itari ikiri mu maboko yabo. Bavuze kandi ko kuba Fiat Amelie yarahawe amafaranga y'ubukode yemejwe n'Urukiko Rukuru rw'Ubucuruzi ari akarengane kuko nta makosa bakoze.

Dunia na Fiat Amelie bo bavuze ko Urukiko Rukuru rw'Ubucuruzi arirwo rwari rufite ububasha bwo gusubirishamo urubanza ku mpamvu z'akarengane gakabije kuko gashingiye ku kwitiranya uko ibintu byagenze kandi hakaba harashingiye ku ngingo z'amategeko zijyanye no gusubirishamo urubanza ingingo nshya.

Barongeye bavuga ko batiyambaje inzira ebyiri z'ubujurire icyarimwe kuko batanga ikirego cyo gusubirishamo urubanza ingingo nshya berekanye ko baretse ubujurire bari baratanze mu Rukiko rw'Ikirenga. Bavuze kandi ko ubugure bwabaye hagati yabo bufitwe agaciro kuko Fiat yarangije urubanza ku neza yishyura BCR ndetse imuha icyemezo cyo kutabamo umwenda inabimenyeshya notaire Kayitesi Judith imusaba guhagarika cyamunara. Byongeye kandi bavuga ko kuba Mberabagabo Innocent na Butera baraguze iyo nzu mu cyamunara bazi neza ko ari inzu yagurishijwe basanga ari amakosa akomeye bagomba kuryozwa bakishyura Fiat Amelie amafaranga y'ubukode bamuvukije.

Basoje basaba guhabwa amafaranga yo gushorwa mu manza ku maherere n'ay'igihembo cy' Avoka. Naho Kayitesi Judith, Mberabagabo Innocent na Butera bavuga ko ayo mafaranga abayasabye batayakwiye kuko nta makosa bakoze.

Dunia Bakarani yatanze ikirego mu Rukiko Rukuru rw'Ubucuruzi kigamije guhagarikisha cyamunara y'inzu ye iri mu kibanza nimeru 339 mu Mujyi wa Rubavu, kubera icyamunara cyakozwe na Noteri Kayitesi Judith nyamara ku tariki ya 15/12/2011 yaramenyeshajwe ko Banki y'Ubucuruzi y'u Rwanda yarangiye kwishyurwa ku itariki ya 13/12/2011. Fiat Amélie we yagobotse ku bushake muri urwo rubanza kuko yari yaguze inzu na Dunia Bakarini ku bwumvikane mbere ya cyamunara.

[2] Ku itariki ya 18/10/2012, Urukiko Rukuru rw'Ubucuruzi rwaciye urubanza rwaregewe RCOM 0070/12/HCC rwemeza ko cyamunara yakurikije amategeko, ko kandi ikirego cya Fiat Amélie, wagobotse ku bushake, kitagomba kwakirwa kuko atari afite ububasha n'inyungu byo kurega, cyane cyane ko inzu yagurishijwe itari ikiri iye.

[3] Dunia Bakarani na Fiat Amélie bongeye kuregera Urukiko Rukuru rw'Ubucuruzi basubirishamo urubanza RCOM 0070/12/HCC ingingo nshya, bashingiye ku ngingo ya 186,

igika cya 3 n'ya 6 y'Itegeko n° 21/2012 ryo kuwa 14/06/2012 ryerekeye imburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegets.

[5] Uru Rukiko kandi rwategetse Kayitesi Judith, Mberabagabo Innocent na Butera Jean-Pierre gufatanya kwishyura Fiat Amélie amafaranga angana na 29.575.000 Frw y'ubukode bw'inzu n'amafaranga angana na 500.000 Frw y'igihembo cy'avoka, yose hamwe angana n'amafaranga 30.575.000 Frw, urubanza rukimara gusomwa bahereye ku mafaranga Noteri Kayitesi Judith yabikije muri Banki Nkuru y'u Rwanda (consignation) kuwa 19/12/2011 amaze guteza cyamunara, rubategeka no gufatanya kwishyura amagarama y'urubanza ahwanyeye na 9.000 Frw.

[6] Kuwa 6/2/2013, Umuvunyi Mukuru yandikiye Perezida w'Urukiko rw'Ikirenga asaba ko urubanza RCOM 0306/12/HCC rwaciye n'Urukiko Rukuru rw'Ubucuruzi rwasubirwamo kubera impamvu z'akaregane gakomoka ku kuba hari amategeko n'ibimenyetso byirengagijwe.

Gushyigikira amanyanga n'amakosa y'abareze; bavuga ko ikirego cy'abareze cyari gishingiye ku manyanga no kwica itegeko kugirango bahagarikishe cyamunara bitwaza amasezerano y'ubugure ku nzu yari yarafatiriwe itakiri mu maboko ya nyirayo bigashimangirwa n'ingingo ya 295 y'Itegeko n° 18/2004 ryo kuwa 20/06/2004 ryerekeye imburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegets yakurikizwaga icyo gihe.

[9] Fiat Amélie asaba Urukiko rw'Ikirenga gutegeka abarega kumwishyura 3.500 USD buri kwezi mu gihe cy'amezi 13 y'ubukode bw'inzu yaguzwe mbere ya cyamunara, hamwe na Dunia Bakarani bagasaba gutegeka abarega kubaha amafaranga 2.000.000 kubera babashoye mu manza ku maherere n'amafaranga 2.000.000 y'igihembo y'avoka. I&M Bank (ex-Banki

y'Ubucuruzi y'u Rwanda) nayo yatanze ikirego cyuririye kucy'abarega isaba Urukiko rw'Ikirenga kubategeka kuyishyura indishyi z'ikurikiranarubanza zingana n'amafaranga 500.000 n'igihembo cya avoka kingana n'amafaranga 500.000.
