Incamake y'ikibazo: Nabahire, Nyaguhirwa, Nsengiyumva na Munyaneza mu Rukiko Rwisumbuye rwa Ngoma bashinjwa ubuhemu bagamije gutwara amafaranga ya Bank y'Abaturage y'u Rwanda, Ishami rya Gahororo. Nsengiyumva na Nabahire bahamijwe gukora inyandiko mpimbano n'ubuhemu bahanishwa igifungo cy'inyaka 2 n'ihazabu ya 50.000Frw kubera gukora inyandiko mpimbano n'igifungo cy'amezi 6 ku cyaha cy'ubuhemu naho Nyaguhirwa na Munyaneza bahamwa no kuba ibyitso mu cyaha cy'ubuhemu gihama Nsengiyumva rubahanisha igifungo cy'amezi 6. Rwemeje kandi ko ubuhemu bwakozwe na Nsengiyumva na Nabahire Nyaguhirwana Munyaneza cyateje iyo banki igihombo kingana na 80.107.800Frw rubategeka kwishyura ayo mafaranga bafatanyije kandi rwemeza ko Nabahire agomba kwishyura igihombo kingana na 9.400.000Frw wenyine rwategetse abashinjwaga bose kandi kwishyura amafaranga y'ikurikiranarubanza.

Abaregwaga bose bajuririyeye mu Rukiko Rukuru, Urugereko rwa Rwamagana nuko rubahindura abere. Iyo banki yajuririyeye urubanza mu Rukiko rw'Ikirenga ivuga ko Urukiko rwirengagije ibimenyetso byose ndetse rurenga ku mvugo z'abashinjwaga bemera kandi bagasobanura uburyo bakoramo ubwo uburiganya bwose.

Mbere y'itangira ry'urubanza, Ubushinjacyaha bwazamuye inzitizi buvuga ko bubona nta mpamvu yo guhamagarwa mu rubanza kuko butajuriye. Ahubwo hajuriye Banki y'Abaturage y'u Rwanda ku bijyanye n'indishyi gusa. Bwasoje buvuga ko bwagombye gukurwa mu rubanza.

[2] Urukiko rwemeje ko Nsengiyumva na Nabahire bahamwa n’ibyaha byo gukora inyandiko mpimbano n’icy’ubuhemu, rubahanisha igifungo cy’imyaka ibiri (2) n’ihazabu ya 50.000 frw ku cyaha cyo gukora inyandiko mpimbano, n’igifungo cy’amezi atandatu (6) ku cyaha cy’ubuhemu naho Nyaguhirwa na Munyaneza bahamwa no kuba ibyitso mu cyaha cy’ubuhemu gihama Nsengiyumva, rubahanisha igifungo cy’amezi atandatu (6).

[3] Rwemeje kandi ko icyaha cy’ubuhemu cyakozwe na Nsengiyumva, Nabahire, Nyaguhirwa na Munyaneza cyateje Banki y’Abaturage y’u Rwanda, ishami rya Gahororo, igihombo kingana na 80.107.800Frw, rubatega kwishyura ayo mafaranga bafatanyije, rwemeza ko Nabahire ku giti cye nawe yayiteje igihombo kingana na 9.400.000Frw, rumatega kuyariha. Rwategetse kandi Nsengiyumva, Nabahire, Nyaguhirwa na Munyaneza kuriha Banki y’Abaturage y’u Rwanda, ishami rya Gahororo 200.000Frw y’ikurikiranarubanza.

[4] Nabahire, Nyaguhirwa, Nsengiyumva na Munyaneza bajuririye Urukiko Rukuru, Urugereko rwa Rwamagana, mu guca urubanza rwemeza ko ubujurire bwabo bufite ishingiro, ko bahanaguweho ibyaha baregwa.

[5] Banki y'Abaturage y'u Rwanda, ishami rya Gahororo yajuririye Urukiko rw'Ikirenga ivuga ko Urukiko rwirengagije ibimenyetso byose ndetse rurenga no ku mvugo z'abashinjwa bemera kandi bagasobanura uburyo bakoragamo ayo manyanga yose, rubagira abere.

II. IKIBAZO KIGIZE URUBANZA N'ISESENGURA RYACYO

Ko nyuma yo kutishimira imikirize y'urubanza, abaregwa bajuririye mu Rukiko Rukuru, Urugereko rwa Rwamagana, rusanga badahamwa n'ibyaha bashinjwa kubera ko nta bimenyetso, icyo cyemezo nicyo Banki y'Abaturage y'u Rwanda yajuririye muri uru Rukiko, ubushinjacyaha ntibwajurira.

[9] Avuga ko ikiburanwa ubu, ari ikirebana n'indishyi gusa, n'ikimenyimenyi umucamanza w'ibanzirizasuzuma yakiriye ubujurire bwa Banki y'Abaturage y'u Rwanda ashingiye ko indishyi zaregwe zirengeje 20.000.000Frw. Akomeza avuga ko ingingo ya 175 n'ya 187 z'itegeko N° 30/2013 ryo ku wa 24/05/2013 ryerekeye imiburanishirize y'imanza z'inshinjabyaha, zisobanura neza ko uregera indishyi ajuririra urubanza rwaciwe, ku byerekeranye n'indishyi gusa, ko kandi urukiko rwajuririwe ruburanisha gusa mu mbibi z'icyajuririwe nkuko ingingo ya 189 y'iryo tegeko ibisobanura.

[10] Uhagarariye Ubushinjacyaha arongera akavuga ko ingingo ya 187 y'itegeko n° 30/2013 ryo ku wa 24/05/2013 ryerekeye imiburanishirize y'imanza z'inshinjabyaha kimwe n'ingingo ya 164 y'itegeko-ngenga n° 51/2008 ryo kuwa 09/09/2008 rigena imiterere, imikorere n'ububasha by'inkiko, zose zihuriza ku kintu kimwe cy'uko iyo uregwa agizwe umwere, bitazitira uwaregeraga indishyi kujurira, izo ngingo zikanagena ko mu gihe ajuriye haburanishwa gusa ibijyanye n'indishyi.

[11] Avuga kandi ko ku bivugwa mu ngingo ya 187 y'itegeko n° 30/2013 ryo ku wa 24/05/2013 ryerekeye imiburanishirize y'imanza z'inshinjabyaha, ko iyo uregera indishyi ajuriye urubanza rwose rwongera gusuzumwa mu mizi yarwo, asanga bishaka kuvuga kurusuzuma rwose ku birebana n'indishyi gusa, akaba asanga rero nta mpamvu yatuma ubushinjacyaha buhamagazwa muri bene izi manza, dore ko no mu ivugururwa ry'inzezo

z'ubucamanza, ubushinjacyaha bwakuwe mu manza z'imbonezamubano kandi urubanza ruburanishwa ubu, rukaba rufite kamere y'urubanza mbonezamubano.

[13] Me Ingabire Solange uburanira Banki y'Abaturage y'u Rwanda, avuga ko urubanza rwajuririwe ari urw'inshinjabyaha, ko kandi n'ubujurire batanze, bushingiye ku rubanza rw'inshinjabyaha, akaba abona nta mpamvu ubushinjacyaha bwakurwa mu rubanza. Yongeraho ko Banki y'Abaturage y'u Rwanda yajuririye ibyo itishimiye muri urwo rubanza rwaciwe abo irega indishyi bakagirwa abere ku cyaha cyari guherwaho hemezwa indishyi, ko iyo ijuririra imbonezamubano gusa, yari kuba ihinduye ikirego kandi bitemewe.

[15] Me Gasasira Jean Claude wunganira Nsengiyumva Prosper nawe avuga ko abona nta mpamvu ubushinjacyaha bugomba guhamagarwa muri izi manza, ko ibirego byari bibiri ariko aho urubanza rugeze, ikirego kikaba ari kimwe kijyanye n'indishyi mbonezamubano, ko rero hashingiwe ku ngingo ya 12 y'itegeko n° 30/2013 ryo ku wa 24/05/2013 ryerekeye imiburanishirize y'ianza z'inshinjabyaha ivuga ko ikirego cy'indishyi kiburanishwa hashingiwe ku mategeko agenga imiburanishirize y'ianza z'imbonezamubano, ubushinjacyaha butagomba kuza muri uru rubanza.

Isesengura ry'iyi ngingo ryumvikanisha ko indishyi zisabwa zigomba kuba zuririye ku cyaha cyakozwe zikaba ari ingurane y'ibyangijwe n'icyo cyaha kirimo kuburanishwa, ko kandi icyo kirego gitangwa mu rukiko ruburanisha imanza z'inshinjabyaha ariko kikaba kigamije gusaba indishyi gusa kitarebana n'ibijyanye n'igihano ku cyaha cyakozwe.

[19] Ingingo ya 164 y'itegeko-ngenga n° 51/2008 ryo kuwa 09/09/2008 rigena imiterere, imikorere n'ububasha by'inkiko, n'ingingo ya 187 y'itegeko n° 30/2013 ryo ku wa 24/05/2013 ryerekeye imiburanishirize y'imanza z'inshinjabyaha, ziteganya ko uregera indishyi ajurira ku bijyanye n'indishyi gusa. Ariko hakongerwamo ko iyo ukurikiranyweho icyaha agizwe umwere, bitabuza uregera indishyi kujurira, ko kandi muri icyo gihe, urubanza rwose rwongera kuburanishwa mu mizi.

[20] Urukiko rurasanga kuba uwari ukurikiranyweho icyaha agizwe umwere bitabuza uwangirijwe n'icyo cyaha kujurira kandi urubanza rukaburanishwa rwose mu mizi, uwajuriye agatanga ibimenyetso bihamya uregwa icyaha byaba ibisanzwe muri dosiye cyangwa se ibindi bishya yaba yungutse, urukiko rukabisuzuma hagamijwe kureba niba uwangirijwe n'icyo cyaha ashobora kwishyurwa indishyi z'ibye byangijwe n'icyaha uregwa yahanaguweho.

[21] Ku kibazo cyo kumenya niba ubushinjacyaha bugomba kuza cyangwa kutaza mu rubanza rusuzuma ubujurire bw'uwaregeye indishyi mu gihe ukurikiranyweho icyaha yagihanaguweho mu rwego rwa mbere, urukiko rurasanga ihame rya mbere ari uko nta rubanza rw'inshinjabyaha rushobora kuburanishwa ubushinjacyaha budahagarariwe.

[22] Urukiko rurasanga kuba uregwa yarahanaguweho icyaha hakajurira uregera indishyi gusa ubushinjacyaha ntibujurire, ibyo bidatuma urubanza ruta kamere yarwo y'urubanza rw'inshinjabyaha ngo ruhinduke urw'imbenezamubano, kuko indishyi zisabwa, zisabwa umucamanza uburanisha imanza z'inshinjabyaha (le juge pénal) kuwa mu rwego rwa mbere, mu bujurire akaba agomba kuzitanga aherye ku bimenyetso yagejejweho n'uregera indishyi amaze kubisuzuma akabiha agaciro. Ko nubwo urubanza rwaburanishwa hakurikijwe amategeko agenga imanza z'imbenezamubano nk'uko biteganywa n'ingingo ya 12 y'itegeko n° 30/2013 ryo ku wa 24/05/2013 ryerekeye imiburanishirize y'imanza z'inshinjabyaha, ibyo ntibiruvana mu mubare w'imanza nshinjabyaha kuko nk'uko byavuzwe haruguru, ruba rwaratangiye ari urubanza rw'inshinjabyaha kandi no mu bujurire, umucamanza aba agihamagariwe gusuzuma uruhare rw'uwakoze icyaha ashingiye ku bimenyetso yagejejweho n'uwajuriye bikimushinja, akabiheraho atanga indishyi.

[23] Urukiko rurasanga, rushingiye ku ihame ryavuzwe haruguru ry'uko nta rubanza rw'inshinjabyaha rushobora kuburanishwa ubushinjacyaha budahagarariwe, no kuba urubanza mu bujurire ruba rucyambaye umwenda w'urubanza nshinjabyaha, ari ngombwa ko ubushinjacyaha buruzamo nk'umuburanyi nkuko bujya mu zindi manza z'inshinjabyaha, kugirango mu gihe bikenewe bube bwagira icyo bwungura urukiko mu itangwa ry'ibimenyetso n'uwaregeye indishyi.

uregwa agizwe umwere, uregera indishyi akajurira, urubanza rwose rwongera kuburanishwa mu mizi.

[25] Urukiko rurasanga ibikubiye muri izi ngingo byumvikanisha ko ubushinjacyaha bugomba guhagararirwa muri izi manza, kubera ko Urukiko rwongera gusuzuma urubanza mu mpande zarwo zose, haba kurw'imikorere y'icyaha no ku rw'indishyi, rusuzuma uruhare rw'uregwa wagizwe umwere kugira ngo urwo ruhare rube arirwo ruherwaho mu kugena indishyi mu gihe rusanze ruhari.
