Amategeko mbonezamubano – Agaciro k'amasezerano atagaragaza icyayakuyeho – Amasezerano akozwe mu buryo bukurikije amategeko aba itegeko ku bayagiranye – Iyo uwagurishije iyemeje gutanga icyagurishijwe akaniyemeza no gukora ibishoboka byose kugira ngo cyandikwe ku uwacyiguze, ntiyavuga ko nta ngaruka ayo masezerano agomba kumugiraho ashingira ko yaba atariwe wagitunze cyangwa wagitanze – Itegeko n° 45/2011 ryo kuwa 25/11/2011 rigena amasezerano, Ingingo ya 64 n'Itegeko ryo kuwa 30/07/1888 rishyiraho Urwunge rw'amategeko y'imbonezamubano, ibyerekeye imirimo nshinganwa cyangwa amasezerano, Ingingo ya 263 na 264.

Amategeko mbonezamubano – Indishyi z'agaciro k'ibyongewe ku nzu – Ugomba gutanga bene izo ndishyi – Uwaguze ikitari icy'umugurishije, iyo gisubijwe bene cyo, uwari waguze ntasubizwa n'umugurishije agaciro k'ibyo yari yacyongereyeho – Indishyi z'ibyakozwe ku nzu biyongerera agaciro zitangwa n'usubijwe umutungo kugirango atigwizaho umutungo nta mpamvu.

Amategeko mbonezamubano – Gusubizwa amafaranga y'ubukode – Uwaguze ikitari icy'umugurishije kigasubizwa bene cyo ntahabwa amafaranga y'ubukode bwacyo kuko atariwe nyiracyo akaba aba nta n'uburenganzira afite ku bukode bwacyo.

Amategeko mbonezamubano – Igihano gihatira kurangiza urubanza by'agateganyo – Iyo urubanza ruciwe ku rwego rwa nyuma kandi nta n'icyagaragarijwe Urukiko cyatuma uwatsinzwe urubanza atazarurangiza, ntibiba ngombwa ko hategekwa igihano gihatira kurangiza urubanza by'agateganyo.

Incamake y'ikibazo: Uru rubanza rwatangije ari imbonezamubano mu Rukiko Rwisumbuye rwa Rusizi, abazungura ba NZISABIRA Trojan barega RWANDA FOAM ko yabagurishije inzu itari iyayo iri mu kibanza n° 33 i Kamembe bayisaba indishyi z'amafaranga yatanzwe hagurwa iyo nzu n'amafaranga yakoreshejwe mu kuyagura. RWANDA FOAM nyuma yo gutsindwa uru rubanza yarujuririye mu Rukiko Rukuru, Urugereko rwa Rusizi rwemeza ko ikiburanwa kiri mu bubasha bw'Inkiko z'Ubucuruzi.

Urukiko Rukuru rwaregewe uru rubanza rwemeje ko ikirego cy'Abazungura ba NZISABIRA Trojan nta shingiro gifite kubera ko nta bimenyetso simusiga bagaragaje bishimangira ibyo bavuga byerekeye amasezerano y'ubugure bw'inzu NZISABIRA yakoranye n'abantu babiri batandukanye aribo RWANDA FOAM n'abazungura ba MPUNYU. Urukiko Rukuru rw'Ubucuruzi rwavuze kandi ko mu manza Abazungura ba NZISABIRA bagobotsemo zarimo n'Abazungura ba MPUNYU, batigeze bagobokeshamo RWANDA FOAM, ko bari bazi neza ko ntacyo bayibaza cyane ko n'ikibanza kitari kiyanditseho.

Abazungura ba NZISABIRA bajuririye mu Rukiko rw'Ikirenga bavuga ko Urukiko Rukuru rw'Ubucuruzi rwirengagije ibimenyetso rwashyikirijwe; basaba ko amasezerano yabaye hagati y'umubyeyi wabo na RWANDA FOAM yateshwa agaciro bagasubizwa amafaranga y'ikiguzi cy'inzu hiyongereyeho ay'agaciro bayivuguruje, indishyi z'akababaro zo kuba barahungabanyijwe mu mutungo w'ababyeyi babo, amafaranga y'ubukode bw'yo nzu kuva bayambuve, amafaranga yo gukurikirana urubanza, indishyi zo kuba baragurishijwe inzu itari iya RWANDA FOAM batabizi, ko kandi hashyirwaho igihano gihatira RWANDA FOAM kurangiza urubanza by'agateganyo.

RWANDA FOAM yo yavuze ko ubujurire bw'Abazungura ba NZISABIRA Trojan butagomba kwakirwa kubera ko batagaragaza abo aribo ku buryo budashidikanywaho, bikaba bisobanuye ko nta bubasha n'inyungu bafite byo kurega. Ku masezerano aburanishwa n'Abazungura ba NZISABIRA, RWANDA FOAM ivuga ko nta kimenyetso na kimwe abajuriye bagaragarije Urukiko cyerekana ko inzu iburanwa yaba ariyo yayibahaye. Naho kubijyanye n'indishyi zasabwe n'abajuriye, RWANDA FOAM ivuga ko nta shingiro zifite kuko nta n'ibimenyetso abazisaba bazitangira.

Incamake y'icyemezo: 1. Inzitizi y'iburabubasha n'inyungu byo kurega ishobora gutangwa aho urubanza rwaba rugeze hose. Zishobora gutangirwa bwa mbere mu rwego rw'ubujurire niyo zaba zarafashweho icyemezo mu rukiko rubanza. Ntibibuza kandi ko zajurirwa hamwe n'urubanza mu mizi kuko iburanisha riba ritahagarariye kuri urwo rwego. Bityo nta ntacyari kubuza RWANDA FOAM kuzitanga mu Rukiko rwajuririwe.

2. Urubanza rukosora n'urukosorwa biruzuzanya bigafatirwa hamwe. Ntirwafatwa nk'icyimenyetso gitanzwe nyuma y'iburanisha mu gihe rwanahawe impande zombi zikarujiyaho

impaka mu rwego rwo kubahiriza uburenganzira bwo kwiregura. Bityo urubanza RC 0098/14/TB/KMB rwaciwe n'Urukiko rw'Ibanze rwa Kamembe kuwa 06/03/2014 rwuzuza urubanza RC 0040/141/TB/KMB rugaragaza ko abajuriye ari abana ba NZISABIRA mu buryo budashidikanywaho, inzitizi ya RWANDA FOAM yo kutakira ikirego cyabo ndetse nuko urubanza RC 0098/14/TB/KMB rukosora urundi rutashingirwaho ngo kuko rwatanzwe nyuma y'ipfundikirwa ry'iburanisha ry'urubanza, zikaba nta shingiro zifite.

3. Amasezerano hagati y'umuguzi n'ugurisha bw'ikintu bumvikanyeho akaniyemeza gukora ibishoboka byose ngo kimwandikweho aba aba itegeko hagati yabo. Bityo amasezerano yo kuwa 10/03/1992 hagati ya RWANDA FOAM na NZISABIRA Trojan akaba afite agaciro hagati yabo kuko RWANDA FOAM ivuga ko itigeze itunga cyangwa ngo ihe NZISABIRA inzu yamugurishije, itagaragaza icyakuyeho amasezerano bagiranye.

4. Ijurisha ry'ikintu cy'undi ni imfabusa, rishobora gutangirwa indishyi iyo umuguzi atigeze amenya ko icyo kintu ari icy'undi. Bityo kuba NZISABIRA yaraguze inzu atari aziko atari iya RWANDA FOAM, Abazungura be bagomba gusubizwa amafaranga 5.500.000 Frw NSIZABIRA yatanze y'ikiguzi cy'inzu n'indishyi za 2.000.000frw zigenwe mu bushishozi bw'Urukiko.

5. Mu gihe umuntu akurikiranye umutungo we utimukanwa k'uufite, indishyi z'ibyakozwe ku nzu biyongerera agaciro bitangwa n'usubijwe umutungo kugirango atigwizaho umutungo nta mpamvu. Bityo abazungura ba NZISABIRA nta ndishyi z'agaciro k'ibyongerwe ku nzu bahabwa kuko inzu RWANDA FOAM yagurishije atari iyayo ahubwo yasubijwe beneyo, bityo bakaba basaba indishyi z'ibayikozweho n'uwayisubijwe.

6. Iyo inzu yasubijwe beneyo, uwari wayiguze ntiyasaba uwayimugurishije indishyi z'ubukode kuko nta burenganzira ku bukode aba afite. Bityo Abazungura ba NZISABIRA ntibagomba guhabwa amafaranga y'ubukode bw'inzu kuko atari iyabo.

7. Iyo urubanza ruciwe ku rwego rwa nyuma kandi nta kigaragariza Urukiko rutazarangizwa ntibiba ari ngombwa ko hategekwa igihano gihatira kwishyura. Igihano gihatira RWANDA FOAM kurangiza urubanza by'agateganyo akaba nta shingiro ryacyo.

RWANDA FOAM yajuririye Urukiko Rukuru, Urugerekko rwa Rusizi rwemeza ko ikiburanwa kiri mu bubasha bw'Inkiko z'Ubucuruzi.

[2] Mu Rukiko Rukuru rw'Ubucuruzi, Abazungura ba NZISABIRA basobanuye ko indishyi basaba zishingiye ku kuba tariki ya 10/03/1992 RWANDA FOAM yaragurishije umubyeyi wabo NZISABIRA Trojan inzu itari iyayo iri mu kibanza n° 33 i Kamembe mu Karere ka Rusizi, ku mafaranga 5.500.000 Frw, ayikoreramo imirimo y'ubucuruzi, ndetse arayagura ayongerera agaciro. Bavuga ko iyo nzu yaje gusubizwa abazungura ba Omar ABDULAZIZ bahagarariwe na ASSIN Omar nyuma yo gutsinda urubanza RCA 0046/05/HC/CYG barezemo Leta y"u Rwanda ihagarariwe na Minisiteri y'Ubutaka, gutuza abantu no kurengera ibidukikije, bakagobokeshamo Abazungura ba MPUNYU n'aba NZISABIRA, basaba gutesha agaciro «certificat d'enregistrement n° VOL RVIII Folio 21» y'icyo kibanza yanditse kuri MPUNYU Zacharie.

Rwasobanuye ko kuwa 10/03/1992 NZISABIRA yabanje gukorana amasezerano yo kugura inzu na RWANDA FOAM ku mafaranga 5.500.000 Frw, nyuma yaho bigaragara ko hari andi masezerano yerekanye n'yo nzu yagiranye n'Abazungura ba MPUNYU bahagarariwe na NIYIBIZI Ruben nk'uko bigaragara mu ibaruwa n° 18.04.081/4189 yo kuwa 30/06/1993 Minisitiri w'imirimo ya Leta n'Ingufu yandikiye Umuyobozi w'imisoro, amusaba uburenganzira bwo gukora "mutation" kubera ko inzu yari yagurishijwe, bakaba rero badatanga ibisobanuro kuri ayo masezerano NZISABIRA yakoranye n'abantu babiri batandukanye.

[4] Urukiko rwavuze kandi ko mu manza Abazungura ba NZISABIRA bagobotsemo zarimo n'Abazungura ba MPUNYU, batigeze bagobokeshamo RWANDA FOAM, bisobanura ko bari bazi neza ko ntacyo bayibaza cyane cyane ko n'ikibanza kitari kiyanditseho, ko no kuba baramaze imyaka 18 yose nta "mutation" basabye ari ikindi kimenyetso ko ntacyo bari bagikurikiranye kuri iyo nzu.

[5] Urukiko rwategetse ko Abazungura ba NZISABIRA bafatanya kwishyura RWANDA FOAM Ltd amafaranga 1.500.000 Frw y"indishyi z'ikurikiranarubanza n'igihembo cya avoka.

[6] Abazungura ba NZISABIRA Trojan bajuririye Urukiko rw'Ikirenga, bavuga ko urukiko rwirengagije ibimenyetso rwashyikirijwe, umucamanza afata icyemezo ashingiye ku

marangamutima yishyira mu mwanya wa RWANDA FOAM Ltd avuga ko kuba abazungura ba NZISABIRA hari imanza baburanye nyamara ntibagobokeshe RWANDA FOAM Ltd, bigaragaza ko bari bazi ko ntacyo bayiryoza. Basaba ko amasezerano yabaye hagati ya NZISABIRA na RWANDA FOAM yateshwa agaciro, ko yabasubiza amafaranga y'ikiguzi cy'inzu hiyongereyezo ay'agaciro ifite ubu, indishyi z'akababaro zo kuba barahungabanyijwe mu mutungo w'ababyeyi babo, amafaranga y'ubukode bw'yo nzu kuva bayambuwe kugeza ubu, amafaranga yo gukurikirana urubanza, indishyi zo kuba baragurishijwe inzu itari iya RWANDA FOAM batabizi, ko kandi hashyirwaho igihano gihatira RWANDA FOAM kurangiza urubanza (astreinte) n'irangizarubanza ry'agateganyo.

[7] Rwanda FOAM yo ivuga ko ikirego cy'ubujurire cy'Abazungura ba NZISABIRA Trojan kitagomba kwakirwa kubera ko nta bubasha n'inyungu bafite bwo kurega, ko ariko mu gihe icyo kirego cyaba cyakiriwe, urukiko rwakwemeza ko nta shingiro gifite, maze bagacibwa indishyi zo kuyishora mu rubanza nta mpamvu, igihembo cya avoka n'ikurikiranarubanza.

[8] Urubanza rwaburanishijwe mu ruhame tariki ya 21/01/2014, kuwa 25/02/2014 no kuwa 29/04/2014, Abazungura ba NZISABIRA Trojan bahagarariwe na Me NGARAMBE Raphaël hamwe na Me HAKIZIMANA Théogène, naho Rwanda FOAM ihagarariwe na Me MHAYIMANA Isaïe na Me ABIJURU Emmanuel.

Bavuga kandi ko batagaragaza inyandiko y'Ubuyobozi yemeza ko batuye aho hantu ko kandi aribo babarizwa, ko n'ibyemezo batanze mu rukiko byagaragaye ko birimo amakuru y'ibinyoma, bakaba baniyemerera ko n'urubanza RC 0040/141/TB/KMB kugera kuri RC 0045/141/TB/KMB rwaciwe n'Urukiko rw'Ibanze rwa KAMEMBE rusimbura inyandiko zabo z'amavuko rwashingiweho mu gukora ibyo byemezo narwo rurimo amakosa nk'aho bivugwa ko rwaciwe kuwa 30/01/2013, rukaba rufite nimerozitabaho n'ibindi.

[10] Basanga kandi urubanza RC 0098/14/TB/KMB rurukosora Abazungura ba NZISABIRA bararushyikirije urukiko nyuma yo gupfundikira iburanisha ry'urubanza mu buryo bunyuranije n'ingingo ya 69 CPCCSA kuko rwatanzwe ku itariki ya 13/03/2014 RWANDA FOAM itabanje kurumenyeshwa kuko yarushyikirijwe kuwa 10/04/2014, rukaba rero rutagomba gushingirwaho.

[11] Bavuga ko ingingo ya 142 y'Itegeko n° 21/2012 ryo kuwa 14/06/2012 ryerekeye imburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi yerekana neza ko izo mpamvu zrimo kutagira ububasha n'inyungu (défaut de qualité, de capacité et d'intérêt d'agir) zituma ikirego kitakirwa ari indemyagihugu (d'ordre public), ko kandi n'urukiko ubwarwo rugomba kwibviriza kuzisuzuma, ko ndetse ingingo ya 2 n'ya 19 zaryo ziteganya ibisabwa kugira ngo ikirego cyakirwe.

[12] Ababuranira Abazungura ba NZISABIRA bavuga ko mu rukiko rubanza RWANDA FOAM yari yatanze inzitizi yo kutakira ikirego cyabo ngo kuko batasobanuye aho babarizwa, batanga n'ibirego mu buryo butari bwo kuko buri wese atatanze ikirego ngo cyandikwe ukwacyo kigire dosiye yacyo, ahubwo bikomatanyirizwa hamwe, umucamanza abifataho icyemezo gisobanutse, RWANDA FOAM ntiyakjuririra, ikaba rero idakwiye kongera kukigarukaho. Bavuga ko inzitizi yo kutagira ububasha n'inyungu izamuwe bwa mbere mu bujurire, ikaba idakwiye kwakirwa, ko kandi urubanza rwajuririwe rwabaye urw'ubucuruzi bisabwe na RWANDA FOAM, ko rukiri imbonezamubano itigeze itanga iyo nzitizi.

[13] Ababuranira Abazungura ba NZISABIRA bavuga ko mu gihe izo nzitizi zaba zakiriwe, urukiko rwakwemeza ko nta shingiro zifite kubera ko RWANDA FOAM idahakana ko NZISABIRA Trojan n'umugore we MUSOMAYIRE Marie bitabye Imana, ko abemerewe kubazungura ari ababakomokaho bajuriye, hakaba hari n'urubanza RC 0040/141/TB/KMB kugera kuri RC 0045/141/TB/KMB rwaciwe n'Urukiko rw'Ibanze rwa KAMEMBE rusimbura inyandiko zabo z'amavuko (jugement supplétif) nk'uko biteganywa mu ngingo ya 86 CCLI, rugaragaza ko bose bakuze, buri wese akaba yaratanz igarama arega.
