Amategeko agenga imiburanishirize y'imanza mbonezamubano – Guhagarika irangizarubanza by'agateganyo – Mu gihe irangizwa ry'urubanza rishobora kononera bamwe mu baburanyi mu gihe baramuka batsinze urubanza baregeye, Urukiko rushobora guhagarika irangiza ry'urubanza mu nyungu z'ubutabera.

Incamake y'ikibazo: Uru rubanza ku nzitizi rukomoka ku rubanza RCA0221/05/HC/KIG - RCA0221/09/HC/KIG rwaburanishijwe mu Rukiko Rukuru rukemeza ko abana bose Karimunda Gérard yabyaranye na Mukasharangabo Eugénie, Nyirakamana Marciana na Mukandori Epiphanie bagomba kumuzungura nta vangura bityo bakagabana umutungo wose uzabuarwa igihe cy'izungura kandi abitabye Imana bakazungurwa n'babakomokaho. Nyirakamana Marciana wari wagobotse muri urwo rubanza ntiyanyuze n'ijo myanzuro maze aza kwiyambaza Urwego rw'Umuvunyi avuga ko urwo rubanza rurimo akarengane. Urwo Rwego rwandikiye Perezida w'Urukiko rw'Ikirenga rumusaba kurusubirishamo ku mpamvu z'akarengane.

Hagati aho ariko, urwo rubanza rwarimo kurangizwa n'uwashinzwe ibyo gushyira mu bikorwa izungura kandi mu byemezo yari ari gushyira mu bikorwa harimo no kugurisha

umutungo wose kugira ngo abazungura babone uko bagabana amafaranga azava mu igurisha. Urukiko rw'Ikirenga rumaze kwandika ikirego, Avoka uhagarariye Karangwa Denis yatanze ikirego cyihutirwa asaba Urukiko gufata icyemezo cy'agateganyo gihagarika irangizwa ry'urwo rubanza mu gihe isubirishamo ryarwo kubera akarengane ritarafatwaho icyemezo ashingiye ku kuba ngo hari inyandiko-mvugo y'inama y'abazungura yabaye hagati ya bamwe gusa kuko hari ubwumvikane buke hagati yabo, igaragaza mu ngingo zayo za 3 na 6 ko inzu iri Gikondo n'indi mitungo itimukanwa bigomba kugurishwa hanyuma bakagabana amafaranga. Yongeraho ko iryo subirishamo ry'urubanza kubera akarengane rishobora kuzavamo icyemezo cy'Urukiko kivuguruzanya n'icy'urubanza ruri kurangizwa, bityo ibyazaba byamaze gukorwa bikaba imfabusa kandi harimo imitungo yaba yaramaze kugurishwa.

Iburanisha ritangiye, Me Twayigize Jean-Claude uhagarariye bamwe mu bazungura baregwa muri urwo rubanza yatanze inzitizi yo kutakira iki kirego cyihutirwa avuga ko kitari mu bwoko bw'ibirego byihutirwa kuko nta kirego remezo kigaragaza ko gishamikiyeho. Yatanze kandi indi nzitizi avuga ko hashingiwe ku ngingo ya 317, 320 na 322 y'Itegeko N°21/2012 ryo ku wa 14/06/2012 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, Urukiko rw'Ikirenga rudafite ububasha bwo gusuzuma ibirego byihutirwa kuko Umushingamategeko atigeze abiteganya kuko kubishyiraho byari kubuza umuburanyi umwe uburenganzi bwo kujurira kuko icyo kirego cyaba kiburanishijwe ku rwego rwa mbere mu Rukiko rw'Ikirenga.

Naho ku byerekeye imizi y'ikirego nyirizina, avuga ko ikirego cyatanzwe nabi kuko urega agaragaza ko icyo yaregeye nta kibazo agifiteho kubera ko irangiza ry'urubanza rrimo gukorwa n'uwashinzwe gushyira mu bikorwa izungura (liquidateur) aryemera ariko akaba yififa gusa ko atagurisha. Akomeza avuga ko inzu iri Gikondo itari kugurishwa ndetse ko nta nzu yigeze igurishwa kuko Uwashinzwe gushyira mu bikorwa izungura akiri mu gihe cyo kumenya abazungura bose no kuzakorana nabo bikaba bitumvukana ukuntu urega we badakorana.

Me Hakizimana John Uhagarariye urega avuga ko ibyavuzwe n'abaregwa nta shingiro bifite kuko ikirego remezo gihari kandi ko ababuranyi muri uru rubanza rurebana n'ikirego cyihutirwa ari bamwe n'abo mu kirego remezo. Bityo umuburanyi watanze icyo kirego ashobora gusaba urukiko gutegeka mu buryo bwihutirwa ihagarikwa ry'irangizarubanza ry'agateganyo.

N'ubwo Urwego rw'Umuvunyi airwo ruregera Urukiko rw'Ikirenga ibirego byerekeranye no gusubirishamo ku mpamvu z'akarengane urubanza rwaciwe ku rwego rwa nyuma, ariko igihe cyo kuburanisha bene ibyo birego, ababuranyi baguma ari ababuranye urubanza rusubirishwamo ku mpamvu z'akaregane ndetse ni nabo batanga imyanzuro yo kurega n'iyo kwiregura. Bityo ababuranyi mu rubanza rwihiutirwa RC0005/15/CS ni nabo bari ababuranyi mu rubanza remezo RS/REV/INJUST/CIV0007/15/CS uretse Urwego rw'Umuvunyi rutari umuburanyi muri zo manza.

4. Kuba Urukiko rw'Ikirenga rufite ububasha bwo kuregerwa ibirego byerekeranye no gusubirishamo ku mpamvu z'akarengane imanza zaciwe ku rwego rwa nyuma, byumvikana nta gushidikanya ko, nk'Urukiko rwaregewe urubanza rw'iremezo rutaraburanishwa n'izindi nkiko, runafite ububasha bwo gusuzuma ibirego byihutirwa bishamikiye ku kirego cy'iremezo kiba cyarugejejweho.
