KAMBA General Merchandise Ltd yajuririye uwo mwanzuro mu Rukiko Rukuru rw'Ubucuruzi isaba ko umusoro ungana na 22.957.627Frw wavanwa mu musoro yishyuzwa kubera ko adakomoka ku bucuruzi ahubwo ari ingwate yatangwaga n'abaguzi. Urwo Rukiko rwemeje ko umusoro ungana na 22.957.627Frw uvanwa mu wemejwe na Komiseri Mukuru, rutegeka kandi RRA kwishyura indishyi z'ikurikiranarubanza n'igihembo cya Avoka no gutanga amagarama y'urubanza.

RRA ntiyishimiye icyo cyemezo akijuririra mu Rukiko rw'Ikirenga avuga ko igenzura ku musoro ryakorewe KAMBA General Merchandise Ltd riri mu bwoko by'isoresha rikorwa hakoreshejwe inyandiko y'ikosora aho mu kubara umusoro hagenderwa ku mahame remezo y'ibaruramari kuko mbere y'uko amafaranga ajyanwa muri Banki agomba kubanza gushyirwa mu bitabo byerekana ko yanyuze muri "caisse", ariko ko kubirebana n'uru rubanza, amafaranga yajyanywe muri Banki atanyujijwe muri "caisse" ari nayo mpamvu agomba gusoreshwa. Ikindi kandi iyo ayo amafaranga aza kuba ingwate hari kugaragara "bordereaux" za banki zibyemeza. Ikindi cyerekana ko atari ingwate ni uko bamwe mubo avuga ko batanze ayo mafaranga atayabasubizaga yose, kandi KAMBA General Merchandise Ltd ivuga ko ayo abakiriya basubijwe adahura n'ayo yakiriye.

KAMBA General Merchandise Ltd yiregura ivuga ko kubika amafaranga y'ingwate kuri banki no gusubiza uje kuyaka hakoreshejwe ari muri caisse nta kosa ririmo. Isobanura kandi ko icyangombwa ari uko amafaranga aba ahari kugira ngo uwatanze ingwate ashobore kuyasubizwa igihe ashakiye.

KAMBA General Merchandise Ltd isoza isaba indishyi z'ikurikiranarubanza n'igihembo cy'Avoka kubera gushorwa mu manza nta mpamvu.

KAMBA General Merchandise Ltd ntiyishimiye umwanzuro w'abagenzuzi, ijuririra Komiseri Mukuru, nawe asubiza ku wa

10/01/2012, ayimenyeshya ko 2.790.000Frw yasubijwe Kigali Multi Choice Ltd avanywe mu musoro wishyuzwa, ikishyura 34.825.340Frw.

[2] KAMBA General Merchandise Ltd ntiyishimiye uwo mwanzuro iregera Urukiko Rukuru rw'Ubucuruzi isaba ko umusoro ungana na 22.957.627Frw uvanwa mu wemejwe na Komiseri Mukuru kubera ko ari amafaranga adakomoka ku bucuruzi ahubwo ari ingwate (caution) abaguzi bashyira kuri konti yayo mu gihe bagitegereje ibicuruzwa.

[6] Asobanura ko igenzura ry'ibitabo by'ibaruramari bigaragaza ko hari amafaranga KAMBA General Merchandise Ltd yita ingwate (caution) y'abaguzi yashyize kuri konti yayo, abo baguzi bayasubizwa bamaze guhabwa ibicuruzwa, nyamara umusororesha akaba agaragaza ko ayo mafaranga atari ingwate (Caution) kubera ko Kamugisha, nyiri KAMBA General Merchandise Ltd, na Sibomana Augustin, Umujyanama wayo mu by'imisoro (Tax Advisor) babwiye abagenzuzi b'imisoro ko, kubera ko amafaranga y'ingwate atari ayabo, bayakiraga mu ntoki (cash), nyuma bakayajyana kuri Banki atanyuze muri "caisse", aribyo bituma ayo mafaranga atagaragara mu bitabo byabo by'ibaruramari.

Asobanura ko Komiseri Mukuru yagejejweho icyo kibazo akemeza ko umusoro ungana na 2.621.716Frw uvanwa mu waciwe ariko ikibazo nyamukuru cy'uko umusoro waciwe hirengagijwe amategeko ntagikemure, ari nacyo cyatumye Kamba General Merchandise Ltd iregera Urukiko Rukuru rw'Ubucuruzi kugira ngo hasuzumwe niba amafaranga y'ingwate yasubijwe beneyo akwiye gusoreshwa nk'akomoka ku bikorwa by'ubucuruzi.

by'ibaruramari byerekana ko hari amafaranga angana na 26.825.000Frw yatanzwe mu ntoki (cash) n'abaguzi ba Kamba General Merchandise Ltd nk'ingwate kugira ngo bazahabwe ibicuruzwa, ayo mafaranga akaba yarashyizwe kuri banki asubizwa ba nyirayo ku mataliki atandukanye anyujijwe muri caisse (Cote 5), kandi ko hanabaye iperereza ryakozwe n'Ikigo cy'Imisoro n'Amahôro kugira ngo hamenyekane umusoro ugomba kwishyurwa hagendewe ku byagaragajwe n'ibaruramari KAMBA General Merchandise Ltd yakoze (Cote 20-21).

[17] Me Gasana Raoul avuga ko ibijyanye n'indishyi z'ikurikiranarubanza n'igihembo cya Avoka zisabwa na KAMBA General Merchandise Ltd byasuzumwa mu bushishozi bw'Urukiko kuko zisabwa zishingiye ku kirego cy'iremezo cyatanzwe.

## **UKO URUKIKO RUBIBONA**

[18] Urukiko rurasanga kuba KAMBA General Merchandise Ltd yararezwe mu Nkiko byatumye igira ibyo itakaza mu gukurikirana uru rubanza ndetse biba ngombwa ko yiyambaza na Avoka uhembwa, bityo hashingiwe ku ngingo ya 258 y'Igitabo cya Gatatu cy'Urwunge rw'Amategeko Mbenezamubano, iteganya ko "igikorwa cyose cy'umuntu cyangirije undi, gitegeka nyiri gukora ikosa rigikomokaho kuriha ibyangiritse", KAMBA General Merchandise Ltd ikaba igenewe, kuri uru rwego, amafaranga ibihumbi magana atanu (500.000Frw) y'ikurikiranarubanza n'igihembo cya Avoka.
