Incamake y'ikibazo: Nyuma y'igenzura ryakorewe Muhire, RRA yamumenyesheje ko agomba kwishyura umusoro ungana na 32.957.990Frw ukubiyemo umusoro ku nyungu no ku nyongeragaciro ku myaka itandukanye atari yarishyuye. Muhire yatakambiye Komiseri Mukuru amusaba kurenganurwa ariko mu ibaruwa yo kuwa 16 Gicurasi 2012 asubizwa ko itakamba rye nta shingiro rifite.

Muhire yaregeye Urukiko Rukuru rw'Ubucuruzi avuga ko umusoro ku nyongeragaciro wo mu mwaka wa 2005, 2006 n'uwa 2007 itagishoboye kwishyurwa kuko RRA itawukurikiranye mbere y'uko habaho ubusaze ndetse ko mu kumwishyura umusoro ku nyungu RRA yabariye amafaranga y'inguzanyo mu nyungu zisoreshwa. Urukiko rwemeje ko ubusaze bw'umusoro ku nyongeragaciro butasuzumwa kuko uwo musoro utigeze ujurirwa kwa Komiseri Mukuru. Rwemeje kandi ko amafaranga Muhire yagurijwe atagombaga gukurwa mu byacurujwe usibye gusa umwenda wa 10.177.083Frw mu byacurujwe muri 2007.

RRA yajuririye mu Rukiko rw'Ikirenga ivuga ko Urukiko Rukuru rwirengagije ibisobanuro byatanzwe kuri 10.177.083Frw yemejwe ko agomba gukurwa mu byacurujwe. Yongeyeho ko mu ngingo zose Muhire yaregeye imwe gusa ariyo yatsindiye bityo akaba atari kugenerwa igihembo cya Avoka.

Muhire yasubije ko 10.177.083Frw ari ayo yagurijwe n'uwitwa Kwitonda nk'uko bigaragaraga mu ibaruwa yasubije RRA abyemera.

Muhire yatanze ubujurire bwuririye ku bundi avuga ko atagombaga kwishyuzwa imisoro ya 2005 na 2006 kuko kuba RRA itaragenzuye ko yakoze neza imenyekanisha mu gihe cy'imyaka 3 yatakaje ubwo burenganzira bituma umusoro uba ndakuka akaba atagomba gucibwa undi muri iyo myaka.

Kuwa 20/03/2012, Muhire Jean-Pierre yatakambiye Komiseri Mukuru asaba kurenganurwa, kuwa 16/05/2012, Komiseri Mukuru amusubiza ko ubujurire bwe nta shingiro bufite.

[2] Muhire Jean-Pierre yaregeye Urukiko Rukuru rw'Ubucuruzi, maze mu rubanza N° RCOM0160/12/HCC rwo kuwa 07/01/2013, rwemeza ko ubusaze bw'umusoro wa TVA w'umwaka wa 2005 (ukwezi kwa mbere kugeza mu kwezi kwa cumi na kumwe) butasuzumwa kubera ko uwo musoro utari ndakuka kubera ko Muhire Jean-Pierre atigeze abijuririra kwa Komiseri Mukuru¹.

[3] Rwemeje kandi ko 9.000.000Frw, Muhire Jean-Pierre yavuze ko yagurijwe n'uwitwa Kayijuka Alphonse, atagombaga gukurwa mu byacurujwe mu mwaka wa 2005; rwemeza ko 7.350.432Frw yavuze ko yishyurwa na MINAGRI, hamwe na 4.863.500Frw yavuze ko yatunze umwuga, adakurwa mu nyungu zisoreshwa mu mwaka wa 2006. Rwemeza ko 10.177.083Frw akurwa mu byacurujwe muri 2007, maze Muhire Jean-Pierre agenerwa 300.000Frw y'igihembo cya Avoka.

[7] Me Byiringiro Bajeni, uhagarariye Ikigo cy'Imisoro n'Amahôro (RRA), avuga ko Urukiko Rukuru rwirengagije imburanire ya RRA ku bijyanye n'umusoro wa 10.177.083Frw wo mu mwaka wa 2007 Muhire Jean-Pierre avuga ko yagurijwe n'uwitwa Kwitonda Jean de Dieu. Asobanura ko amasezerano Muhire Jean-Pierre ashingiraho, Kwitonda Jean de Dieu yayahakanye mu ibaruwa yandikiye RRA kuwa 14/9/2010, kandi ibikubiye muri ayo masezerano bikaba bitandukanye cyane n'ibisobanuro Kwitonda Jean de Dieu ubwe yahaye RRA mu ibaruwa ye yo kuwa 8/1/2010 kuko mu masezerano, Muhire Jean-Pierre avuga ko Kwitonda yamugurije amafaranga, akavuga ko Kwitonda azajya amwungukira 1.000.000Frw kandi ariwe wamugurije, nyamara mu ibaruwa ye Kwitonda Jean de Dieu avuga ko yahaye Muhire Jean-Pierre mu ntoki, uyu akajya amwishyura amafaranga cyangwa "ciment" kuko yubakaga. Asoza avuga ko umukono wa Kwitonda Jean de Dieu uri kuri ayo masezerano ntaho uhuriye n'ugaragara ku mbaruwa yavuzwe haruguru kimwe no ku ndangamuntu ye.

[8] Me Nsengiyumva Abel, uhagarariye Muhire Jean-Pierre, avuga ko 10.177.083Frw, Muhire Jean-Pierre yayagurijwe n'uwitwa Kwitonda Jean de Dieu, Urukiko rukaba rwarashingiye ku masezerano y'imikoranire yo kuwa 4/1/2007 agaragaza ko yayamugurije kugira ngo abashe kurangura isima muri CIMERWA. Akomeza avuga ko RRA yandikiye Kwitonda Jean de Dieu imubaza niba koko yarahaye Muhire Jean-Pierre ayo mafaranga, asubiza abyemeza, bityo akaba asanga iyo ngingo y'ubujurire bwa RRA nta shingiro yahabwa.

[12] Nk'uko bigaragara muri dosiye y'urubanza, Muhire Jean-Pierre yagiranye amasezerano y'imikoranire na Kwitonda Jean de Dieu ku wa 4/1/2007 aho bumvikanye ko Kwitonda Jean de Dieu yahaye Muhire Jean-Pierre amafaranga miliyoni icumi n'ibihumbi ijana na mirongo irindwi na birindwi (10.177.000Frw) kugirango abashe kugura sima muri Cimerwa yo gucuruza, ko azajya ayigura, akayiha Kwitonda Jean de Dieu akayicuruza ku buryo bwa “détail” ku giciro cyemewe na Cimerwa kandi akayitanga ku izina rya Muhire Jean-Pierre, Kwitonda Jean de Dieu akajya yungukira Muhire Jean- Pierre amafaranga angana na miliyoni imwe (1.000.000Frw) ku mifuka ya sima 100, aya masezerano akazarangira mu gihe cyose Muhire Jean-Pierre azaba amusubije amafaranga ye y'ikiranguzo (+ ou - 10.177.083Frw).

[21] Hakurikijwe ibiteganywa n'iyi ngingo ya 258 yavuzwe haruguru, kuriha igihombo (ibyangiritse) bigomba gukorwa mu buryo bwuzuye (intégrale ou complète) ariko kugira ngo bishoboke icyo gihombo kigomba kugaragarizwa ibimenyetso.

[23] Urukiko rw'Ikirenga rurasanga nta makosa Urukiko Rukuru rw'Ubucuruzi rwakoze rugenera Muhire Jean-Pierre amafaranga y'igihembo cya Avoka yari yasabye, rushingiye ku ngingo ya 258 y'Igitabo cya gatatu cy'urwunge rw'amategeko mbonezamubano kuko byabaye ngombwa ko ashaka Avoka umuhagararira nk'uko byagaragaye igihe cy'iburanisha kandi yatsindiye bimwe mu birego yari yatanze. Rurasanga kandi kuba Ikigo cy'Imisoro n'Amahôro (RRA) na Muhire Jean-Pierre baratsindaguranye atari impamvu yari gutuma atagenerwa igihembo cya Avoka yari yasabye mu gihe bigaragara ko hari Avoka wamuhagarariye mu rubanza.

[25] Me Nsengiyumva Abel avuga ko Ingingo ya 27 y'Itegeko N°25/2005 ryo kuwa 4/12/2005 rigena imitunganyirize y'isoresha iteganya ko Ubuyobozi bw'Imisoro bwari bufite uburenganzira bwo kugenzura ko Muhire Jean-Pierre yakoze neza imenyekanisha mu gihe cy'inyaka itatu, ko kuba RRA itararikoze yatakaje ubwo burenganzira, umusoro yamenyekanishije ukaba warabaye ndakuka, bityo nta wundi agomba gucibwa muri icyo myaka yombi.

[26] Ku byerekeranye no kuba Umucamanza yaranze gusuzuma icyo ngingo (mu gace ka 7 k'urubanza) kubera ko itavuzwe mu bujirire bwatanze kwa Komiseri Mukuru, Me Nsengiyumva Abel asobanura ko Muhire Jean-Pierre atigeze ahindura ikirego (demande nouvelle), ko ahubwo ari uburyo bushya (moyen nouveau) bwo gusobanura ko RRA idakwiye kwishyura imisoro ku nyongeragaciro yo mu mwaka wa 2005 n'icyo mu mwaka wa 2006.

[27] Me Byiringiro Bajeni yiregura asaba uru Rukiko kudasuzuma icyo ngingo kuko asanga ari ikirego gishya. Asobanura ko Muhire Jean-Pierre atayijuririyeye kwa Komiseri Mukuru nk'uko biteganywa n'amategeko y'imisoro, bivuze ko yari yemeye icyo cyemezo.

[28] Me Byiringiro Bajeni avuga ko Urukiko ruramutse rusanze ari ngombwa ko runabisuzuma, asanga na none nta gaciro rwabiha kuko Muhire Jean-Pierre yashyikirijwe inyandiko imumenyeshya ko azakorerwa igenzura ry'imisoro y'icyo myaka ku itariki ya 23/12/2008, kandi ikaba itari yagashaje. Akomeza avuga ko ubwo busaze bwahagaritswe n'inyandiko yashyikirijwe ku wa 16/2/2011 kuko umunsi wa nyuma wari itariki 23/12/2011.
