Ntukamazina yaregeye Urukiko rw'Ikirenga asaba ko rwa kemura izo impaka zavutse mwiragiza ryurwo rubanza ,akasaba ko urwo rukiko rwafata icyemezo rugategeka Prime Insurance Ltd kurangiza urwo rubanza, akanasaba ko Prime Insurance Ltd yahabwa igihano kiyihatira kurangiza urubanza hamwe n'indishyi zo gushorwa mu manza nta mpamu n'igihembo cy'Avoka.

Prime Insurance Ltd yatanze ingoboka ijyanye no gukobokesha Ikigo cy'Imisoro n'Amahoro (RRA) n'Ikigo cy'Ubwiteganyirize bw'Abakozi (RSSB) ivuga ko nibyo byatumye urubanza rutarangizwa kuko hari amafaranga yabyo yagombaga kuvanwa mu yemejwe n'Urukiko. Kuri iyi ngoboka, Ntukamazina avuga ko nta nyungu Prime Insurance Ltd ifite yo kugobokesha RRA na RSSB.

Urukiko rwahise rusuzuma iyo ngoboka maze rusanga iryo gobokeshwa ritakwemerwa, bityo rufatira icyemezo mu ntebe cyokutaryakira, iburanisha mu mizi rirakomeza.
