Ibi byatumye BCDI SA imuha gusa 7.516.953Frw nayo ataramufashije kurangiza kubaka inzu ye bituma asaba kongererwa umwenda. Mbere y'uko ahabwa igisubizo ku nyongera yari amaze gusaba, BCDI yamwisyuje 8.527.976Frw y'inyungu. Hagati aho igisubizo ku nguzanyo y'inyongera yagihawe nyuma y'amezi 11 kandi kitayimwemerera, ahubwo Banki ihita imusaba nta nteguza kuyishyura umwenda wose wari umaze kugera kuri 73.836.942Frw.

Mu rwego rwo kwishyura uwo umwenda, Ntegeye Bernard yagiranye amasezerano na Banki, bemeranywa ko ayeguriye inyubako ye n'ibikoresho byari aho, byose hamwe bifite agaciro ka 45.607.038Frw, hasigara umwenda uhwanye na 28.232.000Frw. Bemeranyijwe na none ko Banki miramuka ishatse kugurisha iyo nzu, Ntegeye Bernard afite uburenganzira bwo kugura mbere y'abandi (droit de préemption/préférence) mu gihe cy'imyaka icumi (10). BCDI SA ntuyubahirije amasezerano maze kuwa 11/04/2003, igurisha iyo nzu Banki Nkuru y'u Rwanda, itamenyesheje Ntegeye Bernard.

Ntegeye Bernard yaregeye Urukiko Nkemurampaka avuga ko BCDI S.A yishe y'amasezerano bagiranye, imugurishiriza inzu itabimubwiye, bityo asaba ko igurisha ryateshwa agaciro agahabwa uburenganzira bwo kugura mbere y'abandi, guca BCDI S.A. indishyi n'inyungu. Yagobokeshe kandi Banki Nkuru y'u Rwanda avuga ko icyemezo cyose cyafatwa cyayigiraho ingaruka.

Urukiko Nkemurampaka rwanzuye ko BCDI S.A. itshe amasezerano, ko rusanga nta mpamvu Banki Nkuru y'u Rwanda yagobokesha ndetse ko ibyo kuburanisha uburenganzira bwo kumenyeshwa ubugure «droit de préférence», Ntegeye Bernard aburanisha, ari amagambo gusa (théorie) kuko bigaragara ko atashoboraga kuyigura mu gihe yananiwe kwishyura umwenda wa banki. Rwemeje cyakora ko Banki yateshutse ku nshingano zayo zo kumumenyesha iby'iryo gurisha, ruyitegeka kubitangira indishyi za 5.000.000Frw.

Ntegeye ntuyishimiye icyo cyemezo, aregera Urukiko Rukuru avuga ko Urukiko Nkemurampaka rwakoze ikosa ryo kwakira ikirego cyo kwiregura cya BCDI S.A. bituma

rumutegeka kwishyura iyo Banki umwenda ungana na 28.232.000Frw kandi cyari ikirego kigomba gutangwa ukwacyo mu rundi rukiko rubifitiye ububasha kuko icyo kirego kitakwitiranwa no kwiregura (défense au fond). Yavuze kandi ko Urukiko rwitiranyije ibintu kuko amabwiriza ya Banki Nkuru y'u Rwanda adakuraho amasezerano yabaye hagati ye na banki. Uru Rukiko rwemeje ko Ntegeye yari afite aho abarizwa hazwi na BCDI S.A. ku buryo itari kumubura kugira ngo imumenyeshe ko inzu ye igiye kugurishwa kandi ko inzu igurishwa, igihe cy'emyaka 10 kiri mu masezerano cyari kitararangira ku buryo byafatwa nk'aho Ntegeye yatakaje uburenganzira bwo kumenyeshwa igurisha, bityo rusesa ayo masezerano y'ubugure atamenyeshejwe.

Urukiko Rukuru rw'Ubucuruzi kandi rwemeje ko nta mwenda Ntegeye akibereyemo BCDI S.A. ndetse rumugenera indishyi mbonezamusaruro n'iz'akababaro.

BCDI S.A. na Banki Nkuru y'u Rwanda bajoririye icyo cyemezo mu Rukiko rw'Ikirenga bavuga ko uru rukiko rwemeje iseswa ry'amasezerano y'ubugure kandi bitarasabwe n'urega, ko rwavuze ko nta mwenda abereyemo BCDI S.A. kubwo kudasobanukirwa n'imikorere y'amabanki kubirebana n'uburyo umwenda n'inayungu zose ziwukumokaho bibarwa.

Urukiko rw'Ikirenga rwanzuye ko Ntegeye agifitiye BCDI S.A. umwenda rumutegeka kuyishyura 48.102.687Frw, bituma yandikira Umuvunyi Mukuru amusaba gusuzuma akarengane kabaye mu rubanza maze Umuvunyi Mukuru yandikira Perezida w'Urukiko rw'Ikirenga amusaba ko urubanza rwasubirishwamo ku mpamvu z'akarengane.

Iburanisha rigitangira, ECOBANK Rwanda Ltd yibukije initzizi yatanze yo kutakira ikirego cya Ntegeye kubera ko nyuma y'icibwa ry'urubanza mu Rukiko rw'Ikirenga bumvikanye ku irangizwa ryarwo kandi impande zombi zemeranywa ko ntawuzatesha agaciro amasezerano yo kwikiranura bagiranye. Ntegeye we yiregura avuga ko amasezerano bagiranye ari ayo kurangiza urubanza atari ayo kwikiranura.

Ntegeye Bernard avuga ko 7.516.953Frw yasigaye atashoboye kurangiza kubaka inzu ye bituma asaba kongererwa umwenda. Mbere y'uko ahabwa igisubizo, Banki imwishiya 8.527.976Frw y'inyungu, igisubizo ku nguzanyo y'inyongera kiza nyuma y'amezi 11 kimwangira inyongera y'umwenda yari yasabye, ahubwo asabwa guhita yishyura umwenda wose wari umaze kugera kuri 73.836.942Frw nta nteguza.

[6] Ntegeye Bernard ntiyishimiye icyo cyemezo, aregera Urukiko Rukuru avuga ko Urukiko Nkempurampaka rwakoze ikosa ryo kwakira ikirego cyo kwiregura cya BCDI S.A bituma rumutegeka kwishyura iyo Banki umwenda ungana na 28.232.000Frw kandi cyari ikirego kigomba gutangwa ukwacyo mu rundi rukiko rubifitiye ububasha kuko icyo kirego kitakwitiranwa no kwiregura (défense au fond). Yavuze kandi ko Urukiko rwitiranyije ibantu kuko amabwiriza ya Banki Nkuru y'u Rwanda adakuraho amasezerano yabaye hagati ye na banki.

II. IBIBAZO BIGIZE URU RUBANZA N'ISESENGURA RYABYO

[16] Me Munyanza Remy uburanira ECOBANK Ltd avuga ko nyuma y'icibwa ry'urubanza mu Rukiko rw'Ikirenga, impande zombi zagiranye amasezerano yo kwikiranura (acte transactionnel), buri ruhande rugira icyo rwigomwa, ECOBANK Rwanda Ltd yemera guhara 14.102.687Frw, ihagarika n'imihango y'irangizarubanza yari yatangije, igamije gukumira ko ururabanza rwazasubirishwamo ingingo nshya cyangwa ku mpamvu z'akarengane, bumvikana ko nta ruhande ruzasaba ko ayo masezerano ateshwa agaciro, ayo masezerano akorwa ECOBANK Rwanda Ltd itazi ko Ntegeye Bernard yiyambaje Urwego rw'Umuvunyi, bityo akaba asaba uru Rukiko gushingira ku ngingo ya 583 y'Igitabo cya gatatu cy'urwunge rw'amategeko mbonezamubano, rukemeza ko ikirego kitakiriwe.

[17] Me Cyiza Clément, Me Murego Jean-Léonard na Me Byiringiro Jacques, baburanira Banki Nkuru y'u Rwanda, bavuga ko amasezerano y'ubwumvikane yari agamije kurangiza urubanza rwaciwe n'Urukiko rw'Ikirenga, Ntegeye Bernard ayashyiraho umukono abifitiye ububasha n'ubushobozzi kandi azi ko ingaruka zayo ari ukwikiranura na ECOBANK Ltd kugirango imitungo ye idatezwa cyamunara, bituma ECOBANK Ltd inwemerera kwishyura make kuyo yari yategetswe mu rubanza, bakaba basaba uru Rukiko kwemeza agaciro k'amasezerano yo kwikiranura, ikirego cya Ntegeye Bernard nticyakirwe.

[18] Ntegeye Bernard avuga ko ariwe wasabye kumvikana na banki, ECOBANK Rwanda Ltd yemera ko yishyurwa 34.000.000Frw kubera ko yari izi ko ari ay'ubusa, ayatanga agamije gukumira cyamunara ku bintu bye bifite agaciro, ibyo bikaba ntaho bihuriye n'ibyo kurenganurwa yari yasabye Urwego rw'Umuvunyi.

[19] Me Mubangizi Frank wunganira Ntegeye Bernard avuga ko kurangiza urubanza bidakwiye kwitiranywa no kurusubirishamo ku mpamvu z'akarengane, ko kwita amasezerano yakozwe ayo kwikiranura byaba ari ukuyahindurira inyito kuko nta kwikiranura kwabayeho ahubwo icyabaye ari ukurangiza urubanza. [20] Me Zawadi Stephen nawe uburanira Ntegeye Bernard, avuga ko akarengane karegewe Umuvunyi Mukuru karenze amasezerano y'ubwumvikane, ko ibyabaye hagati ya Ntegeye Bernard na ECOBANK Rwanda Ltd byari uburyo bwo kurangiza urubanza Ntegeye Bernard adahutajwe, amasezerano y'ubwumvikane agabanya ikintu gito cyane ku karengane kariho kandi ko amasezerano ashirwaho umukono, ECOBANK Rwanda Ltd yari ifite ibaruwa Ntegeye Bernard yandikiye Urwego rw'Umuvunyi, akaba asanga uru Rukiko ntacyo rufite cyo gusuzuma kubirebana na "acte transactionnel" ahubwo rukwiye kwakira ikirego rwashikirijwe, Ntegeye Bernard akarenganurwa aho akirengana.

- 1° iyo hari ibimenyetso simusiga bigaragaza ruswa, ikimenyane cyangwa icyenewabo, byagize ingaruka ku mikirize y'urubanza bikaba bitarigeze bimenywa n'uwartsinzwe mu gihe cy'iburana;
- 2° iyo mu icibwa ry'urubanza hirengagijwe amategeko n'ibimenyetso bigaragarira buri wese;
- 3° iyo urubanza rudashobora kurangizwa ukurikije imikirize yarwo.”

Ntawe ushobora gusaba ko ateshwa agaciro yitwaje ko yibeshey e kubyo amategeko ateganya, cyangwa se yitwaje ko yahenzwe”.

[25] Dosiye igaragaza kandi ko Urukiko rw'Ikirenga rwasuzumye ubujurire bwa Banki Nkuru y'u Rwanda bwasabaga kwemeza ko nta nenge iri mu masezerano y'ubugure bw'inzu yagiranye na ECOBANK Rwanda Ltd, Urukiko rusanga ubwo bujurire bufite ishingiro, naho ku bujurire bwuririye ku bundi bwa Ntegeye Bernard wasabaga ko hasuzumwa niba amasezerano yagiranye na ECOBANK Rwanda Ltd yaruhabirijwe, rwemeza ko ikirego cye kitakiriwe kuko kitigeze gisuzumwa n'Inkiko zibanza.
