TOTAL RWANDA S.A.R.L/ENGEN RWANDA Ltd yaregeye Urukiko Rukuru rw’Ubucuruzi isaba kuvanirwaho uwo musoro kuberako TOTAL OUTRE MER yaragurishije imigabane yari ifite muri TOTAL RWANDA S.A.R.L, ibyo bikaba bitandukanye no kugurisha umutungo wa sosiyete ugizwe n’ibantu bitandukanye kandi icyo gikorwa kikaba kidasoreshwa. [16] Basobanura kandi ko impamu mu baregwa harimo ENGEN RWANDA Ltd,byatewe n'uko TOTAL RWANDA S.A.R.L yaburiwe irengero ahubwo haboneka ENGEN RWANDA, ko ariko n'ubwo yaburiwe irengerero mu buryo bw`impapuro, ibikorwa byayo bighari, ikaba kandi yaragombaga kumenyesha RRA ko ihinduye statuts, igakorerwa igenzura nk'uko biteganya n'ingingo ya 10 y'Itegeko N°25/2005 ryavuzwe haruguru, ko kandi kuba mu rwego rw'amategeko TOTAL RWANDA ikiriho, kuko hari inshingano yasize itarangije kandi hari imitungo zarangirizwaho, itegeko rigenga umusoro ku nyongeragaciro (TVA) rikaba ryemera ko icibwa umusoro ujyanye n'igurisha ryakozwe.

[17] Ababuranira TOTAL RWANDA SARL /ENGEN RWANDA Ltdbavuga ko nta gishya RRA yazanye mu bujurire, kuko amasezerano yakozwe asobanura neza ko icyagurishijwe ari imigabane kandi n'Itegeko rigenga amasosiyete riteganya uburyo igurisha ry'imigabane rikorwa (art 75), TOTAL OUTRE MER ikaba yaragurishije uburenganzira yari ifite muri TOTAL RWANDA SARL, bitandukanye no kugurisha umutungo wa sosiyete ugizwe n'ibantu bitandukanye (amamodoka, ibibanza, ama konti, n'ibindi), ko Momar wari ufite umugabane umwe yemeye ko igurisha riba, sosiyete ikaba yarasigaye kuko imigabane itari iyayo, isigarana umutungo wayo ugizwe n'ibantu bitandukanye (ibibanza, amamodoka, biens réalisables, stock ya essence...), ko ahubwo bibaza icyo TOTAL RWANDA S.A.R.L yagurishije cyatuma icibwa umusoro mu gihe uwagurishije ari TOTAL OUTRE MER.

[18] Bavuga ko iyo haza kuba haragurishijwe umutungo wa TOTAL RWANDA S.A.R.L, RRA yari kubarira umusoro ku gaciro kawo kari karenze miliyari esheshatu z'amafaranga y'u Rwanda, ukaba utari kugurishwa miliyonu ebyiri zonyine, ko kandi igurisha ry'imigabane ryanabaye mu yandi masosiyete ariko akaba ataraciwe umusoro, RRA ikaba rero itagomba kwitiranya igurisha ry'imigabane n'iry'umutungo, kuko wo ari uwa sosiyete nkuko byemeranyijweho mu rubanza rwaciwe n'Urukiko rw'Ikirenga rwo mu Bwongereza, haburana Macaura v Nothem Assurance company, ndetse no mu rubanza rwaciwe n'Urukiko Rusesa imanza rwo mu Bufaranga haburana sosiyete Beauvallet v sosiyete Naturana, ko n'ingingo ya 8 y'Itegeko ryagengaga amasezerano ubwo igurisha ryabaga nayo yateganyaga ko sosiyete igira umutungo wayo bwite.

[19] Basobanura kandi ko impamu ENGEN RWANDA Ltd yasabye ko umutungo uyandikwaho byatewe n'uko izina rya sosiyete ryari ryahindutse nk'uko byari byemeranyijweho mu ngingo ya 4 y'amasezerano kuko, nka "propriété intellectuelle" ya TOTAL, iryo zina ritari mu byagurishijwe, bakanavuga ko TOTAL RWANDA S.A.R.L na ENGEN RWANDA Ltd zitigeze zibaho nka sosiyete ebyiri zitandukanye, kandi sosiyete imwe ikaba itakwigurishaho imitungo, ko ahubwo "états financiers" za ENGEN ari nazo za TOTAL RWANDA, yahindutse ENGEN.

[20] Ku birebana n'ingingo ya 6.4.1 y'amasezerano RRA iburanisha, bavuga ko n'ubwo sosiyete itandukanye n'abanyamigabane bayo ikanagira imitungo yayo, iyo abanyamigabane bemeje gushora imari muri sosiyete baba bagamije ko ikora ubucuruzi mu nyungu zabo (avoir des dividendes), ko rero na ENGEN INTERNATIONAL yagombaga kumenya uko sosiyete ihagaze n'ubwo itari igiye kugura imitungo yayo. Bavuga kandi ko kuba hari ibyo TOTAL RWANDA S.A.R.L yabujijwe gukora itabiherewe uburenganzira na ENGEN INTERNATIONAL, kwari ukugira ngo uko sosiyete ihagaze bidahinduka mu gihe ihererekanya ry'imigabane ritrarangira. [22] Basanga kandi "notion" ya "corporate veil" itashingirwaho, kuko itegeko ariryo rishyiraho umusoro nk'uko biteganywa n'ingingo ya 81 y'Itegeko Nshinga, hakaba hatanashingirwa ku ngingo ya 4 y'Itegeko N°16/2005 ryo kuwa 18/08/2005 ryavuzwe haruguru kuko ivuga icyagurishijwe ku butaka bw'u Rwanda, usibye ko iyo iba ikemura ikibazo gihari, RRA itari gusaba ko hakoreshw "notion" ya "corporate veil".

[24] Inshuti y'Urukikonayo yatanze ibitekerezo ku kibazo kiri mu rubanza, aho yagaragaje, ishingiye ku ngingo za 4 na 37 z'Itegeko N°16/2005 ryo kuwa 18/08/2005 rigena imisoro itaziguye ku musaruro, ko niba igikorwa cyakozwe ari icy'ubucuruzi cyabyaye inyungu ku musaruro ukomoka mu Rwanda, umusoro ku nyungu ugomba gutangwa, ko kandi igikorwa gifatwa nk'icy'ubucuruzi igihe gikozwe n'umuntu cyangwa sosiyete ku buryo bwa kinyamwuga, ku birebana na TOTAL RWANDA S.A.RL, akaba asanga ibikorwa byagiye bibaho ari uguhererekanya imigabane muri iyo sosiyete yaje guhinduka ENGEN RWANDA Ltd, ibyo kandi bikaba atari ibikorwa by'ubucuruzi kuko bitakozwe na sosiyete isanzwe ikora ibikorwa byo gucuriza imigabane mu rwego rwo gushaka inyungu, ko no guhindura izina atari igikorwa cy'ubucuruzi cyabyarira ugikoze inyungu, n'ubwo ibyo bitavanaho uburyozwe ku musoro TOTAL RWANDA S.A.R.L yaba ifite nka sosiyete y'ubucuruzi.

[28] RRA isanga kandi kuvuga ko habaye ihererekanya ry'imigabane gusa binyuranye n'ibyo ababuranira TOTAL RWANDA bavuga ndetse n'ibimenyetso bihari byerekana ko ari imitungo yagurishijwe, ko ikibazo Inshuti y'Urukiko yagombaga gusesengura ari ukumenya niba haragurishijwe imigabane cyangwa umutungo, bitewe n'uko sosiyete yose yagurishijwe, hakibazwa niba muri icyo gihe n'imitungo yayo itaba igurishijwe, bityo umusoro ukaba wabarwa mu buryo bumwe n'ubw'inyungu z'umuntu ku giti cye, naho ku birevana na TVA hagashingirwa ku ngingo ya 3 y'Itegeko N°06/2001 riyishyiraho, irebewe hamwe n'iya 4.1 hamwe n'iya 85.16 z'iryo tegeko, ko kandi kuba kugurisha imitungo atari ko kazi abaregwa basanzwe bakora bitabakuraho inshingano yo kwishyura TVA mu gihe hari ikiguzi babonye.

[32] Amasezerano yakozwe kuwa 30/07/2008, agaragaza ko ari ay'igurisha ry'imigabane (sale shares), RRA ikavuga ko ahishe igurisha ry'imitungo ya TOTAL RWANDA SARL. Ayo masezerano agaragaza ko uwagurishije ari TOTAL OUTRE MER S.A, umwe mu banyamigabane babiri bari bagize TOTAL RWANDA SARL, naho uwaguze akaba ENGEN INTERNATIONAL (Mauritius) Ltd.

[33] Ingingo ya 8 y'Itegeko N°06/1988 ryo kuwa 12/02/1988 ryagengaga amasosiyete y'ubucuruzi ubwo amasezerano yakorwaga, yateganyaga ko sosiyete igira umutungo wayo bwite, iningo ya 122 y'iro tegeko ikavuga ko imigabane ishobora guhabwa uwo ariwe wese mu gihe amategeko ya sosiyete atabiteganya ukundi, naho amategeko yagengaga TOTAL RWANDA S.A.R.L (statuts) nayo akaba ateganya mu ngingo ya 11, ko imigabane ishobora gutangwa ariko ubwo burenganzira bukabanza guhabwa abandi banyamigabane cyangwa sosiyete.

[34] Mu kugaragaza itandukaniro riri hagati y'igurisha ry'imigabane n'igurisha ry'imitungo, inyandiko z'ababisesenguye zigaragaza ko igurisha ry'imitungo riba hagati ya sosiyete n'ugura, mu gihe igurisha ry'imigabane riba hagati y'umunyamigabane n'ugura.¹ Bagaragaza kandi ingaruka iryo gurisha rigira, aho basobanura ko iyo hagurishijwe imigabane, sosiyete idahinduka ahubwo hahinduka gusa abayigize, mu gihe igurisha ry'imitungo ya sosiyete rigira ingaruka zikomeye ku buzima bwa sosiyete, ko muri icyo gihe havuka sosiyete nshya iyo mitungo ishyirwamo.²
