**Incamake y'ikibazo:** Nyakwigendera Nyagatare Théogene yari yarahawe na Banki ya Kigali Ltd inguzanyo zitandukanye agatanga n'ingwate y'umutungo utimukanwa ariko aza gupfa atarangije kwishyura uwo myenda bituma banki ya Kigali irega abazungura be mu Rukiko Rukuru rw'Ubucuruzi isaba kwishyurwa, urukiko rubategeka kwishyura.

Abazungura ba nyakwigendera harimo n'umugore we nabo bahise batanga ikirego mu Rukiko rw'Ubucuruzi rwa Nyarugenge basaba ko amasezerano y'inguzanyo yatangiweho izo ngwate yaseswa kuko batigeze bayamenya kandi ko atigeze ashyirwaho umukono n'umugore wa nyakwigendera. Urukiko rwemeza ko nta seswa ry'amasezerano y'ingwate ryabaho kuko atabayeho bitewe nuko izo ngwate zatanzwe zidafite agaciro kuko zitigeze zandikishwa mu bitabo by'umwanditsi Mukuru byagenewe kwandikwamo umuttingo utimukanwa, bityo ko bagomba kwishyura Banki indishyi n'igihembo cy'avoka.

Bajuriye mu Rukiko Rukuru rw'Ubucuruzi bavuga ko urukiko rwirengagije ibyemezo byagiye bifatwa mu bibazo bisa nibi baregeye (jurisprudences). Urukiko rwemeza na none ko nta masezerano y'ingwate yabaye hagati ya nyakwigendera na banki, bityo ko bagomba kuyiha izindi ndishyi ziyongera kuzo baciwe mu rwego rwa mbere,

Abazungura ba Nyagatare bajuriye mu Rukiko rw'Ikirenga bavuga ko Urukiko rwavuze ko nta masezerano y'ingwate yabayeho kuko atanditse mu gitabo cy'Umwanditsi Mukuru, nyamara yarabayeho Umwanditsi Mukuru atarabaho ndetse n'Itegeko ryo kwandikisha ingwate ritarajyaho. Bavuga kandi ko amategeko yateganya ko umutungo utangwaho ingwate ari uko abagize umuryango bose bawufiteho uburenganzira babyemeye ariko akaba atariko byagenze kuko Nyagatare Théogène yatanze ingwate zose yahaye Banki ya Kigali Ltd, umugore we n'abana be batabyemeye.

Uhagarariye banki we avuga ko nta masezerano y'ingwate yabaye hagati yayo na nyakwigendera kuko atayitanze, avuga ko umutungo ariwo wagombaga kuzaba ingwate.

Abazungura ba nyakwigendera kandi bavuze kobakwiye kugenerwa indishyi zo gushorwa mu manza. Uhagarariye Banki ya Kigali avuga ko nta ndishyi bakwiye guhabwa kuko ikirego cyabo nta shingiro gifite.

3. Kuba Tuyisenge Rachel na Ishimwe Leah Aliah baratakaje byinshi muri izi manza bishyura ba Avoka bakazikurikirana, ni ngombwa ko bahabwa indishyi, ariko kuko izo basaba ari nyinshi, bagomba bakazigenerwa mu bushishozi bw'Urukiko.

## Urubanza

### I. IMITEREREY'URUBANZA

[1] Nyakwigendera Nyagatare Théogène akiraho yafashe umwenda muri Banki ya Kigali, atanga ingwate y'imitungo itimukanwa (inzu) apfa atarangije kwishyura umwenda wose, mu rubanza RCOM 0295/11/HCC rwaciwe kuwa 14 Nzeli 2012 n'Urukiko Rukuru rw'Ubucuruzi, abazungura be bategekwa kuwishyura. Umugore we Mujawimana Rose, Tuyisenge Rachel na Ishimwe Leah Aliah, abana be, bavuga ko ajya gufata umwenda batabimenye cyangwa ngo babyemere, bakaba batabazwa iby'uwo mwenda. Aho niho bahereye batanga ikirego kigamije gusaba ko amasezerano yatangiweho izo ngwate yaseswa.

[2] Urukiko rw'Ubucuruzi rwa Nyarugenge rwaciye urubanza RCOM 0722/13/TC/NYGE kuwa 17/01/2014, rwemeza ko ubugwate bw'imitungo itimukanwa ivugwa n'abarega nta gaciro bufite kuko butigeze bwandikwa mu gitabo cyandikwamo ingwate ku mutungo utimukanwa mu bitabo by'Umwanditsi Mukuru, ruvuga ko nta seswa ry'amasezerano y'ingwate atarabayeho ryashoboka, rutegeka abaregwa kwishyura Banki ya Kigali Ltd indishyi n'igihembo cya Avoka zingana na 600.000Frw.

[3] Mujawimana Rose, Tuyisenge Rachel na Ishimwe Leah Aliah bajuririye Urukiko Rukuru rw'Ubucuruzi bavuga ko Urukiko rwitiranyije ikorwa ry'amasezerano n'iyandikishwa ryayo, ndetse no mu bisobanuro by'Urukiko hakaba harabayeho ukwivuguruza gukomeye no kwirengagiza ibyemezo byagiye bifatwa mu bibazo bisa n'icyo baregeye (jurisprudences).

[4] Urukiko Rukuru rw'ubucuruzi rwaciye urubanza RCOMA0552/13/HCC kuwa 17/1/2014, rwemeza ko nta masezerano y'ubugwate yabaye hagati ya Banki ya Kigali Ltd na Nyagatare Théogène, rutegeka abarega guha Banki ya Kigali Ltd 400.000Frw y'igihembo cya Avoka yiyongera kuri 600.000Frw bari baciwe mu rwego rwa mbere n'indishyi zingana na 1.000.000Frw.

[5] Mujawimana Rose, Tuyisenge Rachel na Ishimwe Leah Aliah ntibishimiye imikirize y'urubanza bajarira mu Rukiko rw'Ikirenga, bavuga ko hirengagijwe ibimenyetso, amategeko, ndetse n'izindi manza zaciwe, ntirubahe n'indishyi basabye.

[6] Iburanisha mu ruhame ryabaye kuwa 07 Kamena 2016, Mujawimana Rose, Tuyishime Rachel na Ishimwe Lea Aliah bahagarariwe na Me Mutabazi Abayo Jean Claude, Banki ya Kigali Ltd ihagarariwe na Me Rusanganwa Jean Bosco.

## **II. IBIBAZO BIGOMBA GUSUZUMWA MU RUBANZA N'ISESENGURWA RYABYO.**

Muri uru rubanza harasuzumwa niba hari amasezerano y'ingwate yabaye hagati ya Nyagatare Théogène na Banki ya Kigaki, nibigaragara ko yabayeho, hasuzumwe niba akwiriye guseswa, hanasuzumwe ibijyanye n'indishyi zasabwe.

### **1) Kumenya niba hari amasezerano y'ingwate yabaye hagati ya Banki ya Kigali Ltd na Nyagatare Théogène.**

[7] Me Mutabazi Abayo Jean Claude avuga ko Urukiko rwavuze ko nta masezerano y'ingwate yabayeho kuko atanditse mu gitabo cy'Umwanditsi Mukuru, nyamara yarabayeho kuko n'uwo baburana ari we Banki ya Kigali Ltd ayemera uretse kuba iyanenga ko atanditse, ayo

masezerano akaba yarabayeho Umwanditsi Mukuru atarabaho ndetse n'Itegeko ryo kwandikisha ingwate ritarajyaho. Avuga ko ingwate zatanzwe zigaragara n'aho ziherereye hazwi, n'uko zatanzwe, ko amasezerano y'ingwate aba hagati y'impande ebyiri, akaba atagira agaciro kuko hagiymo Umwanditsi Mukuru. Avuga ko ikigaragaza ko ayo masezerano yabayeho ari uko ibyangombwa by'inzu y'i Remera mu kibanza N°2685 n'iby'iyo mu Karere ka Rwamagana byose bifitwe na Banki ya Kigali kimwe n'undi mutungo Nyagatare yatanzeho ingwate, uri Kabare- Muhazi n'inzu iri mu kibanza N°1647, giherereye Kigabiro-Rwamagana, Banki ya Kigali ikaba ibifite kuko ari ingwate yayo, kandi ko imihango yashyizweho n'itegeko ijyanye no kwandikisha ingwate ikorwa iyo impande zombi zimaze kumvikana ku ngwate.

[8] Me Mutabazi Abayo Jean Claude akomeza avuga ko ku bw'itegeko ryagiyeho mu mwaka wa 2009 rikavugururwa mu mwaka wa 2010, inshingano yo kwandikisha ingwate ifitwe na Banki ya Kigali kuko ari nayo ifite ibyangombwa by'imitungo yatanzeho ingwate kugeza uyu munsi, ko niba itarandikishije ingwate kandi biri mu nshingano zayo itahindukira ngo ivuge ko amasezerano adafite gaciro.

[9] Me Mutabazi Abayo Jean Claude asobanura ingaruka zo kutandikisha ingwate avuga ko iyo uwahawe umwenda yatanze ingwate ntiyandikishwe atawishyuye, Banki ibanza kujya mu Rukiko, ingwate ikagurishwa mu buryo busanzwe binyuze ku Muhesha w'inkiko, mu gihe iyo atishyuye ariko ingwate yarandikishijwe Banki yandikira gusa RDB, igaha uburenganzira abo bita "receivers" bakagurisha ingwate Banki ikishyurwa itiriwe ibanza kuregera Inkiko. Avuga ko mbere y'uko Umwanditsi Mukuru ashirwaho, iyo Banki yabaga ifite ingwate, hashingirwaga ku ngingo ya 53 y'itegeko ryerekeye imiburanishirize y'imanza z'imbonezamubano, ingwate ikagurishwa muri "vente par voie parrée", ko ku byerekeye amasezerano yabaye hagati ya Banki ya Kigali na Nyagatare Théogène, uwari ufite ishingano zo kwandikisha ingwate ari Banki kuko mu masezerano bagiranye handitsemo ngo "*le client autorise expressément la Banque à requérir au près de Monsieur le conservateur des Titres Fonciers l'inscription hypothécaire de 1er rang sur les biens décrits ci-avant....*", bikaba bigaragara ko uburenganzira bwo kwandikisha ingwate Nyagatare Théogène yabutanze, kuba Banki itarandikishije iyo ngwate bikagira ingaruka y'uko idashobora kugurisha ngo yiyishyure, ahubwo igomba kuregera urukiko igitegereza ko urubanza rurangira, kandi ko Banki itaza imbere y'Urukiko ngo ivuge ko hari ingwate ifite itarayandikishije.

[10] Me Rusanganwa avuga ko abarega batavuguruza ibyo umucamanza yashingiyeho bijyanye n'ingingo ya 4 y'Itegeko N°10/2009 ryo kuwa 14/05/2009 ryerekeye ubugwate ku mutungo utimukanwa nk'uko ryahinduwe kugeza ubu, iteganya ko "byitwa ko ubugwate bufite agaciro iyo bwanditse mu gitabo cyandikwamo ingwate ku mutungo utimukanwa mu biro by'Umwanditsi Mukuru", ko ntawasaba gutesha agaciro ikitagafite. Avuga ko nta bimenyetso abarega bagaragaza byirengajjwe, ko ashingiye ku masezerano yitwa "ouverture de crédit avec constitution d'hypothèque" bagaragaza bashaka gusaba ko amasezerano y'ingwate ateshwa agaciro, no ku mabaruwa menshi agaragaza amazu yatanzeho ingwate avugwa muri ayo masezerano, abona ntaho abazungura ba Nyagatare bahera bavuga ko ibyo yakoze batabyemera, cyane cyane ko Banki ya Kigali ivuga ko nta ingwate Nyagatare yatanze, ko icyabaye ari amasezerano y'umwenda n'ingwate yagombaga gutangwa (avec hypothèque à constituer), umutungo ukaba ariwo wagombaga kuzaba ingwate, kuko muri ayo masezerano ku rupapuro rwa 2 hagaragaramo icyo bise "*inscription de l'hypothèque*", aribyo kwandikisha ingwate, berekana uburyo bizagenda. Avuga ko atabona uburyo abazungura ba Nyagatare basaba ko aya

masezerano ateshwa agaciro ndetse bakongeraho ko ari amasezerano y'ubugwate, nyamara Nyagatare yarasinyiye gusa ko ingwate izatangwa.

[11] Me Rusanganwa Jean Bosco yabajije uburyo Banki ya Kigali Ltd itunzemo ibyangobwa by'inzu zavuzwe muri uru rubanza nyamara avuga ko nta masezerano y'ingwate (constitution d'hypothèque) yabayeho, asubiza ko Banki ya Kigali ifite ibyo byangombwa koko, kuko abazungura ba Nyagatare Théogène batigeze babyaka Banki ngo ibibime. Anavuga ko kuba Banki ibifite byerekana ko iby'itangwa ry'ingwate byatangiye ariko bikaba bitararangije, ko Banki ya Kigali yahawe izo nyandiko na Nyagatare kugira ngo ingwate zitangwe kuko hari ibyo bari bumvikanyeho, ko ariko ibyakozwe ari intangiriro (processus) kuko mu masezerano bari bumvikanye ko ingwate izandikishwa ku Mubitsi w'Impapurompamo z'ubutaka.

## UKO URUKIKO RUBIBONA

[12] Ingingo ya 33 y'Itegeko ryo kuwa 30/07/1888 rishyiraho Igitabo cya gatatu cy'Urwunge rw'amategeko y'imbonezamubano yakoreshwaga igihe Nyagatare Théogène na Banki ya Kigali Ltd bashyiraga umukono ku masezerano ya "ouverture de crédit avec constitution d'hypothèque" bagiranye kuwa 19/07/2005 n'ayakurikiyeho, iteganya ko amasezerano akozwe ku buryo bukurikije amategeko aba itegeko ku bayagiranye. Naho iningo ya 34 y'iryo Tegeko ryavuzwe haruguru iteganya ko amasezerano adategeka icyemejwe ahubwo akubitiraho n'ingaruka ubutabera, imigenzereze cyangwa amategeko byageneye inshingano bikurikije kamere yayo<sup>1</sup>.

[13] Dosiye igaragaza ko Nyagatare Théogène yasabye gukomerezwa umwenda kuwa 2 Gashyantare 2009, maze Banki ya Kigali Ltd imusubiza kuwa 5 Werurwe 2009 imumenyesha ko umwenda we ugeze kuri 124.000.000Frw, abarirwamo 24.000.000Frw agomba kuba yarangije kwishyura kuwa 31Gicurasi 2009 kandi agakomeza kwishyura umwenda ungana 15.472.369Frw yahawe agura inzu yo mu kibanza N°2685 iri Remera-Kimironko. Yibutswa kugura ubwishingizi bw'ingwate (garantie) Banki yari ifite arizo: "hypothèque" ifite agaciro ka 50.000.000Frw yagombaga kwandikwa ku rwego rwa mbere ku kibanza N°2685 kiri i Remera-Gasabo, mu Mujyi wa Kigali, Hypothéque ifite agaciro ka 21.000.000Frw yagombaga kwandikwa ku rwego rwa 1 ku kibanza N°1647 kiri i Kigabiro-Rwamagana, ikaba yari yahawe n'ibyemezo by'umutungo utimukanwa birimo icyemezo cy'umutungo w'inzu iri Kabare-Muhazi ho mu Burasirazuba n'ibyemezo by'imitungo itimukanwa iherereye Kigabiro-Rwamagana (izindi nzu 2) akaba ataragombaga kuwugurisha, kuwutangira ubuntu cyangwa kuwutangaho ingwate Banki itabanje kubimwemerera, Banki ikaba yaranahaweho ingwate ku rwego rwa mbere, umutungo wimukanwa ufite agaciro ka 50.000.000Frw.

[14] Dosiye igaragaza na none ko kuwa 17 Kamena 2009 Nyagatare yongeye kwaka inguzanyo y'igihe gito, maze kuwa 27 Nyakanga 2009, Banki ya Kigali Ltd imwandikira imumenyesha ko umwennda we ugeze kuri 148.000.000Frw, na none yibutswa ko ingwate (garanties) Banki ifite ari imitungo yose yavuzwe mu gika kibanziriza iki. Izo ngwate Banki ya Kigali Ltd ikaba ariyo yagombaga kuzandikisha nk'uko biteganyijwe mu masezerano y'umwenda utangwa hatanzwe ingwate (ouverture de crédit avec constitution d'hypothèque) yo kuwa 19 Nyakanga 2005 yavuzwe haruguru (ku rupapuro rwa kabiri/deuxième Feuillet) nk'uko

kandi byagiye byibutswa mu nyandiko yose imwemerera inguzanyo inagaragaza ingwate Banki ihawe.

[15] Urukiko rw'Ikirenga rurasanga bigaragara ko Banki ya Kigali na Nyagatare Théogène bagiranye amasezerano atandukanye y'umwenda, yose akaba yaragiye ahabwa umwenda ari uko atanze ingwate, Banki ya Kigali Ltd ikaba ariyo ifite ishingano yo kwandikisha izo ngwate. Muri ayo masezerano harimo ayo kuwa 19 Nyakanga 2005, yabayeho hakorwa ivugururwa rya mbere ry'amasezerano (avenant N°001) ku masezerano y'umwenda utangwa hatanzwe ingwate (ouverture de crédit avec constitution d'hypothèque), yashyiriweho umukono imbere ya noteri wa Leta Norbert Kamugisha. Muri ayo masezerano Nyagatare Théogène yahaye Banki ya Kigali Ltd ingwate ho inzu zubatse n'izizubakwa mu kibanza N°1647 kiri Kigabiro-Rwamagana, ayiha n'amasezerano N° L139/rwa/2005 y'ubukode bw'icyo kibanza. Hari kandi inyandiko yo kuwa 27/07/2009, Banki ya Kigali Ltd yandikiye Nyagatare Théogène imumenyesha ingano y'umwenda ayifitiye, inamwibutsa ko ingwate Banki ifite z'yo myenda yose ari inzu iri mu kibanza N°2685 i Remera-Kimironko, inzu iri mu kibanza N°1647 Kigabiro-Rwamagana (izo ngwate zombi zagombaga kwandikishwa kuri "hypothèque de 1<sup>er</sup> rang"), inzu 2 ziri Kigabiro-Rwamagana, n'ingwate y'imitungo yimukanwa (gaje de fonds de commerce) ifite agaciro ka 50.000.000Frw, ibyangombwa by'yo mitungo yose itimukanwa Nyagatare Théogène akaba yarabihaye Banki ya Kigali Ltd, ayiha n'uburenganzira bwo kwandikisha ingwate.

[16] Ku bijyanye no kwandikisha ingwate, abahanga mu mategeko babivuga ko bikorwa mu rwego rwo kugira ngo uwahawe ingwate agire icyizere cyo kwishyurwa mbere y'abandi bantu umubereyemo umwenda yaba afitiye indi myenda, bigakorwa kugira ngo abo bandi bamenye ko uwo mwenda uraho kandi nyirawo afite uburenganzira bwo kwishyurwa mbere, kuko mu gihe ingwate itandikishijwe nta burenganzira uwayihawe aba arusha abandi bafitiwe imyenda, ariko kutayandikisha bikaba bitavanaho ko amasezerano yabayeho kuko iryo yandikishwa riba rigamije gusa kumenyesha abandi ko uwo mutungo utimukanwa watanzweho ingwate<sup>2</sup>.

[17] Urukiko rurasanga rero nk'uko rumaze kubigaragaza, amasezerano y'ingwate hagati ya Nyagatare Théogène na Banki ya Kigali Ltd yarabayeho, akaba afite agaciro hagati y'abayagiranye kuko yubahirije ingingo ya 33 yavuzwe haruguru, akaba nk'uko byasobanuwe, adashobora kuvanwaho cyangwa ngo ateshwe agaciro n'uko ingwate zatanzwe zitandikishijwe, akaba nta n'ushobora kuyahakana kandi inyandiko zayo zihari.

## **2) Kumenya niba amasezerano y'ingwate Banki ya Kigali yagiranye na Nyagatare Théogène agomba guseswa.**

[18] Me Mutabazi Abayo Jean Claude avuga ko itegeko ry'ubutaka ryo mu mwaka wa 2005 ryateganya mu ngingo yaryo ya 35 ko kugira ngo uhagarariye umuryango ashobore gutanga
