Incamate y'ikibazo: Nyuma y'urupfu rwa Muhumuza wahitanywe n'impanuka ya moto yari yagonganye n'imodoka byombi bifite ubwishingizi muri SORAS AG Ltd. Umuhaha, Izabayo na Niyoyita bareze SORAS AG Ltd mu Rukiko Rwisumbuye rwa Nyarugenge basaba kuyitegeka ko yabaha indishyi mbonezamusaruro, iz'ibangamira ry'umubano, amafaranga baguze ibyemezo binyuranye, ayo batanzeho ingwate y'amagarama n'igihembo cya Avoka. SORAS AG Ltd yiregura ivuga ko batahabwa ibyo basaba kuko muri bo nta n'umwe nyakwigendera yari atunze.

Urukiko Rwisumbuye rwemeje ko nyakwigendera ariwe warutunze abarega hashingiwe kunyandiko yanditswe n'Umunyamabanga Nshingwabikorwa w'Umurenge wa Gitega maze rutegeka SORAS guha abarega indishyi mbonezamusaruro, iz'ibangamira ry'umubano hamwe n'igihembo cya Avoka ndetse ikanabasubiza amafaranga batanzeho ingwate y'amagarama.

SORAS AG Ltd yajuririye Urukiko Rukuru ivuga ko abarega bahawe indishyi mbangamirabukungu batazikwiye kuberako icyemezo batanze kigaragaza ko bari batunzwe na nyakwigendera gikemagwa kandi ko igipimo cy'ibitsa cyari gikwiye kubarirwaho ari 8% gikoresha na Banki Nkuru y'u Rwanda aho kuba 4% akoresha n'amabanki asanzwe. Ikomeza ivuga ko indishyi z'ibangamira ry'umubano zitari gushingirwa ku mushahara nyakwigendera yahembwaga ku mwaka kuko itegeko rivuga umushahara muto ntarengwa wemewe n'amategeko.

Umuhaha nabagenzi be batanze ubujurire bwuririye ku bundi bavuga ko indishyi z'ibangamira ry'umubano zabazwe nabi kuko umucamanza yibagiwe gukuba imibare abonye na 12. Urukiko rwemeje ko ubujurire bwa SORAS AG Ltd nta shingiro bufite naho ubwatanzwe na Umuhaha n'abagenzi be bufite ishingiro.

SORAS AG Ltd yajuririye urwo rubanza mu Rukiko rw'ikirenga ivuga ko Urukiko rwirengagije impamvu yajuririrwaga maze rugenera abaregwa indishyi mbangamirabukungu kandi batazikwiye kuko batari batunzwe n'uwahohotewe; ikindi rwabaze indishyi ku gipimo kitari cyo kuko rwazibariye ku gipimo cy'ibitsa kingana na 8% mu gihe urubanza rucibwa cyari kuri 7,960%, ndetse rugenera abaregwa indishyi z'ibangamira ry'umubano rushingiye ku mushahara nyakwigendera yahembwaga ku mwaka kandi zibarirwa ku mushahara

w'umwaka muto ntarengwa wemewe n'amategeko ungana 2,500Frw wemejwe n'Urukiko rw'ikirenga.

Umuhaza n'abavandimwe be bireguye bavuga ko iyi ngingo y'ubujurire nta shingiro ifite kuko nta kimenyetso na kimwe SORAS AG Ltd itanga gihamya ko bataribatunzwe na nyakwigendera.

Incamake y'icyemezo: 1. Bityo rero icyemezo cyatanzwe n'ubuyobozi bw'umurenge wa Gitega nta gaciro cyahabwa kuko atari kimenyetso gihamya ko Umuhaza n'abavandimwe bari batunzwe mu buryo buhoraho na nyakwigendera cyane ko kitanagaragaza impamvu idasazwe yatumaga abatunga kandi bose bujije imyaka y'ubukure.

2. Ibijyanye n'igipimo cy'ibitsa cyashingirwaho mu kubara indishyi mbangamirabukungu ntibyasuzumwa kuko izo ndishyi zitagenwe muri uru rubanza.

3. Indishyi z'ibangamira ry'umubanozibarwa hashingiwe ku mushahara muto ntarengwa wemewe n'amategeko ariko bitewe n'uko ubuzima bugenda burushaho guhendakubera ko ibiciro by'ibintu nkenerwa bya ngombwa bidahwema kuzamuka, ndetse n'imishahara n'ibihembo bikagenda byongerwa kugira ngo abahaha bashobore guhangana n'izamuka ry'ibyo biciro; umushahara muto ntarengwa (SMIG) nawo ukaba ukwiye kuzamuka ugashyirwa ku mafaranga 3.000Frw akaba kandi ari nawo washingirwaho mu kugena izo indishyi abavandimwe banyakwigendera bagomba guhabwa.

4. Igihe ababuranyi bose bafite ibyo batsindiye ndetse n'ibyo batsindirwa indishyi z'ikurikiranarubanza n'igihembo cy'avoka ntibigenerwa.

[1] Uru rubanza rukomoka ku rupfu rw'uwitwa Muhumuza Jean Pierre wahitanywe n'impanuka ya moto yagonganye n'imodoka, byombi bifite ubwishingizi muri SORAS AG Ltd, maze Umuhuza Pacifique, Izabayo Sylvie na Niyoyita Jacques, abavandimwe ba nyakwigendera Muhumuza Jean Pierre, baregera Urukiko Rwisumbuye rwa Nyarugenge, basaba gutegeka SORAS AG Ltd kubaha indishyi mbonezamusaruro, iz'ibangamirwa ku muco, amafaranga baguze *attestations* zinyuranye, ayo batanzeho ingwate y'amagarama n'igihembo cya Avoka, indishyi zose basaba zingana na 76.754.048Frw. SORAS AG Ltd yireguye ivuga ko batahabwa ibyo basaba kuko muri bo nta n'umwe nyakwigendera yari atunze.

[2] Urukiko Rwisumbuye rwa Nyarugenge rwaciye urubanza RC0656/13/TGI/NYGE ku wa 07/02/2014, rwemeza ko nyakwigendera ariwe wari utunze abarega hashingiwe ku nyandiko yo ku wa 30/07/2013, yanditswe n'Umunyamabanga Nshingwabikorwa w'Umurenge wa Gitega, naho ku birebana n'indishyi mbonezamusaruro, ruvuga ko zibarwa hashingiwe ko nyakwigendera yinjizaga 499.289Frw ku kwezi kandi akaba yarapfuye asigaje imyaka 38. Bityo, rutegeka SORAS guha abarega, indishyi zose hamwe zingana na 58.726.799Frw zikubiyemo 57.677.866Frw y'indishyi mbonezamusaruro, 748.933Frw y'indishyi z'ibangamira ku muco na 300.000Frw y'igihembo cya Avoka, rutegeka na none SORAS AG Ltd kubasubiza 12.000Frw batanzeho ingwate y'amagarama.

[3] SORAS AG Ltd yajuririye urwo rubanza mu Rukiko Rukuru, ivuga ko abarega bahawe indishyi mbangamirabukungu batazikwiriye kubera ko icyemezo cy'Umunyamabanga Nshingwabikorwa w'Umurenge wa Gitega kivuga ko nyakwigendera yari abatunze gikemangwa, kandi ko *taux de placement* yari ikwiriye kubarirwa kuri 8% kuko aricyo gipimo gikoreshwa na Banki Nkuru y'u Rwanda, aho kuba 4% akoreshwa n'amabanki asanzwe. Ivuga kandi ko *préjudice moral* itari gushingirwa kuri *salaire net annuel* ya nyakwigendera kuko itegeko rivuga umushahara muto ntarengwa wemewe n'amategeko. Umuhuza Pacifique, Izabayo Sylvie na Niyoyita Jacques nabo batanze ubujurire bwuririye ku bundi bavuga ko indishyi z'ibangamira ku muco zabazwe nabi kuko umucamanza yibagiwe gukuba imibare abonye na 12.

[4] Urwo rukiko rwaciye urubanza RCA0089/14/HC/KIG ku wa 28/11/2014, rwemeza ko ubujurire bwa SORAS AG Ltd nta shingiro bufite, rusobanura ko SORAS AG Ltd uretse amagambo gusa y'uko nyakwigendera atariwe wari utunze abayireze, ko nta kimenyetso yabashije kugaragariza Urukiko gihinyuza icyemezo cy'Ubuyobozi bw'Umurenge cyashyikirijwe Urukiko, kandi ko n'ibindi yajuririye nabyo nta bimenyetso ibitangira. Ku birebana na *taux de placement*, SORAS AG Ltd ivuga ko yari ikwiriye kubarirwa kuri 8% igipimo gikoreshwa na BNR aho gushingira kuri 4% ya za Banki z'ubucuruzi.

[5] Urukiko rwasanze SORAS AG Ltd usibye kubivuga gusa itagaragaza *taux* yagenderwagaho na BNR igihe ubwishyu bwagombaga gukorwa, n'urubanza rw'icyitegererezo yatanze, impanuka ruvuga ikaba itarabereye rimwe n'iyi muri uru rubanza, kandi Iteka rya Perezida n° 31/01 ryo ku wa 25/08/2003 rishyiraho uburyo bwo kwishyura indishyi ku bubabare bw'umubiri buturutse ku mpanuka zitewe n'ibinyabiziga, rivuga ko igipimo gishingirwaho ari ikingana nibura n'igipimo cy'inyungu y'ibitsa gikoreshwa n'amabanki, bivuze amabanki asanzwe kuko ariyo menshi aho kuganisha kuri BNR, iba ari

imwe rukumbi. Ruvuga kandi ko ku birebana na *préjudice moral*, Urukiko Rwisumbuye rutari gushingira ku mushahara muto ntarengwa “SMIG” mu gihe umushahara nyakwigendera yakoreraga wari uzwi neza. Rwemeje kandi ko ubujurire bwuririye ku bundi bwatanzwe n’abaregwa bavuga ko imibare yakozwe nabi bufite ishingiro, kuko habayeho kwibagirwa kukuba n’umubare 12. Urwo rukiko rwategetse SORAS AG Ltd guha Umuhiza Pacifique, Izabayo Sylvie na Niyoyita Jacques indishyi zose hamwe zingana na 67.465.068Frw, akubiyemo 8.987.202Frw y’indishyi zibangamirwa ku mucu, 57.677.866Frw y’indishyi z’ibangamirabukungu na 500.000Frw y’ikurikirana rubanza n’igihembo cya Avoka, yo ku rwego rw’ubujurire.

[6] SORAS AG Ltd yajuririye urwo rubanza mu Rukiko rw’Ikirenga, ivuga ko Urukiko rwirengagije impamvu yajuririrwaga, rugenera abaregwa indishyi mbangamirabukungu kandi batazikwiye kuko batari batanzwe n’uwahohotewe; ko kandi Urukiko rwabaze indishyi ku gipimo kitari cyo kuko rwazibariye ku gipimo cy’ibitsa kingana na 8% (*taux de placement*) mu gihe urubanza rucibwa cyari kuri 7,960%, ndetse rugenera abaregwa indishyi z’ibangamirwa ku mucu rushingiye ku mushahara nyakwigendera yahembwaga ku mwaka kandi zibarirwa ku mushahara w’umwaka muto ntarengwa wemewe n’amategeko (*salairé annuel minimum interprofessionnel garanti*).

[8] Me Mukanzigiye Donatille uburanira SORAS AG Ltd avuga ko Urukiko rwageneye abaregwa indishyi z’ibangamirabukungu kandi batazikwiye kuko izo ndishyi zihabwa abafite uburenganzira ku buryo bwumvikana ko bari batanzwe n’uwahohotewe nk’uko biteganywa n’ingingo ya 22 y’Iteka rya Perezida N°31/ ryo ku wa 25/08/2003 rishyiraho uburyo bwo kwishyura indishyi ku bubabare bw’umubiri buturutse ku mpanuka zitewe n’ibinyabiziga. Avuga ko Urukiko rwageneye izo ndishyi abaregwa rushingiye ku cyemezo cy’Umunyamabanga Nshingwabikorwa w’Umurenge wa Gitega, kivuga ko bari batanzwe na nyakwigendera kandi ataricyo cyagombaga gushingirwaho kuko abaregwa bese bari bafite imyaka y’ubukure harimo n’uwakoraga kandi batanabarizwa mu Murenge umwe na nyakwigendera Muhumuza Jean Pierre, ku buryo Urukiko ntaho rwari guhera ruhamya ko ariwe wari ubatunze, kuko bitumvikana ukuntu umuntu utuye mu Gitega yatunga utuye Rwezamenyo cyangwa utuye i Nyamirambo. Asobanura ko bene izi ndishyi zihabwa umugore n’abana ba nyakwigendera, ariko ko nyakwigendera Muhumuza Jean Pierre ntabo yasize. Asobanura ko *la prise en charge* batayikoreye ubushakashatsi, ariko ko ubundi umuntu atunga umuntu bari kumwe mu rugo babana kandi bigaragara ko ariwe ushinze urwo rugo (*responsable*).

nyakwigendera Muhumuza Jean Pierre ariwe wari utunze bariya bavandimwe be. Asobanura ko kuba utunzwe (*pris en charge*) n'undi muntu bitavuze ko byanze bikunze ugomba kubana nawe mu nzu imwe cyangwa ko aba akugaburira.

[10] Ingingo ya 9, igika cya mbere, y'Itegeko N°41/2001 ryo ku wa 19/09/2001, ryerekeye itangwa ry'indishyi ku bahohotewe biturutse ku mpanuka zo ku mubiri zitewe n'ibinyabiziga, iteganya ko mbere yo gutangira kuregera indishyi mu nkiko, uwangirijwe cyangwa abamuhagarariye bemewe n'amategeko, cyangwa iyo yapfuye, abafite uburenganzira ku bintu bye, bishyuzwa indishyi uwishingiye uwateje impanuka, cyangwa byaba ngombwa ikigega cy'ingoboka ku binyabiziga bigenzwa na moteri bigendera ku butaka, binyuze mu bwumvikane, bakamwereka inyandiko zose zemeza ishingiro ry'ibyo basaba.

[11] Ku birebana n'indishyi mbangamirabukungu, isesengura ry'ingingo y'itegeko imaze kuvugwa haruguru, ryumvikanisha ko, abafite uburenganzira bwo gusaba izo ndishyi ari abari batunzwe n'uwahohotewe wafuye.

[12] Ku byerekeranye n'igisobanuro cy'amagambo "gutunga umuntu", ingingo ya 198 CCL.I iteganya ko "umurimo nshinganwa wo gutunga umuntu ni uwo itegeko ritegeka umuntu gutanga ibitunga umubiri k'uwundi muntu ubikeneye". Ingingo ya 199, yo ikavuga ko ibitunga umuntu bitangwa mu mafaranga cyangwa mu bintu. Ingingo ya 200 yo, igateganya ko abashyiranywe bafite umurimo nshinganwa wo guhana ibibatunga. Ababyeyi nabo bafite umurimo nshinganwa wo guha abana babo ibibatunga n'abana bikaba uko. Iyo ngingo iteganya kandi ko abana bagomba gufasha abo bakomokaho igihe batishoboye. Abo nabo bagomba gufasha abana.

[13] Mu miburanire yayo, SORAS ivuga ko abavandimwe ba nyakwigendera batagomba kugenerwa indishyi mbangamirabukungu kubera ko atari abatunze, bityo ko icyangombwa cyatanzwe n'Ubuyobozi bw'Umurenge wa Gitega kivuga ko yari abatunze kidakwiye guhabwa agaciro.

[14] Mu ngingo ya 200 CCL.I yavuzwe haruguru, nta hagaragara ko umuntu afite umurimo nshinganwa wo gutunga abavandimwe be (*ses frères et sœurs*). Umuhanga mu mategeko Laëtitia STASI nawe avuga ko inshingano yo gutanga ibitunga umuntu iba ireba gusa abafitanye amasano ataziguye kandi kugeza ku gisanira cya kabiri no kurengaho, ni ukuvuga hagati y'abuzukuru n'aba nyirakuruza na sekuruza. Akomeza avuga ko hagati y'abashyiranywe, ubushyiranywe butuma havuka inshingano hagati y'imiryango yabo ariko ko inshingano yo gutanga ibitunga umuntu ibaho igihe gusa ubushyiranywe bukiriho, asoza avuga ko nta umurimo nshinganwa wo gutunga umuntu uba hagati y'abavukana, ni ukuvuga hagati ya musaza na mushiki we¹.

muvukana, aho avuga tugenekereje ko amasano yose aba hagati y’abantu adatanga uburenganzira ku bitunga umuntu, ko ababigiraho uburenganzira ari abateganywa n’amategeko, agakomeza yerekana ko abafitanye inshingano yo guhana ibitunga umubiri ari abafite amasano ataziguye ku bisanira byose, ariko ko iyi nshingano itaba hagati y’abavukana².

[16] Ku birebana n’uru rubanza, Umuhaza Pacifique, Izabayo Sylvie na Niyoyita Jacques, bavuga ko indishyi mbangamirabukungu basaba, bazishingira ku byago bagize byo kubura ibibatunga (préjudice matériel) bahabwaga n’umuvandimwe wabo Muhumuza Jean Pierre wazize impanuka yo mu muhanda kandi ariwe wari ubatunze, bakaba barashyikirije inkiko harimo n’Urukiko rw’Ikirenga icyemezo cyatanzwe ku wa 30/07/2013, na Nkurunziza Idrissa wari Umunyamabanga Nshingwabikorwa w’Umurenge wa Gitega, kivuga ko nyakwigendera yari atunze abavandimwe be.

[17] Ubwo impanuka yo mu muhanda yabaga ku wa 19/03/2011, igahitana nyakwigendera Muhumuza Jean Pierre, Umuhaza Pacifique yari afite imyaka 30, Izabayo Sylvie afite imyaka 26, naho Niyoyita Jacques afite imyaka 22, bivuga ko bose bari bujije imyaka y’ubukure.

[18] N’ubwo amategeko ateganya mu buryo butaziguye (expressément) abafite inshingano yo gutunga abandi, ni ukuvuga abafite umwenda wo gutanga ibitunga umuntu (débiteurs alimentaires) ndetse n’ababifiteho uburenganzira (créanciers alimentaires), umuhanga Yvonne Lambert-Faivre mu gitabo cye, Droit du dommage corporel, ku gice kirebana no kwishyura indishyi zirebana n’ibyago bituruka ku rupfu rwatwe n’impanuka yo mu muhanda, avuga ko n’abadafite uburenganzira bwo kwishyura ibitunga umubiri bataziturwa gusaba ibibatunga iyo bagaragaje ikimenyetso ko bari batunzwe na nyakwigendera koko: atanga urugero nk’umuvandimwe w’ikimuga, umwana wabyaye mu batisimu cyangwa imfubyi³.

Hagombaga rero kugaragazwa ibimenyetso gifatika (urugero nk’impapuro zo kwa muganga zerekana niba bafite ubumuga, bordereau za banki yaheragaho amafaranga, message za mobile money se yabandikiye aboherereza amafaranga n’ibindi...) kandi byaboneka Urukiko rwari gushingiraho rusuzuma niba indishyi mbangamirabukungu basaba bazikwiye kuko hashingiwe ku mategeko n’inyandiko z’abahanga zasobanuwe haruguru, nta nshingano iteganywa n’itegeko Muhumuza Jean Pierre yari afite yo gutunga abavandimwe be, ko naho yaba yarabikoraga, byafatwa nk’ubufatanye busanzwe buba hagati y’abagize umuryango (entraide familiale).

Ku birebana na *jurisprudences* zatanzwe na SORAS AG Ltd, avuga ko Urukiko Rukuru rwabisobanuye neza ko nyakwigendera yari afite umushahara w'umwaka uzwi hakaba hatashingirwa ku mushahara muto w'umwaka ntarengwa, ko rero izo *jurisprudences* zitakoresheya muri uru rubanza kuko SMIG ya 2009 itahura n'ya 2016, cyane ko mu rubanza rwemeza SMIG ya 2.500Frw, Urukiko rwavuze ko ishingiyeye ku buryo ubuzima buhagaze, hatirengagijwe ko nta tegeko rishyiraho umushahara muto ntarengwa w'umwaka mu Rwanda.

Ababyeyi n'abana b'isezerano cyangwa bemewe n'amategeko: 0.75 x umushahara w'umwaka muto ntarengwa wemewe n'amategeko;

Abavandimwe babo: 0,5 x umushahara w'umwaka muto ntarengwa wemewe n'amategeko".

[27] Urukiko rusesenguye umushahara uvugwa mu ngingo ya 23 imaze kuvugwa hejuru, rurasanga ari umushahara muto ntarengwa wemewe n'amategeko bita SMIG mu ndimi z'amahanga, uyu mushahara akaba atari umusaruro w'umwaka uwahohotewe yatahanaga nk'uko byemejwe n'Urukiko Rukuru mu gika cya 13 cy'imikirize y'urubanza rwajuririwe. Ku byerekeranye n'ingano ya SMIG, Urukiko rurasanga kugeza ubu nta tegeko ryishyiraho rirajyaho ariko ko Urukiko rw'Ikirenga mu rubanza RCAA0202/7/CS, rwaciwe ku wa 09/04/2009, n'izindi zarushingiyeho (urubanza RCAA0003/11/CS rwo ku wa 12/10/2012 n'urubanza RSOCAA0112/10/CS rwo ku wa 15/02/2015), rwemeje ko yaba 2.500Frw, uyu mubare ukaba waragenywe mu bushishozi bw'uru rukiko rushingiye ku biciro biri ku isoko.

[28] Urukiko rurasanga ariko uko imyaka ishira indi igataha, ubuzima bugenda burushaho guhenda kubera ko ibiciro by'ibintu nkenerwa bya ngombwa bidahwema kuzamuka, ndetse n'imishahara n'ibihembo bikagenda byongerwa kugira ngo abahaha bashobore guhangana n'izamuka ry'ibyo biciro, rukaba rusanga ubu SMIG nayo ikwiye kuzamuka ikaba yashyirwa ku mafaranga 3.000Frw, ubu ahembwa umukozi ufasha umufundi (umuyede – aide maçon) ku muni.

d. Ku byerekeye indishyi z'ikurikiranarubanza kuri uru rwego.
