Amategeko agenga umurimo – Gusesa amasezerano y'umurimo – Uburenganzira bw'umukozi iyo asezerewe mu kazi – Indishyi zikomoka ku kwirukanwa nta mpamvu – Indishyi zo kwirukanwa nta mpamvu zitandukanye n'amafaranga umukozi ahabwa nk'uburenganzira yemererwa n'amategeko iyo asezerewe mu kazi – Itegeko N°13/2009 ryo kuwa 27/05/2009 rigenga umurimo, ngingo ya 32, 33 niya 57.

Amategeko agenga umurimo – Umushahara – Amafaranga y'urwunguko na y'ishimwe – Umukoresha atanga amafaranga y'urwunguko nay'ishimwe abyibwirije kandi ku bushake, ariko iyo ayemeye aba ari itegeko kuri we kuko biba ari kimwe mu bigize umushahara w'umukozi.

Incamake y'ikibazo: Ruhimbaza yasezerewe ku kazi ku mpamvu yuko Umukoresha we Banki ya Kigali yavugaga ko atari yujuje ibisabwa n'imbonerahamwe y'imyanya nshya yemejwe n'Inama y'Ubutegetsi ya Banki. Yaregeye Urukiko Rwisumbuye rwa Nyarugenge asaba indishyi zinyuranye kubera kwirukana mu buryo bunyuranije n'amategeko. Urwo Rukiko rwemeje ko yirukanywe mu buryo bunyuranyije n'amategeko, rumugenera indishyi zikubiyemo izo kwirukanwa mu buryo bunyuranye n'amategeko, amafaranga y'integuza, ay'ikiruhuko atabonye, ay'imperekeza, indishyi zo kudahabwa icyemezo cy'umukoresha cyuzuye, amafaranga y'ishimwe, ay'urwunguko, ay'ikiruhuko atafashe hamwe nay' ikurikiranarubanza n'igihembo cy'Avoka.

Umukoresha yajuririye icyo cyemezo mu Rukiko Rukuru, narwo rwemeza ko urubanza rwajuririwe ruhindutse gusa ku bijyanye n'indishyi zigomba guhabwa uregwa. Yarongeye ajuririra Urukiko rw'Ikirenga arushyikiriza impamvu zari zatumye ijuririra Urukiko Rukuru, narwo rumaze kuzisuzuma, rwemeza ko uregwa yirukanwe mu buryo bunyuranye n'amategeko, maze rumugenera indishyi zihwanye n'umushahara we w'amezi icyenda, ariko rutegeka ko zikurwamo amafaranga yari yarahawe n'umukoresha we igihe cyo kumusezerera, akubiyemo ay'integuza, ay'imperekeza, n'ay'ikiruhuko atari yarafashe, runategeka umukoresha kumuha indishyi zo kuba yarahawe icyemezo cy'umukoresha we wa nyuma kituzuye, n'amafaranga y'ikurikiranarubanza n'igihembo cy'Avoka.

Uregwa ntiyishimiye imikirize y'Urukiko rw'Ikirenga, bityo yiyambaza Urwego rw'Umuvunyi asaba ko urwo rubanza rwasubirwamo ku mpamvu z'akarengane, kuko rwategetse ko mu ndishyi rwamugeneye zo kwirukanwa mu buryo budakurikije amategeko, hakurwamo amafaranga y'integuza, ay'imperekeza n'ay'ikiruhuko yahawe asezererwa kandi ntaho ahuriye nazo kandi rutamugeneye amafaranga y'urwunguko n'aya amashimwe umukoresha yamwimye kandi yari asanzwe ayahabwa.

Urwo rwego narwo rwasabye ko urwo rubanza rwasubirwamo, nyuma yo kubisuzuma, Perezida w'Urukiko rw'Ikirenga yemeje ko rwongera kuburanishwa. Mu iburanisha habanje gusuzumwa inzitizi y'ukutakira ikirego, aho Umukoresha yavugaga ko kitubahirije ibiteganywa n'amategeko kuko icyabayeho mu icibwa ry'urubanza atari akarengane ahubwo ari ukwitiranya indishyi zo kwirukanwa binyuranyije n'amategeko n'amafaranga yahawe ahagarikwa ku kazi, icyo kibazo rero, kikaba cyaramuhaga uburenganzira bwo gusubirishamo urubanza ingingo nshya, bityo kikaba kitagomba gushingira ku nzira yo gusubirishamo urubanza ku mpamvu z'akarengane, nk'uko biteganywa n'ingigo ya 81 y'Itegeko N°03/2012/OL ryo ku wa 13/06/2012 rigena imiterere, imikorere n'ububasha by'Urukiko rw'Ikirenga.

Kubyerekeye iyo nzitizi, uwasabye gusubirishamo urubanza avuga ko ingingo ya 186 y'Itegeko N°21/2012 ryo ku wa 14/06/2012 yerecyeye ugusubirishamo urubanza ingingo nshya ikoresheya iyo mu ica ry'urubanza habaye amakosa akomeye yo kwitiranya uko ibintu byagenze bigatuma Urukiko rufata icyemezo kitari cyo, akaba atari ko bimeze muri uru rubanza, kuko Urukiko rutigeze rwitiranya uko ibintu byagenze, ahubwo ko rumaze gusobanura no gusesengura uko ibintu byagenze rwasanze yarirukanwe mu buryo budakurikije amategeko rumugenera indishyi, ikibazo kivuka ari uko rutegetse ko izo ndishyi zivanwamo amafaranga yari yarahawe yirukanwa ku kazi, ari naho hagaragarira akarengane yagiriwe.

Mu iburanisha mu mizi, uwasabye gusubirishamo urubanza avuga ko urubanza rwaciwe n'Urukiko rw'Ikirenga harimo akarengane kubera ko rwemeje ko indishyi rwamugeneye zo kwirukanwa nta mpamvu zikurwamo amafaranga y'ibyo yemererwa n'amategeko; akomeza avuga ko ayo mafaranga atari kwitiranywa n'indishyi zo kwirukanwa nta mpamvu. Yongeraho ko Urukiko rwavuze ko adafite uburenganzira ku mafaranga y'amashimwe rushingiye ku kuba atarakorewe isuzumabushobozi, runamwima n'amafaranga y'urwunguko rushingiye ku kuba yarahagaritswe "bilan" itarakorwa ngo hagaragare umusaruro umukoresha we yabonye, akaba asanga iyo atirukanwa yari gukorerwa iryo suzuma kandi ko mu mezi icumi yari amaze gukora yagize uruhare ku nyungu umukoresha yabonye. Asoza asaba ko yahabwa amafaranga y'igihembo cy'Avoka na y'ikurikiranarubanza.

Uregwa yiregura avuga ko nta karengane kari mu rubanza kuko Urukiko rutegeka ko ahabwa indishyi zo kwirukanwa mu buryo bunyuranye n'amategeko hakuwemo amafaranga yari yarahawe ahagarikwa mu kazi, ari uko rwabyumvise, kandi ko kutishimira imikirize y'urubanza bitafatwa nk'akarengane. Kubirebana na amafaranga y'ishimwenay'urwunguko yisobanura avuga ko itegeko rigenga banki ya Kigali Ltd, riteganyako amafaranga y'ishimwe atangwa nyuma y'umwaka kandi ko umukoresha adategetswe kuyitanga, naho kubirebana n'amafaranga y'urwunguko rigateganyako itangwa mu kwezi kwa gatatu hashingiwe ku musaruro Banki yabonye, bimaze kwemezwa n'inama y'ubuyobozi, ari nayo igena ingano yayo, kandi ko kuyitanga nayo atari itegeko. Kubirebana n'amafaranga y'igihembo cy'Avoka na y'ikurikiranarubanza avuga ko niwe ufite kuyagenerwa kuko indishyi yatsindiye yazihawe mu manza zabanje ariko akomeza kumushora mu manza zitari ngombwa.

Incamake y'icyemezo: 1. 2. Indishyi zigenwa mu gihe habayeho ikosa ryo kwirukana umukozi nta mpamvu ni izishingira ku kababaro katewe n'iryo sezererwa zitandukanye n'andi mafaranga umukozi ahabwa nk'uburenganzira yemererwa n'amategeko iyo asezerewe mu kazi. Bityo amafaranga y'integuza, ay'imperekeza zo gusezererwa ku kazi n'ay'ikiruhuko yari yari yarahawe ntabwo agomba gukurwa mu mafaranga y'indishyi zo kwirukanwa binyuranyije n'amategeko.

3. Umukoresha ntashobora kwanga guha umukozi amafaranga y'ishimwe n'ay'urwunguko yitwaje ko umukozi nta suzumabushobozi yakorewe cyangwa umusaruro w'umukoresha wari utaragaragazwa, mu gihe yirukanwe ku mpamvu itumvikana igihe cyo kubikora kitaragera, kuko iryo ikosa ry'umukoresha ryo kumwirukana nta mpamvu ari ryo ryatumye adakomeza akazi ngo arangize umwaka akorerwe isuzumwa, n'umusaruro w'umukoresha we ugaragazwe. Bityo izi mpamvu zikomoka ku ngaruka zo kwirukanwa nta mpamvu, ntizashingirwaho yimwa amafaranga y'ishimwe nay'urwunguko yari kubona iyo aguma mu kazi.

4. Amafaranga y'ishimwe nay'urwunguko atangwa n'umukoresha abyibwirije kandi ku bushake, ariko iyo ayemeye iba ari itegeko kuri we kuko iba ari kimwe mu bigize umushahara w'umukozi.
5. Igikorwa cyose cy'umuntu cyangirije undi gitegeka nyir'ugukora ikosa rigikomokaho kuriha ibyangiritse. Bityo urega agenewe amafaranga y'igihembo cy'Avoka na y'ikurikiranarubanza mu bushishozi bw'urukiko kuko ayo asaba ari menshi.
