Amategeko agenga imiburanishirize y'ianza z'imbonezamubano – Inzitizi – Ibisabwa ngo ikirego cyakiriwe – Inyungu yo gutanga ikirego – Inyungu igomba kuba iriho igihe ikirego gitangwa, ntibyemewe ko umuntu aregera inyungu ishobora kuzabaho mu gihe kizaza – Itegeko N°21/2012 ryo kuwa 14/06/2012 ryerekeye imiburanishirize y'ianza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, ingingo yi 142.

Incamake y'ikibazo: Uru rubanza rwatangiriye mu Rukiko rw'Ibanze rwa Nyamirambo aho Ntakirutimana mu izina ry'abana be Umuhoza Aline, Ntakirutimana Elie, Ntakirutimana Yves na Ntakirutimana Honoré yareze Musasangohe asaba ko urwo Rukiko rwamutegeka kubandika ku mutungo asangiye na Ntigurirwa wari umugabo we wa mbere w'isezerano banabyaranye mwana witwa Mbatezimana Pautin. Urukiko rwemeje ko abana bahagarariwe na Ntakirutimana bandikwa ku mutungo ya nyina Musasangohe, kandi ko bayifiteho uburenganzira bungana na 25% naho Mbatezimana Pautin yabyaranye n'umugabo we wa mbere akaba ayifiteho 75% mu gihe cy'izungura; runemeza ko nta ndishyi zatangwa muri uru rubanza kuko byaba ari ugusesagura umutungo ugomba kurera abana.

Ababuranyi bombi bajuririye urukiko rwisumbuye aho Ntakirutimana yavugaga ko Urukiko rwaciye urubanza kukitaregewe ndetse ntirwanagena indishyi yari yasabye kuko byaba ari ugusesagura umutungo w'umuryango mu gihe batasezeranye nkuko Musasangohe abivuga. Kurundi ruhande, Musasangohe avuga ko abana yabyaranye na Ntakirutimana batagombye kwandikwa ku mutungo yashakanye n'umugabo w'isezerano kuko yabashakiye iyabo afatanyije na Ntakirutimana bityo ko imitungo iburanwa ikwiye guharirwa we na Mbatezimana yabyaranye n'umugabo w'isezerano.

Urukiko rwaciye urubanza rwemeza ko ubujurire bwabo ntashingiro bufite bityo ko urubanza rwaciye n'urukiko rw'Ibanze rwa Nyamirambo rudahindutse. Nyuma yaho urwo rubanza ruciriwe Musasangohe yiyambaje Urwego rw'Umuvunyi, maze narwo rwandikira Perezida w'Urukiko rw'Ikirenga rusaba ko urubanza rwaciye n'Urukiko Rwisumbuye rwa Nyarugenge rwasubirwamo kuko rubonamo akarengane gashingiye ku mpamvu y'uko rwirengagije Itegeko N°43/2013 ryo kuwa 16/06/2013 rigenga ubutaka mu Rwanda n'Iteka rya Minisitiri N°002/2008 ryo kuwa 01/04/2008 rigenga iyandikishwa ry'ubutaka, maze Perezida w'Urukiko rw'Ikirenga ateguka ko urwo rubanza rwongera kuburanishwa .

Mu Rukiko rw'Ikirenga, Musasangohe yatanze impamvu ndemyagihugu zigaragaza ko ikirego cya Ntakirutimana kitagombaga kwakirwa n'inkiko zabanje kuko nta nyungu yemewe n'amategeko abana ahagarariye bari bafite yo kuregera urukiko, kubera ko umutungo basaba kwandikwaho atari uwe ku giti cye, ahubwo awufatanyije na Ntigurirwa, umugabo we w'isezerano, ko kandi adakwiye kubuzwa uburenganzira ku mutungo we bitewe nuko izungura rizaba atakiriho.

Ntakirutimana avuga ko yatanze ikirego mu izina ry'abana be kuko umutungo uburanwa wanditswe kuri Musasangohe n'umwana we Mbatezimana wenyine, akaba yarifuzaga ko n'abandi bana bawandikwaho kugirango bazagire uburenganzira bungana ku mutungo wa nyina.

[1] Ntakirutimana Ezira, mu izina ry'abana be Umuhoza Aline, Ntakirutimana Elie, Ntakirutimana Yves na Ntakirutimana Honoré, yareze Musasangohe Vestine, nyina w'abo bana, mu Rukiko rw'Ibanze rwa Nyamirambo asaba ko urwo rukiko rumutegeka kubandika ku mutungo asangiye na Ntigurirwa Cyprien wari umugabo we wa mbere w'isezerano, babyaranye undi mwana witwa Mbatezimana Pautin. Kuwa 14/06/2013 urwo rukiko rwaciye urubanza RC0051/13/TB/NYB, rwemeza ko abana Umuhoza Aline, Ntakirutimana Elie, Ntakirutimana Yves na Ntakirutimana Honoré bandikwa ku mutungo wa nyina ugizwe n'amazu yubatse mu kibanza N°1342 mu Mudugudu w'Ingezi, ari mu kibanza N°59 mu Mudugudu wa Nkundumurimo, umurima ufite N°2118 mu Mudugudu wa Kamenge n'ishyamba riri mu kibanza N° 2172 mu Mudugudu wa Kamenge, ko kandi bafite uburenganzira bungana na 25% kimwe n'umwana we witwa Mbatezimana Pautin yabyaranye n'umugabo we w'isezerano uwufiteho uburenganzira bungana na 75% mu gihe cy'izungura, ugakomeza gucungwa na nyina, runategeka ko nta ndishyi n'amafaranga y'igihembo cy'Avoka bigomba gutangwa kuko byaba ari ugusesagura umutungo ugomba kurera abana.

[2] Musasangohe Vestine na Ntakirutimana Ezira bajuririyeye Urukiko Rwisumbuye rwa Nyarugenge, Ntakirutimana Ezira avuga ko urukiko rwagiye ruvuga uruhare rwa buri mwana ku mitungo yanditse kuri Musasangohe Vestine, rugena ijanisha (*pourcentage*) nyamara ibyo bitari mu byo baregeye, ko kandi nta ndishyi zatanzwe hashingiwe ko byaba ari uguhombya umuryango, nyamara Musasangohe

avuga ko Ntakirutimana Ezira atari umugabo w'isezerano, naho ku ruhande rwa Musasangohe Vestine ajurira avuga ko abo bana yabyaranye na Ntakirutimana Ezira batagombye kwandikwa ku mutungo w'umugabo w'isezerano kubera ko yabashakiye imitungo yabo afatanyije na Ntakirutimana Ezira, ko kandi umugabo we ashobora guhunguka umwanya uwo ariwo wose, kuko yaburiye muri Kongo, ko imitungo iburanwa yagombye guharirwa we n'umwana witwa Mbatezimana Pautin yabyaranye na Ntigurirwa Cyprien.

[14] Me Bundogo Innocent, uhagarariye Ntakirutimana Ezira, avuga ko amafaranga yose asabwa na Musasangohe Vestine adakwiye gutangwa kubera ko uwo ahagarariye yareze mu izina ry'abana be, akaba ari we ubarera, ko rero amafaranga yacibwa yava mu mutungo bashakanye.

UKO URUKIKO RUBIBONA

[15] Urukiko rurasanga nta kigaragaza ko imitungo ya Ntakirutimana Ezira ayifatanyije na Musasangohe Vestine, cyane cyane ko batasezeranye mu buryo bwemewe n'amategeko, hakaba rero nta cyatuma atamuha indishyi asaba mu gihe byaba ari ngombwa ko azitanga.

[16] Ku byerekeye 1.500.000Frw y'indishyi z'akababaro Musasangohe Vestine asaba Ntakirutimana Ezira, Urukiko rurasanga koko yaramushoye mu rubanza bitari ngombwa, ariko ayo mafaranga asaba akaba ari ikirenga, bityo mu bushishozi bwawo akaba agenewe angana na 500.000Frw.

[17] Naho 1.000.000Frw y'igihembo cya Avoka na 500.000Frw y'ikurikiranarubanza kuri uru rwego Musasangohe Vestine asaba Ntakirutimana Ezira, Urukiko rurasanga koko yarashatse Avoka wo kuburana urubanza kandi ararukurikirana, ariko ntagaragaza ko ayo mafaranga ari yo yakoresheje koko kuri uru rubanza, bityo mu bushishozi akaba agenewe 500.000Frw y'igihembo cya Avoka na 200.000Frw y'ikurikiranarubanza, yose hamwe akaba 700.000Frw kuri uru rwego.
