FCVG yajuririye icyo cyemezo kwa Komiseri Mukuru nawe ayisubiza ko ubujurire bwayo bufite ishingiro kuri bimwe yemeza ko, ku musoro yaciwe hakurwamo ungana na 20.186.699Frw, ajyanye n'umusoro ufatirwa wa 15% kuko yawugaragarije ibimenyetso bityo akishyura umusoro ungana na 105.551.109Frw.

FCVG ntiyishimiye icyo cyemezo iregera Urukiko rw'ubucuruzi rwa Nyarugenge irusaba kwemeza ko, nta musoro ku nyongeragaciro ugomba gucibwa kuri avansi yo gutangira imirimo ya 90.876.120Frw yahawe muri 2012, ko avansi yo gutangira imirimo ya 52.665.710Frw yahawe muri 2012 atabarirwa mu mafaranga acibwaho ihazabu yo kutiyandikisha mu musoro ku nyongeragaciro (TVA), ko yacibwa ibihano bibariwe kuri 50%, ko avansi yo gutangira imirimo yahawe muri 2012 ikwiye gukurwa mu mafaranga acibwaho umusoro ku nyungu, ko umusoro ku nyungu wa 2011, 2012 na 2013 ukwiye kubarwa hashingiwe ku gipimo cy'urwunguko rwa 3%; hashingiwe ku ihame ryo kugereranya abasoreshwa bakora imirimo isa kuko COCOASTER bakora imirimo imwe ariko isoreshwa, ko Urukiko rutegeka Ikigo cy'Imisoro n'Amahoro kwishyura igihembo cy'Avoka.

FCVG Ltd ntiyishimiye uwo mwanzuro, ijuririra Urukiko Rukuru rw'Ubucuruzi ivuga ko avansi yo gutangira imirimo itari gucibwaho umusoro ku nyongeragaciro kuko atari ubwishyu kandi ko hari ibyo yaregeye urukiko ntirwabisuzuma.

Urukiko nyuma yo gusuzuma ubujurire rwemeje ko nta gihindutse ku mikirize y'urubanza rwajuririwe kuko rwasanze FCVG Ltd yarakoreye inyemezabwishyu avansi yo gutangira imirimo yahawe zigaragaza umusoro ku nyongeragaciro (TVA) kandi n'ibihano yaciwe kubera kunyereza umusoro byaratanzwe hashingiwe ku mategeko agenga isoresha nta nteguza.

FCVG Ltd ntiyanyuzwe n'imikirize y'urwo rubanza maze ijuririra mu Rukiko rw'Ikirenga ivuga ko Urukiko Rukuru rw'Ubucuruzi rwavuze ko avansi yo gutangira imirimo igomba gucibwaho umusoro TVA kuko wanditse ku nyemezabuguzi kandi ataribyoye, ibihano bikwiye kubarirwa kuri 50% aho kuba 100% hashingiwe ku ihame rya «indépendance de l'exercice fiscal»; avansi yo gutangira imirimo ikurwa mu mafaranga asoreshwa umusoro ku nyungu, asaba kandi urukiko gutegeka ko yasoreshwa ku kigero cy'urwunguko nkicyo abo bakora akazi kamwe basoreshwaho.

[1] Forest Company Volcanoes Gorillas (FCVG) yakorewe igenzura ry’umusoro mu myaka ya 2011, 2012 na 2013, icibwa umusoro n’ibihano, itegekwa kwishyura 125.737.718Frw.FCVG Ltd ntiyishimiye umwanzuro w’abagenzuzi, ijuririra Komiseri Mukuru, nawe asubiza ku wa 08/10/2012, ayimenyesha ko ubujurire bwayo bufite ishingiro ku bijyanye n’umusoro ufatirwa wa 15% ungana na 1.293.537Frw igomba kwemererwa kuko yawugaragarije ibimenyetso, yemeza ko ku musoro yaciwe hakurwaho ungana na 20.186.699Frw, ikishyura ungana na 105.551.109Frw.

d) Mu kubara umusoro ku nyungu, umusoresha yagereranyije FCVG Ltd n'abandi bahuje imirimo, amubarira urwunguko rwa 21% kandi azi neza ko uwitwa Cocaster Ltd bakora imirimo imwe, yamenyekanishije urwunguko rwa 1% mu mwaka wa 2011, urwa 6% mu mwaka wa 2012 n'urwa 1% mu mwaka wa 2013, impuzandengo (moyenne/average) ikaba 3% FCVG Ltd yamenyekanishije.

Asobanura ko Ikigo cy’Imisoro n’Amahôro cyafashe iyo « avance de démarrage » nk’ubwishyu, babijurira kwa Komiseri Mukuru, ku mpapuro za 5, 6 na 9 z’icyemezo cye bikaba bigaragara ko nawe yakomeje kubifata atyo, bageze mu Rukiko Rukuru rw’Ubucuruzi narwo rwemeza ko ayo mafaranga ari ubwishyu bugomba gucibwaho umusoro. Asobanura ko Urukiko Rukuru rw’Ubucuruzi rwashingiye icyemezo cyarwo ku kuba FCVG Ltd yaribeshye igashyira umusoro ku nyemezabwishyu yakoreye MINAGRI, rwirengagiza ikibazo rwari rwabajijwe cyo kumenya niba « avance de démarrage » isoreshwa. Avuga ko « avance de démarrage » yasobanuwe bihagije n’uru Rukiko mu rubanza Ikigo cy’Imisoro n’Amahôro cyaburanaga na Misigaro Louis,<sup>1</sup> rwemeza ko atari ubwishyu kuko ari amafaranga asubizwa Leta isoko ireba ryaba ryarangiye cyangwa ritarangiye, ariyo mpamvu asaba uru Rukiko kuguma mu murongo rwemeje, rukavuga ko ariya 90.876.520Frw atagomba gucibwaho umusoro ku nyongeragaciro n’umusoro ku nyungu.

[11] Me Byiringiro Bajeni avuga ko Itegeko risobanura neza ko « avance de démarrage » isonewe umusoro ari iyatanzwe ku mirimo y’ubwubatsi kandi akaba atari yo yakozwe na FCVG Ltd. Asobanura ko iyo FCVG Ltd yumva idakwiye gucibwa umusoro ku nyongeragaciro yari kuvangura fagitire zayo zijyanye n’isoko yari yatsindiye n’izijyanye na « avance de démarrage », ariko ko atari uko yabikoze, ahubwo ko fagitire zijyanye niyo « avance de démarrage » yakoreye MINAGRI yashyizemo n’uwo musoro, irawuhabwa ariko ikaba idashaka kuwushyikiriza umusoresha, ariyo mpamvu asanga ibisobanuro byatanzwe n’uru Rukiko kuri « avance de démarrage » mu rubanza Ikigo cy’Imisoro n’Amahôro cyaburanaga na Misigaro Louis ntacyo byarumarira kuko zitandukanye bitewe nuko Misigaro Louis yari akurikiranweho kudaca uwo musoro muri fagitire za « avance de démarrage » yari yakoze.
