**Incamake y'ikibazo:** Ikigo cy'Imisoro n'Amahôro cyafatiriye imitungo itimukanwa y'abanyamigabane ba sosiyete Quincaillerie du Nil mu rwego rwo kwishyura umusoro icyo kigo cyishyuzaga iyo sosiyete, ibyo bituma abo banyamigabane barega Ikigo cy'Imisoro n'Amahôro mu Rukiko rw'Ubucuruzi rwa Nyarugenge bavuga ko cyatandukiriye gifatira imitungo yabo bwite kandi ubusanze umuyobozu cyangwa umunyamigabane wa sosiyete adashobora kuryozwa umusoro iyo bidategetswe n'urukiko, basaba kuvanirwa ho iryo fatiramitungo.

Urwo rukiko rwemeje ko iryo fatira ku mitungo itimukanwa y'abanyamigabane rinyuranyije n'amategeko kuko aho gufatira imitungo ya Quincaillerie du Nil hafatiriwe iya banyamigabane bayo, ibyo kandi bigakorwa nta cyemezo cy'urukiko cyemeza uburyozwe bw'abanyamigabane bayo.

Ikigo cy'Imisoro n'Amahôro nticyishimiye icyo cyemezo maze rukijurira mu Rukiko Rukuru rw'Ubucuruzi ivuga ko itegeko rirebana n'imitunganyirize yisoresha ridateganya ko habanza kwemezwa uburyozwe bw'umuyobozu cyangwa umunyamigabane wa sosiyete kugira ngo ibikorwa byo kwishyuza umusoro bibone gukorwa. Urukiko rwemeza ko Ikigo cy'Imisoro n'Amahôro cyari ifite uburenganzira bwo gufatira imitungo y'abanyamigabane ba sosiyete Quincaillerie du Nil mbere yuko urukiko rubifitiye ububasha rwemeza uruhare rwabo mu kutishyura imisoro.

Abanyamigabane ba Quincaillerie du Nil ntibanyuzwe n'icyo cyemezo cy'urukiko maze bajurira mu Rukiko rw'Ikirenga bavuga ko imitungo yabo yafatiriwe mu buryo bunyuranyije n'amategeko kuko byakozwe nta cyemezo cy'urukiko kibitegetse, bavuga kandi ko imitungo yabo bwite itandukanye n'imitungo ya sosiyete babereye abanyamigabane, basaba uru rukiko gusuzuma niba ifatira ry'imitungo itari ya nyiri gucibwa imisoro ryemewe mbere yuko urukiko rubifitiye ububasha rwemeza uburyozwe.

Mu kwiregura, Ikigo cy'Imisoro n'Amahôro kivuga ko imitungo yafatiriwe itatejwe cyamunara kandi ko ifatira ry'umutungo w'abayobozi cyangwa abanyamigabane ba sosiyete itarujuje inshingano zayo zo kwishyura umusoro bitewe n'uburangare cyangwa imicungire n'imikoreshereze mibi y'umutungo wayo, riba rigamije gukumira ihinduranyamitungo (mutation) kuko bitabaye umutungo wari kuzavamo umusoro waciwe, wanyerezwa maze umusoro ukabura.

Quincallerie du Nil Ltd ntiyanyuzwe n'ico cyemezo, yiyambaza inzira zose ziteganywa n'amategeko harimo n'Inkiko isaba ivanwaho ry'umusoro yaciwe. Ku rwego rwa nyuma, Urukiko rw'Ikirenga rwaciye urubanza RCOMA0029/12/CS, rwemeza ko Quincaillerie du Nil Ltd yishyura umusoro yaciwe.

[2] Mu rwego rwo kwishyuza umusoro wari umaze kugera kuri 1.031.615.726Frw, Ikigo cy'Imisoro n'Amahôro cyafatiriye umutungo utimukanwa wa Munyampundu Antoine na Mukarugambwa Béatrice kuko ari abanyamigabane ba Quincallerie du Nil Ltd. Munyampundu Antoine na Mukarugambwa Béatrice baregeye Urukiko rw'Ubucuruzi bavuga ko aho kugirango Ikigo cy'Imisoro n'Amahôro gishake ubwishyu mu mutungo wa Quincaillerie du Nil Ltd yaciwe umusoro, cyatandukiriye, gifatira umutungo bwite wabo kandi ataribo bawuciwe, ko ibi binyuranije n'gingingo ya 48 y'Itegeko N°25/2005 ryo kuwa 04/12/2005 rigena imitunganyirize y'isoresha kubera ko umuyobozi cyangwa

umunyamigabane wa sosiyete adashobora kuryozwa umusoro waciwe iyo sosiyete bitategetswe n'Urukiko.

[4] Urukiko rw'Ubucuruzi rwa Nyarugenge rwasanze kandi ibyo ikigo cy'imisoro n'amahôro cyaburanishaga ko hakwemezwa uruhare n'uburyozwe bya Munyampundu Antoine na Mukarugambwa Béatrice mu gutuma Quincaillerie du Nil Ltd itubahiriza inshingano zayo kuko aribo bayobozi n'abanyamigabane bayo nta shingiro bifite kuko babisabye nyuma yo gufatira imitungo bwite yabo.

[5] Ikigo cy'imisoro n'amahôro nticyishimiye icyo cyemezo, ikijuririra mu Rukiko Rukuru rw'Ubucuruzi kivuga ko ingingo ya 46 bis y'Itegeko N°25/2005 ryo kuwa 04/12/2005 rigena imitunganyirize y'isoresha ntaho iteganya ko habanza kwemezwa uburyozwe bw'umuyobozi cyangwa umunyamigabane wa sosiyete kugira ngo ibikorwa byo kwishyuza umusoro bibone gukorwa, ahubwo ko umusoresha afite uburenganzira bwo kubishyuza bose mu gihe abona baragize uburangare cyangwa ubushake buke byatumye sosiyete itishyura imisoro yaciwe, havuka impaka, bakaregera Urukiko kugirango rwemeze uburyozwe cyangwa bukurweho.

[6] Mu rubanza RCOMA0024/16/HCC rwaciwe kuwa 15/04/2016, Urukiko rwasanze ikibazo ababuranyi batumvikanaho ari ukumenya niba ari ngombwa kubanza kuregera urukiko kugira ngo rwemeze uburyozwe bw'abayobozi cyangwa abanyamigabane ba sosiyete mbere y'uko imitungo yabo ifatirwa hagamijwe kwishyurira sosiyete imisoro, rusesenguye ingingo ya 46 bis y'Itegeko N°25/2005 ryo kuwa 04/12/2005 rigena imitunganyirize y'isoresha, rusanga ntaho ivuga ko nta fatira rikorwa ku mitungo y'abayobozi cyangwa abanyamigabane ba sosiyete mbere y'uko Urukiko rwemeza uburyozwe bwabo kuko ifatira rikorwa mbere y'igurisha kugira ngo imitungo itarigiswa mbere y'icyemezo cy'Urukiko cyemeza uburyozwe bwa ba nyirayo.

[7] Urukiko rwemeje ko ikigo cy'imisoro n'amahôro cyari gifite uburenganzira bwo gufatira imitungo itimukanwa ya Munyampundu Antoine na Mukarugamba Béatrice, abanyamigabane ba Quincaillerie du Nil Ltd, mbere y'uko urukiko rubifitiye ububasha rwemeza ko bagize uruhare mu kutishyura imisoro ya sosiyete, ni uko rwemeza ko imikirize y'urubanza rwajuririwe ihindutse.

[8] Munyampundu Antoine na Mukarugambwa Béatrice ntibishimiye icyo cyemezo bajurira mu Rukiko rw'Ikirenga basaba ko hasuzumwa ikibazo cyo kumenya niba ifatira ry'umutungo utari uwa nyiri gucibwa umusoro ryemewe mbere y'uko urukiko rubyemeza kuko basanga ingingo ya 46 bis y'Itegeko N°25/2005 ryo kuwa 04/12/2005 rigena imitunganyirize y'isoresha itavuga mu buryo bweruye niba ifatira ry'umutungo w'abayobozi n'abanyamigabane ba sosiyete yaciwe umusoro rikorwa mbere cyangwa nyuma y'icyemezo cy'Urukiko rubifitiye ububasha kigaragaza uburyozwe bwabo, nubwo bo basanga kwemeza uburyozwe aribyo byari bikwiye kubanziriza ifatira bitewe n'uko ifatira rikorwa kugirango umutungo uzagurishwe havemo ubwishyu.

Uwo munsi iburanisha ribera mu ruhame, Mukarugambwa Béatrice ahagarariwe na Me Ndayisabye Alex, Munyampundu Antoine aburanirwa na Me Twilingiyemungu Joseph naho Ikigo cy'Imisoro n'Amahôro, kiburanirwa na Me Gatera Jean Clément na Me Twahirwa Jean-Baptiste.

[10] Me Ndayisabye Alex avuga ko imitingo ya Mukarugambwa Béatrice yafatiriwe mu buryo bunyuraniye n'amategeko bitewe n'uko byakozwe nta cyemezo cy'Urukiko kibitegetse nk'uko biteganywa n'ingingo ya 46 bis y'Itegeko N°25/2005 ryo ku wa 04/12/2005 rigena imitunganyirize y'isoresha. Asobanura ko Urukiko Rukuru rw'Ubucuruzi rwakoreye iyo ngingo isesengura ritari ryo kuko rwavuze ko nta kigaragaza ko ifatira ryari gukurikirwa n'igurisha, ruraryemeza nyamara icyatumye imitingo itagurishwa ari uko batanze ikirego cyihutirwa gihagarika igurisha, ko Urukiko rwivuguruje kuko nyuma yo kwemeza ifatira, rwavuze ko ikirego cy'uburyozwe kitagombaga kwakirwa, hakibazwa icyo ifatira ryari gushingiraho. Avuga ko gufatira umutungo w'umuntu ku mpamvu z'umusoro bibanzirizwa no kubanza kugaragaza ko ari umusoreshwa, ko ibyo aribyo biteganywa n'ingingo ya 48 y'Itegeko rimaze kuvugwa, kubikora hatabanje kugaragazwa ko nyiri umutungo ari umusoreshwa ari ukuvogera umutungo we bwite, ibyo bikaba bibujije n'ingingo ya 34 y'Itegeko-Nshinga ryo mu 2003 ryavuguruwe mu 2015<sup>1</sup>, binyuranye n'ihame ry'amategeko rya "piercing corporate veil" ndetse bihabanye n'ibyemezo by'Inkiko zo mu bindi bihugu nko mu Bwongereza aho mu rubanza rwa *Solomon v. Solomon*<sup>2</sup>, Urukiko rw'Ikienga rwavuze ko umutungo bwite w'umuryango cyangwa w'umuntu ku giti cye utakwitiranwa n'umutungo wa sosiyete, ariyo mpamvu asaba uru Rukiko guhindura urubanza rujuririrwa.

[11] Me Twilingiyemungu Joseph uburanira Munyampundu Antoine avuga ko umusoro wishyuzwa Quincaillerie du Nil Ltd, ikaba ifite umutungo wayo utandukanye n'uwa Munyampundu Antoine na Mukarugambwa Béatrice. Asobanura ko aha ariho Urukiko Rukuru rw'Ubucuruzi rwitiranyije ibintu, ruvuga ko hakozwe ifatira ry'agateganyo nyamara dosiye igaragaza ko nyuma y'ifatira, umusoresha yahise

ashyiraho amatariki y'igurisha, ibyo bikaba bitari gukorwa nta cyemezo cy'Urukiko kigaragaza uburyozwe bw'aba nyiri umutungo.

[12] Me Gatera Jean Clément, uburanira Ikigo cy'Imisoro n'Amahôro, avuga ko ifatira ry'umutungo w'abayobozi cyangwa abanyamigabane ba sosiyyete itarujuje inshingano zayo zo kwishyura umusoro, bitewe n'uburangare cyangwa imicungire n'imikoreshereze mibi y'umutungo wayo, riba rigamije gukumira ihinduranyamitungo (mutation) kuko bitabaye umutungo wari kuzavamo umusoro waciwe, wanyerezwa. Asobanura ko ingingo ya 46 bis y'Itegeko N°25/2005 ryo kuwa 04/12/2005 ryavuzwe haruguru itanga inzira yo gufatira iyo mitungo nta zindi manza zibayeho kuko umushingamategeko yasanze habanje imanza, umutungo wahishwa cyangwa ukarigiswa, aricyo kigaragaza ko nta burenganzira ku mutungo bwavogerewe. Asobanura ko ifatira ryari rigamije gukumira ko imitungo inyerezwa umusoro ukazabura, kuko gutegereza imanza bishobora kurangira imitungo yarikuvamo ubwishi irigishijwe.

[16] Ingingo ya 46 bis y'Itegeko N°25/2005 ryo ku wa 04/12/2005 rigena imitunganyirize y'isoresha ivuga ko abayobozi bafite uruhare mu buryo butaziguye mu igenzura no mu micungire y'isosiyete idahamagarira rubanda kuyiguramo imigabane, baryozwa bose hamwe imisoro iyo sosiyyete ibazwa, iyo bigaragaye ko ku bushake cyangwa ku burangare bwabo batumye isosiyete iryozwa iyo misoro. Abanyamigabane na bo baryozwa imisoro y'isosiyete iyo bafite uruhare mu micungire y'isosiyete cyangwa mu mikoreshereze mibi y'umutungo wayo ku buryo bituma idashobora kuzuza inshingano zijiyanje n'imisoro. Urukiko rubifitiye ububasha rwemeza uburyozwe bw'abayobozi n'abanyamigabane buvugwa muri iyi ngingo.

Ibyafatiriwe bitezwa cyamunara nyuma y'iminsi umunani (8) umusoreshwa amenyeshejwe inyandiko y'ifatira (.....). Gufatira no guteza cyamunara umutungo wafatiriwe bikurikiza amategeko y'imbonezamubano n'ubucuruzi. sosiyete iyo rusanzé uwo munyamigabane yarakoresheje nabi imiterere ya sosiyete agamije uburiganya cyangwa kwica amategeko cyangwa yarafashe nabi umutungo wa sosiyete nk'aho ari umutungo w'abantu ku giti cyabo.” Cyakora, mu kwemeza uburyozwe, Inkiko zishimangira ko bidapfa gukorwa, ahubwo hagomba gushingirwa ku mpamvu zisobanutse (*circumstances in which the corporate veil may be lifted are greatly circumscribed*) zigaragaza igituma abayobozi cyangwa abanyamigabane bagomba kuryozwa ibyakaryojwe sosiyete<sup>5</sup>, nabyo bishimangira ko gutandukanya ubwo buzimagatozi bitemezwá n'uwo ari we wese cyangwa ngo abikore uko yiboneye, ahubwo ni umwihariko (exception) wemezwá n'Inkiko mu rwego rwo kurengera inyungu runaka zitari kurengerwa Urukiko ruramutse rutemeje uruhare rw'abayobozi cyangwa abanyamigabane mu gutuma sosiyete itubahiriza inshingano zayo<sup>6</sup>.
