

# CHEON KWANG DEVELOPMENT COMPANY Ltd N'INDI v. LETA Y'URWANDA/MINAGRI

*Amategeko agenga amasezerano – Amasezerano y'ubukemurampaka – Iyo abagiranye amasezerano y'ubukemurampaka bateganyije ko bagomba kunyura mu nzira ya "adjudication" mbere yo kwiyambaza ubukemurampaka bigomba kubahirizwa, iyo bidakozwe inteko y'ubukemurampaka nta bubasha iba ifite bwo kwakira ikirego gikomoka kuri ayo masezerano.*

*Amategeko agenga imiburanishirize y'imanza z'ubucuruzi – Inteko y'abakemurampaka ishobora kwanga kwakira imyanzuro y'ababuranyi hakurijwe ubukererwe bw'ibihindurwa cyangwa ibyongerwamo – Itegeko N°005/2008 ryo ku wa 14/02/2008 ry'ubukemurampaka n'ubwunzi mu by'ubucuruzi, ingingo ya 35.*

**Incumake y'ikibazo:** Sosiyete CHEON KWANG DEVELOPMENT COMPANY Ltd na EXERT ENGINEERING GROUP Ltd zishyize hamwe zigirana amasezerano na Leta y'u Rwanda (MINAGRI) yo kubaka ibidamu no kuhira imyaka mu misozi, impande zombi zikaba zarateganyije mu masezerano zagiranye, ko ziramutse zigiranye ibibazo, bizakemurwa n'Ubukemurampaka ariko zibanje kwiyambaza *adjudicator*.

Nyuma yaho izo sosiyete zitangiriye imirimo, ntizabashije kubahiriza igihe imirimo igomba kurangirira zisaba Leta y'u Rwanda ko yazongerera igihe cyo kurangiza imirimo, nyuma yo kubisuzuma Leta yanga kongera icyo gihe ahubwo ifata umwanzuro wo gusesa amasezerano. Izi sosiyete ntizishimiye iki cyemezo ziregera abakemurampaka.

Impande zombi zatanze imyanzuro, maze Inteko y'Abakemurampaka itegeka ko iburanisha mu mizi y'urubanza izakomeza aruko impande zombi zishyize umukono ku nyandiko yateguve n'inteko yabakemurampaka, ariko Leta y'u Rwanda/MINAGRI yavuze ko adashyira umukono kuri iyo nyandiko kuko yatanze inzitizi, mu mwanzuro wayo, ivuga ko nta bukemurampaka bwaba igehe ari nta cyemezo cya "adjudicator" gihari, byatumye Inteko itegeka ko impande zombi zitegura imyanzuro kuri iyo nzitizi kugirango hazabe iburanisha kuriyo, kandi itanga itariki ntarengwa yo kuba impande zombi zayishyikirije iyo myanzuro.

Mu myanzuro, abarega bagaragaje ko Leta y'u Rwanda/MINAGRI yanze inzira ya "adjudication", bityo akaba nta kundi bari kubigenza uretse kwiyambaza ubukemurampaka nk'uko amasezerano yabiteganyaga, kandi ngo ntabwo byari itegeko ko bagombaga kubanza gushyikiriza ikirego "adjudicator". Ku bijyanye n'imyanzuro y'inyongera inteko y'abakemurampaka yanze kuyakira kuko yatanze ikererewe inteko yamaze gufata icyemezo uretse kandi ko ntacyo yari kumarira inteko. Hanyuma Inteko ifata icyemezo cy'uko nta bubasha ifite kuko nta cyemezo cya "adjudicator" gihari.

Abarega ntibishimiye icyo cyemezo, baregera Urukiko Rukuru rw'Ubucuruzi, barusaba ko rwakwemeza ko Inteko y'Abakemurampaka yari ifite ububasha, bavuze kandi ko batishimiye uburyo Inteko yafashe icyemezo mbere y'uko ababuranyi baburana, kandi ko inteko yirengagije ibiteganywa n'ingingo ya 35 (2) y'Itegeko N°005/2008 ryo ku wa 14/02/2008, ndetse yirengagiza icyo amasezerano ateganya. Uru rukiko rwemeje ko nta gihindutse ku cyemezo cy'Inteko y'Abakemurampaka.

Abarega ntibishimiye imikirize y'urwo rubanza bajorira mu Rukiko rw'Ikirenga bavuga ko Urukiko Rukuru rw'Ubucuruzi rwashingiye ku Itegeko ry'imiburanishirize riri rusange kandi hari itegeko ryihariye ry'ubukemurampaka bituma rwemeza ko inteko y'abakemurampaka yari ifite uburenganzira bwo kwanga kwakira imyanzuro y'inyongera yatanzwe n'abarega ku nzitizi. Kandi ko urwo rukiko rutasobanuye icyo ingingo y'amasezerano irebana n'icyemezo cyagombaga kujya mu bukemurampaka kuko iyi ngingo idafata "adjudication" nk'itegeko kugirango ikirego cyakirwe n'abakemurampaka ndetse ko ubukemurampaka butagombaga gukorwa hashingiwe ku cyemezo cya "adjudicator" ahubwo ko iyo ngingo ivuga ku mpaka zose zivutse mu masezerano.

Leta y'u Rwanda ivuga ko nta kuvuguruzanya kuri hagati y'ngingo ya 69 y'Itegeko N°21/2012 ryo ku wa 14/06/2012 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, n'iya 35 y'Itegeko ry'Ubukemurampaka. Kandi ko uburyo bwo gukemura impaka bwateganyijwe mu masezerano bubanzirizwa na adjudication byananirana hakiyambazwa ubukemurampaka.

## **I. IMITERERE Y'URUBANZA**

[1] Amasosiyete y'ubucuruzi CHEON KWANG DEVELOPMENT COMPANY Ltd na EXERT ENGINEERING GROUP Ltd yishyize hamwe (joint venture), hanyuma agirana amasezerano na Leta y'u Rwanda (MINAGRI), binyuze mu mushinga wo kubaka ibidamu no kuhira imyaka mu misozi mu Karere ka Rwamagana (Construction works of a 14 meters high earth-fill dam and 267 ha Hillside Irrigation System), impande zombi zikaba zarateganyije, mu masezerano zagiranye, ko ziramutse zigiranye ibibazo, bizakemurwa n'Ubukemurampaka.

[2] Nk'uko amasezerano abiteganya, impande zombi zashyizeho abakemurampaka babiri (2), nabo bahitamo undi uzaba Perezida w'Inteko, hanyuma Inteko itumiza ababuranyi i Nairobi muri Kenya, mu

iburanisha ry'ibanze, impande zombi zumvikana ko amategeko azakoreshwa ari ay'u Rwanda. Muri iryo buranisha, Leta y'u Rwanda/MINAGRI yagaragaje ko Umukemurampaka washyizweho n'amasosiyete yareze ari umujyanama wayo, bityo akaba adakwiriye kuba Umukemurampaka, hanyuma Inteko ifata icyemezo cyo kutabiha agaciro.

[3] Impande zombi zatanze imyanzuro, maze Inteko y'Abakemurampaka itegeka ko iburanisha mu mizi y'urubanza rizakorwa ku wa 16/06/2016 no ku wa 17/06/2016. Ku wa 16/06/2016 iyo Nteko yazanye inyandiko, isaba ko ababuranyi bayisinya, iyo nyandiko ikaba yari ikubiyemo ibi bikurikira: “*Notwithstanding the provision of clause 24 of the contract which obliged the parties in the first instance to refer their disputes and differences to an adjudicator and only refer the matter to arbitration after the adjudicator's written decision thereon, the parties agree to refer the disputes and differences between them arising out of the contract to arbitration by a tribunal of three arbitrators two of whom shall be the parties appointees and the third one who shall be the presiding arbitrator shall be appointed by the two party arbitrators*”.

[4] Nyuma yo gutanga inyandiko imaze kuvugwa haruguru, uhagarariye Leta y'u Rwanda/MINAGRI yavuze ko adashyira umukono kuri iyo nyandiko kuko yatanze inzitizi, mu mwanzuro we, avuga ko nta bukemurampaka bwaba igithe ari nta cyemezo cya “adjudicator” gihari. Ibyo byatumye Inteko itegeka ko impande zombi zitegura imyanzuro kuri iyo nzitizi, igatangwa bitarenze saa sita z'ijoro ryo ku wa 16/06/2016 kugira ngo ku munsi ukurikiyeho (ku wa 17/06/2016) hazabe iburanisha kuri iyo nzitizi.

[5] Mu iburanisha ryo ku wa 17/06/2016 no mu myanzuro, abarega (joint venture) bagaragaje ko Leta y'u Rwanda/MINAGRI yanze inzira ya “adjudication” kuko yandikiwe kugira ngo hajyeho “adjudicator”, isubiza mu buryo bw'amananiza, bityo akaba nta kundi bari kubigenza uretse kwiyambaza ubukemurampaka nk'uko amasezerano yabiteganyaga, kabone n'ubwo bitari itegeko ko bagombaga kubanza gushyikiriza ikirego “adjudicator”.

[6] Ku wa 29/06/2016, abarega batanze umwanzuro w'inyongera wo kwiregura ku nzitizi, bashingiye ku ngingo ya 35 (2) y'Itegeko N°005/2008 ryo ku wa 14/02/2008 ryerekeye ubukemurampaka n'ubwunzi mu bibazo by'ubucuruzi, hanyuma ku wa 25/07/2016, Inteko ifata icyemezo cy'uko nta bubasha ifite kuko nta cyemezo cya “adjudicator” gihari.

[7] Amasosiyete CHEON KWANG DEVELOPMENT COMPANY Ltd na EXERT ENGINEERING GROUP Ltd ntiyishimiye icyo cyemezo cy'Inteko y'ubukemurampaka, aregera Urukiko Rukuru rw'Ubucuruzi, arusaba ko rwakwemeza ko inteko y'abakemurampaka yari ifite ububasha bwo gukemura izo mpaka bagiranye. Ayo masosiyete yavuze kandi ko ikindi atishimiye ari uko Inteko y'Abakemurampaka yafashe icyemezo mbere y'uko ababuranyi baburana, no kuba yarirengagije nkana ibiteganywa n'ingingo ya 35 (2) y'Itegeko N°005/2008 ryo ku wa 14/02/2008 ryerekeye ubukemurampaka n'ubwunzi mu bibazo by'ubucuruzi, ndetse no kuba yarirengagije icyo amasezerano ateganya.

[8] Mu rubanza RCOMA00476/2016/CHC/HCC rwaciwe ku wa 28/10/2016, Urukiko Rukuru rw'Ubucuruzi rwemeje ko nta gihindutse ku cyemezo cy'Inteko y'Abakemurampaka. Mu gufata icyo cyemezo, Urukiko Rukuru rw'Ubucuruzi rwasanze kuvuga ko Inteko y'Abakemurampaka yafashe icyemezo ku rubanza, rutabanje kumva impande zombi, bitahabwa ishingiro kuko, kuba impande zombi zarumvikanye ko mw'iburanisha hazakoreshwa amategeko y'u Rwanda, ingingo ya 78, igika cya 2,

n'iya 142 z'Itegeko N°21/2012 ryo ku wa 14/06/2012 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi zemerera umucamanza, abyibwirije, kubyutsa inzitizi y'iburabubasha aho urubanza rwaba rugeze hose, hanyuma iyo Nteko y'Abakemurampaka iza kubyutsa iyo nzitizi y'iburabubasha, nyuma yo kumva ababuranyi, rukayifataho icyemezo, ibyo byerekana ko rutanyuranyije n'amategeko y'u Rwanda impande zombi zemeranyije ko ariyo azakurikizwa.

[9] CHEON KWANG DEVELOPMENT COMPANY Ltd na EXERT ENGINEERING GROUP Ltd ntizishimiye imikirize y'urubanza rwaciwe n'Urukiko Rukuru rw'Ubucuruzi, zижурirira mu Rukiko rw'Ikirenga kubera impamvu zikurikira:

1. Kuba Urukiko Rukuru rw'Ubucuruzi rwarashingiye ku ngingo ya 69 y'Itegeko N°21/2012 ryo ku wa 14/06/2012 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, rwemeza ko urukiko rufite ububasha bwo kuba rwakwemera umwanzuro w'inyongera cyangwa indi nyandiko itanzwe nyuma yo gupfundikira iburanisha, ariko ko rwirengagije ko Itegeko N°21/2012 rimaze kuvugwa ari "general procedure law/droit commun" rikoreshwa gusa iyo itegeko ryihariye ari ntacyo ryavuze ku kibazo; ko Itegeko ry'ubukemurampaka ari "specific" ku kibazo cy'ubukemurampaka ari naryo ryagombaga gukoreshwa kuko ingingo yaryo ya 35 igaragaza igithe umwanzuro w'inyongera ushobora kwakirwa cyangwa ntiwakirwe.

Kuba Urukiko Rukuru rw'Ubucuruzi rutarigeze rushaka gusobanura icyo ingingo ya 24 y'amasezerano yavugaga ku bijyanye n'icyemezo cyagombaga kujya mu bukemurampaka; ko iyo ngingo idateganya ko ubukemurampaka bugomba gukorwa hashingiwe ku cyemezo cyafashwe na "adjudicator", ahubwo ko ivuga impaka zose zifyanye n'amasezerano, ndetse ko idafata "adjudication procedure" nk'itegeko kugira ngo ikirego cyakirwe n'Inteko y'Abakemurampaka, ahubwo ko iyo "procédure" iteganyijwe mu yindi nyandiko yiswe "General conditions of contract" mu ngingo ya 24.1-3 ku byemezo byafashwe na "Project manager" gusa.

[10] Urubanza rwaburanishijwe mu ruhame ku wa 14/02/2017, CHEON KWANG DEVELOPMENT COMPANY Ltd na EXERT ENGINEERING GROUP Ltd zihagarariwe na Me Butare Emmanuel, naho Leta y'u Rwanda ihagarariwe na Me Rubango Epimaque, Intumwa ya Leta, uyu akaba yaratane inzitizi y'iburabubasha ry'Urukiko rw'Ikirenga, ariko uru Rukiko rusanga iyo nzitizi nta shingiro ifite, urubanza ruburanishwa mu ruhame ku wa 23/05/2017, impande zombi zihagarariwe nk'uko byari bimeze mu iburanisha ryo ku wa 14/02/2017.

Asobanura ko, kugira ngo imyanzuro ntiyakirwe,

ari uko iba yaratanzwe ikererewe; ko igihe baburanaga mu bukemurampaka, babwiwe ko bazasomerwa "on notice", maze kuwa 29/06/2016, batanga imyanzuro y'inyongera, bigeze ku wa 08/07/2016 babona "e-mail" ibamenyesha ko iyo myanzuro itakiriwe, ariko ko bigaragara ko, mu gutanga iyo myanzuro y'inyongera, nta bukererwe bwabayeho, bityo ko basaba Urukiko rw'Ikirenga kwemeza ko iyo myanzuro yagombaga kwakirwa. Akomeza avuga ko ikindi ari uko Urukiko Rukuru rw'Ubucuruzi, ku bijyanye no gutanga imyanzuro y'inyongera, rwashingiye ku ngingo ya 69 y'Itegeko N°21/2012 ryo ku wa 14/06/2012 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, ariko rwirengagiza ko iri tegeko ari "droit commun", ko ahubwo rwagombaga gushingira ku ngingo ya 35 y'Itegeko ryerekeye ubukemurampaka n'ubwunzi mu bibazo by'ubucuruzi.

[12] Me Rubango Epimaque, uhagarariye Leta y'u Rwanda, avuga ko, ku bijyanye no kuba umucamanza yakwanga cyangwa akemera imyanzuro y'inyongera, asanga nta kuvuguruzanya kuri hagati y'ingingo ya 69 y'Itegeko N°21/2012 ryo ku wa 14/06/2012 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, n'iya 35 y'Itegeko ry'Ubukemurampaka.

[13] Ingingo ya 35, igika cya kabiri, y'Itegeko N°0005/2008 ryo ku wa 14/02/2008 ryerekeye ubukemurampaka n'ubwunzi mu bibazo by'ubucuruzi, iteganya ko: "Uretse igihe abiyambaje ubukemurampaka babyemeranyijweho ukundi, uwiyambaje ubukemurampaka wese ashobora guhindura cyangwa kugira ibyo yongera mu mwanzuro wo gutanga ikirego cye cyangwa mu mwanzuro wo kwiregura, mu gihe cy'isuzumwa ry'ikirego, keretse Inteko y'Abakemurampaka isanze atari byiza kwemera uko guhindura hakurijwe ubukererwe bw'ibihindurwa cyangwa ibyongerwamo".

[14] Muri uru rubanza, dosiye igaragaza ko, nyuma y'uko ikibazo impande zombi zifitanye kigejejwe ku Nteko y'Abakemurampaka i Nairobi muri Kenya, mu iburanisha ryo ku wa 16/06/2016, Leta y'u Rwanda yatanze inzitizi y'iburabubasha y'Inteko y'Ubukemurampaka, hanyuma iyo Nteko ifata icyemezo cyo kwimurira iburanisha ku wa 17/06/2016 kugira ngo impande zombi zikore imyanzuro kuri iyo nzitizi, kuri iyo tariki urubanza ruraburanishwa, rurapfundikirwa, bigeze ku wa 29/06/2016 uburanira abarega yongera cohoreza imyanzuro y'inyongera kuri iyo nzitizi, hanyuma ku wa 08/07/2016, Perezida w'Inteko Nkemurampaka amusubiza ko iyo myanzuro itakiriwe kuko, uretse kuba ntacyo yamarira Inteko mu ifatwa ry'icyemezo, n'ubundi yakiriwe Inteko yaramaze kwemeranya ku mwanzuro wabo ku bubasha bw'Inteko y'Abakemurampaka<sup>1</sup>.

[15] Urukiko rurasanga, nk'uko bitemanywa n'ingingo ya 35, igika cya kabiri, y'Itegeko N°005/2008 ryavuzwe haruguru, uwiyambaje ubukemurampaka wese afite uburenganzira bwo kutanga imyanzuro y'inyongera mu gihe cy'isuzuma ry'ikirego, ariko iyi ngingo inateganya ko iyo Nteko nayo ifite ububasha bwo kwanga kwakira iyo myanzuro hakurikijwe ubukererwe bw'ibihinduka cyangwa ibyongerwamo. Niba rero, nk'uko byasobanwe haruguru, iyo Nteko yarasobanuye ko impamvu yanze kwakira iyo myanzuro y'abarega yiregura ku nzitizi yari yatanze na Leta y'u Rwanda/MINAGRI, ari uko ntacyo yabamarira, byongeye kandi ikaba yaratanzwe abagize Inteko barbarangije kwemeranya ku mwanzuro wabo (deliberation), ibyo byerekana ko iyo Nteko nta tegeko yishe.

## **2. Kumenya niba harirengagijwe icyo amasezerano ateganya ku bijyanye n'ikurikizwa ry'inzira ya "adjudication".**

[17] Me Butare Emmanuel, uhagarariye CHEON KWANG DEVELOPMENT COMPANY Ltd na EXERT ENGINEERING GROUP Ltd avuga ko Inteko y'Abakemurampaka yirengagije icyo amasezerano ateganya. Asobanura ko mu ngingo ya 2.3 ya "General conditions of contract", humvikanywe uburyo inyandiko zitandukanye zifitanye isano n'amasezerano (*contract agreement*) zikurikirana mu kugira agaciro (*hiérarchie des normes*), ko "Particular conditions of contract" ziza mbere ya "General conditions of contract". [20] Dosiye y'uru rubanza igaragaza ko ikibazo kiri hagati y'ababuranyi gishingiye ku iseswa ry'amasezerano bari baftanye yiswe "Construction works of a 14 meters high earth-fill dam (lot 1) and 267 ha Hillside Irrigation System (lot 2) for Rwamagana-34 site in Gahengeri Sector, Rwamagana District, Eastern Province", ryatewe nuko imirimo yakererewe gukorwa.
