Uubo iburanisha ry'urubanza no RS/INJUST/RC 00024/2017/SC ryabaye ku wa 30/01/2018 ryari rigeze hagati, Me NIYONDORA Nsengiyumva, uburanira Ndenegeyintwari Fabien, yavuze ko uwo aburanira atizeye ubutabera ku mucamanza Hatangimbabazi Fabien uyoboye inteko y'urwo rubanza, bitewe n'uko yari mu nteko yaburanishije urubanza n° RC 00006/2017/SC ku kirego cyihutirwa rwaciwe ku wa 23/08/2017, ari nawe ushinzwe gutegura urubanza, ariyo mpamu amwihammye, asaba ko urubanza rwazakomeza yarasimbuwe. Urubanza rwarasubitswe, Me Niyondora Nsengiyumva asabwa kubahiriza ibiteganywa n'amategeko ku bijyanye no kwihana umucamanza.

Asobanura ko uwo munsi Me Niyondora Nsengiyumva yatanze indi nzitizi yo kutakira ikirego, iraburanishwa, Urukiko rwemeza ko izasuzumirwa rimwe n'urubanza mu mizi, yumvise atanyuzwe, abona kumwihana, akaba yibaza mpamvu atamwihannye urubanza rugitangira kandi avuga ko mpamvu ashingiraho ubwihane zariho mbere, byongeye kandi akaba atagaragaza icyo ashingiraho avuga ko yabogamiye kuri Karamaga Thomas cyangwa afitanye ubucuti nawe, ariyo mpamvu asanga ubwihane bwatanzwe na Ndenegeyintwari Fabien nta shingiro bufite. bashobora kumwihana iyo: ..4° umucamanza yagaragaje ubucuti afitiye umwe mu baburanyi cyangwa kuva aho urubanza rutangiriye, yarigeze kwakirwa n'umwe mu baburanyi ku mafaranga ye, cyangwa yaremeye impano ahawe n'umuburanyi; 5° yigeze kugira icyo avuga cyangwa agatanga inama kuri urwo rubanza mbere y'uko ruburanishwa ...7° yigeze kuba mu rubanza ari umucamanza, umwunzi, umushinjacyaha, umugenacyaha, umuburanyi, umutangabuhamya, umusemuzi, inzobere cyangwa umukozi wo mu butegetsi bwa Leta ...”

¹ “No person should be required to stand trial before a judge with a “bent of mind”. [But] if the only objective were to assure litigants that the presiding judge was utterly unbiased and impartial, it would be simple to institute a system, [...] by which both parties could peremptorily strike the assigned judge without giving a reason. If the process of peremptory challenge were endless, some judges would never try cases, others would be heavily overburdened, and the system of assigning judges would become much too cumbersome for everyday operation. [That is the reason why], the objecting party [must] demonstrate some sound reason for doubting the impartiality of the Judge... [For the judge's expressed view], if the circumstances or contents of a judge's statements indicate that the judge's mind is made up on the factual or legal merits of a reasonably litigated issue and this has occurred before the judge has heard the evidence and arguments of the litigants, then the judge should not sit.” Reba Charles W.
