Urukiko Rukuru, Urugerekero rwa Rwamagana rwaciye urwo rubanza, ruvuga ko ikirego cyihutirwa cya Kangabe nta shingiro gifite, nyuma yo gusanga ataragaragarije Urukiko uburyo impamvu atanga ari ibibazo byihuta mu rubanza rw'iremezo.

Yajuririrye Urukiko rw'Ikirenga avuga ko Urukiko Rukuru rwirengagije ibimenyetso bigaragaza impamvu asaba guhagarika kurangiza imanza yasubirishijemo ingingo nshya birimo ibigaragazako afite uburwayi buhoraho bw'igifu ndetse n'umugabo we akaba afite uburwayi buhoraho bwa Hepatite B, bakaba banafite abana babiri bato.

Ubushinjacyaha bwo bukaba bwaragaragazako impamvu uwajuriye atanga zaburanywe mu Rukiko Rukuru, urugerekero rwa Rwamagana, bukaba busanga ikirego cyihuritwa ari uburyo bwo gutinza urubanza kugira ngo rutarangizwa, bityo ko kitakwakirwa.

Uru rubanza kandi rwarimo na BPR Ltd, yo ikagaragazako nta nyungu ifite zo kuba Kangabe yafungwa ariko ko muri gereza hari uburyo bafata abafite uburwayi nk'ubwe.

Iyi ngingo ishimangirwa n'ingingo ya 1 y'Itegeko N°21/2012 ryo kuwa 14/06/2012 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, iteganya ko iri tegeko rigenga imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi.
