Umusoresha yajuririye mu Rukiko Rukuru rw'Ubucuruzi avuga ko urukiko rubanza rwemeje ko ubujurire bwa Ruberandinda kwa Komiseri Mukuru bufite ishingiro kandi ataribyo, uru Rukiko rwemeza ko ubujurire bwa RRA bufite ishingiro kuko rushingiye ku ibaruwa urega yandikiye Komiseri Mukuru, n'ibaruwa nawe yamusubije ishinganye, igashyikirizwa iposita ya Kigali igeria kuri poste ya Muhanga aho urega abarizwa rwasanze umusoresha yarabonye igisubizo cya Komiseri Mukuru iminsi 60 yateganyijwe n'itegeko.

Ruberandinda yajuririye mu Rukiko rw'Ikirenga avuga ko ingingo z'ubujurire batanzé zihuriye ku ngingo imwe gusa igamije kumenya aho icyemezo cya Komiseri Mukuru kigomba kunyuzwa kugirango kigere ku musoreshwa kuko Komiseri Mukuru wa RRA yashyize ubutumwa bwe kw'iposita ya Kigali kandi we abarizwa i Muhanga, akaba kandi yarahaye RRA aderesi ya Muhanga, ko rero RRA yagombaga gushyikiriza ubutumwa bwe ku iposita ya Muhanga.

Akomeza avuga ko itariki yagombaga guherwaho habarwa iminsi 60 RRA yagombaga kuba yamugejejeho ubutumwa, ari igaragazwa na kashe y'iposita ya Muhanga igomba kuba iri ku ibaruwa irimo ubutumwa, avuga ko ubujurire bwa Ruberandinda bwakiriwe ku wa 01/10/2015, kandi umunsi wa nyuma wo ku wa 30/11/2015, aribwo igisubizo cyagombaga kuba kigeze ku

iposita ya Muhanga, mu gihe ibaruwa yandikiwe na Komiseri Mukuru iriho kashe igaragaza ko yageze mu iposita ya Muhanga ku wa 02/12/2015, iminsi 60 yararangiy. Bityo akaba asaba n'indishyi hamwe n'inyungu yagombaga kubona mu gihe cy'iminsi 82 yamaze akurikirana urubanza.
