**Incamake y'ikibazo:** Urukiko Gacaca rw'akagari ka Rwaza kaciye urubanza rw'umutungo gategeka Bizimana André kwishyura abo yangiriye muri jenoside yakorewe abatutsi mu 1994, mu rwego rwo kurangiza urwo rubanza, Umuhesha w'inkiko Niyonshuti yagurishije inzu ye mu cyamunara igurwa na Rutabikangwa, ariko uwitwa Ngoboka yanga kuva muri iyo nzu avuga ko ari iye yaguze na Bizimana. Ngoboka yareze Umuhesha w'Inkiko Niyonshuti n'uweguze iyo nzu Rutabikangwa mu Rukiko Rwisumbuye rwa Rubavu, asaba ko iyo cyamunara yateshwa agaciro kuko iyo nzu yagurishijwe ari iye, akaba yarayiguze na Bizimana. Muri urwo rubanza hagobokeshejwemo Murindangabo kuko yasinye ku cyemezo cyashingiweho mu guteza cyamunara. Naho Bizimana na Banki ya Kigali bagoboka ku bushake, Banki yavugaga ko inzu yatejwe cyamunara ari ingwate yayo yahewe na Ngoboka. Uru rukiko rwemeje ko cyamunara igumanye agaciro kayo. Rusanga ukugoboka kwa banki nta shingiro gufite kuko Ngoboka yatanze ingwate ku mutungo utari uwe. Uru rukiko rwategetse kandi Ngoboka gutanga indishyi zitandukanyo no kuva mu nzu yaburanwaga.

Ngoboka ntiyishimiye imikirize y'urwo rubanza, ajurira mu Rukiko Rukuru, Urugerekko rwa Musanze urwo Rukiko rwemeje ko ubwo bujurire butakiriwe. Ngoboka ntiyishimiye imikirize y'urubanza mu rukiko rukuru, ajurira mu Rukiko rw'Ikirenga Umucamanza mu cyemezo cy'ibanzirizasuzuma, yemeje ko ubujurire bwa Ngoboka butakiriwe.

Ngoboka ntiyishimiye icyo cyemezo akijuririra kwa Perezida w'Urukiko rw'Ikirenga avuga ko Umucamanza yirengagije ko hashingiwe ku gaciro k'inzu iburanwa, ubujurire bwe buri mu bubasha bw'Urukiko rw'Ikirenga. Urukiko rw'Ikirenga rwaciye urubanza rubanziriza urundi, rwemeza ko ubujurire bwe bufite ishingiro, ko buri mu bubasha bwarwo.

Mu rubanza mu mizi Ngoboka avuga ko Urukiko rubanza rwirengagije ibimenyetso bigaragaza ko inzu iburanwa ari iye, bigizwe n'amasezerano y'ubugure yagiranye na Bizimana, ko rwanavuze ko ayo masezerano afite inkomyi iyasesa kuko ateganya ko agomba kuba yarangije kwishyura igiciro cy'inzu ku wa 15/1/2007 nyamara iyo tariki ikaba yarageze Ngoboka atararangiza kwishyura.

Niyonshuti, Umuhesha w'inkiko w'umwuga avuga ko yagurishije iyo nzu atarabona amasezerano y'ubugure bw'inzu hagati ya Ngoboka na Bizimana. Avuga kandi ko inzu

yagurishijwe yari yanditse kuri Bizimana kandi ko yari yarafatiriwe n'Urukiko gacaca rw'akagari ka Kibuye.

Rutabikangwa yunganwiwe na Nkanika bavuga ko igurishwa ry'inzu iburanwa hagati ya Ngoboka na Bizimana ari "simulation". Bityo asaba urukiko kwemeza ko yaguze nta buryarya.

Murindangabo avuga ko Ngoboka na Bizimana bakoresheje amayeri kugirango banyereze umutungo yagombaga kwishyurwamo.

Naho Bizimana avuga ko icyemezo cy'Urukiko Gacaca rw'Akagali ka Kibuye cyafatiriye imitungo ye kandi rutari rufite ububasha kuko yari yarashiyizwe mu rwego rwa mbere ndetse ngo rwamuburanishije atahamagawe. Avuga ko yagurishije Ngoboka inzu iburanwa kandi ko amasezerano bagiranye arimo inkomyi nsesamasezerano kuko Ngoboka atararangiza kumwishyura ikiguzi cyayo, akaba asanga ayo masezerano nta gaciro yahabwa.

Ngoboka François-Xavier yatanze ikirego mu Rukiko Rwisumbuye rwa Rubavu, arega Umuhesha w'Inkiko Niyonshuti Iddi Ibrahim n'uwigaze iyo nzu, Rutabikangwa Emmanuel, asaba ko iyo cyamunara yateshwa agaciro kuko iyo nzu yagurishijwe ari iye, akaba yarayiguze na Bizimana André hakurikijwe amasezerano yo ku wa 21/12/2006

Avuga kandi ko Urukiko rwirengangije ko icyamunara cyakozwe gishingiye ku nyandiko zaje kugirwa inyandiko mpimbano mu rubanza RP0209/08/TM rwaciwe ku wa 5/3/2009, ko Urukiko Gacaca rw'Akagali ka Kibuye rwandikiye Ngoboka François-Xavier ibaruwa, rumutegeka kudaha Bizimana André amafaranga yamusigayemo bagura inzu, ndetse ko inzu yagurishijwe nta mpapurompesha ziteyeho kashi mpuruza.
