

## SEMAPONDO v RWASIMPENZI N'ABANDI

[Rwanda URUKIKO RW'IKIRENGA – RS/INJUST/RAD 00002/2020/SC– (Ntezilyayo, P.J., Nyirinkwaya, Cyanzayire, Hitiyaremye na Karimunda, J.) 10 Ukuboza 2021]

*Amategako agenga imiburanishirije imanza zasabiwe gusubirishywamo ku mpamvu z'akarengane – Iyo Perezida w'Urukiko rw'Ikirenga asuzumye raporo yashyikirijwe ku rubanza rw'akarengane, akemeza ko rwongera kuburanishwa, Urukiko ruburanisha urubanza mu mizi bundi bushya nta zindi nzitizi zitanzwe zatuma urubanza rutaburanishwa mu mizi uretse inzitizi ndemyagihugu.*

**Incamake y'ikibazo:** Semapondo yatanze ikirego mu Rukiko Rwisumbuye rwa Gasabo arusaba gutegeka Koperative Goboka kumuha icyangombwa gituma yiyandikishaho ikibanza baguze, gukuraho amasezerano y'ubukode burambye afitwe na Rwasimpenzi no kumuha indishyi z'akababaro kubera icyo kibanza ariwe wakiguzwe ubwo yishyuraga amafaranga miliyoni ene n'ibihumbi magana cyenda kuri konti yiyo Koperative ariko yajya kukiyandikishaho agasanga cyanditseho undi muntu ariwe Rwasimpenzwe. Urukiko rwemeje ko icyo kibanza ari icye, ko amasezerano y'ubukode buramye ateshejwe agaciro ndetse agabwa n'amafaranga y'indishyi.

Uregwa yajuririye urwo rubanza mu Rukiko Rukuru avuga ko ikirego cy'Urega kitagombaga kwakirwa kuko kirebana n'umutungo waburanywe mu rubanza rwabaye itegeko. Indi mpamvu ni uko urukiko rwirengagije ibimenyetso yarushyikirije ahubwo rukagendera ku magambo y'Urega gusa. Urukiko rwemeje ko iyo nzitizi ifite ishingiro, rwemeza ko urubanza rwaciwe n'Urukiko Rwisumbuye ruvanyweho, rutegeka Urega kumuha indishyi zitandukanye.

Urega yajuririye mu Rukiko rw'Ikirenga ariko ubujurire bwe bwimurirwa mu Rukiko rw'Ubujurire nyuma y'ivugururwa ry'urwego rw'ubucamanza, aho avuga ko Urukiko Rukuru rwibeshye mu kwemeza ko urubanza RC 1207/14/TB/KCY rwabaye itegeko kandi ataribyoye. Uru rukiko rwarabisuzumye, rwemeza ko rutabaye itegeko, ruvuga ko urubanza rwaciwe n'Urukiko Rukuru ruhindutse ku birebana n'iyakirwa ry'ikirego cye mu Rukiko Rwisumbuye, rusanga cyaragombaga kwakirwa, bityo ko rutagombaga kuvanwaho.

Ku birebana n'ubujurire ku mizi y'urubanza rw'Uregwa yari yaratanzwe mu Rukiko Rukuru, Urukiko rw'Ubujurire rwemeje ko bufite ishingiro kuri bimwe, ko ikibanza kiburanwa ari icye, ko amasezerano y'ubukode burambye kuri icyo kibanza yabaye hagati ye na Leta y'u Rwanda agumaho, rutegeka Urega kumuha indishyi no kuziha Koperative Goboka.

Nyuma yo kwemererwa n'Urukiko rw'Ikirenga ko urubanza rwaciwe n'Urukiko rw'Ubujurire rusubirwamo ku mpamvu z'akarengane, Urega avuga ko muri urwo rubanza Urukiko rwirengagije ibimenyetso yarugaragarije byerekana ko ari we waguze ikibanza kiburanwa, ariko Abaregwa hamwen' Ikigo cy'Igihugu gishinzwe imicungire n'imikoreshereze y'ubutaka bo bakavuga ko nta bimenyetso byirengagijwe, ko ahubwo rwabisuzumye rugasanga nta shingiro bifite.

Mbere y'uko uru rubanza ruburanishwa mu mizi, Abaregwa batanze inzitizi ko nta mpamvu mu ziteganywa n'ingingo ya 55 y'Itegeko rigena ububasha bw'inkiko Urega agaragaza kugirango urwo rubanza rusubirwemo ku mpamvu z'akarengane ariko Urukiko rw'Ikirenga rwafatiye icyemezo mu ntebe, ruvuga ko iyo nzitizi itakiriwe.

Iburanisha ryakomereje ku ngingo irebana no kumenya uwaguzwe na Koperative Goboka ikibanza kiburanwa hagati y'Urega n'Uregwa, aho Urega avuga ko Urukiko rw'Ubujurire rwamurenganyije rwima agaciro ibimenyetso byanditse, n'ibishingiye ku buhamya bw'abatangabuhamya bari bazi neza uburyo iyo Koperative yatangaga ibibanza mu mwaka wa 2007. Avuga ko abatangabuhamya birengagijwe baguze

ikibanza na mu mwaka wa 2007 harimo n'uwari *ingénieur* wa Koperative Goboka, uyu akaba ariwe wari ushinzwe gukora amakarita (*maps*) y'ibibanza no kwereka abaguzi aho ibibanza byabo biherereye.

Akomeza avuga ko n'ubwo Urukiko ari rwo rwemeza abatangabuhamya rugomba kumva, rutagombaga kwanga kumva abo batangabuhamya bari bazi neza uburyo ibibanza byagurwaga icyo gihe, ibimenyetso by'ubugure byatangwaga n'uburyo nimeru z'ibibanza zagiye zihindagurika, iryo akaba ari ikosa rwakoze, ko icyo bimenyetso biza kwitabwaho, Urukiko rwari kubona ko ikibanza kiburanwa ari we wakiguzwe mbere mu mwaka wa 2007. Avuga ko ikindi kimenyetso yerekanye kikirengagizwa ari "*bordereau de versement*" ya 4.900.000 Frw yishyuye kuri compte ya Koperative ikaba yarayakiriye igasinyaho ko yakiriye icyo *versement espèces* ku itariki ya 19/11/2007, ko ibyo bigaragaza ko habayeho ubwumvikane ku kigurwa no ku kiguzi, kuko icyo bitaba ibyo, nta mpamvu ubwo bwishyubura bwarabayeho.

Uregwa avuga ko nta bimenyetso byirengagijwe n'Urukiko rw'Uburundi mu kwemeza ko atari Urega Goboka yagurishije ikibanza kiburanwa. Asobanura ko ikimenyetso kigizwe na "*bordereau de versement*" Urega yishyuriyeho 4.900.000 Frw kuri compte ya *Association* GOBOKA, Urukiko rwagisuzumye rugasanga ntacyo cyafasha mu kwemeza ko byanze bikunze ayo mafaranga yari ayo kugura icyo kibanza, cyane cyane ko n'amagambo agaragara kuri icyo *bordereau* yanditswe n'umukozi wa Banki, atagaragaza nimeru y'ikibanza, ingano yacyo, aho gihereye n'abo gihana imbibi.

Akomeza avuga ko ibyo Urega avuga ko yaguzwe ikibanza mu mwaka wa 2007 bitahabwa ishingiro, kuko bitumvikana ukuntu yaba yarageze mu mpera za 2015 ataragishakira ibyangombwa, cyane cyane ko kwandikisha ubutaka ku bantu babutunze ari itegeko. Avuga ko ikindi kigaragaza ko ibyo Urega avuga ko yaguzwe ikibanza kiburanwa nta shingiro bifite, ari uko atigeze agitangira umusoro, byongeye kandi akaba yarabonaga buri mwaka agihingamo ibihingwa bitandukanye, ntamwegere ngo amubaze impamvu amuhingira mu kibanza cyangwa ngo amuregere ubuyobozi bw'inzego z'ibanze; icyo myitwarire ikaba igaragaza neza ko ikibanza atari icye kandi ko nta na rimwe cyigeze kiba icye.

Ku bijyanye n'abatangabuhamya, Uregwa avuga ko Urukiko nta kosa rwakoze mu kudatumiza abo batangabuhamya, kuko rwasanze imvugo zabo zitasimbura ibimenyetso Urega yakagombye kuba yari afite bishyigikira "*bordereau de versement*" aburanisha, cyane cyane ko n'ubwo avuga ko atashoboraga guhabwa ibyangombwa by'icyo kibanza avuga ko yaguzwe, ngo kuko Goboka itamuhaye "*attestation d'attribution de parcelles*", ntiyashoboye nibura kugaragariza Urukiko ko yifashishije abo batangabuhamya avuga, kugira ngo agaragarize ubuyobozi ko icyo kibanza kirimo amakimbirane, kugira ngo hatagira undi ucyibaruzaho.

## **I. IMITERERE Y'URUBANZA**

Avuga ko ayo mafaranga yari ayo kugura na *Association* Goboka yahindutse Koperative, ikibanza nimeru 12438 cyaje guhinduka nimeru 1418 kiri mu Mudugudu wa Nyirabwana, Akagari ka Kibagabaga, Umurenge wa Kimironko, Akarere ka Gasabo, Umujyi wa Kigali; nyuma y'ubwo bugure, Ikigo gishinzwe imicungire n'imikoreshereze y'ubutaka mu Rwanda kimubwira ko icyo kibanza cyanditse kuri Rwasimpenzi Wellars, bituma atanga ikirego mu Rukiko Rwisumbuye rwa Gasabo arusaba gutegeka Koperative Goboka kumuha icyangombwa gituma yiyandikishaho ikibanza baguze, gukuraho amasezerano y'ubukode burambye afitwe na Rwasimpenzi Wellars no kumuha indishyi z'akababaro.

Nyuma yo kumva ibisobanuro n'ibimenyetso byatanzwe n'abaturanyi kuri icyo kibazo, urubanza rwarapfundikiwe, Urukiko rumenyeshya abaturanyi ko ruzasomwa ku itariki ya 30/04/2021, ariko kuri uwo munsu ntirwasomwa kubera ko umwe mu bacamanza bari bagize inteko yahinduriwe imirimo.

[16] Urubanza rwapfunduwe ku itariki ya 31/05/2021, abaturanyi bongera kumenyeshwa ko urubanza ruzasomwa ku itariki ya 25/06/2021, ariko mu mwiherero warwo rusanga mbere yo guca urubanza ari ngombwa kugira abatangabuhamya ruhamagaza kugira ngo bazagire ibisobanuro barugezaho ku birebana n'ikiburanwa, iburanisha ryishyirwa ku itariki 08/09/2021. Uwo munsu ugeze, rumaze kumva abatangabuhamya bari bahamagajwe, Urukiko rwifuje ko na Rwasimpenzi Wellars yarwitaba ubwe, iburanisha ryimurirwa ku itariki ya 16/11/2021.

## **II. IKIBAZO KIRI MU RUBANZA N'ISUZUMWA RYACYO**

[18] Me Mutembe Protais uhagarariye Semapondo Charles avuga ko Urukiko rw'Ubujurire rwamurenganyije rwima agaciro ibimenyetso byanditse, n'ibishingiye ku buhamya bw'abatangabuhamya bari bazi neza uburyo Koperative Goboka yatangaga ibibanza mu mwaka wa 2007, ibyo bikaba bigaragara mu gika cya 8, mu gika cya 30 kugeza mu cya 33 by'urubanza rusubirishwamo ku mpamvu z'akarengane, bikagaragara kandi no muri kopi y'urubanza RADA 00037/2017/HC/KIG mu gika cya 25. Avuga ko abatangabuhamya birengagijwe ari Munyanshongore Viateur waguze ikibanza na Koperative Goboka mu mwaka wa 2007 na Musheja Innocent wari ingénieur wa Koperative Goboka, uyu akaba ariwe wari ushinze gukora amakarita (*maps*) y'ibibanza no kwereka abaguzi aho ibibanza byabo biherereye.

Avuga ko Semapondo Charles yakabaye yaragarariye Urukiko ibindi bimenyetso byunganira *bordereau de versement* yatanze yonyine, kubera ko amagambo ayirihye yanditswe n'umukozi wa banki.

iyo myitwarire ikaba igaragaza neza ko ikibanza nimeru 1418 atari icye kandi ko nta na rimwe cyigeze kiba icye.

[25] Ku bijyanye n'abatangabuhama Semapondo Charles avuga ko Urukiko rwanze kubaza, Me Rugeyo Jean avuga ko Urukiko nta kosa rwakoze mu kudatumiza Musheja Innocent na Munyanshongore Viateur, kuko rwasanze imvugo zabo zitasimbura ibimenyetso Semapondo Charles yakagombye kuba yari afite bishyigikira "*bordereau de versement*" aburanisha, cyane cyane ko n'ubwo avuga ko atashoboraga guhabwa ibyangombwa by'ikibanza avuga ko yaguze, ngo kuko Goboka itamuhaye "*attestation d'attribution de parcelled*", ntiyashoboye nibura kugaragariza Urukiko ko yifashishije abo batangabuhama avuga, kugira ngo agaragarize ubuyobozi ko icyo kibanza kirimo amakimbirane, kugira ngo hatagira undi ucyibaruzaho.

[27] Avuga ko na Musheja Innocent uvugwa ko yakagombye kuba yarazanywe mu rubanza asanga ntacyo byari guhindura kuko atari kuvuguriza inyandiko y'inyemezabwishyu (*facture*) yashyizeho umukono ku itariki ya 30/07/2012 Koperative Goboka yakoreye Rwasimpenzi Wellars yemeza ko ari iy'ubugure bw'ikibanza nimeru 12438 cyahindutse nimeru 1418 mu gihe cy'ibarura. [29] Me Barahira Eric uhagararariye Koperative Goboka iri mu iseswa, avuga ko n'ubwo Semapondo Charles anenga ibyavuzwe n'Urukiko rw'Ubujurire mu rubanza RADAA 00006/2018/CA ku birebana n'ikimenyetso cya *bordereau de versement*, aho Urukiko rwasobanuye ko icyo kimenyetso kidafasha mu kumenya ibiranga ikibanza cyishyurirwaga, haba nimeru yacyo, ingano yacyo n'aho gihereye, ko rero ntaho rwari guhera rwemeza ko igifite nimeru 1418 aricyo kirebana n'ubwishyu yakoze, iyo usomye ibyo bisobanuro ukabihuza na *bordereau de versement* yonyine Semapondo Charles yatanze nk'ikimenyetso, usanga ibyo Urukiko rwasobanuye ko iyari *Association* Goboka itigeze imugurisha ikibanza nimeru 1418 byumvikana.

Iyo abibuze, uwarezwe aratsinda. Ibiteganywa n’iyo ngingo, binahura n’ibivugwa mu ngingo ya 3, igika cya mbere, y’Itegeko N° 15/2004 ryo ku wa 12/06/2004 ryerekeye ibimenyetso mu manza n’itangwa ryabyo, iteganya ko “buri muburanyi agomba kugaragaza ukuri kw’ibyo aburana.

naryo ryavuzwe haruguru, ndetse no ku bisobanuro byatanzwe, nk'uko n'Urukiko rw'Ubujurire rwabibonye, uru Rukiko narwo rurasanga ibimenyetso Semapondo Charles atanga bidahagije mu kumvikanisha ko ariwe waguze ikibanza nimeru 12438 cyaje guhinduka nimeru 1418, mu gihe ibimenyetso bya Rwasimpenzi Wellars baburana byavuzwe haruguru byerekana ibiranga icyo kibanza byose birimo nimeru yacyo, aho gihereye n'ubuso bwacyo, byongeye kandi n'uwo bakiguze akaba abyemeza. Kubera izo mpamvu zose rero, Urukiko rukaba rusanga ikirego cyatanzwe na Semapondo Charles asaba gushyirishamo urubanza ku mpamvu z'akarengane nta shingiro gifite.

### **Ku birebana n'indishyi zasabwe muri uru rubanza**

[42] Semapondo Charles asaba Urukiko gutegeka Koperative Goboka na Rwasimpenzi Wellars kumuha indishyi kubera ko bamuvukije amahirwe yo kubaka mu kibanza cye ibiciro bitarazamuka. Asobanura ko uruhare rwa Koperative Goboka ari uko yamwimye "*lettre d'attribution de parcelle*", ikibanza cye ikakigurisha undi muntu bigatuma agana inkiko kuva mu mwaka wa 2013 kugeza uyu muni. Avuga ko uruhare rwa Rwasimpenzi Wellars ari uko yamenye ko ikibanza yaguze na Koperative Goboka cyari cyaragurishijwe undi muntu, aho gusaba gushyirishwa amafaranga ye, agakomeza guhanyanyaza mu manza, bigatuma akomeza gutakaza amafaranga yishyura Abavoka.

[43] Kubera izo mpamvu zose, Semapondo Charles arasaba indishyi zikurikira zigomba gutangwa na Goboka ifatanyije na Rwasimpenzi Wellars:

- 2.500.000 Frw y'igihembo cy'Avoka;
- 1.300.000 Frw yishyuye Rwasimpenzi Wellars hiyongereyeho inyungu zayo zibazwe nk'iza banki (16% ku mwaka);
- 10.000.000 Frw y'ibiciro byo kubaka byazamutse no kudashobora kubanza umusaruro ikibanza cye mu myaka irenze icumi (10); hamwe n'akababaro yatewe n'akarengane yagiriwe.

[44] Me Rugeyo Jean uhagarariye Rwasimpenzi Wellars avuga ko nta ndishyi Semapondo Charles akwiriye kuko ariwe wishoye mu manza, akaba akwiriye kwirengera ingaruka zazo zose. Avuga ko ahubwo ariwe Urukiko rukwiye gutegeka guha Rwasimpenzi Wellars indishyi kubera kumuhoza mu manza z'urudaca nta mpamvu. Indishyi basaba akaba ari 3,000,000 Frw y'igihembo cy'Avoka hamwe na 500,000 Frw y'ikurikiranarubanza kuri uru rwego.

[45] Me Barahira Eric uhagarariye Koperative Goboka iri mu iseswa, avuga ko ashingiye ku ngingo ya 111 y'Itegeko ryerekeye imiburanishirize y'imanza z'imbonezambano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, asaba Urukiko gutegeka Semapondo Charles kwishyura Koperative Goboka iri mu iseswa 500,000 Frw y'ikurikiranarubanza na 1,000,000 Frw y'igihembo cy'Avoka kubera kuyishora mu manza zidafite aho zishingiye.

[46] Me Habiya Clément uhagarariye Ikigo cy'Igihugu Gishinzwe Imikoreshereze n'Imicungire y'Ubutaka mu Rwanda, mu mwanzuro we, avuga ko asanga iki Kigo cyarashowe mu rubanza ku maherere, kuko Semapondo Charles yiyemerera ko ikosa ari irya Koperative Goboka itaramuhaye ibyangombwa ngo yiyandikisheho ubutaka yamugurishije, ko kubera izo mpamvu asabira Ikigo aburanira indishyi zingana na 600.000 Frw, harimo 100.000 Frw yo gukurikirana urubanza na 500.000 Frw yo kurutegura.

[48] Urukiko rurasanga amafaranga y'ikurikiranarubanza n'ay'igihembo cy'Avoka Rwasimpenzi Wellars na Koperative Goboka iri mu iseswa basaba bagomba kuyahabwa kuko byabaye ngombwa gukurikirana urubanza no gushyiraho Abavoka bababuranira, ariko kuko ayo basaba ari menshi kandi bakaba badasobanura uko bayabara, mu bushishozi bw'Urukiko bakaba bagenewe buri wese 500.000 Frw y'igihembo cy'Avoka na 300.000 Frw y'ikurikiranarubanza, yose hamwe akaba 800.000 Frw buri wese.

[49] Ku birebana n'amafaranga asabwa n'Ikigo gishinzwe Imicungire n'Imikoreshereze y'ubutaka mu Rwanda, Urukiko rurasanga gikwiye kugenerwa 100.000 Frw y'ikurikiranarubanza yonyine kuko ayo gutegura urubanza basaba batashoboye kuyasobanura, cyane cyane ko batigeze bitabira inama ntegururubanza, n'amaburanisha yabaye bakaba nta na rimwe bitabiriye.
