[1] Ku italiki ya 04/06/2021, Byansi Samuel Baker yatanze ikirego mu Rukiko rw'Ikirenga arusaba kwemeza ko ingingo ya 71, mu gika cyayo cya 5 y' Itegeko N° 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, giteganya ko uburenganzira bwo gufata amajwi n'amashusho mu cyumba cy'iburanisha busabwa mu nyandiko nibura mu masaha mirongo ine n'umunani (48) mbere y'uko iburanisha ritangira, inyuranyije n'ingingo ya 38 y'Itegeko Nshinga rya Repubulika y'u Rwanda ryo mu 2003 ryavuguruwe mu 2015 mu gace kayo kavuga ko ubwisanzure bw'itangazamakuru, ubwo kugaragaza ibitekerezo n'ubwo guhabwa amakuru bwemewe kandi bwubahirizwa na Leta.

Bityo akaba asanga kuba yatanze ikirego cye ikarita ye yararangiye ariko ategereje kubona indi kandi ubu akaba yarayibonye bitaba impamvu yo kutakira ikirego cye kuko akora umurimo w'ubunyamakuru kuva 2017, aho yakoreye ibinyamakuru bitandukanye birimo na *Rwanda Broadcasting Agency* (RBA) na TV 10.

[10] Ingingo ya 72, igika cya mbere y'Itegeko N° 30/2018 ryo ku wa 02/06/2018 rigena ububasha bw'Inkiko iteganya ko umuntu ku giti cye, ikigo cyangwa umuryango ufite ubuzimagatozi bashobora kuregera Urukiko rw'Ikirenga basaba kwemeza ko itegeko rinyuranyije n'Itegeko Nshinga iyo babifitemo inyungu ....

[11] Ingingo ya 3 y'Itegeko N° 02/2013 ryo ku wa 08/02/2013 rigenga itangazamakuru ivuga ko umunyamakuru w'umunyarwanda, yaba ukora mu kigo cy'itangazamakuru cyemewe cyangwa uwigenga cyangwa uhagarariye igitangazamakuru cy'amahanga mu Rwanda, ahabwa uburenganzira n'Urwego rw'Abanyamakuru Bigenzura. Naho ingingo ya 4 igika cyayo cya 1 y'iryo Tegeko igateganya ko imikorere y'itangazamakuru n'imyitwarire y'abanyamakuru umunsi ku wundi bigenzurwa n'Urwego rw'Abanyamakuru Bigenzura (...).

[12] Ibirebana n'inyungu zo gutanga ikirego gisaba gukuraho ingingo y'Itegeko kuko inyuranye n'Itegeko Nshinga, uru Rukiko rwabisuzumye mu rubanza<sup>5</sup> rwaburanishijwemo ikirego Me Mugisha Richard yari yatanze asaba ko ingingo zimwe z'Itegeko N° 68/2018 ryo ku wa 30/08/2018 riteganya ibyaha n'ibihano muri rusange zivaho kuko zinyuranyije n'Itegeko Nshinga. Mu gusobanura icyemezo cyarwo, Urukiko rwasesenguye amategeko asanzwe akurikizwa mu Rwanda arebana n'iki kibazo, runifashisha imanza zaciwe mu bindi bihugu aho ibirego nk'ibi bimaze igihe bitangwa.

[13] Muri urwo rubanza, Urukiko rwasobanuye ibyerekeye inyungu muri rusange n'impamvu ari ngombwa kuzigaragaza kugirango ikirego cyakirwe,<sup>6</sup> ruvuga ariko ko ku birego bijyanye n'Itegeko Nshinga, inyungu igomba kumvikana ku buryo bwagutse, cyane cyane mu Gihugu nk'u Rwanda kikiri mu nzira y'iterambere aho abatwaga batarasobanukirwa uburenganzira bwabo bagenerwa n'Itegeko Nshinga, bakaba bakeneye gufashwa kubugeraho hifashishijwe inkiko. Urukiko rwasobanuye ko imiterere y'imanza zisaba kwemeza ko Itegeko rinyuranyije n'Itegeko Nshinga, igaragaza ko inyungu muri bene izo manza ishingiyeye ku kwemeza ko Itegeko rinyuranyije n'Itegeko Nshinga kuko ribangamiye uburenganzira bw'abasaba ko rivaho, cyangwa se rituma icyari kigamijwe n'Itegeko Nshinga kitagerwaho kandi kigomba kurengeka.<sup>7</sup>

[14] Ibirebana no kuba uwatanze ikirego cyo kwemeza ko Itegeko rinyuranyije n'Itegeko Nshinga agomba kuba afite inyungu bwite, byanasuzumwe n'abahanga mu mategeko ndetse n'izindi nkiko. Nk'umuhanga Sylvie Schmitt avuga ko kugira ngo inyungu umuntu afite yo gutanga ikirego yemerwe, igomba kuba ifite ikintu cy'umwihariko gitandukanya nyirayo n'abandi, kiyigira iye bwite. Bitabaye ibyo, umuntu ubonetse wese ashobora kuregera Urukiko rushinzwe kurinda iremezo ry'Itegeko Nshinga kuko buri muturage cyangwa ikigo bashobora kwibwira ko bafite inyungu zo kuregera Itegeko Nshinga. icyo gihe ikirego cyahinduka nk'ikirego cy'abaturage muri rusange, kandi ibyo bidakwiye. [17] Urukiko rusanga ingingo ya 71, igika 5 y'Itegeko N° 22/2018 ryavuzwe haruguru ireba uburenganzira bwo gufata amajwi n'amashusho mu iburanisha bureba n'abanyamakuru. Bikumvikanisha ko mu gihe Urukiko rwasanga koko icyo ngingo inyuranyije n'ingingo ya 38 y'Itegeko Nshinga nk'uko Byansi Samuel Baker abiburanisha, icyo cyemezo cyaba kimufitiye akamaro, bityo rukaba rusanga afite inyungu yo gutanga ikirego gisaba kvanaho ingingo y'Itegeko avuga ko imwambura uburenganzira ahabwa n'Itegeko Nshinga.
