Muri uru rubanza hari Inshuti y'Urukiko ariyo Umuryango uharanira iterambere ry'ubuzima (*Health Development Initiative, HDI*) na Leta y'u Rwanda nayo ikaba yari ihagarariwe, aho ivuga ko izo ngingo zose zitagomba kwandikwa mu bundi buryo.

Ku kibazo cyabanje gusuzumwa muri uru Rukiko ni ikijyanye no kumenya niba ingingo ya 125, igika cya 2 n'ingingo ya 126, igika cya 3, z'Itegeko N° 68/2018 ryavuzwe haruguru zinyuranye n'uburenganzira bwo kubaho n'uburenganzira ku buzima bwiza buteganywa n'ingingo ya 12 n'iya 21

z'Itegeko Nshinga. Aha Urega asobanura ko ingingo ya 21 y'Itegeko Nshinga iteganya ko abanyarwanda bose bafite uburenganzira bwo kugira ubuzima bwiza kandi ku rwego rwo hejuru rushoboka nk'uko kandi bishimangirwa n'amasezerano mpuzamahanga atandukanye u Rwanda rwashyizeho umukono.

Avuga ko amategeko mpuzamahanga yerekeye uburenganzira bwa muntu ateganya ko, mu rwego rwo kuzamura ireme ry'ubuzima bwiza, ibihugu bifite inshingano zo gushyiraho serivisi zerekanye n'ubuzima bw'imyororokere zujuje ubuziranenge. Kugira ngo iyo nshingano yubahirizwe, bigasaba ko haboneka amakuru ahagije ku bijyanye n'ubuzima bw'imyororokere, ko habaho ibigo byita ku buzima bw'abantu, ko abakozi babihugurirwa kandi bakaba abanyamwuga, ndetse hakaboneka n'imiti y'ingenzi.

Urega asobanura ko kuba abana b'abakobwa basambanyijwe bagaterwa inda, itegeko ribategeka guhabwa serivisi yo gukurirwamo inda na muganga gusa, bibangamiye uburenganzira bwabo kuko uyu muganga aba ku bitaro gusa kandi abo bana nta bushobozi ndetse nta n'igihe cyo kugerayo bafite. Ikindi ni ukuba abandi baturage babonera serivisi z'ubuvuzi ku kigo nderabuzima aricyo cyegerejwe abaturage, ariko abagore n'abana b'abakobwa bo bagategekwa kubonera iyo serivisi ku bitaro, nabyo bibangamiye uburenganzira bwabo ku buzima bwiza.

Asoza avuga ko kuba iyo serivisi idatangirwa ku rwego rw'ubuzima rwegerejwe abaturage kuko aho nta baganga bahaba, ngo ibe yatangwa n'abaforomo n'ababyaza, bituma iyo serivisi itaboneka bigaca intäge abagore n'abana b'abakobwa bigatuma bakuramo inda mu buryo butizewe kandi babyemerewe n'amategeko, bikongera n'ibyago ku bagore n'abakobwa kuko bashobora gupfa babyara.

Uhagarariye Leta avuga ko ingingo ya 123 n'iya 124 z'Itegeko N° 68/2018 ryo ku wa 30/08/2018 ryavuzwe haruguru zirengera uburenganzira bwo kubaho, aho zigara gaza ihame ry'uko gukuramo inda cyangwa gukuriramo undi muntu inda bibujije kandi ko ari icyaha mu gihe ingingo ya 125, igika cya 2, n'iya 126, igika cya 3, z'ryo Tegeko zo zikaba zerekana ibihe bidasanze umugore cyangwa umukobwa yemerewe gukurwamo inda na muganga wemewe na Leta, bityo zikaba ntaho zitanyuranye n'ingingo ya 12 n'iya 21 z'Itegeko Nshinga. Naho ku bijyanye n'Amasezerano Mpuzamahanga, uruhande rurega rushingiraho, akwiye gukurikizwa nk'andi mategeko kuko yemejwe n'u Rwanda, ariko ko amwe muri yo ateganya ko gukuramo inda biterwa n'impamvu zidasanzwe.

Ku birebana no kuba serivisi yo gukuramo inda ku bagore n'abakobwa babyemerewe idashobora gutangirwa ku bigo nderabuzima ngo itangwe n'abaforomo n'ababyaza, Uhagarariye Leta avuga ko gukuramo inda mu buryo bwizewe kandi bwemewe n'amategeko ntibishobora gukorerwa aho hantu ku nyungu z'abashaka iyo serivisi, kuko hari igithe bakenera ubutabazi bwo mu rwego rwo hejuru ntibabe bahabubonera.

Inshuti y'urukiko, ivuga ko iri tegeko rigenga ibyaha n'ibihano muri rusange rituma abashobora kubona serivisi zo gukuramo inda ari abagore bafite ubushobozi bwo kubona umuganga cyangwa bafite amikoro yo kuriha ingendo cyangwa amafaranga yo kwishyura kwa muganga. Ivuga kandi ko mu bindi bihugu, abakozi bashinzwe ubuzima batari abaganga bahuguwe, batanga serivisi zo gukuramo inda mu buryo bwizewe kandi bagakurikirana abarwayi nyuma yo kubaha iyo serivisi. Byongeye kandi n'amabwiriza mpuzamahanga y'ubuvuzi, na yo yemera ko abatanga serivisi z'ubuzima zoroheje bashobora kandi bakwiye kwemererwa gutanga serivisi zo gukuramo inda.

Ikomeza isobanura ko kubera inzitizi zibangamira gukuramo inda mu buryo bwizewe kandi bwemewe n'amategeko, abagore n'abakobwa benshi mu Rwanda bakuramo inda mu buryo butizewe bigashyira ubuzima bwabo mu kaga. Ivuga ko kubanza kwemererwa n'undi muntu gukuramo inda harimo n'undi muganga bikereza guhabwa ubuvuzi, bikaba byatuma serivisi yo gukuramo inda itangwa igithe kigenwa n'amategeko cyarenze bikagorana, ikiguzi cyo kuyikuramo kikiyongera, ndetse bikaba byanashyira ubuzima bw'umugore mu kaga gakomeye.

Ku birebana na serivisi zitangwa n'ababyaza n'abaforomo, HDI, Inshuti y'Urukiko, isobanura ko kuba abaforomo, ababyaza n'abafasha b'abaganga mu Rwanda bemereewe gutanga ubuvuzi ku mugore nyuma yo gukuramo inda, ari bwo buvuzi bwa ngombwa butangwa iyo umugore ahuye n'ibibazo biterwa no

gukuramo inda mu buryo butizewe cyangwa mu gihe inda itavuyemo mu buryo bwuzuye bifashishije uburyo bwo koza nyababyeyi mu gihembwe cya mbere kuva umugore asamye, nta mpamvu abo bakozi baboneka ku kigo nderabuzima batakwemererwa no gutanga serivisi zo gukuramo inda. Bityo, Itegeko N° 68/2018 ryo ku wa 30/08/2018 ryavuzwe haruguru ritari rikwiye kubakura mu bagomba gutanga iyo serivisi.

Ku kibazo cya serivisi yo gukuramo inda ikozwe na muganga wemewe na Leta aho kuba umuntu wese wize ibijyanye n'ubuvazi, Urega avuga ko binyuranye n'uburenganzira bwo kudahungabanywa ku mubiri no mu mutwe biteganywa n'ingingo ya 14 y'Itegeko Nshinga kubera ko bibangamira uburenganzira bw'abagore ndetse n'ubw'abakobwa aho bigabanya umubare w'abatanga iyo serivisi n'uw'abayihabwa.

Urega avuga ko Komisiyo Nyafurika y'Uburenganzira bwa Muntu n'ubw'Abaturage, ishingiye ku Masezerano ya Maputo, mu rwego rwo gushyira mu bikorwa ingingo zirebana no gutanga serivisi z'ubuvazi zo gukuramo inda mu buryo bunoze, bwizewe kandi bwemewe n'amategeko zigaragara muri ayo masezerano, yashyizeho amabwiriza ngenderwaho ko ibihugu bitagomba gushyiraho imbogamizi cyangwa inzitizi ku bisabwa abavazi bemerewe gutanga iyo serivisi y'ubuvazi. Avuga ko Komisiyo yakomeje igaragaza ko, muri rusange kuba mu bihugu byinshi by'Afurika hari umubare udahagije w'abaganga, abafasha b'abaganga, nk'ababyaza ndetse n'abandi bakozi bita ku buzima, bakagombye guhabwa amahugurwa kugira ngo nabo bajye bita ku bakeneye serivisi y'ubuvazi yo gukuramo inda.

Asoza avuga ko asanga ntaho igika cya 2 cy'ingingo ya 125 n'igika cya 3 cy'ingingo ya 126 z'Itegeko n° 68/2018 ryo ku wa 30/08/2018 ryavuzwe haruguru zinyuranyije n'ingingo ya 14 y'Itegeko Nshinga iteganya ibijyanye n'uburenganzira bwo kudahungabanywa ku mubiri no mu mutwe.

Bavuga kandi ko hari irindi vangura no kutareshya rishingiye ku byiciro by'ubukungu kubera ko abagore n'abakobwa bifite arivo bashobora kubonera iyo serivisi ku bitaro bikuru ahaboneka muganga wemewe, mu gihe abatifite badashobora kugerayo kubera ko bihenze cyane.

Nti bagaragaza ibimenyetso byerekana icyo bita kutareshya mu mategeko cyangwa kuvangurwa kw'abashaka guhabwa serivisi z'ubuzima

bw'imyororokere. Avuga kandi ko serivisi z'ubuvuzi zitandukanye zihabwa abagana ibitaro guhera ku mavuriro y'ibanze ibigo nderabuzima, ibitaro by'Uture, ibitaro by'Intara n'ibitaro bikuru zashyizwe ku mugerekwa w'Iteka rya Minisitiri N° 20/39 ryo ku wa 29/01/2016 rigena ibikorwa by'ubuvuzi, kugira ngo bimenyekane kandi buri muntu ugana ibitaro amenye ko ari uburenganzira bwe guhabwa izo serivisi nta vangura cyangwa kutareshya mu matageko Ibyo bikaba byarakozwe mu rwego rwo kugira ngo buri muntu wese nta vangura iryo ariryo ryose ugana amavuriro amenye serivisi ihatangirwa n'ikiguzi cyayo. Bityo, akaba asanga nta kutareshya mu mategeko cyangwa kuvangura uruhande rurega rugaragaza, ko kandi n'iyo byaba, byakorerwa iperereza uwaba yabigizemo uruhare akaba yabitangira indishyi kubera ko bene ibyo bikorwa bibarizwa mu mategeko mbonezamubano aho kuba mpanabyaha.

Na Owolabi O., Minisiteri y'Ubuzima igaragaza ko ubushakashatsi bwerekana ko imwe mu ngaruka zikomeye zikunze kubaho mu gihe cyo gukuramo inda ari ukuba amaraso menshi mu buryo bukabije, icyo gihe bikaba byagorana kubikemurira ku Bigo nderabuzima kuko bisaba kongerera amaraso uwakuriwemo inda (*transfuse*) ndetse bibaye na ngombwa akabagua inda ibyara (*utérus*). Ibyo bikorwa byombi bikaba bisaba kubera ku rwego rw'Ibitaro Bikuru (*Hospitals*) kugira ngo abaganga babizobereyemo (*medical doctors*) babe bafatanya kubikemura.

[23] Izindi mpamvu Minisiteri y'Ubuzima ishingiraho ivuga ko iyo serivisi igomba gutangirwa mu Bitaro Bikuru (*Hospitals*), ni uburyo uwakuriwemo inda aba agomba kwitabwaho haba mbere ndetse na nyuma y'icyo gikorwa kugira ngo hirindwe ingaruka zacyo, ibikoresho bikenerwa mu kubanza kumenya uko umwana ameze mu nda (*ultrasound*) n'ibijyanye no kumenya ubwoko bw'amaraso (*Blood Group*) na Rhesus mu rwego rwo kurinda uwakuriwemo inda mu gihe yongeye gusama. Ikindi kandi usanga abakenera iyo serivisi baba banakeneye inama mu rwego rw'amategeko (*legal services*), ubusanzwe zitangwa na ISANGE One Stop Centre ikorera ku rwego rwa buri Bitaro Bikuru.

[24] Minisiteri y'Ubuzima isobanura kandi ko mu nshingano zitandukanye z'abaforomo (nurses) n'ababyaza (midwives) zigenwa n'Iteka rya Minisitiri N°20/2518/04/2012 rigena uko imyuga y'ubuforomo n'ububyaza ikorwa, ntaho bashinzwe gutanga serivisi yo gukuramo inda. Ndetse umubare muto w'ababyaza (1562 *midwives for a population estimated at 12,518,757*) mu Rwanda, aho usanga hari ikigo nderabuzima kidafite n'umwe, ahandi hari umwe nawe udakora buri munsi, ukaba waba imbogamizi mu gukurikirana umugore wakuriwemo inda ku Kigo Nderabuzima, bityo Minisiteri y'Ubuzima ikavuga ko kubera izo mpungenge zose, gukuramo inda bigomba gukorerwa ku Bitaro Bikuru ahari abaganga babizobereyemo ndetse hari n'uburyo bufasha kuri buri kibazo cyavuka ku buryo cyabasha gukemurwa n'itsinda rigari ry'abaganga.

[25] Ku bivugwa na Minisiteri y'Ubuzima, GLIHD ivuga ko yemeranya nayo ku birebana n'imfu n'ubumuga bikomoka ku gukuramo inda bikozwe mu buryo butizewe kandi ko byakumirwa mu gihe bikozwe n'abantu babifitiye ubumenyi. GLIHD ivuga ko ibi bishyigikira igitekerezo cyayo cy'uko ububasha bwahawe abaganga b'inzobere bwo gukuramo inda mu buryo bwizewe kandi bwubahirije amategeko, bwahabwa abakora mu bigo nderabuzima hagamijwe kwirinda izo mfu mu gihe abakeneye gukurirwamo inda badashoboye kubona abaganga b'inzobere kubera ubuke bwabo. Ku bw'ibyo isaba ko Minisiteri y'Ubuzima yaha amahugurwa abakora mu bigo nderabuzima mbere y'uko batangira gutanga izo serivisi, dore ko benshi muri bo bahuguwe ku birebana n'ubuvuzi burebana n'ingaruka zo gukuramo inda.

[26] GLIHD isobanura ko ibikorwa bigamije gukemura ibibazo bikomoka ku gukuramo inda bigizwe ahanini no gutanga ubuvuzi bwihitirwa, gutanga inama ku birebana n'igihe cyo gukurikiza umwana hagamijwe kwirinda gusama mu buryo butateguwe ku buryo byatuma habaho kongera gukuramo inda mu buryo butizewe. Ivuga ko kuba Ibitaro by'Akarere bifite abaganga b'inzobere bake, umurwayi ashobora kumara amasaha arenze abiri mbere yo gusuzumwa, ariyo mpamu Minisiteri y'Ubuzima ikwiye guhugura abaforomo n'ababyaza ku birebana no gukuramo inda akaba aribo bajya batanga iyo serivisi.

[27] Ku birebana n'ibikoresho, GLIHD ivuga ko hari ibigo nderabuzima byo mu Ntara y'Iburengerazuba no mu Ntara y'Amajyepfo bifite ibikoresho byifashishwa mu gusuzuma uko umwana ameze mu nda ya nyina byatanzwe na Minisiteri y'Ubuzima ifatanyije na *Belgian Development Agency* (ENABEL). Naho ibikoresho byifashishwa mu gupima ubwoko bw'amaraso (*Blood group*) na *rhésus* nabyo biri mu bihabwa ibigo nderabuzima nk'uko bikubiye mu byiciro bya serivisi ibyo bigo bitanga byemejwe na Minisiteri y'Ubuzima. Ivuga kandi ko hari ibigo nderabuzima nk'icya Bigogwe mu Karere ka Nyabihu n'icya Gikonko mu Karere ka Gisagara byamaze kubona ibikoresho nkenerwa ku buryo umuntu ashobora kuhabonera serivisi nk'izitangirwa mu bitaro.

[28] Ku birebana n'ubufasha mu mategeko butangwa na Isange *One Stop Centre* ikorera ku rwego rw'Ibitaro, GLIHD ivuga ko ibyo ntaho biteganyijwe mu Iteka rya Minisitiri, ko uretse n'ibyo hari amakuru yizewe yatanzwe n'Urwego rw'Igihugu rw'Ubugenzacyaha, *Rwanda Bureau of Investigation* (RIB) ko hari gahunda yo kugeza izo serivisi ku rwego rw'ibigo nderabuzima.

[29] Ku kirego cyatanzwe na GLIHD, HDI, inshuti y'urukiko, ivuga ko n'ubwo hatewe intambwe mu birebana n'amategeko, u Rwanda rugifite imbogamizi nyinshi mu Itegeko N° 68/2018 ryo ku wa 30/08/2018 riteganya ibyaha n'ibihano muri rusange mu gufasha abagore n'abakobwa gukuramo inda mu buryo bwizewe kandi bwemewe n'amategeko, kuko hashingiwe kuri iryo Tegeko no ku Iteka rya Minisitiri N° 002/MOH/2019 ryo ku wa 08/04/2019, abaganga bemewe na Leta bonyine aribo bemerewe gukuriramo abantu inda mu buryo bwizewe kandi bwemewe n'amategeko, abandi bashinzwe ubuzima bw'imyororokere nk'ababyaza cyangwa abaforomo bo bakaba batabyemerewe.

[30] Igaragaza ko mu Rwanda abaganga ari bake kuko imibare iheruka gutangazwa na Minisiteri y'Ubuzima yerekana ko abaganga bakorera mu mavuriro ya Leta n'ayigenga ari 709 gusa, bivuze ko umuganga umwe yita ku baturage 15.510, kandi muri bo abemera gukuriramo abantu inda bakaba baherereye mu Mujyi wa Kigali no mu nkengero zawo gusa. Ivuga ko iri tegeko rituma abashobora kubona serivisi zo gukuramo inda ari abagore bafite ubushobozi bwo kubona umuganga cyangwa bafite amikoro yo kuriha ingendo cyangwa amafaranga yo kwishyura kwa muganga. Ivuga kandi ko mu bindibihugu, abakozi bashinzwe ubuzima batari abaganga bahuguwe, batanga serivisi zo gukuramo inda mu buryo bwizewe kandi bagakurikirana abarwayi nyuma yo kubaha iyo serivisi. Byongeye kandi n'amabwiriza mpuzamahanga y'ubuvuzi, na yo yemera ko abatanga serivisi z'ubuzima zoroheje bashobora kandi bakwiye kwemererwa gutanga serivisi zo gukuramo inda.

[31] Ikomeza isobanura ko kubera inzitizi zibangamira gukuramo inda mu buryo bwizewe kandi bwemewe n'amategeko, abagore n'abakobwa bensi mu Rwanda bakuramo inda mu buryo butizewe bigashyira ubuzima bwabo mu kaga. Itanga urugero rwa raporo yavuze ko inda zirenga kimwe cya kabiri zikurwamo mu Rwanda, zivanwamo mu buryo butizewe bikozwe n'abantu batabihuguwemo, nk'abavazi ba gakondo, cyangwa na ba nyir'ubwite. Ivuga ko abagore bo mu cyaro bafite amikoro make aribo bari ku gipimo cyo hejuru cya 74% cy'abakuramo inda muri bene ubwo buryo, ugereranyije na 15% by'abagore bafite amikoro batuye mu Mujyi wa Kigali. Inagaragaza ko 40% by'inda zivanwamo ziteza ibibazo, muri zo 67% zakuwemo na ba nyir'ubwite, naho 61% zikurwamo n'abavazi ba gakondo. Ivuga kandi ko n'ubwo nta mibare ihari igaragaza abana b'abakobwa bakuramo inda mu buryo butizewe mu Rwanda, Leta yasohoye raporo yerekana ko inda zitateganyijwe mu rubyiruko ari ikibazo gikomeye, iyo nayo ikaba ari impamvu ishobora gutuma bakuramo inda mu buryo butizewe.

[32] Ikomeza ivuga ko mu Nyandiko y'Umurongo ngenderwaho mu gukuramo inda mu buryo bwizewe, Ishami ry'Umuryango w'Abibumbye ryita ku buzima, World Health Organisation (WHO) ryasanze ibihugu bitagomba gusaba ko hagira undi muntu utanga uburenganzira bwo gukuramo inda usibye umugore bireba n'umukozi wo mu buvuzi umuha iyo serivisi. Isobanura ko WHO ivuga ko gukuramo inda bigomba gukorwa nta bukererwe, cyane cyane iyo ubuzima bw'umugore bubangamiwe haba ku mubiri cyangwa mu mutwe. Ishingira kuri ibyo bisobanuro ivuga ko kubanza kwemererwa n'undi muntu gukuramo inda harimo n'undi muganga bikereza guhabwa ubuvuzi, bikaba byatuma serivisi yo gukuramo inda itangwa igehe kigenwa n'amategeko cyarenze bikagorana, ikiguzi cyo kuyikuramo kikiyongera, ndetse bikaba byanashyira ubuzima bw'umugore mu kaga gakomeye.

[33] Kubera umubare muto w'abaganga bafite ubumenyi mu bijyanye n'ubuzima bw'imyororokere, HDI ivuga ko Komisiyo Nyafurika ishinzwe Uburenganzira bwa Muntu n'ubw'Abaturage yatanze igitekerezo rusange aho isobanura mu buryo burambuye imbibi z'ingingo ya 14 (2) y'Amasezerano y'i Maputo, yemera ko hari umubare muto w'abaganga bahuguwe, bityo ihamagarira ibihugu biyahuriyeho guhugura abatanga serivisi z'ubuzima zoroheje nk'ababyaza n'abandi bashinzwe ubuzima kugira ngo babashe gukuriramo abantu inda mu buryo bwizewe. Ubwo buryo nibwo butuma serivisi yo gukuramo inda ku bayikeneye itangwa vuba kandi ihenduka kuko itangirwa ku rwego rw'ibanze (Ibigo nderabuzima) aho abayikeneye batuye. Inatanga ingero z'Ibihugu muri Afurika nka Etiyopiya, Kenya, Afurika y'Epfo, Mozambique, Ghana, Senegali na Burukina Faso byemerera abatanga serivisi z'ubuzima zoroheje gukuriramo abantu inda, hakoreshejwe uburyo bwo koza nyababyeyi mu gihembwe cya mbere n'imiti ikuramo inda.

[34] Ku birebana na serivisi zitangwa n'ababyaza n'abaforomo, HDI isobanura ko kuba abaforomo, ababyaza n'abafasha b'abaganga mu Rwanda bemerewe gutanga ubuvuzi ku mugore nyuma yo gukuramo inda, ari bwo buvuzi bwa ngombwa butangwa iyo umugore ahuye n'ibibazo biterwa no gukuramo inda mu buryo butizewe cyangwa mu gihe inda itavuyemo mu buryo bwuzuye bifashishije uburyo bwo koza nyababyeyi mu gihembwe cya mbere kuva umugore asamye, nta mpamvu abo bakozi baboneka ku kigo nderabuzima batakwenrerwa no gutanga serivisi zo gukuramo inda. HDI irangiza ivuga ko Itegeko N° 68/2018 ryo ku wa 30/08/2018 ryavuzwe haruguru ritari rikwiye kubakura mu bagomba gutanga iyo serivisi.

UKO URUKIKO RUBIBONA

Ku bijyanye n'uburenganzira bwo kubaho (right to life) buteganywa n'ingingo ya 12 y'Itegeko Nshinga

[35] Ingingo ya 12 y'Itegeko Nshinga, iteganya ko umuntu wese afite uburenganzira bwo kubaho, ko ntawe ushobora kuvutswa ubuzima mu buryo bunyuranyije n'amategeko. Ubu burenganzira tubusanga no mu masezerano mpuzamahanga anyuranye, harimo Itangazo mpuzamahanga ryerekeye

uburenganzira bwa muntu (*Universal Declaration of Human Rights*)⁴, Amasezerano mpuzamahanga mu by’imbonezamubano na politiki (*International covenant on civil and political rights*)⁵, Amasezerano nyafurika ku burenganzira bwa Muntu n’ubw’Abaturage (*African charter on human and people’s rights*)⁶, Amasezerano y’ibihugu by’Uburayi ku burenganzira bwa muntu (*European Convention on Human Rights*)⁷.

[36] Mu rwego rwo gushyira mu bikorwa Amasezerano y’Inyongera ya Maputo ku Masezerano Nyafurika ku burenganzira bwa Muntu n’ubw’Abaturage, aho mu ngingo yayo ya 14.2(c), ibihugu byayashyizeho umukono harimo n’u Rwanda byiyemeje gufata ingamba zo kurinda uburenganzira bw’igitsina gore bwo gukuramo inda mu bihe biteganywa muri iyo ngingo⁸, mu Itegeko N° 68/2018 ryo ku wa 30/08/2018 riteganya ibyaha n’ibihano muri rusange, Leta y’u Rwanda yashyizemo ingingo ya 125 iteganya igihe nta buryozwacyaha bubaho ku wakuyemo inda⁹. Mu rwego rwo kugera kuri iyo ntego yo gufasha uwahuye n’ikibazo, mu gika cya kabiri cy’iyo ngingo n’icya gatatu cy’ingingo ya 126, umushingamategeko yateganyije ko gukuramo inda ku bari mu byiciro biteganyijwe muri izo ngingo bikorwa na muganga wemewe na Leta gusa. Ubwo buryo Umushingamategeko akaba yarabuhisemo kugira ngo ikigamijwe muri izo ngingo kigerweho neza nta zindi ngorane zivutse, n’izavuka zikabona uko zikemurwa mu buryo bwhuse mu rwego rwo kurengera ubuzima bw’abahabwa iyo serivisi nk’uko Minisiteri y’Ubuzima yabigaragaje mu nyandiko iri muri dosiye.

[37] Ishingiye kuri ubwo buryo Umushingamategeko yahisemo ko gukuramo inda umugore cyangwa umwana w’umukobwa ubyemerewe bikorwa na muganga wemewe na Leta gusa, GLIHD yatanze ikirego isaba ko ingingo ya 125, igika cya kabiri n’iya 126, igika cya gatatu, z’Itegeko ryavuzwe haruguru zibiteganya zakurwaho ivuga ko zibangamiye uburenganzira bwo kubaho buteganywa n’ingingo ya 12 y’Itegeko Nshinga. Mu gukemura icyo kibazo, Urukiko rurasanga ari ngombwa kubanza gusobanura icyo ubwo burenganzira buvuga, no kureba niba koko, kuba muganga wemewe na Leta ariwe wenyine wemerewe gutanga serivisi yo gukuramo inda bibangamiye uburenganzira bwo kubaho ku bakeneye iyo serivisi.

[38] Mu gusobanura uburenganzira bwo kubaho burengerwa na Leta, Urukiko rw’Ibihugu by’Uburayi rushinzwe kurengera Uburenganzira bwa Muntu (*European Court of Human Rights*), mu rubanza rwa *Centre for Legal Resources on behalf of Valentin Câmpeanu c. Romania*¹⁰, rwasobanuye ko ingingo ya 2§1 y’Amasezerano y’Ibihugu by’Uburayi yerekeye uburenganzira bwa Muntu idategeka ibihugu kwirinda icyatuma ababituyemo bapfa mu buryo budasobanutse gusa, ko ahubwo inategeka ibyo bihugu gufata ingamba za ngombwa mu rwego rwo kurinda ubuzima bwabo. Mu rubanza rwa Öneryıldız

c. Turquie¹¹, Urukiko rwasobanuye ko uburenganzira ku buzima buvugwa mu ngingo ya 2 butagarukira gusa ku mfu z'abantu zikomoka ku bakozi ba Leta bakoresha imbaraga z'umurengera, ahubwo inareba inshingano ibihugu bifite zo gufata ingamba za ngombwa mu rwego rwo kurinda ubuzima bw'abantu babituyemo. Iyo nshingano igomba kumvikana nk'igomba kubahirizwa mu bikorwa byose bya buri munsi mu gihe hari icyashyira uburenganzira ku buzima mu kaga, cyane cyane nk'ibikorwa by'inganda bikunze gukurura ibyago, urugero nk'ibikorwa byo kubyaza umusaruro ubuhunikiro bw'imyanda.

[39] Mu gusobanura nanone icyo ijambo ubuzima rishatse kuvuga, mu rubanza rwaciwe n'Urukiko rw'Ikirenga rw'Ubuuhinde haburana uwitwa Francis Coralie Mullin vs The Administrator, Union Territory of Dheli and others on 13 January, 1981,¹² rushingiye ku ngingo ya 21 y'Itegeko Nshinga ry'Ubuuhinde, iteganya ko ntawe ushobora kwamburwa ubuzima bwe n'ukwisyira ukizana kwe uretse mu gihe byaba bikozwe mu buryo buteganyijwe n'amategeko (*No person shall be deprived of his life or personal liberty except according to procedure established by law*), rwasobanuye ko ijambo ubuzima rikwiye kumvikana nk'ikintu kirenze kubaho bisanzwe, ko kuvutsa umuntu ubuzima bigera no kumubangamira mu buryo bwose bwatuma yisanzura mu mibereho ye. Rwasobanuye ko itegeko ribuza konona umubiri uwukuraho kimwe mu bice biwugize ari nabyo bituma umuntu abaho agashobora kubana n'abandi.

[40] Mu bisobanuro byatanzwe kandi n'Akanama k'Umuryango w'Abibumbye gashinzwe uburenganzira bwa muntu (*Human Right Committee*), ubwo kasobanuraga ingingo ya 6 y'Amasezerano mpuzamahanga mu by'imbonezamubano na politiki (*International covenant on civil and political rights*) yavuzwe haruguru ivuga ku burenganzira bwo kubaho, kasobanuye ko uburenganzira bwo kubaho ari ubutuma ntacyo umuntu yakwikanga cyamukururira urupfu rudasanzwe cyangwa rw'imburagihe, kandi akabaho yumva afite agaciro. Kavuze ko ingingo ya 6 iha ubwo burenganzira abantu bose nta vangura iryo ariryo ryose kugeza ndetse no ku bantu bakatiwe nyuma yo guhamwa n'ibaha by'ubugome. Kabivuze muri aya magambo: *the right to life is a right which should not be interpreted narrowly. It concerns the entitlement of individuals to be free from acts and omissions that are intended or may be expected to cause their unnatural or premature death, as well as to enjoy a life with dignity. Article 6 guarantees this right for all human beings, without distinction of any kind, including for persons suspected or convicted of even the most serious crimes.*¹³

[41] Nanone mu gusobanura icyo uburenganzira bwo kubaho bishatse kuvuga, Komisiyo Nyafurika y'uburenganzira bwa Muntu n'ubw'Abaturage, ubwo yatangaga ibisobanuro ku ngingo ya 4 y'Amasezerano Nyafurika ku burenganzira bwa Muntu n'ubw'Abaturage¹⁴, yavuze ko ubwo burenganzira bugomba kumvikana mu buryo bugari, aho Leta ifite inshingano zo kurinda abaturage bayo

ku buryo ntacyahungabanya ubuzima bwabo bitewe n'ibikorwa by'abandi bantu cyangwa se kutagira igikorwa mu gihe bugarijwe n'akaga. Izo ngamba ni nko kurinda ibidukikije, gutanga ubufasha mu gihe abaturage bugarijwe n'ibiza, amapfa cyangwa indwara z'ibyorezo, no gutanga ubundi butabazi bwihutirwa¹⁵.

[42] Urukiko rurasanga uburenganzira bwo kubaho ari uburenganzira shingiro bw'ikiremwamuntu ubundi burenganzira bwose bushingiyeho, ingingo ya 12 y'Itegeko Nshinga ikaba iteganya ko ari uburenganzira bugomba kurindwa ku buryo nta muntu ushobora kubuvutswa mu buryo bunyuranyije n'amategeko. Mu rwego rwo kurinda ubwo burenganzira nk'uko Akanama k'Umuryango w'Abibumbye gashinzwe uburenganzira bwa Muntu kabitanzeho icyifuzo¹⁶, mu Itegeko N° 68/2018 ryo ku wa 30/08/2018 riteganya ibyaha n'ibihano muri rusange, hateganyijwemo ingingo ibuza kuba umuntu yakwambura undi ubuzima, aho yateganyije igihano kiremereye ku wabikora.¹⁷ Umushingamategeko yashatse kurengera ubwo burenganzira nanone ashyira muri iryo tegeko ingingo zibuza gukuramo inda¹⁸, kubera ko umwana wasamwe nawe aba afite uburenganzira mbonezamubano bwemererwa buri muntu¹⁹, gusa akaba yarashyizeho irengayobora yemera ko kuvanamo inda bishoboka mu bihe bivugwa mu ngingo ya 125, igika cya mbere, y'Itegeko N° 68/2018 ryo ku wa 30/08/2018 riteganya ibyaha n'ibihano muri rusange²⁰, kandi nabwo bigakorwa n'abaganga babifitiye ubumenyi kandi bafite ibyangombwa byose nkenerwa kugira ngo bidashyira mu kaga ubuzima bw'ukeneye gukuramo inda ku buryo bwanahatakarira.

[43] Ku bijyanye n'ingorane zikunze kuvuka mu gukuramo inda, ubushakashatsi bukubiye mu nyandiko yiswe “*Abortion incidence and postabortion care in Rwanda*” bwakozwe na Dr Basinga Paulin na begenzi be, bugaragaza ko mu mwaka wa 2009, mu Rwanda hari abagore n'abakobwa 25.727 bitaweho n'abaganga nyuma yo kugira ibibazo bikomeye bifitanye isano no gukuramo inda, 40 % byabo bikaba byarabaye ngombwa ko bakurikiranwa n'umuganga (*medical doctor*) kubera ibibazo bikomeye. Muri iyo nyandiko, abahanga bayikoze bavuga ko ingorane zivuka mu gukuramo inda zituruka ku bunararibonye buke bw'abatanga serivisi yo gukuramo inda cyangwa no kuba iyo serivisi itangirwa ahantu hadatunganye (*Complications may result, however, from procedures conducted by trained providers who have little experience or who work in unhygienic settings*) [...]. Basobanura ko mu Rwanda abaganga bakoresha uburyo bukurikira mu gukuramo inda: *surgical method (evacuation dilation and curettage), oral and vaginal administration of hormonal medication n'ubwa manual vacuum aspiration (MVA)*. Bavuga ko uburyo bukunze gukoreshwa n'Ibitaro by'Uturere kimwe n'Ibitaro by 'Icyitegererezo (*district and referral hospitals*) ari ubwa *surgical method (evacuation dilation and curettage)*. Nyuma yo kubona ibibazo bivuka mu gukuramo inda, basaba ubuyobozi ko uburyo bwo kubikora byemewe n'amategeko bwanzoza, urugero hakemezwia ko muganga (*medical*

*doctor) ari we wenyine wemererwa kugena ko gukuramo inda bikorwa, kandi hakajyaho amabwiriza yerekana abakozi bo mu buvuzi bemerewe gutanga bene iyo serivisi n'ibigo by'ubuvuzi igomba gutangirwamo*²¹.

[44] Ku birebana n'uburyo bwa surgical method nka bumwe mu bukunze gukoreshwa mu Rwanda nk'uko bimaze kugaragazwa haruguru, Umuryango mpuzamahanga wita ku buzima (WHO), mu nyandiko yitwa safe abortion: technical and policy guidance for health system, uvuga ko ari uburyo bubabaza cyane, uga tanga inama ko aho ubwo buryo bwaba bugikoreshwa hakorwa ibishoboka byose bugasimbuzwa ubwa *manual vacuum aspiration* mu rwego rwo kunoza uburyo abagore bakenera iyo serivisi bitabwaho, ko aho ubwo buryo butarashoboka, *surgical method* yakorwa n'abakozi babihuguriwe bihagije kandi bakagenzurwa neza²². Naho Patrick Adams mu nyandiko ye yitwa in Hospital across Africa, A Lack of post-abortion care, avuga ko ubushakashatsi bwagaragaje ko uburyo bwa dilation and curetage aribwo bufite ingaruka nyinshi, budatanga umusaruro kandi bubabaza ugereranyije n'uburyo bwa manual vacuum aspiration, ikindi kandi kuba busaba ko bukoreshwa n'umuganga ufite uburyo ashobora guhita abaga umugore cyangwa umukobwa wakuyemo inda bibaye ngombwa, burahenze cyane²³.

[45] Urukiko rurasanga ibimaze kuvugwa haruguru bigaragaza ko kwemerera ubu ababyaza n'abaforomo cyangwa abaforomokazi gukuramo inda kandi bigakorerwa ku bigo nderabuzima nk'uko uwatanze ikirego abyifuza, bishobora gushyira mu kaga ubuzima bw'abagore n'abakobwa bakenera guhabwa iyo serivisi kurusha uko byabafasha. Kubibemerera bisaba ko baba barahawe amahugurwa yihariye, hakajyaho n'amabwiriza yihariye abasaba gukuramo inda bakoresheje uburyo bwa vacuum aspiration na medical abortion, ndetse n'ibigo nderabuzima bakoreramo bigahabwa ibikoresho bijyanye n'iyo serivisi. Iki ariko akaba atari ikibazo cy'amategeko, ahubwo ari ikirebana n'ingamba zigomba gufatwa n'inezgo zibishinzwe mu rwego kunoza imitangire ya serivisi yo gukuramo inda bigendanye n'amikoro y'Igihugu.

[46] Ku bivugwa n'urega bijyanye no guhugura abatanga serivisi z'ubuzima zoroheje nk'ababyaza n'abandi bashinzwe ubuzima kugira ngo babashe gukuriramo inda ababikeneye mu buryo bwizewe kandi bikorewe mu bigo nderabuzima, Urukiko rusanga, n'ubwo ibyo byakumvikana harebwe ingorane n'ibibazo bishobora kuvuka mu gutanga bene iyo serivisi nk'uko byasabanwe haruguru, ariko bitakemurirwa mu kirego gisaba gukuraho iningo z'amategeko ziteganya ko iyo serivisi itangwa na muganga wemewe na Leta gusa, mu yandi magambo, ubifitiye ubushobozi n'ubumenyi, ahubwo ari ibyagezwa ku nzego zishinzwe gushyiraho ingamba mu bijyanye n'ubuzima, kuko kugeza ubu izo nzego zasanze muganga wemewe na Leta ariwe ufite ubumenyi buhagije bwo gutanga serivisi yo gukuramo inda mu buryo bwizewe. Gusaba Urukiko gutegeka ibigomba gukorwa mu rwego rw'ingamba na politiki zirebana n'urwego rw'ubuzima, byaba binyuranyije n'ihame ry'uko inzego z'ubutegetsi za Leta zitandukanye kandi zigenga zikanubahana (*separation of powers*)²⁴. Uyu akaba ari nawo murongo watanzwe n'uru Rukiko mu manza n° RS/SPEC/0001/16/CS, Akagera Business Group²⁵, na RS/INCONST/SPEC 00001/2019/SC²⁶.

[47] Hashingiwe ku bisobanuro byose byatanzwe, Urukiko rurasanga GLIHD yatanze ikirego itarashoboye kurugaragariza uburyo kuba ingingo ya 125, igika cya 2 n'gingo ya 126, igika cya 3, z'Itegeko N° 68/2018 ryo ku wa 30/08/2018 ryavuzwe haruguru ziteganya ko serivisi yo gukuramo inda ku bagore no ku bana b'abakobwa babyemerewe itangwa na muganga wemewe na Leta gusa, bibangamiye uburenganzira bwo kubaho buteganywa n'gingo ya 12 y'Itegeko Nshinga. Kubera iyo mpampu, ikirego cyayo kuri yi ngingo kikaba nta shingiro gifite.

Ku bijyanye n'uburenganzira bwo kugira ubuzima bwiza (right to good health) buteganywa n'gingo ya 21 y'Iteko Nshinga

[48] Ingingo ya 21 y'Itegeko Nshinga, iteganya ko abanyarwanda bose bafite uburenganzira bwo kugira ubuzima bwiza. Ubu burenganzira tubusanga kandi no mu masezerano mpuzamahanga anyuranye, harimo Itangazo mpuzamahanga ryerekeye uburenganzira bwa Muntu (*Universal Declaration of Human Rights*)²⁷, Amasezerano Mpuzamahanga agamije kurandura ivangura iryo ariryo ryose rishingiye ku bwoko yasinywe mu mwaka wa 1965 (*International Convention on the Elimination of All Forms of Racial Discrimination*)²⁸, Amasezerano Mpuzamahanga arebana n'uburenganzira mu by'ubukungu, imibereho myiza n'umuco (*International Covenant on Economic, Social and Cultural Rights*)²⁹, Amasezerano Mpuzamahanga agamije kurandura ivangura iryo ariryo ryose rikorerwa abagore (*Convention on the Elimination of All Forms of Discrimination against Women*)³⁰, Amasezerano nyafurika ku burenganzira bwa Muntu n'ubw'Abaturage (*African Charter on Human and Peoples' Rights*)³¹.

[49] Itegeko shingiro ryashyizeho umuryango mpuzamahanga w'ubuzima ryatanze igisobanuro cy'ubuzima bwiza ko ari ukuba umuntu yumva ameze neza mu mubiri, mu mitekerereze no mu mibereho ye n'abandi, ko kugira ubuzima bwiza bidasobanuye gusa kuba umuntu yumva atarwaye cyangwa se yumva nta bumuga afite³².

[50] Ku bijyanye n'uko uburenganzira ku buzima bwiza bugomba kumvikana, Akanama k'Umuryango w'Abibumbye gashinzwe uburenganzira mu by'ubukungu, imibereho myiza n'umuco (*Committee on Economic, Social and Cultural Rights*), ubwo kasobanuraga ingingo ya 12 y'Amasezerano Mpuzamahanga arebana n'ubukungu, imibereho myiza n'umuco yavuzwe haruguru, kanzuye ko uburenganzira buvugwa muri iyo ngingo butagarukira ku buvuzi buboneye gusa, ko ahubwo bugenda bukagera no ku bijyana nabwo nk'amazi meza n'isuku, ibiribwa biteguye neza kandi bifite akamaro, aho gutura heza, gukorera mu mwuka mwiza no kubona inyigisho zirebana n'ubuzima harimo n'uburebana n'imyororokere. [51] Mu nyandiko yiswe “*Ruling for Access, Leading court cases in developing countries on access to essential medicines as part of the fulfilment of the right to health*” yashyizwe ahagaragara n'Umuryango Mpuzamahanga wita ku buzima (WHO), abahanga bayanditse basobanuye ko kugira ngo byemezwe ko ighugu cyahutaje uburenganzira ku buzima bwiza, ari ngombwa kureba niba icyo gihugu nta bushobozi gifite cyangwa se niba ari ubushake bubura kugira ngo kirangize inshingano cyiyemeje mu ngingo ya 12. Bifatwa ko ighugu cyarenze ku nshingano zacyo iyo nta ngamba za ngombwa cyafashe kugira ngo umuntu wese agire uburenganzira ku buzima bwiza. Ingero zatanzwe n'Akanama k'Umuryango w'Abibumbye gashinzwe uburenganzira mu by'ubukungu, imibereho myiza n'umuco, ni ukuba nta politike yashyizweho ituma abantu bose bagira ubuzima bwiza, kutagena ingengo y'imari ihagije, kutagenzura uburyo uburenganzira ku buzima bwiza bwubahirizwa, no kutagira igikorwa mu rwego rwo kugabanya ubusumbane bw'ibikorwa remezo n'izindi serivisi zo mu rwego rw'ubuzima³⁴.

[52] Nk'uko byagarutsweho n'Akanama k'Umuryango w'Abibumbye gashinzwe uburenganzira mu by'ubukungu, imibereho myiza n'umuco, kugira ngo uburenganzira ku buzima bwiza bugerweho mu gihugu, ni ngombwa ko ibantu bikurikira by'ingenzi kandi bifitanye isano biba bihari, ariko nanone mu rugero rugendanye n'ubushobozi bwa buri gihugu:

- Kuba mu gihugu hari amavuriro ahagije kandi ubuvuzi bukora neza na serivisi muri ayo mavuriro zitangwa neza (*availability*);
- Kuba umuntu wese ashobora kugera ku mavuriro yose na serivisi ziboneka muri ayo mavuriro nta vangura iryo ariryo ryose (*accessibility*);

- Kuba mu mavuriro yose na serivisi zitangirwamo harangwa n'imyifatire myiza ikwiye abakozi bo kwa muganga, mu mikorere yabo bakamenya kwita ku muntu wese bitaye ku kuntu ameze, urugero nk'umugore bakamenya uko bamufata, rubanda rugufi, n'ibindi byiciro by'ababagana. Bagomba kandi kugirira ibanga uje abagana, buri gihe bagashishikazwa no gutuma uje abakeneyeho serivisi agira ubuzima bwiza kurushaho (*acceptability*);
- Kuba mu mavuriro hatangirwa sirivisi zifite ireme. Ibi bisobanuye ko kuri ayo mavuriro hagomba kuba hari abakozi b'bahanga babyigiye, haboneka imiti myiza n'ibikoresho bigezweho (*quality*)³⁵.

- uburenganzira ku buzima bwiza butagarukira ku buvuzi buboneye gusa, ko ahubwo bugenda bukagera no ku bijyana nabwo nk'amazi meza n'isuku, ibiribwa biteguye neza kandi bifite akamaro, aho gutura heza, gukorera mu mwuka mwiza no kubona inyigisho zirebana n'ubuzima harimo n'uburebana n'imyororokere;
- uburenganzira ku buzima bwiza bugendana no kuba mu gihugu gifite amavuriro ahagije kandi atanga serivisi mu buryo bunoze hagendewe ku bushobozi bwa buri gihugu;
- Bifatwa ko ighugu cyarenze ku nshingano zacyo iyo nta ngamba za ngombwa cyafashe kugira ngo umuntu wese agire uburenganzira ku buzima bwiza.

[54] Hashingiwe ku bimaze kuvugwa, Urukiko rurasanga ku bijyanye n'uburenganzira ku buzima bwiza, ighugu gifite inshingano zo gushyiraho politiki, amategeko n'amabwiriza bigenga ibigo by'ubuvuzi bya Leta n'iby'abikorera kugira ngo harengerwe ubuzima bw'abantu. Iyo inzego z'ubuvuzi zihari ndetse n'abakozi bazobereye bakaba bahari nk'uko GLIHD ibiyugira, inshingano z'ighugu ziba zisigaye ni uguuzuma niba abaturage bose bahabwa serivisi kimwe hakurikijwe amahame yashyizweho, Leta ikaba yagira ibyo ibazwa ari uko ubuzima bw'umuturage bushyizwe mu kaga bitewe ni uko yangiwe guhabwa serivisi iriho kandi yari yemerewe.

[55] Ku bireba uru rubanza, bigaragara ko ighugu cyashyizeho ibitaro bihabwa n'abaganga bashobora gukuriramo inda abagore n'abakobwa mu buryo bunoze. Kuba iyo serivisi itangirwa ku bitaro kandi igatangwa n'abaganga aho gutangirwa ku Bigo Nderabuzima ngo itangwe n'ababyaza cyangwa abaforomo nk'uko uwatanze ikirego abyifuza, sibyo byafatwa nko kutubahiriza uburenganzira ku buzima bwiza. Byari gufatwa nko kutubahiriza ubwo burenganzira iyo serivisi iba yemewe n'amategeko ariko idatangwa na mba, itangirwa ahantu hadakwiye, itangwa n'abatabifitiye ubumenyi n'ubushobozi cyangwa byaragaragaye ko abayikinera ari benshi cyane ugereranyije n'abashinzwe gutanga iyo serivisi, ku buryo gutinda kuyihabwa bibagiraho ingaruka.

[56] Urukiko rusanga ahubwo ibikubiye mu ngingo ya 125, igika cya 2 n'ingingo ya 126, igika cya 3, z'Itegeko N° 68/2018 ryo ku wa 30/08/2018 riteganya ibyaha n'ibihano muri rusange, ari zimwe mu ngamba zigamije kurengera uburenganzira ku buzima bwiza ku bireba by'umwihariko ubuzima bw'imyororokere, igikorwa cyo gukuramo inda mu bihe bigenwa n'itegeko gishyirwa mu biganza by'umuganga ubifitiye ubumenyi n'ibikoresho bya ngombwa. Nyuma y'ibyo bisobanuro, Urukiko rukaba rusanga GLIHD itarashoboye kurugaragariza uburyo kuba iningo z'itegeko iregera zarateganyije ko serivisi yo gukuramo inda itangwa na muganga wemewe na Leta gusa binyuranyije

[57] Mulisa Tom uhagarariye GLIHD n'abamwunganira bavuga ko ibisabwa n'Itegeko riteganya ibyaha n'ibihano muri rusange ryavuzwe haruguru ko serivisi y'ubuvuzi yo gukurirwamo inda mu buryo bwemewe n'amategeko kandi bunoze itangwa na muganga wemewe na Leta gusa aho kuba umuntu wese wize ibijyanye n'ubuvuzi, bibangamira uburenganzira bw'abagore ndetse n'ubw'abakobwa kubera ko bigabanya umubare w'abatanga iyo serivisi n'uw'abayihabwa.

[58] Basobanura ko Ishami ry'Umuryango w'Abibumbye ryita ku Buzima ryagaragaje neza ko abafasha b'abaganga, nk'abaforomo n'abaforomokazi, ababyaza cyangwa se abandi bakozi bo mu mavuriro bashobora gutanga neza kandi mu buryo bwizewe serivisi zo gukuramo inda. Bavuga ko Komisiyo Nyafurika y'Uburenganzira bwa Muntu n'ubw'Abaturage, ishingiye ku Masezerano ya Maputo, mu rwego rwo gushyira mu bikorwa ingingo zirebana no gutanga serivisi z'ubuvuzi zo gukuramo inda mu buryo bunoze, bwizewe kandi bwemewe n'amategeko zigaragara muri ayo masezerano, yashyizeho amabwiriza ngenderwaho ko ibihugu bitagomba gushyiraho imbogamizi cyangwa inzitizi ku bisabwa abavuzi bemerewe gutanga iyo serivisi y'ubuvuzi. Bavuga ko Komisiyo yakomeje igaragaza ko, muri rusange kuba mu bihugu byinshi by'Afurika hari umubare udahagije w'abaganga, abafasha b'abaganga, nk'ababyaza ndetse n'abandi bakozi bita ku buzima, bakagombye guhabwa amahugurwa kugira ngo nabo bajye bita ku bakeneye serivisi y'ubuvuzi yo gukuramo inda.

[59] Barangiza bavuga ko kuba abagore n'abakobwa bemerewe gukuramo inda bahura n'imbogamizi yo kuuya ku bitaro bikuru ahashobora kuboneka muganga kubera ko biri kure yabo, usanga birangiyе bagiye gukuramo inda mu buryo butaboneye, ibyo bigatumra bajya kwa muganga benda gupfa, byongeye kandi bagahanirwa icyaha cyo gukuramo inda, bakavuga ko ibi bibahungabanya ku mubiri no mu mutwe.

[60] Uhagarariye Leta y'u Rwanda avuga ko kuri iyi ngingo, bigaragara ko Leta yahisemo ko ufite ubushobozi bwo gufasha umugore wifuza gukuramo inda ari umuganga (*medical doctor*) ufite ubumenyi bwemewe n'inzezo zibifitiye ububasha. Ibi bivuze ko utari umuganga adashobora gutanga iyo serivisi kubera ingaruka z'ubuzima zishobora gukomoka mu gukurwamo inda mu gihe bikozwe n'undi muntu utari umuganga. Ibyo bikanashimangirwa ni uko mu ngingo ya 4 n'iya 7 z'Iteka rya Minisitiri N° 002/MoH/2019 ryo ku wa 08/04/2019 rigena ibigomba kubahirizwa kugira ngo muganga akuriremo umuntu inda hateganyijwe ko usaba gukurirwamo inda agomba kubanza gusuzumwa ko ari muzima mu buryo bwimbitse, kandi ko iyo nda igomba kuba itarengeje ibyumweru makumyabiri na bibiri (22) ndetse akabanza kugirwa inama ku ngaruka zo gukuramo inda.

[61] Avuga kandi ko Iteka rya Minisitiri N° 002/MoH/2019 ryavuzwe haruguru risobanura ko umuganga wemewe na Leta ari umuntu ufite ubumenyi mu buvuzi bw'abantu, ufite nibura impamyabushobozi y'icyiciro cya kabiri cya Kaminuza mu ishami ry'Ubuvuzi kandi wemewe n'urwego rushinzwe kugenzura imirimbo y'ubuvuzi mu Rwanda, ukorera mu kigo cy'ubuvuzi cya Leta cyangwa cyigenga. Ibi bisobanuye ko ugomba gufasha umuntu gukuramo inda agomba kuba yemera ingaruka zabyo kandi akaba afite ubumenyi buhagije bwo gukuramo inda.

[62] Asoza kuri iyo ngingo avuga ko asanga ntaho igika cya 2 cy'ingingo ya 125 n'igika cya 3 cy'ingingo ya 126 z'Itegeko N° 68/2018 ryo ku wa 30/08/2018 ryavuzwe haruguru zinyuranyije

n'ingingo ya 14 y'Itegeko Nshinga iteganya ibijyanye n'uburenganzira bwo kudahungabanywa ku mubiri no mu mutwe.

UKO URUKIKO RUBIBONA

[63] Ingingo ya 14 y'Itegeko Nshinga iteganya ko umuntu wese afite uburenganzira bwo kudahungabanywa ku mubiri no mu mutwe. Ntawe ushobora kwicwa urubozo, gukorerwa ibibabaza umubiri cyangwa ngo akorerwe ibikorwa by'ubugome, ibikorwa bidakwiye umuntu cyangwa bimutesha agaciro. Ntawe ushobora gukorerwaho igerageza atabyiyemereye. Uburyo bwo kubyemera kimwe n'ubw'iryo gerageza bugenwa n'itegeko. Ubu burenganzira tubusanga kandi no mu masezerano mpuzamahanga atandukanye harimo Itangazo mpuzamahanga ryerekeye uburenganzira bwa Muntu (*Universal Declaration of Human Rights*)³⁶, Amasezerano mpuzamahanga mu by'imbonezamubano na politiki (*International covenant on civil and political rights*)³⁷, Amasezerano y'Umuryango w'Ubumwe bw'Ibihugu bw'Uburayi (*The Charter of Fundamental Rights of the European Union*)³⁸, Amasezerano nyafurika y'uburenganzira bwa Muntu n'ubw'Abaturage (*African charter on human and people's rights*)³⁹.

[64] Ingingo ya 14 y'Itegeko Nshinga igaragaramo ibice bitatu by'ingenzi bikurikira:

- Kuba ntawe ugomba guhungabanywa ku mubiri no mu mutwe.
- Kuba ntawe ushobora kwicwa urubozo, gukorerwa ibibabaza umubiri cyangwa ngo akorerwe ibikorwa by'ubugome, ibikorwa bidakwiye umuntu cyangwa bimutesha agaciro.
- Kuba ntawe ushobora gukorerwaho igerageza atabyiyemereye.

[65] Ku birebana n'igice cya mbere, Akanama k'Umuryango w'Abibumbye gashinzwe uburenganzira bwa Muntu (*Human Rights Committee*), ubwo kasobanuraga iningo ya 7 y'Amasezerano mpuzamahanga mu by'imbonezamubano na politiki yavuzwe haruguru, kavuze ko intego y'iyo ngingo ari ukurinda agaciro umuntu afite, haba ku mubiri cyangwa mu mutwe, ko ibihugu byose bitegetswe gushyiraho amategeko no gufata ibindi byemezo bya ngombwa mu rwego rwo gukumira ibikorwa bibuijwe mu ngingo ya 7, byaba bikozwe n'umuntu igihe ari mu kazi, yaba atari mu kazi cyangwa se bikozwe n'umuntu ku giti cye. Kavuze ko n'uwakwamburwa uburenganzira agomba gukomeza gufatwa mu buryo bumuhesheje icyubahiro gikwiye ikiremwamantu. Kabivuze muri aya magambo:" *The aim of the provisions of article 7 of the International Covenant on Civil and Political Rights is to protect both the dignity and the physical and mental integrity of the individual. It is the duty of the State party to afford everyone protection through legislative and other measures as may be necessary against the acts prohibited by article 7, whether inflicted by people acting in their official capacity, outside their official capacity or in a private capacity. The prohibition in article 7 is complemented by the positive requirements of article 10, paragraph 1, of the Covenant, which stipulates*

that “All persons deprived of their liberty shall be treated with humanity and with respect for the inherent dignity of the human person”.⁴⁰

In the Committee’s view, moreover, the prohibition must extend to corporal punishment, including excessive chastisement ordered as punishment for a crime or as an educative or disciplinary measure. It is appropriate to emphasize in this regard that article 7 protects, in particular, children, pupils and patients in teaching and medical institutions.*⁴¹

The Committee notes that the reports of States parties generally contain little information on this point. More attention should be given to the need and means to ensure observance of this provision. The Committee also observes that special protection in regard to such experiments is necessary in the case of persons not capable of giving valid consent, and in particular those under any form of detention or imprisonment. Such persons should not be subjected to any medical or scientific experimentation that may be detrimental to their health.*⁴²

Naho iya 16 y'Itegeko Nshinga na none, igiteganya ko ivangura iryo ariryo ryose cyangwa kurikwirakwiza byaba bishingiye ku bwoko, ku muryango cyangwa ku gisekuru, ku nzu, ku ibara ry'umubiri, ku gitsina, ku karere, ku byiciro by'ubukungu, ku idini cyangwa ukwemera, ku bitekerezo, ku mutungo, ku itandukaniro ry'umuco, ku rurimi, ku bukungu, ku bumuga bw'umubiri cyangwa ubwo mu mutwe no ku rindi vangura iryo ari ryo ryose, bibujijwe kandi bihanwa n'amategeko.

[81] Ingingo GLIHD isaba ko zakurwaho ivuga ko zinyuranye n'ingingo z'Itegeko Nshinga zimaze kuvugwa, ni iningo ya 125, igika cya 2, n'ingingo ya 126, igika cya 3, z'Itegeko N° 68/2018 ryo ku wa 30/08/2018 riteganya ibyaha n'ibihano muri rusange. Muri rusange izo ngingo ziteganya ko gukurirwamo inda ku mugore cyangwa umukobwa ubyemerewe bikorwa na muganga wemewe na Leta gusa.

[82] Kugira ngo byumvikane niba muri izi ngingo hagaragaramo kutareshya imbere y'amategeko cyangwa ivangura rishingiye ku gitsina no ku byiciro by'ubukungu nk'uko GLIHD yatanze ikirego ibivuga, bityo zikaba zinyuranyije n'ingingo ya 15 kimwe n'iya 16 z'Itegeko Nshinga, ni ngombwa kubanza gusobanura uburyo izo ngingo zumvikana. Nk'uko byasobanuwe mu rubanza rw'Akagera Business Group⁴⁹ rwaciwe n'uru Rukiko ku itariki ya 23/09/2016, iningo ya 15 n'iya 16 z'Itegeko Nshinga zifitanye isano ku buryo mu kuzisobanura zidakwiye gutandukanywa. Nk'uko byasobanuwe kandi muri urwo rubanza, iningo ya 15 ivuga ko abantu bose bareshya imbere y'amategeko kandi bakarengerwa n'amategeko mu buryo bumwe. Ni ukuvuga ko hatagomba kubaho ivangura rituma abantu batarengerwa mu buryo bumwe cyangwa kutagira uburenganzira aho bakabugize. Naho iningo ya 16 ikomerezaho ivuga uburyo gutandukanya abantu bifatwa nk'ivangura kandi ko bitemewe n'Itegeko Nshinga. Twavuga nk'ingingo ya 7 y'Itangazo mpuzamahanga ryerekeye uburenganzira bwa Muntu (*Universal Declaration of Human Rights*), ryo mu mwaka wa 1948⁵⁰, iningo ya 26 y'Amasezerano Mpuzamahanga ku burenganzira mu by'imbonezamubano na Politiki (*International Covenant on Civil and Political Rights*, 1966)⁵¹. Ivuga ko Ibihugu byemeraaya masezerano bifite inshingano yo kuvugurura amategeko n'imigirire bisanzweho bigaragaramo ivangura mu rwego rwo guteza imbere no kurinda uburenganzira bw'umugore ("Women and men are equal before the law and shall have the right to equal protection and benefit of the law. Iri hame ry'uko kugira ngo byitwe ko hari ivangura cyangwa ukutareshyeshya abantu ari uko abantu bari mu cyiciro kimwe baba bafashwe mu buryo butandukanye kandi nta mpamvu yumvikana, ryanagarutsweho mu rubanza rwa Thlimmenos v. Ubu burenganzira tubusanga no mu masezerano mpuzamahanga anyuranye, harimo Itangazo mpuzamahanga ryerekeye uburenganzira bwa Muntu (*Universal Declaration of Human Rights*)⁵⁸, Amasezerano mpuzamahanga mu by'imbonezamubano na politiki (*International covenant on civil and political rights*)⁵⁹, Amasezerano y'ibihugu by'Iburayi ku burenganzira bwa Muntu (*European Convention on Human Rights*)⁶⁰.

[94] Ku birebana n'icyo uburenganzira ku buzima bwite bw'umuntu aricyo, mu rubanza Bărbulescu v. Romania⁶¹, Urukiko rushinzwe kurengera Uburenganzira bwa Muntu rw'Ibihugu by'Iburayi (*European Court of Human Rights*) rwasobanuye ko ari uburenganzira bugomba kureberwa mu buryo bugari, ko ingingo ya 8 y'Amasezerano y'ibihugu by'Iburayi ku burenganzira bwa Muntu irengera ukwisyira ukizana kwa muntu harimo no kubaho ntawivanze mu buzima bwe atabimwemereye. Uburenganzira ku buzima bwite bugomba gutuma umuntu akora mu bwisanzure yiteza imbere. Mu

rubanza Justice K S Puttaswamy (Rtd) vs Union of India⁶² rwaciwe n'Urukiko rw'Ikirenga rw'Ubuhinde, rwasobanuye ko kugira ubuzima bwite ari ukuba umuntu ari ahantu ha wenyine ntawe umuvogera, n'ubwo uko kwishyira ukizana guterwa n'imibanire ye n'abandi. Rwabivuze muri aya magambo:" *Privacy, in its simplest sense, allows each human being to be left alone in a core which is inviolable. Yet the autonomy of the individual is conditioned by her relationships with the rest of society. Those relationships may and do often pose questions to autonomy and free choice...".*

[95] Mu nyandiko yiswe "Internet: Case-law of the European Court of Human Rights"⁶³ yashyizwe ahagaragara n'ishami ry'ubushakashatsi ry'Urukiko rushinzwe kurengera Uburenganzira bwa Muntu rw'Ibihugu by'Iburayi (*Research Division*), batanze igisobanuro cy'ubuzima bwite buvugwa mu ngingo ya 8 y'Amasezerano y'Ibihugu by'Uburayi ku burenganzira bwa muntu (*European Convention on Human Rights*) yavuzwe haruguru. Bavuze ko ubuzima bwite bukubiyemo itumanaho bwite rrimo inzandiko, telefoni, imeyiri (*email*) n'ubundi buryo bw'itumanaho. [96] Akanama k'Umuryango w'Abibumbye gashinzwe uburenganzira bwa Muntu (*Human Rights Committee*), ubwo kasobanuraga ingingo ya 17 y'Amasezerano mpuzamahanga mu by'imbonezamubano na politiki yavuzwe haruguru, kavuze ko iyo ngingo iha buri muntu uburenganzira bwo kuba ntawemerewe kwivanga mu buzima bwe bwite, mu muryango we no mu rugo rwe cyangwa mu butumwa yohererezanya n'abandi no kumutesha agaciro mu buryo bunyuranyije n'amategeko. Kavuze ko mu myumvire yako, ubwo burenganzira bugomba kurindwa ku buryo ntawabuhungabanya, byakorwa n'inezgo za Leta cyangwa undi wese. Za Leta zasabwe gushyiraho amategeko no gufata izindi ngamba zose mu rwego rwo kurengera ubwo burenganzira. Kabivuze muri aya magambo:" *Article 17 provides for the right of every person to be protected against arbitrary or unlawful interference with his privacy, family, home or correspondence as well as against unlawful attacks on his honour and reputation. Private life includes the privacy of communications, which covers the security and privacy of mail, telephone, e-mail and other forms of communication; and informational privacy, including online information (Copland v. the United Kingdom, no. 62617/00, ECHR 2007-I). The concept of private life moreover includes elements relating to a person's right to their image (Sciaccia v. Italy, no. 50774/99, § 29, ECHR 2005-I). In other words, photographs or videos which contain a person's image will fall within the scope of Article 8. In fact, the right to the protection of one's image presupposes the individual's right to control the use of that image, including the right to refuse publication thereof (Von Hannover v. Germany (no. 2) [GC], nos. 40660/08 and 60641/08, § 96, ECHR 2012). This is relevant for the storing of images on communal or social websites. This is an area where the protection of the reputation and the rights of others takes on a special importance, as photos may contain highly personal or even private information about an individual or his or her family. The Verlagsgruppe News GmbH and Bobi v. Austria case (no. 59631/09, 4 December 2012) is interesting in this connection. Photos were taken in the course of a private event in the applicant's apartment. They were taken with his agreement but were not meant for the eyes of outsiders (§ 86).
