Amategeko agenga amasezerano – Kwishyuzwa ingwate yo kurangiza neza imirimo – Rwiyezamazirimo wahawe isoko ryo gukurikirana imirimo (Supervising works) ntiyakwitwaza ko igihe cyari kiri mu masezerano cyo gukora akazi cyarangiyeye ngo yake ingwate mu gihe atagaragaza imirimo yakozwe – Itegeko N 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezambano, iz'ubucuruzi, iz'umurimo n'iz'ubutegetsi, ingingo ya 75, Itegeko No 12//2007 ryo ku wa 27/03/2007 rigenga amasoko ya Leta, ingingo ya 75 na 101.

Incamake y'Ikibazo: Uru rubanza rwatangiriye mu Rukiko rw'ubucuruzi rwa Nyarugenge aho IGIP mbH Ingénieurs-Conseils yareze Leta y'Urwanda mu izina rya MININFRA ko itubahirije amasezerano bagiranye yo kugenzura imirimo yakorwaga na Sosiyete yitwa ESPINA ngo kuko itayishyuye amafaranga agaragara ku nyemezabwishyu eshanu yayishyikirije. Ivuga andi ko itahawe amafaranga y'ingwate yo kurangiza imirimo neza Mu guca urubanza Urukiko rwavuze ko ikirego cyatanze na IGIP MBH Ingénieurs-Conseils nta shingiro gifite ko ndetse umwenda yishyuzwa n'indishyi zinyuranye isaba itazihabwa ngo kuko nta bimenyetso bifatika yabashije gushyikiriza Urukiko.

IGIP mbH Ingénieurs-Conseils ntiyishimiye imikirize bityo ijuririra Urukiko Rukuru rw'Ubucuruzi, mu bujurire bwayo yavuzeko Urukiko rubanza rutahaye agaciro ibimenyetso rwashyikirijwe ndetse runasobanura nabi Itegeko rigenga amasoko ya Leta rusobanura amasezerano yakoranye na MININFRA. Urikiko Rukuru rw'Ubucuruzi rwaciye urubanza rwemeza ko ubujurire bwa IGIP mbH Ingénieurs-Conseils nta shingiro bufite, ruvuga ko nta gihindutse ku mikirize y'urubanza rwajuririwe.

IGIP mbH Ingénieurs-Conseils yajuririye Urukiko rw'Ikirenga, ivuga ko Urukiko Rukuru rw'Ubucuruzi rutategetse ko yishyurwa umwenda ku mirimo yakoze itarishyuwe, kandi yarawutangiyeye ibimenyetso bigizwe n'inyemezabuguzi z'umwimerere zakiriwe na MININFRA, ikaba itarigeze izihakana cyangwa ngo ivuge ko imirimo itarangiyeye. Avuga ko raporo y'akazi yakozwe igashyikirizwa MININFRA ndetse ko kopi yayo yashyikirijwe Urukiko.

Uhagarariye Leta muri uru rubanza avuga ko iyi ngingo y'ubujurire nta shingiro ifite ngo kuko nkuko byakunze gusobanurwa ikibazo cy'ingenzi ari ukugaragaza ibimenyetso, nk'inyemezabuguzi zashyizweho umukono na "fonctionnaire dirigeant", ariko ko kugeza ubu uwo baburana atabigaragaza nubwo agerageza kwerekana ko Inkiko zitabiha agaciro nyamara ntacyo baba barugaragarije. Ibyuko imirimo y'umushinga yarangiye byo asobanura ko abayikoraga basabye ko haba réception provisoire, ariko muri réception technique yagombaga kuyibanziriza basanga hari byinshi bitakozwe, bituma hataba réception provisoire na réception définitive. Bityo rero bikaba bisobanuye neza ko akazi katarangiye.

IGIP mbH Ingénieurs-Conseils ivuga kandi ko Urukiko rwitiranyije ingwate itangwa mbere yo gutangira isoko itangwa nuwatsindiye isoko ndetse n'ingwate yo kurangiza imirimo neza (garantie de bonne fin des travaux). kuko iyi igenda ikatwa kuri buri fagitire ishyikirizwa urwego ruba

Kuba rero ESPINAYarataye imirimo itarangiye kandi IGIP mbH Ingénieurs-Conseils nta Raporo yigeze itangwa igaragaza imikorere idahwitse ya ESPINA kuburyo isoko ririnda riseswa imirimo itarangiye batahindukira ngo bavuge ko bo akazi bari bashinzwe bakarangije neza.

[1] Uru rubanza rukomoka ku masezerano y'akazi (contrat de service) No 096/S/2006/IR/MINITERE/NTB yo ku wa 23/06/2006, Leta y'u Rwanda ihagarariye na Minisitiri yari ifite amazi mu nshingano zayo (MINITERE) yagiranye na IGIP mbH Ingénieurs-Conseils, yiswe "Contrat de consultants pour prestations de services de validation des études d'exécution établies par l'Entreprise, contrôle et surveillance des travaux de renforcement d'AEP de la Ville de Kigali à partir de la nappe phréatique de la Nyabarongo". Ayo masezerano y'akazi yari afite agaciro ka 428.275 Euro na 31.700.000 Frw, kandi ako kazi kagomba gukorwa mu gihe cy'amezi 14, ariko icyo gihe kikaba cyarangiye cyongerwa. Incuro ya mbere, amasezerano yongerewe kuva ku wa 24/04/2008 kugeza ku wa 30/11/2008 (avenant N° 1 au contrat N° 096/S/2006/IR/MINITERE/NTB), yongera kongererwa igihe ku wa 24/12/2008 agomba kurangira ku wa 31/03/2009 (avenant N° 2 au contrat N° 096/S/2006/IR/MINITERE/NTB).

Ivuga ko nyuma y'aho Minisitiri w'Ubutabera akaba n'Intumwa Nkuru ya Leta agiriye inama MININFRA ko kugirango IGIP mbH Ingénieurs - Conseils izishyurwe imirimo yakozwe hagati yo kuwa 31/03/2009 kugeza kuwa

30/11/2009, hagomba gukorwa amasezerano yanditse ajyanye n'imirimo yakozwe muri icyo gihe, ku wa 14/05/2010 IGIP mbH Ingénieurs - Conseils na MININFRA basinyanye amasezerano yiswe "contract of consultancy service for supervision of the works for the project to supply water to Kigali city from Nyabarongo ground water resources". Ayo masezerano akaba yari ay'igihe cy'amezi umunani (8) kuva ku wa 31/03/2009 kugeza ku wa 30/11/2009, akaba ari nayo aregerwa ko atubahirijwe.

IGIP mbH Ingénieurs-Conseils ivuga ko MININFRA yanze kuzishyura kugeza ubu, ikaba isaba ko yazishyurwa hiyongereyeho inyungu z'uwo mwenda zibariwe kuri 18% ku mwaka kuva mu mwaka wa 2009 na 2010 kugeza igihe umwenda wose uzishyurirwa, ndetse ikanishyurwa amafaranga y'ikurikiranarubanza angana na 2.000.000 Frw n'igihembo cy'avoka gihwanye na 7% y'umwenda wose wishyuzwa.

Rwasobanuye ko urega nta bimenyetso bifatika yarugaragariye byerekana ko izo nyemezabuguzi zishyuzwa zaba zarakiriwe muri MININFRA ikirengagiza kuzishyura, bityo Urukiko rukaba ntaho rwahera ruyitegeka kwishyura amafaranga n'ama Euro yaregeye. Urwo Rukiko rwasobanuye ko IGIP MbH Ingénieurs-Conseils itigeze ishyikiriza Urukiko amasezerano yo ku wa 14/04/2009 yagiranye na MININFRA, ahubwo ko ayo yashyikirije Urukiko ari ayo ku wa 14/05/2010, kandi ikaba itarashoboye kugaragaza isano iri hagati y'ayo masezerano yombi, n'akwiye gushingirwaho ayo ariyo.

[5] IGIP mbH Ingénieurs-Conseils ntiyishimiye icyo cyemezo, ijuririra Urukiko Rukuru rw'Ubucuruzi, ivuga ko Urukiko rubanza rwayirenganyije ku mpamvu ebyiri, aho rwemeje ko kongera amasezerano (avenant) byakozwe mu buryo budakurikije ingingo ya 74 y'Itegeko N° 12/2007 rigenga amasoko ya Leta, n'aho rwemeje ko nta bimenyetso bigaragaza ko umwimerere w'inyemezabuguzi yishyuza zashyikirijwe MININFRA. Isobanura ko Urukiko rutahuje ibikubiye mu masezerano y'inyongera n'ibyo Itegeko ritaganyaga, kuko rivuga impinduka ibaye mu masezerano kandi akaba nta mpinduka yabaye ahubwo ko habayeho kongerera igihe amasezerano bikozwe n'Umunyamabanga Uhoraho wa MININFRA, ku busabe bwa IGIP mbH Ingénieurs-Conseils. Ivuga kandi ko ikindi kiregerwa ari ingwate yo kurangiza imirimo neza (garantie de bonne fin) ihwanye na 10%.

zivugwa n'ingingo ya 74 yavuzwe haruguru. Naho ku birebana n'ingwate yo kurangiza imirimo neza (garantie de bonne fin) uwajuriye asaba, MININFRA ivuga ko atayihabwa kuko atagaragaza niba imirimo yarangiye.

[7] Urukiko Rukuru rw'Ubucuruzi rwaciye urubanza RCOMA 00494/2016/CHC/HCC, ku wa 06/01/2017, rwemeza ko ubujurire bwa IGIP mbH Ingénieurs-Conseils nta shingiro bufite, rutegeka ko nta gihindutse ku mikirize y'urubanza rwajuririwe. Ku bijyanye no kumenya niba haragombaga kubaho amasezerano yihariye yo kongera igihe cy'amasezerano y'ibanze, Urukiko Rukuru rwakosoye ibyari byasobanuwe n'Urukiko rubanza, rugaragaza ko kuba icyahinduwe ari amatariki yo kurangirizaho imirimo biturutse ku busabe bwa rwiyezamirimo, kandi urwego rwatanze isoko rukaba rwaramwandikiye rumwemerera ko yongerewe igihe asaba, bitagombaga andi masezerano yihariye kuko nta mpinduka yabaye, bityo ibyakozwe bikaba bitanyuranye n'ibiteganywa n'amategeko. Ku birebana n'ingwate yo kurangiza imirimo neza (garantie de bonne fin) ingana n'ama Euro 102.786,13 isabwa n'uwajuriye, Urukiko rwasanze nta shingiro byahabwa kuko usibye no kuba atabasha kurugaragariza ko iyo ngwate yatanzwe koko, atanagaragaje ibimenyetso by'uko imirimo yarangiye, ndetse ikanakirwa burundu nk'uko amategeko abiteganywa.

[8] IGIP mbH Ingénieurs-Conseils yajuririye Urukiko rw'Ikirenga, inenga Urukiko Rukuru rw'Ubucuruzi kuba rwaremeje ko inyemezabuguzi zashyikirijwe MININFRA zidahagije kugirango zihanywe umwenda iberewemo, ko hagomba ibimenyetso bigaragaza ko yatanze ingwate mbere yo gutangira isoko, kandi icyaregewe atari ingwate yo gutangira isoko ahubwo ari ukwishyurwa umwenda ujyanye n'imirimo yakozwe ntiyishyurwe, no gusubizwa amafaranga yagiye akatwa ku nyemezabuguzi nk'ingwate yo kurangiza imirimo neza.

[9] Mu myanzuro yo kwiregura ku bujurire bwa IGIP mbH Ingénieurs-Conseils, uburanira Leta y'u Rwanda (MININFRA) yatanze inzitizi y'iburabubasha bw'Urukiko rw'Ikirenga, avuga ko agaciro k'ikiburanwa katageze kuri 50.000.000 Frw cyangwa se ngo muri urwo rubanza habe haragenwemo indishyi zingana na 50.000.000 Frw, kandi ko IGIP mbH Ingénieurs-Conseils yatsinzwe ku rwego rwa mbere n'urwa kabiri ku mpamvu imwe yo kubura ibimenyetso.

[10] Urukiko rwaburanishije kuri iyo nzitizi ku wa 13/06/2012, rufata icyemezo ku wa 20/04/2018, rwemeza ko nta shingiro ifite, rutegeka ko iburanisha rizasubukurwa ku wa 19/06/2018. Uwo munsu urubanza ntirwaburanishijwe bitewe n'impinduka z'amategeko, rwimurirwa ku wa 02/10/2018, ruburanishwa mu ruhamo Me Ndagijimana Emmanuel ahagarariye IGIP mbH Ingénieurs-Conseils, naho Me Umwali Munyentwari Claire ahagarariye Leta y'u Rwanda (MININFRA), Urukiko rwemeza ko urubanza ruzasomwa ku wa 09/11/2018. Mu gihe Urukiko rwari mu mwiherero, Me Ndagijimana Emmanuel yohereje ibimenyetso bitagiweho impaka, bigizwe na « dispositions générales » na « conditions particulières du contrat », ndetse n'ibaruwa yitiriwe Umunyamabanga Uhoraho muri MININFRA yo ku wa 06/12/2009.

[11] Urukiko, rushingiye ku ngingo ya 75 y'Itegeko N° 22/2018 ryo ku wa 29/04/2018 ryerekeye imiburanishirize y'imanza z'imbonezamubano, iz'ubucuruzi, iz'umurimo, n'iz'ubutegetsi no ku ruhare ibimenyetso byatanzwe na Me Ndagijimana Emmanuel bishobora kugira ku mikirize y'urubanza, rwasanze ari ngombwa ko iburanisha ryongera gufungurwa kugirango ababuranyi bagire icyo babivugaho, rishyirwa ku wa 15/01/2019.

Nyuma yo kumva icyo buri ruhande ruvuga kuri ibyo bimenyetso, Urukiko rwafatiye icyemezo mu ntebe cy'uko mbere yo guca urubanza, ari ngombwa kubanza kubaza MININFRA ibijyanye n'ibaruwa yasinywe na Marie Claire Mukasani ku wa 06/12/2009 nk'Umunyamabanga Uhoraho, mu gihe Umunyamabanga Uhoraho yitwaga Mukasine Marie Claire, igasobanura niba ibaruwa ari iyayo hakaba harabayeho kwibeshya. Urubanza rwimuriwe ku wa 19/03/2019, kuri uwo munsu iburanisha ribera mu ruhande, hasuzumwaga igisubizo MININFRA yahaye Urukiko ivuga ko ibaruwa yo ku wa 06/12/2009 itanditwe n'uwaru Umunyamabanga Uhoraho Mukasine Marie Claire, ko ahubwo ifite numero y'indi baruwa yo ku wa 07/05/2009; hasuzumwaga kandi n'ibindi bimenyetso Me Ndagijimana Emmanuel yari yatanze nyuma yo gupfundikira iburanisha. Iburanisha ntiryashojwe uwo munsu kubera ko Urukiko rwasanze ari ngombwa ko mbere y'uko urubanza rucibwaga, hari ibigomba kubanza gusobanuka, rusaba Me Umwali Munyentwari Claire kujya gushakira amakuru yuzuye ku mushinga harimo n'impapuro zijyanye nawo.

- Imirimo IGIP mbH Ingénieurs-Conseils ivuga ko yakoreye Surveillance ikarangiza mu gihe uhagarariye Leta avuga ko ESPINA yagenzurwaga itarangije imirimo;
- Kumenya niba réception provisoire na définitive byarakozwe, n'ibindi bisobanuro byaba ngombwa ku bijyanye n'umushinga.

[14] Niwenshuti Emmanuel yabwiye Urukiko ko imirimo y'umushinga itigeze irangira, ko abayikoraga basabye ko haba réception provisoire, ariko muri réception technique yagombaga kuyibanziriza basanga hari byinshi bitakozwe, bituma hataba réception provisoire na réception définitive. Yasobanuye ko uruhare rwa IGIP mbH Ingénieurs-Conseils rwari ukugenzura imigendekere myiza y'umushinga, harimo no kureba ibitarakozwe neza. Yavuze kandi ko, iyo IGIP mbH Ingénieurs-Conseils iza gukora rapport provisoire igaragaza uko imirimo ihagaze, ibyagenze neza n'ibyagenze nabi, yashoboraga gusubizwa 5% y'ingwate yo kurangiza neza imirimo, ariko ko bitakozwe.

[15] Ku bijyanye n'uko inyemezabuguzi zakirwaga n'uwazakiraga, Niwenshuti Emmanuel yabwiye Urukiko ko IGIP mbH Ingénieurs-Conseils yohererezaga MININFRA inyemezabuguzi iherekejwe na raporo y'imirimo, yamara kwakirwa igahabwa ingénieur ukurikirana imirimo, akagenzura ko ihuje n'ibisabwaga, agatanga approbation ikabona kujya muri Finance kugirango yishyurwe.

[16] Ku bijyanye no kumenya uburyo ingingo ya 6.4, iii ya conditions particulières yubahirijwe, Yaramba Albert yasobanuriye Urukiko ko ingwate yo kurangiza imirimo neza yagombaga gusubizwa yari 10%, 5% agomba gusubizwa ari uko habaye „réception provisoire des travaux, andi 5% agasubizwa nyuma ya réception définitive Avuga ko imirimo itarangiye, ntihaba kuyakira, ntiha gira na raporo zitangwa, bituma hataba no gusubiza ingwate yo kurangiza imirimo neza. Yasobanuye ko raporo z’ibyakoze zatangwaga na IGIP mbH Ingénieurs-Conseils, kandi ko guzubiza ingwate yo kurangiza imirimo neza bitakorwaga kuri buri nyemezabuguzi, ahubwo byagombaga gukorwa ari uko hamaze kubaho réception provisoire na réception définitive

II. IBIBAZO BIGIZE URUBANZA N’ISESENGURA RYABYO

A. Kumenya niba hari amafaranga Leta y’u Rwanda (MININFRA) igomba kwishyura IGIP mbH Ingénieurs-Conseils y’umwenda w’imirimo ivuga ko yakoze ntiyishyurwe

[18] Me Ndagijimana Emmanuel ahagarariye IGIP mbH Ingénieurs- Conseils avuga ko impamvu yamujurije ari uko Urukiko Rukuru rw’Ubucuruzi rutategetse ko yishyurwa umwenda ku mirimo yakozwe itarishyurwe, kandi yarawutangiyeye ibimenyetso bigizwe n’inyemezabuguzi z’umwimerere zakiriwe na MININFRA, ikaba itarigeze izihakana cyangwa ngo ivuge ko imirimo itarangiye. Asobanura ko amasezerano yasinywe mu mwaka wa 2006 n’ayasinywe mu 2010 ari amwe kandi ko yuzuzanya, ndetse ko ayo mu 2010 yasinywe nyuma y’uko Minisitiri w’ubutabera agiriye inama MININFRA ko kugira ngo imirimo yakozwe nta masezerano ibashe kwishyurwa, ari uko hasinywe andi masezerano arebana n’iyo mirimo, ko rero atari "avenant" ahubwo ari amasezerano yakozwe hongerwa igihe cy’imirimo (prolongation de délais).

[19] Avuga ko IGIP mbH Ingénieurs yakozwe akazi yahawe ikakarangiza ndetse ikanongerwa akandi, ko nta kuntu yari kuba itarangiye akazi ka mbere ngo yongere ihabwe akandi. Avuga ko amasezerano yose IGIP mbH Ingénieurs-Conseils yahawe yayubahirije, ko kandi n’ibikorwa byakozwe bihari.
