Incamake y’ikibazo: Access Bank Rwanda Ltd (Access Bank) yagiranye amasezerano y’inguzanyo zitandukanye na SOTIRU Ltd. Icyaje kugaragara ni uko hari amafaranga Access Bank yakuye kuri konti ya SOTIRU bitari ngombwa ndetse iza gushyira SOTIRU mu cyiciro cya 5 cy’abatishyura imyenda neza kandi ahubwo yaragombaga kuyishyira mu cyiciro cya 2 kugira ngo ibashe kubona uko yaka imyenda mu yandi mabanki ndetse no kuzahura ubucuruzi bwayo.

SOTIRU yaje kuregera Urukiko Rukuru rw’Ubucuruzi isaba ko yasubizwa amafaranga yakaswe kuri konti yayo atari ngombwa no kubihererwa inyungu ziyakomokaho, gushyirwa mu cyiciro cya 2 n’indishyi zitandukanye. Urukiko rwemeje ko ikirego cyayo gifite ishingiro rutegeka Acees Bank kwishyura amafaranga n’inyungu zayo yakuye kuri konti ya SOTIRU nta mpamvu n’indishyi zitandukanye.

Impande zombi ntizishimiye imikirize y’urubanza zizuririra Urukiko rw’ikirenga; SOTIRU ivuga ko inyungu z’amafaranga yakaswe nta mpamvu zabazwe nabi, ko itasubijwe amafaranga y’ikinyuranyo hagati y’umwenda yishyuzwaga n’uwamenyeshwaga BNR; ko yimwe indishyi yasabaga zo kuba itahawe amafaranga yari kunguka iyo ACCESS BANK RWANDA Ltd itayima *crédit documentaire*

yari yarayemereye no kuba yarahawe indishyi nkeya kandi ACCESS BANK RWANDA Ltd yarayiteje igihombo gikomeye yanga kuyikura muri *classe* ya

Access Bank yo yajuriye ivuga ko Yaraciwe indishyi nyinshi kandi ko yarategetswe kwishyura amafaranga yose y'umuhanga kandi atari ko bigomba kugenda.

Urukiko rw'Ikirenga rwemeje ko ubujurire bwa SOTIRU bufite ishingiro kuri bimwe rutega Access Bank kwishyura SOTIRU 3.766.742 Frw ya "agios"; 10.000.000 Frw ajyanye no kuba yaranze kuyihindurira icyiciro cy'inguzanyo nta mpamvu (*classe*) ; 10.000.000 Frw yo kuba yaranze kuyifungurira *crédit documentaire*, igahagarika imyiteguro igeze kure, nta mpamvu ishyitse itanze ; 5.000.000 Frw ya "transfert" Banki yakoze ya *crédit à l'importation* ikajya kuyicungira hamwe na *crédit de Caisse* kandi zidahuje kamere; amafaranga y'ikurikirana rubanza n'igihembo cya Avocat.

Ku rundi ruhande rwemeje nanone ko ubujurire bwa Access Bank bufite ishingiro kuri bimwe kuko yaraciwe indishyi nyinshi ku bijyanye no kuba yarimuriye hamwe umwenda wose wa SOTIRU Ltd kandi ibipimo by'inyungu bitandukanye, bityo aho kwishyura indishyi za 10.000.000 Frw igategekwa kwishyura 5.000.000 Frw kandi ko impande zombi zigomba kugabana amafaranga yahembwe umuhanga washyizweho n'Urukiko Rukuru rw'Ubucuruzi, bityo ayo buri ruhande rwatanze akaba aruherereyeho.

SOTIRU yasubirishijemo urubanza ku mpamvu z'akarengane rwonnera kuburanishwa. Impamu yashingiragaho Access Bank hari amafaranga yakuye kuri konti yayo nta mpamvu ntiyatangira inyungu; yakuye; ko Access Bank yagombaga gutegekwa gusubiza ikinyuranyo cy'amafaranga yishyujwe SOTIRU Ltd n'ayo yabwiraga Banki Nkuru y'igihugu (BNR); ko Access Bank yagombaga gutegekwa kwishyura indishyi zishingiye ku kuba yaranze gusubiza SOTIRU Ltd muri *classe* 2; ko Access Bank yagombaga gutegekwa kwishyura indishyi zishingiye ku kuba yaranze gufungirira SOTIRU Ltd *Crédit documentaire* no kuba Acess Bank yagombaga gutegekwa kwishyura yonyine amafaranga yishyuwe umuhanga, ay'ikurikiranarubanza n'ay'igihembo cya avoka.

Kuri izi ngingo Access Bank yireguye ivuga ko yemera gusubiza amafaranga yakase SOTIRU nta mpamvu kandi ikishyura inyungu mu buryo bubazwe neza zitabanje guteranywa n'umwenda remezo. Ku mpamvu yakabiri, yavuze ko nta ndishyi SOTIRU ikwiye kuko izo yaka iterekana ishingiro yazo. Kubijanye na credit documentaire yavuze ko itayari yujuje nibisabwa kugira ngo iyihabwe. Ku kijyanye n'amafaranga y'igihembo cy'umuhanga, yavuze ko impande zombie zayagabana kuko buri ruhande hari ibyo rwatsindiye.

6. Kubara indishyi hashingiwe kuri *business plan* nta shingiro bihabwa, kuko *business plan* muri kamere yayo itagaragaza ibyagezweho hanyuma wenda ngo hagire ikibivutsa nyira byo ahubwo igaragaza urutonde rw'ibyifuzwa kugerwaho, ingamba n'ikiguzi bisaba kugira ngo bigerweho. Ikindi kandi indishyi ntizashingira ku kintu kitariho nkaho cyagombaga kubaho byanze bikunze nk'uko uwabigennye yabitekereje.
