Incmake y'ikibazo: Nshimiyimana yakoranye na Sebutinde amasezerano y'ubugure bw'inzu ku wa 28/12/2014 amwishyura igice cy'ikiguzi ikindi gice gisigaye bumvikana ko azakimuha bamaze gukora ihererekanya mutungo. Kuwa 31/10/2016 Sebutinde yongeye gukora andi masezerano y'ubugure bw'yo nzu na Ciftci amwishyura igice ikindi gice bumvikana ko azakimuha bamaze gukora ihererekanya mutungo, bukeye ku wa 01/11/2016 bayajyana kwa Noteri nawe ayashyiraho umukono.

Nshimiyimana yareze Sebutinde mu Rukiko Rwisumbuye rwa Gasabo asaba ko yakorerwa ihererekanyamutungo, Ciftci agoboka muri urwo rubanza avuga ko uwo mutungo yawuguze binyuze mu masezerano bakoreye imbere ya Noteri. Urukiko rwemeje ko ubutaka bwaguzwe na Nshimiyimana maze rutegeka ko abwandikwaho runemeza kandi ko kugoboka mu rubanza kwa Ciftci nta shingiro gufite.

Ciftci ntiyishimiye icyo cyemezo maze ajuririra mu Rukiko Rukuru, ruza gusanga ubujurire bwe bufite ishingiro rutegeka ko iyo nzu yandikwa kuri Ciftci naho Nshimiyimana agasubizwa amafaranga yatanze.

Nshimiyimana yajuririye urwo rubanza mu rukiko rw'ikirenga maze kubera amavugurura yari yakozwe urubanza ruhabwa Urukiko rw'Ubujurire avuga ko Sebutinde yamugurishirije inzu arusaba kwemeza ko igurisha ry'ikintu cy'undi ari imfabusa. Urukiko rw'Ubujurire bwemeje ko ubujurire bwa Nshimiyimana bufite ishingiro rutegeka ko yandikwaho inzu yaguze hashigiwe ko ariwe waguze iyo nzu mbere kandi ko amasezerano Ciftci avuga ko yakoreye imbere ya Noteri ataribyo kuko kwa Noteri bayajyanyeyo bamaze kuyakora no kuyasinya bityo akaba ahuje kamere n'ayo Nshimiyimana yagiranye na Sebutinde.

Ciftci yaje gusaba ko urwo rubanza rusubirwamo ku mpamvu z'akarengane n'urukiko rw'ikirenga avuga ko Urukiko rubanza rwemeje ko amasezerano ya Nshimiyimana afite agaciro kandi atarakorewe imbere ya Noteri. Yakomeje avuga ko amasezerano ya Nshimiyimana Urukiko rubanza rwahaye agaciro ari inyandiko bwite bityo rukaba rwarirengangije amasezerano ye yakorewe imbere ya Noteri nkuko bitemanywa n'amategeko bityo agasaba Urukiko kwemeza ko

amasezerano ya Nshimiyimana nta agaciro afite kandi rukemeza ko aye ariyo afite agaciro anasaba ko yanakwandikwaho ikibanza kiburanwa. Nshimiyimana we avuga ko Ciftci adashobora kubarurwaho iyo nzu kuko yayiguze n'utari nyirayo dore ko yayiguze yaramaze kugurishwa. Anavuga kandi ko amasezerano avuga ko yakorewe imbere yanoteri ataribyo kuko bayajyanyeyo ku munsi ukurikira uwo bayasinyiye.

[2] Ku itariki ya 31/10/2016, Sebutinde Edouard yongeye gukorana andi masezerano y'ubugure bw'inzu na Ciftci Inanc, bukeye bwaho ku itariki ya 01/11/2016, ayo masezerano bayajyana kwa Noteri na we ayashyiraho umukono. [17] Me Rugaza David uburanira Ciftci Inanc avuga ko impamvu basaba ko urubanza N° RCAA 00035/2018/CA rwasubirwamo ku mpamvu z'akarengane, ari uko mu guca urwo rubanza Urukiko rw'Ubujurire rwirengagije amategeko aho rutabonye ko ari Ciftci Inanc wakoreye amasezerano y'ubugure imbere ya Noteri nk'uko biteganya n'amategeko, mu gihe amasezerano Nshimiyimana Yvon aburanisha ari inyandiko bwite itemewe, bityo agasaba Urukiko kwemeza ko ayo masezerano nta gaciro afite, rugategeka ko umutungo ubaruwe kuri UPI 1/02/07/01/826 ari nawo uburanwa muri uru rubanza ari uwa Ciftci Inanc, ukamwandikwaho kuko yawuguze mu buryo bukurikije amategeko.

Avuga ko amasezerano y'ubugure Ciftci Inanc yagiranye na Sebutinde Edouard atagomba kubangamira Nshimiyimana Yvon kuko atamureba, ko ahubwo akwiye guhabwa umutekano usesuye mu mutungo we yaguze mu buryo bwemewe n'amategeko, kubera ko habayeho kumvikana ku giciro no ku kintu, kandi akaba yarahawe imfunguzo nk'uburyo bwo gushyikirizwa icyaguzwe, bityo amasezerano yagiranye na Sebutinde Edouard mu rwego rw'amategeko akaba yuzuye.

[19] Arangiza avuga ko amasezerano Sebutinde Edouard yagiranye na Ciftci Inanc nayo atakorewe imbere ya Noteri nk'uko uyu abivuga ukurikije igihe yakorewe n'igihe Noteri yayashyiriyeho umukono, kuko yakozwe ku itariki ya 31/10/2016, hanyuma akajyanwa kwa Noteri bukeye bwaho ku itariki ya 01/11/2016. Avuga kandi ko ubusanzwe Noteri w'ubutaka atita ku masezerano, ko ahubwo icyo areba ari ukuzuza inyandiko zabugenewe iyo abona ko umutungo nta kindi kibazo ufite.

Asobanura ko ku birebana n'hererekanya ry'ubutaka, hari amategeko yihariye kugira ngo amasezerano abe akozwe mu buryo bwemewe.

Ingingo ya 34, igika cya mbere, y'Iteka rya Minisitiri N° 002/2008 ryo ku wa 01/4/2008 rigena uburyo iyandikishwa ry'ubutaka rikorwa, iteganya ko ihererekanya rishingiye ku masezerano yo kwegurira undi ibantu ridashobora gukorwa iyo amasezerano rishingiyeho atakozwe ku buryo

bw'inyandiko y'umwimerere¹ (Les mutations en vertu de contrats d'aliénation ne peuvent être opérées que si les contrats sont passés en forme authentique). Iyo ngingo inateganya ifishi igomba gukoreshwa.

Ni ukuva ko Sebutinde Edouard ategetswé gusubiza Nshimiyimana Yvon 12.000.000 Frw kuko ari yo bigaragara mu masezerano ko ari yo yishyuye, naho Ciftci Inanc agasubizwa 30.000 USD agaragara mu masezerano ko ari yo yari amaze kwishyura.
