Urukiko mu rubanza N° RC 00203/2018/TGI/GSBO rwifashishije raporo z’abahanga ndetse n’abatangabuhamywa rwasanze urwo rukuta rwasenyutse biturutse ku gutsikamirwa n’uburemere bw’itaka Murenzi yakoresheje nawe yubaka urukuta rwe ndetse rukaba rwarasaga n’urwegamiye urukuta rwa Mutabazi nuko rutegeka Murenzi na Uwamahoro kwishyura abarega indishyi zinyuranye.

Murenzi na Uwamahoro bajuririye Urukiko Rukuru bavuga ko urukiko rwabanje rwirengagije ko urukuta rwasenywe no kuba rwarubatswe na Murenzi na Uwamhaoro badafite icyangombwa cyo kubaka bityo rwubakwa nabi hatubahirijwe ibipimo kandi ko raporo y'abahanga idakurikije amategeko kuko abayikoze batumvikanye ku mwanzuro, ko ataribo bayishyikirije urukiko kandi ko batayirahiriye. Mutabazi na Muhawenimana nabo bajuririye Urukiko rukuru bavuga ko hari indishyi batahawe zikomoka ku modoka zakodeshejwe zo gutwara itaka. SANLAM nayo yatanze ubujurire bwuririye ku bundi isaba ko indishyi yagenewe mu rukiko rubanza zashyirwa muri uru rubanza.

Murenzi yasabye ko urwo rubanza rwasubirwamo ku mpamvu z'akarengane maze ruhabwa Urukiko rw'Ikirenga ngo rwongere ruruburanishe maze rusuzuma ibibazo by'ingenzi bikurikira: Kumenya niba raporo y'abahanga yashingiweho mu icibwa ry'urubanza No RCA 00499/2019/HC/KIG- CMB RCA 00506/2019/HC/KIG ikwiye guteshwa agaciro no kumenya icyateye isenyuka ry'urukuta rw'urugo rwa Mutabazi na Muhawenimana.

Usubirishamo urubanza yatanze inzitizi y'uburegeke avuga ko hari ikirego Mutabazi yatanze mu Rukiko rw'Ibanze rwa Gasabo kandi kikaba gifitanye isano n'Uru rubanza akaba aribyo byabanza gusuzumwa. Asobanura ko muri urwo rubanza haregerwa ubwishyu bw'urukuta rushya rwubatswe n'agaciro k'amazu ya annexes yasenye rwubakwa. Icyo kirego gisaba kubanza kwemeza nyir'uburyozwe, hakaba hari impungenge z'uko icyemezo urwo rukiko rwafata cyaza kinyuranye n'ikizafatwa n'uru Rukiko bityo agasaba ko zahurizwa hamwe ngo hirindwe ko ibyemezo byafatwa byaba bivuguruzanya.

### **I. IMITERERE Y'URUBANZA.**

[1] Uru rubanza rwatangiriye mu Rukiko Rwisumbuye rwa Gasabo, Mutabazi Abayo Jean Claude na Muhawenimana Joselyne bavuga ko ku bw'amakosa y'imyubakire mibi ya Murenzi Alphonse na Uwamahoro Jacqueline, ku wa 25/05/2018, urukuta rw'urugo rwabo rwasenyutse, rwangiza imodoka ebyiri, amazu ya annexes, ibigega by'amazi n'inkingi z'ibyuma byari bibifashe. Basabye ko iryo senyuka n'ibyangijwe biryozwa Murenzi Alphonse na Uwamahoro Jacqueline, bagategekwa kubaha indishyi zitandukanye.

[2] Murenzi Alphonse na Uwamahoro Jacqueline bavuze ko nta ruhare bagize muri iryo senyuka ry'urukuta rwabo, ko Mutabazi Abayo Jean Claude atagaragaza ko ubwo Murenzi Alphonse yubakaga aribwo haje umututu muri urwo rukuta. Yasobanuye ko isenyuka ry'urukuta ryatewe n'ibiza byasanze Mutabazi Abayo Jean Claude yarubatse nabi kuko yubatse atabiherewe uruhushya, asaba Urukiko kwemeza ko ikirego nta shingiro gifite.

[3] SORAS AG Ltd (yahindutse SANLAM Assurances Générales Plc) yagobotse mu rubanza, isaba ko Murenzi Alphonse na Uwamahoro Jacqueline bategekwa kuyishyura 2.183.000 Frw yakoreshejwe hasanwa imodoka RAD 995F yangiritse bitewe n'isenyuka ry'urukuta rwabo.

[5] Murenzi Alphonse na Uwamahoro Jacqueline bajuririye Urukiko Rukuru bavuga ko Urukiko rwirengagije ko kuba urukuta rwa Mutabazi Abayo Jean Claude rutarihanganiye amazi byatewe n'uko atubahirije ibipimo kuko yubatse atabihereye uruhushya. Bavuga ko na raporo y'Abahanga yashingiweho hafatwa icyemezo ku rwego rwa mbere yakozwe mu buryo bunyuranije n'amategeko kuko abayikoze batumvikana ku mwanzuro yagezeho, ko ataribo bayishikiriye Urukiko ndetse ko batayirahiriye. Mutabazi Abayo Jean Claude na Muhawenimana Joselyne nabo bajuririye Urukiko Rukuru bavuga ko hari indishyi batahawe kandi bazikwiriye, ko bagenewe amafaranga make kuyo bakodesheje imodoka nyamara ibimenyetso batanze bihamya ko imodoka RAD 586 M yishyuwe 850.00 Frw naho RAC 847 Y yishyurwa 360.000 Frw.

[6] SANLAM Assurances Générales Plc yatanze ubujurire bwuririye ku bundi, isaba ko 2.183.000 Frw yemejwe ku rwego rwa mbere ashirwa mu cyemezo cy'Urukiko Rukuru.

Mu Rukiko rw'Ibanze harasabwa uruhare rwa Murenzi Alphonse na Uwamahoro Jacqueline ku rukuta n'amazu ya annexes yubatswe nyuma y'isenyuka ry'urukuta rwa Murenzi Alphonse. Mu Rukiko rw'Ikirenga harasabwa ibintu umunani (8), ku bijyanye n'urukuta n'amazu ya annexes, harasabwa ikiguzi cya 34.038.316 Frw z'ibyangiritse, bityo kwishyura ikiguzi cy'ibyubatswe no kwishyura ikiguzi cy'ibyangiritse bikaba bitakwitiranywa cyane cyane ko ntaho bigaragara ko agaciro kishyuzwa kubyangijwe kangana n'agasabwa kubyubatswe. Kuri iyi ngingo, umuhanga Serge Guinchard avuga ko uburegeke bubaho iyo inkiko zaregewe ikirego kimwe zigifitiye ububasha, bivuze ko iyo rumwe muri izo nkiko rudafite ububasha, hatangwa inzitizi y'iburabubasha aho kuba

iy'uburegeke.<sup>1</sup> Loïc Cadiet na Emmanuel Jeuland nabo bashimangira ko uburegeke bubaho iyo inkiko ebyiri zaregewe urubanza ruhuriye ku kiburanwa kimwe hagati y'ababuranyi bamwe kandi zombi zirufitiye ububasha.<sup>2</sup>

Naho urubanza N° RS/INJUST/RC 00009/2021/SC ruri kuburanishwa n'uru Rukiko rwarangirije inzira z'ubujurire zisanzwe n'izidasanzwe mu Rukiko Rukuru. Urukiko rw'Ikirenga ruri kuruburanisha mu rwego rwo kurusubirishamo ku mpamvu z'akarengane hashingiwe ku biteganywa n'ingingo ya 53, igika cya mbere, y'Itegeko n° 30/2018 ryo ku wa 02/06/2018 ryavuzwe haruguru, iruha ububasha bwo kuburanisha imanza zose zisubirishwamo ku mpamvu z'akarangane cyane cyane izigamije gutanga umurongo wihariye ku zindi nkiko.

[21] Urukiko rurasanga kandi ibivugwa n'ababuranyi ko nubwo nta buregeke bwaba buriho izo manza zombi zahuzwa mu nyungu z'ubutabera kuko n'ubundi Urukiko rw'Ikirenga rufite ububasha buruta ubw'Urukiko rw'Ibanze nabyo nta shingiro bifite. Nubwo ingingo ya 100, igika cya mbere, agace ka 3, y'Itegeko N° 30/2018 ryo ku wa 02/06/2018 ryavuzwe haruguru iteganya ko iyo hari uburegeke Urukiko rwisumbuyeho ruhabwa ibanze (priorité/ primacy) ku rukiko rwo hasi, ntibivanaho ko hagomba kubanza kubahirizwa amahame ateganywa n'icyo gika y'uko inkiko ziba zararegewe ikirego kimwe hagati y'ababuranyi bamwe kandi zikaba zose zigifitiye ububasha.

[22] Urukiko rurasanga kubibona ukundi hakomezwa ko imanza zihuzwa bitewe gusa n'uko urubanza rumwe ruri mu Rukiko rukuriye urundi bitaba bitewe n'uko hari uburegeke hagati y'ibirego ahubwo byafatwa ko bishingiye ku gushyira mu gaciro k'Urukiko. Nyamara kandi gushyira mu gaciro k'Urukiko bigomba kwitonderwa. Tom Bingham wahoze ari Perezida w'Urukiko rw'Ikirenga rw'Ubwongereza, kimwe mu bihugu bizwiho cyane guteza imbere iryo hame, yibutsa ko Urukiko rutiyambaza iryo hame mu kwemeza ibyabaye (facts) cyangwa ibasanzwe biteganywa n'amategeko. Ahubwo ko iyo rumaze kubona ibyabaye n'amategeko agomba gushingirwaho, aribwo ruba rwemerewe gufata ibyemezo bitandukanye, icyo gihe
