[51] Muri uru rubanza, Mudenge Emmanuel n'abamwunganira bahera ku ngingo ya 64 y'Itegeko N° 25/2005 ryavuzwe haruguru, bavuga ko RRA ariyo yagombaga kuregera Ubushinjacyaha. Nk'uko byavuzwe haruguru, iri tegeko ryaje guhindurwa n'Itegeko N° 026/2019 kandi muri iri tegeko, nta hateganyijwe ko kugira ngo icyaha cyo kunyereza umusoro gikurikiranwe n'inzego zishinzwe ikurikiranacyaha, RRA igomba kubanza kuzishyikiriza ikirego. Ikibazo gisigaye gusuzumwa akaba ari igehe ryakurikizwaga igehe Ubushinjacyaha bwatangiraga ikurikiranacyaha ry'icyaha cyo kunyereza imisoro kuri Mudenge Emmanuel.

[52] Ihame rusange ni uko amategeko ajyanye n'imihango ikurikizwa mu ikurikirana ry'icyaha n'abafite ububasha bwo kugikurikirana ari amategeko y'imigenzo ikurikizwa (règles de procédure /procedural rules), akaba ahita ashirwa mu bikorwa akimara gusohoka (les règles de procédure sont d'application immédiate/ procedural rules are immediately applicable), kuko aba agamije kunoza ibikorwa by'ikurikiranacyaha. Urukiko rurasanga Itegeko N° 25/2005 ryavuzwe haruguru ryakurikizwaga ubwo ibikorwa Mudenge Emmanuel akurikiranyweho byakorwaga, kimwe n'Itegeko N° 026/2019 ryo ku wa 18/09/2019 rigena uburyo bw'isoresha ryakurikizwaga ubwo yatangiraga gukurikiranwa, ari amategeko afite impu zombi (lois de fond et de forme/ substantive and procedural laws) kuko agena uburyo icyaha kigomba gukurikiranwa n'abafite ububasha bwo kugikurikirana akanateganya ibihano, ariko ikibazo gisuzumwa muri uru rubanza kikaba gishingiye ku kumenya ufite ububasha bwo gukurikirana, kuko icyo Mudenge Emmanuel n'abunganizi be banenga atari ibihano, ahubwo ari ukuba Ubugenzacyaha bwaratangiye ibikorwa by'ikurikiranacyaha butabisabwe na RRA.

[53] Urukiko rurasanga, hashingiwe ku ihame ryavuzwe haruguru ry'uko amategeko y'imigenzo ikurikizwa (règles de procédure /procedural rules) ahita ashirwa mu bikorwa akimara gusohoka (les règles de procédure sont d'application immédiate/procedural rules are immediately applicable), kuba Mudenge Emmanuel yaratangiye gukurikiranwa ku itariki ya 06/05/2020 (bigaragara ko habayeho kwibeshya umugenzyaha yandika ko ari mu mwaka wa 2019),⁴ Itegeko N° 026/2019 ryo ku wa 18/09/2019 ariryo ryagombaga gukurikizwa, kandi nk'uko byibukijwe haruguru, iby'uko nyuma yo kubona ko hari umusoreshwa wanyereje umusoro Ubuyobozi bw'imisoro bushyikiriza ikirego Ubushinyacyaha, ntibyagarutsemo. Ibi bikaba byumvikanisha rero ko nta cyabuzaga Ubushinjacyaha gutangiza ikurikiranacyaha butabanje kuregerwa na RRA.

[54] Ku birebana n'ingingo ya 3, agace kayo ka 5, y'Itegeko N° 08/2009 ryo ku wa 27/04/2009 rigena imiterere, imikorere n'inshingano by'Ikigo gishinzwe kwinjiza mu isanduku ya Leta imisoro n'amahoro (RRA), Mudenge Emmanuel n'abamvunganira baburanisha bashaka kugaragaza ko RRA ariyo igomba gukora iperereza ku byaha byo kunyereza imisoro, Urukiko rurasanga nta shingiro bifite kuko iyo ngingo ntaho igaragaza ko ariyo yonyine ifite inshingano yo kugenza bene ibyo byaha, mu gihe Ubushinjacyaha bwo bufite inshingano rusange yo gukora iperereza no gukurikirana ibyaha mu gihugu hose⁵ harimo n'ibyaha bimunga ubukungu n'imari by'igihugu.⁶

[55] Urukiko rusanga iby'uko Urwego rushinzwe imisoro rwabanza gushyikiriza ikirego Ubushinjacyaha byaragaragaraga no mu mategeko y'ibindibihugu, nko mu Bufaransa, aho bamaze igihe kirekire amategeko yabo ateganya ko gukurikirana icyaha cyo kunyereza umusoro bigomba gutangizwa n'uko Urwego rushinzwe imisoro rubanza gushyikiriza ikirego Umushinjacyaha kandi bikaba byanemejwe na Komisiyo ishinzwe ibyaha byerekeye imisoro. Ubu buryo bwari bwashyizweho hagamijwe kurengera uburenganzira bw'abasoreshwa no kubarinda kuba bahohoterwa n'Urwego rushinzwe imisoro. Cyakora ubu buryo bwakomeje kunengwa cyane cyane hashingiwe ku kuba ari imbogamizi ku butabera, kuba busumbanya abantu n'ibindi, kuko byagaragaraga ko amadosiye yoroheje ari yo aregerwa mu Bushinjabyaha, naho amadosiye agoye akabanza gukemurirwa ku rwego rw'Urwego rushinzwe imisoro bigatuma abanyabyaha bazi amayeri menshi kimwe n'abakoresha uburyo buhambaye mu gukora ibyaha batagezwa imbere y'ubutabera.

Nibyo byatumye mu mwaka wa 2018 hakorwa amavugurura kuri ubu buryo bwo kubanza gutanga ikirego bikozwe n'Urwego rushinzwe imisoro, hongerwaho ubundi buryo bw'uko ku madosiye igenzura ryagaragaje ko afite uburemere bwihariye, Urwego rushinzwe imisoro rutegetswe kujya ruyamenyesha Ubushinjacyaha.⁷ Ikindi ni uko, nk'uko Urukiko rushinzwe kurinda Itegeko Nshinga mu Bufaransa rwabivuze mu isesengura ry'icyemezo N° 2016-555 QPC cyo ku wa 22 Nyakanga 2016, guhera igihe igika cy'ingingo ya 1741⁸ cyaviriyeho, nta yindi ngingo iteganya mu buryo bweruye ko gutangiza ikurikiranacyaha ry'icyaha cyo kunyereza imisoro rigomba kubanzirizwa n'ikirego cy'Ubuyobozi bw'Imisoro.⁹

[56] Hashingiwe ku bisobanuro byatanzwe haruguru, Urukiko rurasanga ikirego cy'Ubushinjacyaha ku cyaha cyo kunyereza imisoro cyaratanzwe mu buryo bukurikije amategeko, bityo Urukiko Rukuru rukaba rwaragombaga kucyakira rukagisuzuma.
